Eriz gets 40 years to life for freeway shooting

He was convicted in January of killing Aiden Leos, 6, on 55 Freeway.

A man who opened fire at a car during a road-rage confrontation on the Costa Mesa (55) Freeway, killing a 6-year-old boy who was strapped in a child seat as his mother drove him to kindergarten in Yorba Linda, was sentenced Friday to 40 years to life in prison.

Marcus Anthony Eriz, 26, of Costa Mesa, was convicted in January of second-degree murder and firing at an occupied vehicle for the deadly May 21, 2021, shooting on the freeway that killed Aiden Leos. Jurors also found true allegations of personal use of a handgun.

Co-defendant Wynne Lee, 26, Eriz's girlfriend, is awaiting trial for being an accessory after the

Laguna looks to rehabilitate its historic fire engine

The 1931 Seagrave served the city's fire department until 1962.

Laguna Beach has a host of traditions it celebrates, including an annual visit by jolly old St. Nicholas, who used to ride into downtown each December on a vehicle nearly as old-fashioned as his fabled sleigh.

A 1931 Seagrave fire engine, the original apparatus purchased by Laguna Beach, is being kept at Fire Station No. 2 on Agate Street. When it was new the fire engine cost \$7,500, which would equate to nearly \$150,000 today.

"The city incorporated in



Chalupnik played big for Newport Harbor

Ryan Chalupnik was not a focus for the Newport Harbor High girls' water polo team when the Sailors won the CIF Southern Section Open Division title in 2022.

She still not only got in the water as a sophomore, but scored a fourth-quarter goal in the title-match win over Laguna Beach.

"That was a great moment," she said.

Coming back for her final two years, Chalupnik immediately became the starting center, the player that opponents tried to shut down.

The Sailors (19-10) couldn't quite get back to the Open Division title match, but it wasn't for lack of effort. They pushed eventual champion Orange Lutheran in the semifinals this year before falling 7-6; the Lancers would go on to an undefeated season.

Meanwhile, Newport Harbor suffered seven one-goal losses. Yet, every time, Chalupnik led the team back to work.

For her efforts, she is the 2023-24 Daily Pilot Dream Team Player of the Year.

Newport Harbor still shared the Surf League title with Laguna Beach this season, with Chalupnik earning co-league MVP honors and All-CIF accolades. The Sailors finished fifth at the Santa Barbara Tournament of Champions, the highest of any local team.

On a team that had contributions from every grade level, including three freshmen, the UCLA-bound Chalupnik's work ethic helped set the tone.

"Coming into this season, all of us seniors

fact. Eriz was a passenger in the car driven by Lee when the shooting oc-

Aiden's mother, Joanna Cloonan, was driving her Chevrolet Sonic with the child strapped into a child seat in the back seat of the vehicle, taking the boy to kindergarten in Yorba Linda. At about 8 a.m., Cloonan and her son were cut off by the defendants in a Volkswagen Golf Sportwagen with Lee behind the wheel of the car. Lee made a peace sign, which Cloonan took as sarcastic, and a few miles later as Cloonan was merging over to the Riverside (91) Freeway east she passed the defendants and gave them a middle finger, Senior Deputy Dist. Atty. Dan Feldman said during opening statements of the trial.

The defendants then positioned their car behind Cloonan's, and Eriz fired a shot from a 9-millimeter Glock that struck the Chevrolet, went into the passenger compartment and hit the boy.

Cloonan, who northbound on the freeway, heard a loud bang that sounded like a rock striking her vehicle followed by her son's cry, Feldman said. She immediately pulled over, the prosecutor added.

Her son, who had turned 6 a week and a half before the shooting, was bleeding from a bullet that ripped through his liver, lungs and heart before coming out of his abdomen, Feldman said. The boy died in her arms.

Lee and Eriz, who lived together in a Costa Mesa apartment, were driving to their workplace at Gerber Glass, a collision repair shop, Feldman said. Eriz kept his loaded gun in the car.

During the sentencing hearing, Eriz issued an emotional apology to Cloonan and her family, referring to Aiden as "a son, a little brother and a friend to others," as well as "truly one of God's little angels."

"I am so sorry for ever hurting him, and the pain he went through because of me," Eriz said.

He later added, "Ms.

Cloonan, I am truly sorry." Orange County Superior Court Judge Richard King acknowledged Eriz's apology, but said he killed "the most vulnerable vic-

tim that you can even imagine" — a 6-year-old boy in the back seat of his mother's car, going to school. "She, the mom, did

some driving maneuver that caused your girl-friend to give the peace sign, that caused the mom to flip [you] off, that caused you to get behind the car," the judge said. "And in that particular moment, you had the power. And the power was handgun. And whether it was to impress your girlfriend, to release your anger, you fired. And that little boy died. And when everything is said and done, that's what

happened. King said there was "no legal justification being provoked other than, 'I'm going to get back at her."

As for the mother's suffering, King said, "I don't think the English lan-

guage can even attempt to describe what Aiden's mother went through after he says 'ouch.' ... She pulls over and her little boy dies in her arms. I don't think anyone can comprehend what the rest of her life is going to be like. And the court puts a great weight on that."

Orange County Dist. Atty Todd Spitzer recalled after the hearing Friday how he said during a news conference while authorities were looking for the killer that he wanted the shooter to turn himself in or else he would bring the full force of the law on him.

"He didn't, and we had to find him and catch him," Spitzer said.

Spitzer railed against the defense attorney and state legislators for laws that give judges discretion to strike gun-use enhancements in some cases for defendants 25 younger. Spitzer claimed that gang members are taking advantage of the law to "give the gun to a kid," who will get a lesser sentence.

community art project was launched four years ago on Balboa island to create a massive iridescent tile mural under the direction of a grassroots committee of Balboa Island residents. Local artist Barbara Abbott was selected to design this mural.

Now in the final phase of transforming her design, showcasing a series of individual

panels depicting iconic and historic images of Balboa Island landmarks, a fundraising campaign has been launched to secure taxdeductible support of

"The creative process has been a great joy," Abbot said. "I am sincerely proud to be able to share this urban art form with our own Newport family community, along with so many people who visit Balboa Island year-round. Most exciting and gratifying is that the mural will hopefully bring a smile to faces

for generations to come." More than decoration, this mural is a legacy gift. The half-inch squared recycled vitreous glass mosaic tiles fabricated by Charleston, Mass.-based Artaic Innovative Mosaics, will be installed by Palace Stoneworks, a highly experienced installation team that has placed similar art on the walls of the UCLA Botany Building (a mural designed by the late renown Los Angeles based architect and artist Paul Williams), and recently, an installation in Huntington Beach on a massive fivestory wall at the Paséa

Hotel on Pacific Coast Highway. The Paséa mural is a remarkable visual of a turning wave, about to crash on shore.

The Park Avenue Mural Project committee was formed by **Lee** and **Sue Pearl**, who invited Island residents to join. Among the committee members are Miriam Baker, Debra Huse, Georgie Fenton, Terry Janssen, Pierce Stemler, Shirley Pepys Cynthia Shafer, Michelle Bendetti and Lisa Skelly.

Abbott was selected as the artist/designer following an outreach for proposals for the assignment.

Presented to the Balboa Island Improvement Assn. and adopted by the Balboa Island Museum Board of Directors, led by president John Conners and founder/CEO **Shirley Pepys**, the large undertaking became a reality given the generous support of Irvine Ranch Market building owner and businessman Manouch Moshayedi.

Fabrication will continue over the next six months, followed by wall preparation, including lighting and painting. The completed work will not fade and will be graffiti resistant, allowing the tiles to be cleaned.

In our age of technology, QR codes may be installed as well, allowing visitors gazing upon the mural to learn the local Balboa Island history using both audio and visual materials.

With the gift of the blank wall at the local Irvine Ranch Market, the mural project fundraising campaign, led by the Pearls and Fenton, is proceeding with the call for action of gathering funds to cover the costs of fabrication and installation.

"We are seeking as many generous community art lovers as we can and encourage all to share in

Barbara Abbott's celebration of the island's unique heritage. Every donation matters. We need to complete our campaign by midsummer," said Lee Pearl, who has championed other civic art projects in the community with his wife. "Art is so important to the soul of the community. We must support and celebrate this legacy project."

Famed production designer to talk plants on sets

BY SARA CARDINE

Whether peeking out of a mantelpiece vase or sumptuously surrounding broad architectural planes, the plants that appear on a television or film set are often as meticulously selected as the actors at the center of a scene.

Perhaps no one knows this better than Nelson Coates, an Emmy Award-winning production designer whose painstaking attention to detail has graced and enhanced the sets of numerous film and television hits, including "The Morning Show" on Apple TV+ and the visually resplendent "Crazy Rich Asians."

For more than three decades Coates - an architect and interior design expert who splits his time between Laguna Beach and Studio City — has been building sets in studios and on location, ensuring every plant and flower not only accurately represents the time and location being portrayed in a scene but also drives the narrative of a character or story arc.

"There are ways you can see the story through the plants and through the natural environments and not-so-natural environments

you make with natural things," he said in an interview Thursday.

"If a character is eccentric, maybe you have 30 pots of ivy. Or maybe it's a super-tailored wall of sansevieria, and it's really tight and orderly. [With] anything you

put in front of the camera — if you're a good storyteller there should be no unnecessary elements."

Coates will explore the impact of plants and gardens in film narratives in a lecture Tuesday evening at Sherman Library & Gardens, as part of a monthly series that features speakers and topics intertwining history, horticulture and the arts.

Scott LaFleur, executive director of the Corona del Mar botanical garden, said he became affiliated with the designer and his work through Coates' partner Ruben Flores, owner of Laguna Nursery, whom he met shortly after arriving at the Gardens in

But it wasn't until several years later, when he heard Coates speak during a meeting of the Men's Garden Club of Los Angeles on the topic of plants in productions, that he knew he'd be a perfect fit for the series.

"He was one of the most wellreceived speakers we've ever had. I absolutely knew he'd be a knockout and so worked with him to get him on the calendar," LaFleur recalled Thursday. "He was really engaging, and the subject matter, for the gardens, was right on spot. And who doesn't love Hollywood and the movies and this wonderful thing we have here?

In addition to elaborating on the narrative elements embodied by different species of flora, Coates may also discuss the importance of understanding how plant propagation, selection and arrangement changes from one era to the next and from place to

"One of the things that's really interesting is to see how, just like fashion, plants come in and out of style in an environment," he said, time-hopping from Victorian "parlor palms," to fiddle-leaf figs. 'Floral design has also changed over time, so you want to make sure your choice of a combination of flowers fits a certain period.

'You have to immerse yourself in an entire era, immerse yourself in the culture and in the characters," he continued. "I'm a visual anthropologist, basically."

"Creating Worlds – The Impact of Plants and Gardens in Film Narratives" takes place Tuesday, from 7 to 8 p.m. at Sherman Library & Gardens, 2647 East Coast Hwy, in Corona Del Mar. Tickets cost \$5 for members, \$10 for nonmembers. For more information, visit thesherman.org.

1927," Laguna Beach fire battalion chief Andrew Hill said. "A couple years later, they built Fire Station No. 1 in downtown, and they bought this engine, which was the very first engine the city ever owned that was a commercially built fire engine.

"Prior to that, the firefighters used kind of a mixed bag of vehicles that were converted to serve as firefighting units. This engine was the city's first purpose-built engine, and it was in service from March of 1931 to June of

Hill said he spoke with an outof-state fire engine expert about the Seagrave, and when the latter took note of there being two wheels on both sides in the back, he said the vehicle would have been built for an area with a lot of hills.

That drew a laugh from Hill, who knew the expert had identified a main feature of Laguna without having been

The Seagrave would convince few that it belongs on the road, although it could pass for a vehicle found on Main Street inside

proudly. "This was a Laguna Beach engine, and it never left here. It always stayed here. The city's always kept it, and I think

that's pretty unique. Our goal is to restore it, restore it very well, ... but allow people to still climb on it, allow the kids to get on it, allow the community to enjoy it up close and personal and not behind a velvet rope."

Hill envisions the engine, transmission and brakes being modernized, making it functional for decades to come.

City Councilman George Weiss said the restoration effort could be funded through a combination of city funds and community contributions. He said an agenda item could come to the City Council in the near future to help with the repairs for the fire engine, which he called "a nostalgia piece."

"It's going to be a fun project to get off the ground," Weiss said. "I think only part of the work is over. The big work is getting the public awareness of it and then to raise the money for it on a collaborative basis."

F.V. denied bid for Wave League crown

The elation that had greeted the day, one that promised, hope assured, to be something truly special, had drifted into a resigned acceptance by the close of Fountain Valley's opportunity Thursday evening to claim an outright Wave League boys' volleyball championship.

The Barons had not arrived in their best guise and never appeared, no matter how tight the margin, to challenge enduring Wave League power Los Alamitos. The 25-23, 25-20, 25-18 home defeat was baffling.

"It wasn't us tonight," Fountain Valley coach Rebecca Cheltenham offered.

Fountain Valley (21-5, 4-1) is still in line to win a share of the Wave League crown, the program's first league title in 20 years, unless something crazy happens in next week's finales. And then there's the promise, if on its game, of contending for the CIF Southern Section Division 3 championship.

"It's a huge disappointment," said outside hitter Thomas Ho, one of the Barons' two senior leaders. "But we still get the coleague champ title, so it isn't too bad. I feel like we didn't play our best, but what can you do? Some days we're on, some days we're off. Today, we definitely didn't show up like how we normally do, or else we would have definitely taken the title.

They ought to claim their share, and maybe more, and Los Alamitos (12-15, 4-1) its portion, in home games Wednesday. Fountain Valley takes on Laguna Beach (3-14, 0-5), which has captured just six sets all season — all in tournament play on Feb. 17 and has dropped a dozen consecutive straight-set decisions. The Griffins have a tougher test, against Marina (10-14, 2-3), which took them to five games in mid-

Los Alamitos, which won the first three Wave League titles after the Sunset League split in 2018 and last year was on the superior Surf League side of the conference, was in charge from the start, a few tense moments aside, and trailed after just 11 of the 136 rallies in the romp. They were dominant at the net, sharper with the ball, and far more assertive.

"We didn't come out with the right mindset. I'm not sure what mindset it was ...," said Cheltenham, who in two years has guided Fountain Valley, hardly a power beforehand, to a 43-12 record, two victories over the Griffins (after one in 17 league meetings over the previous eight seasons), into last year's Division 3 quarterfinals, and to the No. 2 spot in the current Division 3 rankings.

"We couldn't figure out a way to be consistent in the back line, but more so in our hitting and blocking. [Los Al] did a good job at swinging, and we had a hard time stopping them, a hard time slowing them down.

Ho, who said the team came in "a little intimidated" and failed to "play delivered together," game-best 13 kills, but the Barons lacked other weapons. Ivy League-bound opposite Bennett Heydorn, their other leader and usually a force at the net, was diminished after working on a school assignment until almost dawn and getting little sleep before school. He contributed seven kills, but Cheltenham pulled him for the third set.

"It's hard when your key players aren't on," she said. You've got to have them all on.

Los Alamitos, led by outside hitters Jette Estes (10 kills) and Enzo Kerley (six kills, two blocks, three service aces) and middle blocker Adrian Parra (nine kills, four blocks), used big, mostly early runs to take

command in each set.

The Griffins dropped a five-set decision, with just two points separating the teams over the duration, in the first meeting three weeks earlier. This time they didn't falter, weathering a late Fountain Valley rally in the opening set (a five-point lead whittled to 24-23, the last point on an Alec Pinedjian ace, before the Barons hit long on the final rally).

"We beat them last time because everyone had a great game," Cheltenham said. "I think maybe they were a little off [in that game], and they had a great, fantastic day tonight, and we had people who were a little off. That's the reality. It's going to be good for us going into CIF continuing to understand that we have to show up. That's

what I keep telling them." The dissatisfaction will pay off, Ho said.

"Now we're working 10 times harder, I promise you," he said. "I promise you we're working 10 times harder. We're going to be in the gym, we're practicing probably longer, we're going to get everyone on a gym plan right now, and we're going to show at CIF, for sure.'
