Aspiring social media maven's Make-A-Wish request brings her to South Coast Plaza

Teen Kate Guerrero's epic journey living with non-Hodgkin's lymphoma inspired her to share her story on social media. Macy's and Make-A-Wish helped give her dream a leg up on Monday.

Even amid a pandemic, wishes can come true — just ask 16-year-old Kate Guerrero, a San Bernardino resident and budding YouTube influencer who on Monday received the red-carpet treatment at Macy's South Coast Plaza, courtesy of the Make-A-Wish Foundation.

Kate rolled up to the Costa Mesa shop-

Officials: Hospitals could be overrun

Governor warns of stricter measures, including a stay-at-home order, as COVID-19 hospitalization numbers surge in state.

With coronavirus cases on the rise, Gov. Gavin Newsom on Monday indicated that a stay-at-home order could again be on the way if hospitalization numbers do not improve.

State and public health officials expressed concern that the healthcare system could be overrun in the upcoming weeks by the pandemic as it is surging once more.

Data presented during Newsom's coronavirus briefing showed that approximately 75% of intensive care unit beds in California are currently occupied. Projections for ICU capacity have Southern California reaching its limit by mid-to-late December. The region is currently at about 74% capacity for its ICU beds.

"If these trends continue, we're going to have to take much more dramatic, arguably drastic action," Newsom said.

Those actions could include a stay-at-home order for regions in purple that is more along the lines of the one seen earlier in the year. The state announced that there are now 51 counties in the purple tier. That number includes Orange County, which slipped back into the most restrictive tier regarding virus transmission on Nov. 16.

The state has already issued a curfew of 10 a.m. to 5 p.m. for counties in the purple tier through Dec. 21.

"We're not just now looking at positivity rates," Newsom said. "We're not now just looking at case rates. We are now looking in real time at hospitalization numbers and ICU capacity in those regions."

The Orange County Health Care Agency reported Tuesday that the county currently has 648 hospitalizations due to COVID-19, the disease caused by the virus. The number of

Newport insurance agent pleads not guilty in \$4M fraud scheme

A 63-year-old Newport Beach insurance executive pleaded not guilty to charges in what state authorities said was a \$4-million securities fraud scheme that affected more than 20 victims.

Robert Andrew Lotter denied more than 20 felony charges filed against him, which include assertions of untrue statements or omission in connection with purchase or sale and use of a device, scheme or artifice to defraud with sentencing enhancements

aggravated white-collar crime, according to court records. Jail records state Lotter was arrested on Nov. 24 with his co-defendant, Charles Albert Major, 71.

Court records show charges dating incidents as far back as

State officials said in a statement issued the day after the arrests that an investigation by the California Department of Insurance alleges that Lotter and Major fraudulently solicited and sold victims more than \$4 million in

stock certificates in both of Lotter's companies — eAgency, Inc. and Mymobilewatchdog, Inc.

Officials said that Lotter owns R.A. Lotter Insurance Marketing, Inc. and that Major, a resident of Irvine, was a licensed insurance

Investigators said the two contacted clients of R.A. Lotter Insurance Marketing and used various schemes to fraudulently obtain private financial information in order to identify potential in-

Catmosphere Laguna, county's first cat cafe, closes due to pandemic

In May 2017, Gail Landau was in the Southeast for her stepson's graduation from the College of Charleston.

Before she left Charleston, S.C., the self-proclaimed feline afficionado stopped by a cat cafe. Her first thought was that Laguna Beach was ready for the same sort of experiment.

"I wrote my business plan on the airplane on the way home," Landau said, "and I presented at City Hall the next week."

By the summer of 2018, Landau had opened Catmosphere Laguna, Orange County's first cat cafe.

The cat cafe and lounge brought happy memories for many. Landau, who has a lexicon of cat puns at her disposal, said that people could sit down

for "meow-mosas" for brunch,

have birthday parties, and even get engaged.

"I got the ring ahead of time from the gentleman, and I took one of the cats that his fiancé was very interested in and took her collar and put the ring on the collar," Landau said. "When the cat walked over to her, the ring was hanging from the collar. There was not a dry eye in the room."

Unfortunately, the Laguna Beach cat cafe, like many businesses, has found it difficult to operate during the coronavirus pandemic, and last week, the decision was made to close its

Although the brick and mortar aspect of her operation is going away for now, Landau said the mission to find the "purrfect" home for abandoned and

Move toward regular COVID-19 testing for healthcare workers brings relief

Following numerous rallies and demonstrations among California healthcare workers for more workplace protections against a swiftly surging coronavirus, state health officials have released guidelines recommending hospitals regularly screen employees and newly admitted patients for COVID-19.

In a Nov. 25 all-facilities letter issued by California Public Health Department, Deputy Director Heidi Steinecker strongly recommended general acute care hospitals implement a weekly screening testing program for all healthcare workers by Dec. 14.

Employees determined to be at high risk of contracting the virus should be tested starting next week, the letter states.

"Routine SARS-CoV-2 screening testing of hospital healthcare personnel may aid in early

detection and work exclusion of infected healthcare providers, reduce transmission of risk to other healthcare providers and

patients and prevent hospital outbreaks," Steinecker wrote.

Hoag receives \$7.5 million from O.C. philanthropists Julia and George Argyros

Hoag Memorial Hospital Presbyterian in Newport Beach announced that it has received a \$7.5-million donation from philanthropists Julia and George

The gift will be directed to Hoag's nursing services. Hospital officials said that the Argyros family has given tens of millions of dollars to Hoag. A total of \$15 million was directed to Hoag's nursing, with the \$7.5-million donation in November building upon a previous gift in 2016.

Dr. Flynn Andrizzi, the president of the Hoag Hospital Foundation, said the gifts from the Argyros family have provided scholarships to more than 1,300 nurses to pursue advanced education.

"As a direct result of Julia Argyros' extraordinary generosity and kindness, her name has become synonymous with Hoag's commitment to nursing excellence," Andrizzi said in a statement.

In response to the 2016 gift, Hoag established the Julia Argyros Center for Nursing Excellence.

"The enormity of the impact of her gifts is incalculable," Andrizzi. said. "It is safe to say that every nurse scholar at Hoag, and every

patient and family member whose lives they touch, has good reason to be grateful to her. All of us at Hoag certainly are."

Rick Martin, Hoag's senior vice president of clinical operations and chief nursing officer, described the \$7.5-million gift as a "watershed."

Martin said the gift would allow for Hoag to push "beyond generalized nursing to a comprehensive corps of nurse specialists" and would elevate Hoag's care by expanding advanced nursing education. Hospital officials said that about 83.2% of Hoag nurses have received their bachelor of science in nursing degrees, while others have gone on to receive their master's.

"For many years, I have watched with great admiration as Hoag has used its resources to thoughtfully develop what is without question one of the nation's finest nursing services," Julia Argyros said in a statement. "Hoag's nurses are incredibly talented, dedicated and compassionate."

Hoag Memorial Hospital Presbyterian has received other large donations this year, including from philanthropist Sue Gross.

Huntington Beach-based Surfline announces \$30M investment, hiring of CEO

Surfline\Wavetrak Inc., the company behind the surf forecasting website Surfline, announced Tuesday that it has received an investment of \$30 million from investment firm TCG.

Additionally, the Huntington Beach-based company announced that it has appointed Kyle Laughlin as its CEO. Laughlin takes over for Jeff Berg, who will remain in the company as executive chairman.

Surfline, which says it has more than 3 million users, is where surfers turn to access surf conditions. It is powered by a 35-year data set, as well as proprietary swell, wind and weather modeling.
It features live high-defi-

nition cameras at more than 700 locations worldwide and also publishes editorial content related to Surfline founded in 1985 by Sean Collins as a pay-per-call telephone surf report. The website was launched a decade later. Surfline.com now has some free data but is mostly subscriptionbased, with plans that start at \$7.99 per month.

Laughlin said in a phone interview Tuesday that he

loved the Surfline story. "It truly is one of heritage and grit," Laughlin said. "This is a team that brought everything from fax, to 976-SURF, to an adsupported web-based experience to now a leading mobile subscription product. They've built a successful company with a world-class product and

editorial offering, and it serves a massive audience in a fast-growing category. I'm humbled to join this organization incredible with such an amazing leg-

acy." The company has grown into one of the biggest and most trusted in the surfing industry, with its forecasts used for events like the U.S. Open of Surfing, held on the south side of the Huntington Beach Pier each summer. The U.S. Open was canceled this year due to the ongoing coronavirus pandemic.

Collins died in 2011 after suffering a heart attack. Berg has served as the company's CEO since 2015.

Laughlin, 42, is a Laguna Niguel resident. He has most recently worked at Amazon, and before that he was a senior vice president at the Walt Disney Co., as well as the head of Sport & Games at Yahoo.

Pedestrian struck and killed by SUV in Huntington Beach

A pedestrian was struck and killed by an SUV while crossing Beach Boulevard in Huntington Beach on Monday night, authorities

The Huntington Beach Police Department responded to the incident, which occurred 6:12 p.m. Monday, near Beach Boulevard and Yorktown Avenue. A 59-yearold woman from Corona del Mar, who was driving a 2017 Mitsubishi Outlander, struck and killed an unidentified man, police said.

Police said that the man was known as a transient. The Orange County coroner's office identified him as a 61-year-old in a news release, but has not released his name pending family notification.

The driver remained on scene and cooperated with police, Sgt. Joshua Page said. Alcohol and drugs are not suspected.

An initial police investigation showed that the woman was driving southbound on Beach Boulevard when she struck the man,

who was crossing westbound on Beach outside of the crosswalk.

He suffered extensive injuries and was transported to UC Irvine Medical Center, where he was pronounced dead.

The investigation is ongoing and being conducted by the HBPD Multidisciplinary Accident Investigation Team. Anyone with information is asked to contact Traffic Investigator Doug Demetre at (714) 536-5670.

homeless cats and kittens will go on through the Catmosphere Laguna Founda-

As of last week, Catmo-Laguna adopted out 195 cats. Landau added that the demand for pet companions has gone up during the pandemic, but she continues to be particular about the conditions of adoption. She wants to make sure the cats are going to an environment that they will fit into and that they will continue to receive veterinary care, if necessary.

"[The cats] are fully vetted, spayed or neutered, receive all their vaccinations, they're socialized, they've been with fosters, and I carefully interview the prospective adopting pawrents," Landau said.

"I make sure they go to a home where they will be an indoor cat only. The individuals sign an adoption agreement after the interview process with me. I used to go to the homes and do a home check, but now I do a Zoom check or I do a FaceTime check."

Landau is also conscious of relationships that have been formed between the cats, and she said that she does not allow for separation of bonded pairs.

As a nonprofit organization, Landau said the Catmosphere Laguna Founda-

tion pays for veterinary bills and food with the help of donations. Donations can be made at mosphere la guna. com.

Adoptions through Catmosphere Laguna are \$300. Landau added that the cats are microchipped, and a veterinarian health report, flea treatment and a super "purr-sonality" cluded.

Landau said she is on the hunt for her next location, as she hopes to open a cat cafe again after things improve from the impact of the pandemic.

Catmosphere Laguna has also partnered with rescue outfits like the Ark of San Juan and the Laguna


investments. Officials said the two led several victims to believe that the company was authorized or affiliated with the California State Teachers' Retirement System, which provides retirement pension advice to state public school educators. Some did not discover that it was not authorized or affiliated until after they'd invested substantial funds in Lotter's companies, according to officials.

Even though these insurance agents had a fiduciary responsibility to represent their clients' best interest, they allegedly put greed above their clients' needs," Insurance Commissioner Ricardo Lara said in a statement. "Their arrest shows the department of insurance will persist in investigating and stopping insurance professionals who put their clients at financial risk."

State officials said Lotter and Major continued to do this between 2003 and 2018, claiming that profits from the two companies were "just around the corner" and that they had partnerships with large internet companies and prominent mobile carriers.

"They showed clients

ping complex in a limousine, alongside her mom, Alvarez, Martha youngest brother, Emilio, 11. She received a red-carpet welcome from a small phalanx of masked and socially distant organizers and store employees congratulating her on her wish day.

"Wish Granted. Happy Wish Day. #1 Fan. We love you," read a series of handmade signs crafted for the occasion.

The ebullience of the scene was a far cry from September 2019, when Kate's family learned a severe and persistent pain in her right leg, misdiagnosed for more than a year as sciatica, was actually non-Hodgkin's B-cell lymphoma. Finally, an MRI revealed the source of her pain, a football-shaped tumor curled inside the

curve of her pelvis. "It was very hard but also relieving to find out what was actually wrong after being misdiagnosed," the teen recalled Monday. "It was definitely an adjustment and hard to process. But my family was there for me.

Kate has also been buffered by fans and followers on social media, where she's turned to share her personal story with others who may be going through similar challenges.

When two rounds of treatments at Loma Linda University Medical Center wrapped up earlier this year, Kate's cancer appeared to be in remission.

A Feb. 12 video, showing the tearful teen ringing a bell to signify completion of her final treatment, garnered hundreds of thousands of supportive clicks and comments.

Wanting to continue to share her story with others, Kate now hopes to widen her social media presence by wading into YouTube. In her Make-A-Wish request, she asked for computer and video equipment to increase the production quality of her posts.

"I wanted to get this so I could share about my journey and my experience and what it was like for me," she said, telling her story Monday before a lineup of TV news cameras.

Kate's wish was granted

and much, much more. Representatives from Macy's teamed up with Make-A-Wish to enhance the teen's request as part of the store's "Believe" campaign, where for each child's letter to Santa Claus, Macy's will donate \$1 to Make-A-Wish up to \$1 million.

In addition to the equipment, Kate received a \$1,000 Macy's gift card and expert cosmetics clothing consultations from staff on site.

She learned the importance of good angles during a quick eyebrow consultation and YouTube tutorial from social media savvy cosmetic expert Paola Regalado.

"The best videos are actually the ones that are not edited, where you're talking from your heart," Regalado advised the teen. "Be yourself when you talk to the camera. And keep posting. You have to be consistent and post every

day.' In the store's juniors clothing section, Macy's stylist Gabriela Rosales had put together some outfits based on Kate's style. The two chatted about colors and tastes, and Rosales promised to have the perfect picks ready for a postpress junket shopping

Kate's wish is one of more than 7,300 requests

granted to critically ill children between the ages of $2\frac{1}{2}$ and 18 by the regional Make-A-Wish office since the national organization's founding in 1983, according to Gloria Jetter Crockett, president and chief executive of Make-A-Wish Orange County and Inland Empire.

"It's all about providing hope and inspiration to these kids while they're going through something terrible and lifting their spirits," Jetter Crockett said of the group's work. "It makes you feel good inside.'

For Kate's mom, Martha Alvarez, Monday's celebration is an exciting chapter in her daughter's contin-

uously unfolding story. "It was exciting just coming here — we didn't expect all this," Alvarez said, reflecting on the ups and downs of the past year and a half. "It's been hard. But she's a really, really strong little woman.

As difficult as parts of her experience have been, Kate says she hopes being vulnerable and honest will encourage others.

"For everybody going through cancer, or just fighting something, I just want to say, 'Don't give up,' " she said. "Take it day by day — it's a journey, so just stay strong.'

tensive care units is at 158. California Health and Human Services Secretary Dr. Mark Ghaly said that all options are in play for how the state will navigate the challenge of the pandemic. He added that officials will focus on measures that will be "impactful and timelimited.'

Ghaly also said that the availability of ICU beds was being looked at as "the primary trigger for deeper, more restrictive actions.

"Statewide, we see that the second half of December could be pushing the limits in some areas," Ghaly said. "We want to act sooner than that so that we

can get transmission down and we can handle those potential high ICU surges."

Orange County reported 790 new coronavirus infections on Tuesday. The county did not report any additional deaths due to the virus, keeping the county's cumulative related fatalities at 1,577. Since the onset of the pandemic, the county has experienced 79,343 cases.

The county healthcare agency also reported 17,236 tests for the virus within the last day, bringing the total number of tests administered to 1,469,434. An estimated 60,186 people have recovered after contracting the virus countywide.

Newsom said on Monday that the state is expecting to receive 327,000 doses of Pfizer's COVID-19 vaccine in the middle of December. Here are the latest cumu-

The guidance advises new patients and employees who may be exhibiting symptoms of the virus to receive immediate COVID-19 testing.

Hospitals must by Monday submit testing plans identifying the number of at-risk and total employees and explaining how they will test for, report and trace positive cases.

Those directives align with proposals put before the state by leaders of the National Union Workers Healthcare (NUHW), who have organized demonstrations highlighting the need for coronavirus protections, including several at Fountain Valley Regional Hospital & Medical Center.

That was where, on Nov. 23, workers rallied to memorialize Armando Rodriguez, an imaging aide who reported being exposed to the virus in his Santa Ana home in July and was told to continue working and check for symptoms.

Barbara Lewis, NUHW's Southern California hospital division director, said Tuesday union representatives were pleased state health officials had acted on behalf of the safety of frontline workers.

"There's absolutely no doubt healthcare workers, as a result of this, will be safe," she added. "And when healthcare workers are safe, that means patients are safe and communities are safer."

The union leader praised the courage of employees who stood up and risked their jobs to expose inadequacies at their respective hospitals. A July 1 complaint filed on behalf of Fountain Valley Regional Hospital employees, for example, triggered a state investigation into the site's COVID-19 policies and practices that resulted in systemic improvements.

"They knew what was happening and they knew it wasn't good enough for patient care," Lewis said. "When we talk about healthcare heroes — this was their heroic act."

Josh Jesus, a CT scan tech at the Fountain Valley facility, was one of several employees who participated in rallies held in July and August. He self-quarantined in late June after a coworker was hospitalized with COVID-19. Hospital supervisors refused to test the exposed workers.

"That's the kind of thing we're trying to prevent," Jesus said Tuesday. "I feel the [guidance] is going to make an impact. Patients coming in will know workers are being tested — and it's going to help us feel a lot safer."

Todd Burke, a spokesman for Tenet Healthcare, which owns and operates Fountain Valley Regional Hospital, said officials were aware of the recommendations and in the process of evaluating them. The hospital, he said, employs some 2,200 employees. It is unclear whether a funding source has been identified to help facilities implement testing plans.

In a release issued Monday, NUHW President Sal Rosselli acknowledged the recommendations will ultimately save lives but said more employee groups working in highrisk areas outside hospitals should also receive regular testing.

"Gov. Newsom deserves credit for recognizing the urgency of the problem and taking decisive action to finally make hospitals test all workers and patients upon admission," Rosselli said. "[But] we still need to expand testing requirements to caregivers in home health settings and in correctional facilities where outbreaks continue unabated."

Beach Animal Shelter.

"You have to sit down and get to know that cat and be friends with the cat and have the cat accept you as much as you want to accept the cat, and that was the beauty of it."
