#### NMUSD officials put anti-bias training on hold

Although the school district has partnered with the Anti-Defamation League to bring training sessions to schools in the past, parent fears about critical race theory gave trustees pause at a recent meeting.

Amid parent concerns about critical race theory being brought into classrooms, Newport-Mesa Unified School District officials recently tabled a discussion on continuing a series of anti-bias trainings offered by the Anti-Defamation League, saying more research was needed.

Trustees at a July 13 meeting were set to consider a contract with the New York-based nonprofit — which provides training on promoting diversity and confronting racism and other forms of bigotry — for 25 secondary school training sessions in the year ahead at a cost not to exceed \$38,600.

Courses offered for educators, school employees and, in one case, student leaders under the league's "A World of Difference" program would explore bias, the dynamics of power, privilege and perspective and combating bullying.

Similar trainings had been of-

fered before the pandemic, under the aegis of NMUSD's Human Relations Task Force, and the latest contract aimed to continue and build upon those sessions.

But board members decided to hold off on discussing a new contract with the Anti-Defamation League, saying they had more questions about course content.

"I think we need some more information," said Board President Karen Yelsey. "[This] has language that we had not seen before, and I think it creates issues in our community and we need to do a little bit more research."

Several parents in public comments urged trustees to deny the

## Balboa Yacht Club sailboat race carries on an 85-year tradition

unday found local sailing enthusiasts vying for bragging rights in the 85th annual Flight of Newport Beach, but one did not need to be a sailor to appreciate the stirring vision as the race got underway on the south side of Balboa Island.

"You'll never see that many sailboats on a start line at the same time," said David Beek, race chairman. "They all line up and want to be the first one across the start line."

Beek's father, Balboa Island resident Seymour Beek, began racing in the event in 1941 when it was Flight of the Snowbirds. He was 7 years old and captured the award for the youngest skipper.

Today at 88 he continues to enjoy sailing

## No action on filling H.B. seat vacated by Ortiz

The City Council fails to name a replacement or agree on a special election during Monday's meeting.

The Huntington Beach City Council did not have enough votes to nominate a candidate. It also did not have enough votes to call for a special election.

As a result, Monday night's special meeting to appoint a member to the vacant seventh seat could not be resolved.

The council adjourned, vowing to return within seven days to resume negotiations. If the panel cannot agree on a replacement by the end of this month, a special election Nov. 2 that City Manager Oliver Chi estimates would cost the city about \$1 million will be triggered.

Monday's 140-minute special meeting was marked by audience members giving their opinions loudly, sometimes by talking over council members. Many in the crowd were there in support of Gracey Van Der Mark, who finished fourth in last November's election that brought Tito Ortiz, Dan Kalmick and Natalie Moser onto the dais.

Ortiz, whose resignation from the mayor pro tem position on June 1 created the opening, also attended the meeting in support of Van Der Mark. Her supporters wore shirts and carried signs asking the council to "honor the vote" by appointing her, since she was the first runner-up.

### O.C. Fair sells out for first time in more than 130 years

Orange County residents hankering for a corndog and pig races will have to act fast, as O.C. Fair organizers reported Monday the regional festival sold out on opening weekend for the first time in more than a century.

Demand for admittance on Saturday and Sunday exceeded 45,000 single-day capacity limits earlier imposed by organizers.

And since tickets must be purchased online in advance, anyone who may have waited until arriving to book slots would have been turned away at the gates.

## Rick 'Rockin' Fig' Fignetti, Huntington surfing local celebrity, dies at age 64

Huntington Beach native Rick "Rockin' Fig" Fignetti, a fixture in the local surf community, died Friday of a heart attack at the age of 64.

Fignetti was well known in Surf City and beyond for his contributions to the local surf culture. He owned Rockin' Fig Surf Headquarters, on the third block of Main Street in Huntington Beach, for decades.

Mourners put flowers there over the weekend as a memorial.

Fignetti, who long had a "Wet N

Fignetti, who long had a "Wet N Wild" column in the Huntington Beach Independent, was also well known as a surfing announcer. He was the voice of the U.S. Open of Surfing for 20 years, a run that ended in 2013 when the event changed sponsorships. He was also a longtime announcer for the U.S. Pro Tour.

Instantly recognizable with his thick glasses, long hair and

goatee, Fignetti was also a voice that many grew up hearing. For 25 years, he did the morning surf report on KROQ-FM radio, until

#### Police arrest 4 on suspicion of evading, obstruction after high-speed pursuit in C.M.

Costa Mesa police on Monday arrested four men on suspicion of evading police and obstruction after a high-speed vehicle pursuit led to a yard-byvard search for the possibly armed suspects near the city's Mesa Del Mar neighborhood, officials reported.

The incident began at 12:15 p.m. Monday, when an officer patrolling a parking lot on the 3300 block of Bristol Street near South Coast Plaza observed a sedan with dark tinted windows in violation of California's vehicle code and initiated a stop, according to a release issued Tuesday.

The driver of the vehicle, later identified as Dennis Junior Johnson, 25, of Los Angeles did not possess a valid ID and initially gave the officer false information about his identity.

When the officer asked Johnson to step out of the car, he fled from the scene, driving south on Bear Street with three passengers still inside the sedan.

A pursuit ensued, as the suspect's car reached speeds above 80 mph, police reported.

At one point, the sedan

was driven across a center median on Bear Street and into oncoming traffic. Johnson reportedly drove through a red light in his attempt to flee.

Although officers lost sight of the vehicle near the intersection of Bear and Baker streets, the sedan was soon located near the junction of Bear and St. Clair streets, after it had hit a curb and crashed into a nearby stop sign, according to the release.

But the chase didn't end there. Johnson and the three passengers fled the scene on foot, running west into a residential area, according to witnesses. Police reported a handgun was found in the roadway near the suspect vehicle.

Officers established a perimeter in the area and conducted a yard-to-yard search for the four men, the release indicated.

County The Orange Sheriff's Department provided K-9 assistance, while the Anaheim Police Department aided in the search effort with the use of a helicopter.

Johnson was located on the 800 block of Sonora Road. Two more suspects identified as Myles Edward Rutledge and Naypone Malik Gaines, both

22, of Los Angeles — were found hiding together in the backyard of a home on the 2800 block of Drake Avenue.

third passenger, Dvaryae Deshawn Bryant, 18, of Los Angeles had been hiding in a storage bin in the backyard of another home on the 800 block of Santiago Road and was detained, police reported Tuesday.

The officer who'd initially stopped the vehicle identified all four suspects, who were arrested and booked on suspicion of evading police, obstruction and felony possession of a firearm.

Of the four suspects, only Rutledge remained in custody in Orange County's Theo Lacy Facility as of Tuesday afternoon.

The other three men were released on bond earlier that morning, according to an online inmate locator maintained by the Sheriff's Department.

contract, fearing it would promote a curriculum that categorized students as victims and oppressors based on their skin color.

Costa Mesa resident Haley Jenkins questioned the appropriateness of bringing trainings from the Anti-Defamation League, which describes itself as a global leader in exposing extremism, to Newport-Mesa campuses.

"Are we seeing extremely violent hate crimes occur on campus? Or is this the result of a very small group of people on your task force ... pushing critical race theory in our schools?" Ienkins asked board members. "I was assured critical race theory was not in our schools, but here it comes."

A scholarly approach to looking at American history and jurisprudence through

the lens of racism, critical race theory was developed in the 1970s and 80s as a way of trying to understand why, if certain protections and civil rights exist within the law, inequality seems to

In recent months, the approach has been taken from an academic context and placed into a political one, as conservative politicians rally against critical race theory being taught in schools, where antibullying anti-discrimination and lessons have existed for vears.

singular agenda or theory to put forth.

"The scholars who wrote in the area came from different scholarly grounds," Gustafson said. [They] were trying to examine what it is beyond just law that allows racism to continue — our culture, history, the refusal to grapple with our history."

Still, certain repeating themes arise, including the idea that all people have agency in perpetuating or dismantling racist systems and should remain aware of privilege and personal blind spots that may impede understanding.

Gustafson said while debates over critical race theory may be ramping up in the realm of K-12 education, the opposition seems primarily political.

"It's always helpful to have a bogeyman in politics. And the bogeyman of today is critical race theory," she added. "It's convenient,

"Twenty percent of the people are out there to win a race," Luttrell said. "But with so many boats, most people are trying to either beat the boat ahead or stay in front of the boat behind."


The event is the longest running continuous race in Newport Harbor.

Sponsored by the Newport Beach Chamber of Commerce, Commodores Club, and hosted by the Balboa Yacht Club, Beek explained that the event is free and open to all ages.

though, was the only one to initially nominate Van Der Mark for the position. Per the predetermined rules, council members could bring up to three names to nominate of the 105 people who interviewed on July 9 and 10.

"It is time to shift the community back to our community, to public safety, and away from extremism," Moser said at one

point, above jeers from the crowd. "The work of our city does not stop because an elected official abandons his position ... We did have an election. There

were three open seats. Tito Ortiz, Dan Kalmick and myself were elected. There is no fourth place. There isn't. There were three open seats, and here we are. Unfortunately, Councilmem-

ber Ortiz did not honor the vote, and we are here."

Local business owner and council hopeful Dom Jones also showed up with supporters, but she did not garner a nomination from any member of the council.

Jill Hardy, who termed out from the City Council for the second time last fall but threw her hat back in the ring after Ortiz resigned, was also failed to get a nomination.

After three rounds of voting, the council was down to three names: civil rights attorney Rhonda Bolton, longtime AT&T executive Jeff Morin and Van Der Mark. Bolton had three votes, those of Moser, Kalmick and Mayor Kim Carr, but they could not come up with the fourth vote required to appoint

Individual motions to appoint Van Der Mark and

> Morin both failed 4-2. When it became clear that they were making no progress, Councilman Mike Posey called for a special election, to applause from the audience. It was quickly

seconded by Peterson. "We're really at a stalemate on moving forward and naming somebody tonight, and the only thing that's fair is a special election," Posey said. "Whether it costs \$1 million or \$2 million, that's the cost of democracy ... There is a 3½-year term still left. We have 85% of the term still left, and that's significant."

But the motion for a special election failed 4-2 and later 3-3 as Mayor Pro Tem Barbara Delgleize shifted in

support of it. The other council members, though, remained unwilling to support that as an option.

"Our charter states that it's our job to fill this seat," Kalmick said.

"The weight is on our shoulders, I believe, to come with a consensus pick, because \$1 million is a lot of money that could do a lot of good for our city. That's a lot of roads that we could pave.'

Van Der Mark said after the meeting that she believed a special election would be the fairest thing to do at this point.

"I ran because I got tired of not being heard, and that's how the community feels," she said.

Jaime Strong, the marketing manager of the Downtown Business Improvement District, said the district will be hosting a Surf City Nights celebrating Fignetti on July 27. The local Ramsey Brothers Band will be performing. Strong said Fignetti was

so welcoming in working with her in the institution of the "Rockin' Fig Vintage Surf Festival" last October. That will become an annual event, Strong said, as his family has blessed it. This year's festival will be on Oct. 9 as part of the Surf City Days celebration.

"He was so warm and open," she said. "His friendship and support of me gave me this ability to understand Huntington Beach very quickly, and the downtown community ... He gave me this quick history lesson of downtown Huntington Beach and surf culture, and he honestly changed a lot of things in my career and my life. "I walked into his shop

last July, and it was to find out how he felt about the street being closed. I knew who he was. I grew up listening to the surf report and I was really intimidated to go in and meet him. **Huntington Beach Mayor** Kim Carr said that Fignetti embodied the "aloha spirit" that she sees as a key part of Surf City.

"He was such a good ambassador, not only for surfing, but for the city of Huntington Beach," Carr said. "Everybody was treated like family. His voice is going to be missed, for sure. This one really hit me hard ... He really was a local celebrity, but he never came across as arrogant or full of himself."

Fignetti is survived by his longtime girlfriend Andrea Roberson, his children Chanel and Ricky, and his mother Betty. Plans for a memorial service or paddle out have not yet been announced.
