Kids with special needs 'walk on water' at Blackies

About 60 children, including those with mobility issues, sensitivity to sensory stimuli got a chance to experience the joy of catching a wave Saturday.

amuel Lara normally resists new sounds, textures and tastes. The 9-year-old, diagnosed with Down syndrome and autism, might get distressed in noisy crowds or around unfamiliar faces. So, his parents are careful about exposing him to anything that might push him out of his comfort zone.

"I don't want to hinder him or have him regress," his mother, Melissa Laura told the Daily Pilot Saturday. "That would be my big fear, like, to push him back further. But I want him to experience a lot of things."

For years, it seemed most of Melissa and David Lara's attempts to get their son to try different foods or activities were met with mixed reactions, at best. But the first time Sammy's parents took him to a swimming lesson, they finally saw him embrace something new.

"He almost dove into the water," Melissa Lara said. "We never saw him do that before."

After that day, Sammy became more tolerant of different textures in his food, Melissa Lara said. And despite apprehensions about how he might respond to the feeling of sand between his toes or the roar of waves coming toward him, "he lit up" every time they brought him out to the heach

Sammy's love of water helped him open up to more of what life might have to offer, Melissa Lara said. That's why the Rancho Cucamonga family spent about three or four years trying to get him a spot in a surf therapy session.

"I can be typing, just finishing

Rivian donates electric vehicles for marine safety fleet in Laguna Beach

Laguna Beach has added a couple of electric vehicles to its municipal fleet, as city officials accepted a donation of two RIS vehicles from Rivian for marine safety operations in a ceremony on Monday at Main Beach Park.

The retail value of a 2025 RIS starts at \$75,900, a Rivian representative said. That price tag did

not factor in modifications made to meet the needs of the marine safety department, including the transportation of life-saving equipment.

"Our team's mission is to keep our coastline safe for residents and visitors, which demands specialized vehicles that can perform reliably in challenging

Mayor holds firm in Costa Mesa

Stephens' maintains lead in reelection bid as votes favor two new conservative candidates in council districts 1, 6.

If preliminary results in the races for three seats on the Costa Mesa City Council — including the at-large position of mayor — remain unchanged, a mix of old and new faces could be sworn into office in early December.

Figures updated by the Orange County Registrar of voters Thursday at 5 p.m. showed Mayor John Stephens holding firm in his reelection campaign, after being appointed to the position in 2021 and winning his first two-year term the following year.

Stephens continued to maintain a strong lead Thursday, receiving 52.43% of the vote, with 16,646 ballots cast, compared to

Grandis, Bui likely to stay on F.V. council

Mayor and vice mayor have strong leads in their reelection bids for a second term.

The Fountain Valley City Council appears as though it will remain in status quo, as voters backed the incumbents in the race for two seats on the dais.

Vice Mayor Ted Bui paced the vote-getters with 36.14% of the ballots so far counted at 11,674, as updated by the Orange County Registrar of Voters on Thursday evening.

Mayor Glenn Grandis was also on track to defend his seat on the five-person governing body, securing 10,635 votes, representing 32.93%.

Bui claimed victory in his reelection campaign in a statement released on social media on Wednesday.

"I am deeply honored by the trust and confidence that the residents of Fountain Valley have placed in me to represent the val-

Newport Harbor flag football sets precedent at CIF luncheon

It isn't an exaggeration to say the Newport Harbor High girls' flag football team is on the precipice of history.

The No. 2-seeded Sailors play top-seeded Orange Lutheran for the sport's first CIF Southern Section Division 1 title on Saturday at 4:45 p.m. at El Modena High.

Three days before the show-down on the gridiron, both teams attended the section's inaugural girls' flag football CIF press conference and luncheon, held Wednesday at the Grand in Long

Newport Harbor brought four of its top players — senior captains Maia Helmar and Audrey Burns, junior Cooper Dick and freshman Skylie Cid. Sailors coach Jason

Sailors coach Jason Guyser said it wasn't hard to get them to commit.

"The best part was that they all responded to the group text rather quickly," Guyser said. "That made me know that they were excited ... The fact that we're the only other sport besides tackle football to be doing it is fantastic. Super-exciting. It's pretty special to be among the final teams."

Each of the finalists in five playoff divisions was present. The girls got to hear from keynote speaker Katie Sylvan, the director of football administration for the Los Angeles Chargers.

Sylvan, who graduated from



challenger James Peters, who followed with 47.57% approval and 15,100 votes.

The mayor spent election night first in plain clothes passing out pizza and water to voters queued at the city's Senior Center, then at the local event space Celebrations, where he watched initial returns alongside state Sens. Dave Min (D-Irvine), who is in a tight battle for a seat in the U.S. House of Representatives with Republican Scott Baugh, and Josh Newman (D-Fullerton) and Assemblywoman Cottie Petrie Norris (D-Irvine), seeking reelection.

"I feel confident about my lead, but it's important to count every single vote," Stephens said Thursday. "I'm not quite ready to declare victory, but I'm cautiously optimistic."

In addition to continuing the council's work on preventing and reducing homelessness in his next two years in office, Stephens said he hoped to advocate for Costa Mesa's playing a role in the 2028 Olympics in Los Angeles and the FIFA 2026 World Cup.

He suggested the city could be part of a wider network of hospitality and transportation options for Olympics-bound travelers and possibly use its Jack Hammett Sports Complex as a World Cup training facility

"Showcasing Costa Mesa and central Orange County internationally, with everything we have to offer, is really a once-in-a-lifetime opportunity," Stephens said. "It's now or never, and we're very well placed to do that."

In Costa Mesa Council District 1, the race to fill a vacancy left by outgoing Councilman Don Harper, who did not seek reelection to a second term, was still fairly close Thursday evening, with newcomer Mike Buley maintaining a 685-

ballot advantage over current Planning Commission Chair Adam Ereth.

Voting figures showed Buley, a business litigation attorney, ahead with 54.93% of the vote and 3,818 ballots, compared to Ereth's 45.07% voter approval with 3,133 votes cast in his favor.

Buley attributed his apparent success to a grass-roots campaign among the many Mesa Verde neighbors he's come to know in his 21-year residence in the city, who encouraged him to run for office.

"We put in a lot of work and a lot of hours and time," he said Thursday. "Regardless of their political persuasions, they all jumped on board and were willing to put their national politics aside and say, "Shoot, Mike, you're a nice guy — you've got my vote."

While Buley remains cautiously hopeful that vote totals will remain in his favor, he's already beginning to engage in conversations on important local matters. On Thursday, he attended a city leader discussion on addressing homelessness, hosted by the Love Costa Mesa initiative, and said he hopes to educate himself on the complexities surrounding

the issue.

"It's something I'm going to learn about at a more than stump-speech level and really get granular on," he said of his nascent political career. "I'm in the 'education of Mike Buley' phase."

While District 2 City Councilman Loren Gameros ran unopposed in Council District 2, receiving 100% of the vote with 3,862 ballots cast, the race for a contested seat in the city's 6th Council District remained as hot as ever Thursday.

That's where Mayor Pro Tem Jeff Harlan, running for a second term, placed a close second behind conservative challenger Jeff Pettis, with fewer than 250 ballots separating the two contenders.

As of Thursday, Pettis had received 51.92% approval with 3,344 votes cast for him, compared to Harlan's 3,097 ballots (48.08%). Unlike Buley and Stephens, Pettis did not return calls requesting a comment on his lead.

ues that we all hold so dear," Bui said. "Together, we will keep our community clean and safe for all residents."

In a phone interview Thursday, Bui said that sober living homes remain an area of concern for the community. The city passed an ordinance for the regulation of such group homes earlier this year, including permit requirements and restrictions on the proximity of one sober living home to another.

"We put in a sober living ordinance, but we have not, per se, enforced it because we want to give the operator time to make the adjustment," Bui said. "Part of the adjustment that we would like for them to do is, first of all, apply for a permit through the city, so we know that they are operating as such. ... Not every sober living home is a bad operator, but we want the good operators to step forward, and that's one step toward good stewardship is [to] make sure that you get a permit."

Grandis said he felt steps were taken to emphasize transparent local government during his mayoral term, including the implementation of a "Mayor's Message" podcast and community outreach through town hall meetings.

During the campaign, Grandis said public safety was a primary concern he heard voiced by residents, including issues related to homelessness and soberliving homes.

"The biggest issues facing our city coming forward, the three top ones, are homelessness, soberliving homes and potential development of large parcels in our city," Grandis said. "Those are the three big issues that'll be facing us in the next four years."

Four candidates had entered the race for the two available City Council seats this election cycle. As of Thursday evening, Alicia "Rudy" Huebner had secured 5,665 votes, or 17.54%, while Katy Wright had received 4,326 votes, 13.39%.

BOYS' WATER POLO

H.B. uses amazing goal to move to semifinals

WESTMINSTER — Huntington Beach is headed to the CIF Southern Section water polo semifinals for the third time in four years, thanks to a bit of magic and immense resolve.

Dusan Djordjevic's 15vard lob to beat the shot clock late in Wednesday Division evening's quarterfinal showdown at Westminster High somehow found the upper-left corner, lifting the defending champions to an 11-10 upset triumph over No. 2seeded Long Beach Wilson and rewarding the seventhseeded Oilers' exacting defensive performance.

Huntington Beach (15-14), which heads Tuesday to No. 3 Mira Costa for a final four bout, denied the 14time CIF titlists service into star two-meter man Enzo Brigagliano and responded decisively when the Bruins (21-11) twice rallied from three-goal deficits to pull even, finally securing the victory on a Jacob Duong steal in the final seconds.

"It has to be the best [we've played this year]," said first-year Huntington Beach head coach Nick Graffis, the longtime Edison coach who took over when Sasa Branisavljevic resigned Huntington Beach's first CIF championship, a 10-9 thriller

against Laguna Beach a year ago. "The best opponent we've beaten this year, as well."

The defensive work, anchored by goalkeeper Henry Haddad's sterling play, two three-goal bursts – the first in a dominant first-quarter display, the second after Wilson forged a 5-5 tie not quite three minutes into the third quarter — and Isaac Squires' five goals, four in the second half, had Huntington Beach in charge most of the way.

It was Djordjevic's jawdropping strike with 1:06 to play, an unexpected wow to punctuate a sizzling encounter, that will play prominently in Oiler lore. It was 10-10 after Vaughan Baker's third goal, and Wilson's fifth with a manadvantage, with 1:36 left. The senior attacker — one of two starters to return from the title team found himself on the right flank, not so far from midpool, with no reasonable options and the shot clock nearing zero.

Djordjevic, dealing with a head cold, lobbed a nochancer toward the net, and it floated toward and then caromed in off the upper-left corner of the goal frame. His reaction: disbelief and elation.

"Honestly, I didn't know what it was," he said. "I saw six [Wilson] shot-blockers, had no idea what to do, saw the clock at two seconds, wound up, threw it, and it

happened. If I shot that shot a million times, I would never hit it again. Pure luck, but it happened. It's what we needed."

Said Squires: "That was just cherry on the cake."

Wilson had two more forays, but Samson Casem fired wide with 50 seconds remaining, Duong picked off Fernando Rejon's pass on the next incursion, and the celebration was on moments later.

"The energy today was phenomenal," Graffis said. 'I know we're exhausted, I know we're tired, but everybody, man, the energy. We were moving fast on defense, pushing the counterattack, and we always work hard to strike. But there's [an extra burst of energy], and you never know whether it's there or not until a game like this, and they

found out it was there."

Djordjevic scored two goals — the first on a oneon-one break after stealing the ball at mid-pool three minutes into the second quarter — and assisted two more, and Duong, Jay Larson and UC Irvine-bound defender Charlie Jones added goals. Haddad punctuated his performance

Skenderian had three goals, tying him with junior center Max Sauers for the team lead.

"It's my last game ever," Skenderian said after the match, as tears started to form in his eyes. "It's a brotherhood. There's no other sport like it. The older kids talking to the freshman, always hanging out with the freshmen, it's like you look up to the kids who are older than you. It's always setting a good example for the kids under you. Ît's amazing. All of these boys are my best buds."

Laguna Beach (17-15) led visiting Mira Costa (18-11)

my address and all of a sudden: spot gone," Melissa Lara said.

They finally got their chance during "We are Surf Therapy" on Saturday at Blackies North Jetty in Newport Beach. The event was organized by the nonprofit A Walk on Water and hosted by Costa Mesabased eye-wear brand Salt Optics.

About 60 children, those with special needs and their siblings, took part in the event. An army of volunteers wearing rash guards and smiles helped children with mobility issues or sensitivity to sensory stimulation overcome those challenges so they could feel the joy of catching a wave.

"Without the community, without our volunteers, these events wouldn't happen," one of A Walk on Water's co-founders and former competitive surfer Steven Lippman said.

Kids' eyes grew wide as energy gathered in the water behind their boards and the ocean swelled beneath them. Their expressions often broke into smiles and laughter as waves propelled them

forward.
Excited volunteers and their parents waited for them along the shore, arms raised and cheering. Saturday's festivities also included an awards ceremony featuring small wooden trophies shaped like surf boards and plenty of high

fives.

"Most of these kids are picked on, made fun of," Lippman said. "That still does exist, which is hard for me to believe, that people can be so cruel. And what's great about this is these children are the heroes for the day ... everyone's cheering for them. You can imagine that transformation in confidence that builds."

Surf therapy events also offer families of children with special needs respite in a safe space with people who have a better understanding of what they're going through, A Walk on Water board member Agatha Wallen told the Daily Pilot. She's the mother of two sons with special needs, and they've been participating with the nonprofit since 2013. She explained that parents like her and her husband, Ja-

son, spend practically every

waking hour trying to account for any negative interaction their kids might have in public and the potential judgment of strangers.

"I went to this event with another fellow parent and as soon as our kids went out, we cried," Wallen said. "Because it was the first time in years that either of us had a break, a mental break ... we could take a breath."

Although many do, not every child who comes out to a surf therapy event gets comfortable enough to put on a wetsuit and brave the waves, Wallen said. For some, just getting onto the beach and touching the ocean is an accomplishment.

Sammy Lara struggled at first with the tightness of his wetsuit, but his mood reversed 180 degrees once he realized he'd be able to

go into the ocean. And after catching his first wave, his parents could tell he was hooked. The nonverbal child repeatedly communicated "water" in sign lan-

guage with a beaming smile on his face.

"We're just enjoying how stress free it is," Melissa Lara said. "He had a wonderful time. He wasn't scared, and we're just kind of basking in the afterglow of that success."

environments," Marine Safety Chief Kai Bond said. "With the Rivian R1 vehicles, we're able to enhance our rapid response capabilities in areas like beach patrols and search and rescue, especially in rugged and sandy conditions where other vehicles may fall short."

Laguna Beach Mayor Sue Kempf echoed Bond's sentiments, adding that the donated vehicles would allow the city to lead by example in "showing other communities it's possible to prioritize both public safety and environmental sustainability."

"This partnership goes beyond a single donation,"

Kempf continued. "It's a model of what could be achieved when we work together. With these electric vehicles, Laguna Beach is making a powerful statement about our commitment to a cleaner, greener future."

The modified vehicles were stationed on the grass directly in front of the boardwalk and lifeguard tower at Main Beach during the ceremony. Marine Safety Captain Dane Doran said the marine safety department now has 11 rescue patrol vehicles.

Additions made for the marine safety team include lights and sirens, communication systems and customized space for storage of operational gear. An equipment rack on the roof helps hold items such as

the rescue tubes and paddleboard, as well as the Stokes basket, which could be used in a cliff rescue.

While Laguna Beach has several beaches that require stairs for access, the vehicles would be able to maneuver on some of them.

"There are some difficult parts of our cove to access with vehicles," Doran said. "There are plenty of beaches where we actually walk down with our gear via stairs, but there are half a dozen beaches that are just less known in town that we'll use these vehicles on.

"Main Beach is the perfect example of somewhere with an easy access. Treasure Island Beach, Aliso Beach, Camel [Point] and West, those are other examples of beaches that we can drive these vehicles on. The four-wheel drive capabilities are very important because it's soft sand, it's easy to get stuck in, so we're looking forward to testing them out."

Rivian will provide vehicle maintenance at no cost to the city, city officials said. The City Council allocated \$40,000 from the vehicle replacement fund for charginfrastructure ing and emergency response equipment. City officials noted that the electric vehicles would be utilized for a three-year trial period.

The Rivian South Coast Theater opened after extensive renovations in December, providing both a showroom for its vehicles and a shared community space.

"We're proud to support Laguna Beach's commit-
