# Festival of Arts celebrates 90th anniversary in style

#### **BY ANDREW TURNER**

A community that fell in love with the arts long ago celebrated a big milestone for one of its longstanding creative pillars, as Laguna Beach observed the 90th anniversary of the Festival of

The festivities on the grounds Saturday included speeches from local dignitaries, a lively musical performance and even a flash mob.

David Perry, the president of the Festival of Arts, had only begun his opening remarks when a group of people popped up from their chairs and began dancing to Kool and the Gang's "Celebra-

'With the exception of the World War II years and 2020 ..., the festival has taken place each and every summer since 1932," Perry said. "But over those years, it has grown and changed to what you see here today. Now, it's a two-month-long show featuring 120 artists, a dedicated space that is visited by over 200,000 visitors each summer.

"But one thing remains constant. It continues to celebrate all the arts through its exhibits, the Pageant of the Masters, the musical entertainment, the arts and education scholarships, and

As trucks rumbled back and forth ferrying loads of sand on the shore behind them, officials from the U.S. Army Corps of Engineers said during a public update Tuesday the project design for the Surfside-Sunset and Newport Beach sand replenishment project is about 95% com-

"The design and environmental reviews are concurrent. We're

waiting for some final environmental approvals, but I think construction will be the end of 2024 to the beginning of 2025, but we're still waiting on some final approvals," said Chris Hayward, a coastal engineer for the corps' Los Angeles district.

Army Corps of Engineers Col. Julie Balten noted the key to achieving the tentative timeline partnership agreements.

# Arrest made, victim ID'd in L.B. fatal hit-and-run

Laguna Beach police have arrested a Costa Mesa woman in connection with a hit-and-run incident that killed one and injured another late Thursday.

Authorities took Sysillia Morrison Montes De Oca, 18, into custody on Friday at about 6 p.m. She was charged with vehicular manslaughter with gross

negligence and a hit-and-run felony. Montes De Oca posted \$100,000 bail and was released pending further court hearings.

The fatal collision for which Montes De Oca is suspected of being the driver happened at 9:38 p.m. on Thursday. Costa Mesa resident Stanley Isaacs and his wife were walking in a

# 'No more bridesmaid': Bryce Sheridan wins local tournament

Always a bridesmaid, never a bride.

The adage used to be an apt description of local golfer Bryce Sheridan's attempts at winning the Costa Mesa City Championship, a tournament he first entered at around 18 years old and kept chipping away at, placing fourth, third and even second among more than 100 amateur linksmen.

All that changed at this year's 49th annual Will Jordan Classic, where Sheridan shot 7 under for a total gross score of 135, beating out a field of competitors who left their best on the Costa Mesa Country Club golf course during last weekend's tournament.

"It was a great feeling," the 38-year-old said in an interview Friday. "Every tournament is hit or miss, and I've been close before. One of my buddies even made a joke, he said, 'No more bridesmaid."

Sheridan — who spent much of his childhood at the public course in Costa Mesa with his dad and grandpa and began taking lessons there at age 12 before going on to play on golf teams at Costa Mesa High and Orange Coast College — said the victory was emotional for him after losing his father, Scott Sheridan, in 2019.

"I've gone through some

tough things in the last four of five years, so people know it's been rough for me," he said. "I wanted to win this one, not only for myself but for my dad and for a couple of other close friends we lost over the last couple of years."

Sheridan was among 120 championship flight contenders who played the site's Mesa Linda track on Saturday, where he ended the day one stroke behind the leading player and 5 under on the 70-par course.

Although breezy conditions Sunday complicated things, Sheridan stayed strong as other competi-

tors began to fall behind. "I just kept making par and had a feeling I was up in the No. 1 spot for the

time being, but I kept having the feeling someone else was close," he said Friday. "I didn't know until the last hole — I actually ended with a birdie."

Kyle Wilson, the club's director of golf, said Friday that 265 players hit the fairways over the weekend, participating in four flights of the tournament. But among the fray, Sheripersistence stood out.

"Everybody the at course was pulling for him," said Wilson, who had the honor of presenting the winners' trophies. "I know it meant a lot to him, so it was good to see.'

Belmont University in Tennessee, said she has taken ASL classes throughout high school and was drawn to it because it's so visual and creative.

When she published the book with the help of her advisor Penny Warner, she instituted deaf awareness and ASL workshops at local preschools, elementary schools and a Girl Scout Troop, reaching more than 150 students. She then distributed the materials to the teachers so they could continue teaching ASL.

"I put in a lot of hard work and a lot of planning, so I'm really glad it all came through in the end and I didn't have that many hiccups," Goodwin said. "The biggest challenge I faced was trying to work around COVID. Part of my project was going to different schools and working with different kids, so having to work around COVID with the school system was probably the hardest thing I had to go through, making sure all the safety precautions were in place. But I was able to figure that out, so I'm really happy it all worked out in the end."

Nguyen, headed to

ated an online workshop called "Stand Up Against Stress." She also implemented a live version of the program at various youth establishments, including JMAC Karate in Valley Fountain and Thomas House Family Shelter in Garden Grove, to give teens in-depth knowledge on stress, coping mechanisms and how to

Nguyen said growing up, she was very anxious and had a low threshold for stress, which limited her opportunities. There is also a history of stomach problems in her family. triggered by stress.

improve mental health.

"Schools now are beginning to address mental health and stress, but the way that they talk about it is still very general and broad," she said. "For my project, I wanted to teach youths how to better cope with stress and the challenges going on in life, so that they can work toward their goals."

The Tran twins, Emily and Evelyn, also recently graduated from Fountain Valley High. Emily is headed to Stanford University, and Evelyn to UC Berkeley.

Earlier in the school year, they were two of five Barons to earn scholarships for their work in Virtual Enterprises.

Emily Tran's Gold Award project proposed two bills that would allow incarcerated and homeless women to have free and sufficient access to menstrual products. She spent months meeting with politicians and local leaders prior to the implementation of Assembly Bill 367, working with 27 Orange County high schools, particularly Title I schools, to ensure that administrators understood the need for tampons and pads for their students.

AB 367, approved by Gov. Gavin Newsom last October, went into effect last month. It requires Calschools ifornia public grades six through 12 to provide free menstrual hygiene products for their students, regardless of income level.

"I believe that having access to menstrual products is a basic human right that shouldn't be seen as a privilege," Emily Tran said. 'That was my main goal of my Gold Award project."

Evelyn Tran's project sought to break the stigma surrounding mental health in her Asian American community, including at Fountain Valley High.

She noted the corps did have some environmental windows to contend with - grunion spawning season in particular, which occurs between March and August and occasionally in February to September.

Officials from the U.S. Army Corps of Engineers were present at the news conference held at Balboa Tuesday morning alongside other local dignitaries, including U.S. Rep. Michelle Steel (R-Surfside), who they credited with securing the \$15.5 million needed to kick-start the sand replenishment proj-

About \$7.5 million will be supplemented by local jurisdictions and agencies to fund the estimated \$23million project.

The project is intended to combat erosion along Orange County's coastline, which has been long impacted by federal flood channels.

In the 1940s, the federal government widened Anaheim Bay, constructed various breakwaters and jetties for new military bases and created flood channels. The result of those efforts was the narrowing of beaches up and down the coastline.

The San Gabriel to Newport Bay Beach Renourishment Project began in 1964 to replenish local beaches

and was done incrementally until 1990. By 2000, the U.S. Army Corps of Engineers declared it would no longer fund further stages to replenish the beaches, which left the task in the hands of local communi-

Hayward said the corps will dredge about 1.75 million cubic yards 2 miles offshore of Sunset Beach. That sand will then be deposited onto the beach, which will gradually erode over time and make its way down Orange County's

"Generally, that entire beach is expected to erode over a period of five years, which is why the renourishment interval is set to five years," said Hayward.

Coastal erosion has already begun to impact Orange County's beaches, especially in cities like San Clemente and Dana Point, which have begun to see the effects of rising sea levels along with other beaches up and down California. In Newport Beach

the impacts of erosion can be seen near Balboa Pier where the distance between its beach and parking lot is narrowing.

John Kriss, president of the Surfside Storm Water Protection District, said he's been involved with the sand replenishment project since the 1980s.

"It's been a real effort just to try and get people's attention," said Kriss. "It's great to see [the press and public] here, and you're here because of [Steel] as her organizers brought it to attention. really important is this project has not been provided for quite a long time just because people didn't have any interest.

"We didn't have any money."

Kriss said people would understand just how important the replenishment project is when they see its outcome two or three years from now.

Authorities were working to determine whether alcohol or drugs had played a role in the collision. Police believe speeding to have been a factor, according to the news re-

for grabs in Council Districts 3, 4 and 5, where incumbents Andrea Marr, Manuel Chavez and Arlis Reynolds, respectively, plan to run for second terms.

Green confirmed Monday six candidates had filed papers and been qualified to run for the three open seats. Although Chavez is the lone candidate running unopposed, he reported receiving \$24,948 in monetary contributions between Jan. 1 and June 30, adding to a beginning cash balance of \$553. Having spent

\$6,870 so far, he ended the reporting period \$18,631, records show.

Chavez's campaign received \$2,500 from the Orange County Young Democrats, \$4,900 from dentist Zhang Zing and \$1,000 from Assemblywoman Cottie Petrie-Norris (D-Irvine), who is running for election in the state's 74th Assembly

In Council District 3, incumbent Mayor Pro Tem Marr reported in a financial disclosure form highlighting campaigning activities from Jan. 1 to June 30 a beginning cash balance of \$6,455, stating she'd received \$10,507 in monetary contributions and had spent \$3,130, leaving an

ending balance of \$13,831. An engineer and vice president for Willdan Industrial, Marr faces two challengers. Jorge Miron, whose listed occupation is patient care advocate, has thrown his hat into the ring, as has John Thomas Patton, a financial adviser with Edward Iones Investments. Since both candidates filed to run after the June 30 close of the reporting period, no campaign finance information for their runs has yet been released.

Marr amassed several smaller donations, most of them under \$500, with \$3,000 in contributions from Costa Mesa resident Flo Martin and \$1,000 from Stephens' campaign, along with \$500 each from the Orange County Victory Fund and the organization Women in Leadership.

Reynolds also seeks a second term in Council District 5, where she faces challenger Rob Dickson, a senior paralegal at Costa Mesa law firm Latham & Watkins, LLP.

An engineer and principal consultant at Future Energy Enterprises, Reynolds started the year with \$100 in her campaign war chest and by June 30 had collected \$10,639 in monetary contributions. Having spent \$503, she ended the reporting period with a balance of \$10,233.

Reynolds' campaign received a \$1,000 each from Stephens' campaign and from Martin, \$500 from the Orange County Employees Assn. PAC and \$500 each from the Orange County Victory Fund and the Orange County League of Conservation Voters, documents indicate.

In the race for mayor, Moorlach's qualification to run for office came after the close of the most recent campaign finance reporting deadline. He listed his occupation as a municipal finance writer.

His opponent Stephens reported a Jan. 1 beginning cash balance of \$46,876, to

which he added another \$60,345 in monetary contributions received through June 30. Total monetary expenditures amounting to \$6,687 left Stephens with an ending cash balance of \$100,534.

Among Stephens' top donors were Zhang Zing, a self-investor who contributed \$3,000, supermarketowning Northgate Gonzalez, LLC, (\$4,900), Heat & Frost Insulators Local 5 (\$2,500) and attorneys Seymour Everett and Brian Gurwitz, who each contributed \$2,000 to the incumbent mayor.

She networked with experts and nonprofits in the mental health space to create lasting change, through her affiliation with nonprofit Active Minds and National Minds on Mental Illness.

"That's where I gained a lot of my resources," said Evelyn Tran, adding that she has long suffered from trichotillomania, an obsessive hair-pulling disorder. "I used to look at my mental illness as one of my greatest weaknesses, something that I was ashamed about, kind of like a burden that was holding me back. But when I started to mature, I realized that I could shift my perspective from looking at my mental illness as one of my greatest weaknesses to one of my greatest strengths. It enabled me to become more introspective and build resilience within myself, and taught me the power of vulnerability."

Some of the changes that she adopted included a revamping of the FVHS student ID card, to optimize access to mental health resources.

That last aspect is typical of a Gold Award project. Though they are obviously fulfilling for each Girl Scout involved, they are also signified by their ability to make a lasting

impact.
"One of the goals of Gold Award projects is that they're sustainable, that they can live on beyond the girl graduating," Girl Scouts of O.C. comdirector munications Caron Berkley said. "It's not a one-off ... It's just a totally different level of community impact."
