NMUSD honors outgoing Yelsey, Metoyer

Trustees praised in last time on dais as returns show proponents of public school edging out parent-choice advocates.

Outgoing Newport-Mesa Unified School District trustees Karen Yelsey and Charlene Metoyer were recognized for their outstanding service Tuesday during their final appearances on the dais before election winners two incumbents and two newcomers - likely take oaths in December.

In a farewell tribute at a regular meeting, the two school board members received commendations from elected officials and words of praise from colleagues and fellow trustees.

Metoyer has been with NMUSD for 24 years, working as an administrative intern, teacher and principal before serving eight years as a board member. Yelsey's involvement with the district began at the PTA and school-site level before her election to the governing board in

Board president Michelle Barto commended the two for their constant presence at school productions and sporting events and credited them with being role models of bravery and compassion for the entire district.

"I've learned so much from that heart that you have for all students and the appreciation

Bicyclist struck and killed by suspected DUI driver

A Garden Grove man was killed after being struck by a vehicle while riding his bike on a residential street in Fountain Valley Tuesday morning, authorities said in a news release.

Phong Khuu, 62, the bicyclist, was pronounced dead at the

Fountain Valley police responded to a call regarding the incident at the intersection of Sunn Avenue and Los Coches Street, which serves as an entry point to the neighborhood off Edinger Avenue just north of Mile Square Park.

Scott McDonough, 43, of Fountain Valley, the driver of the vehicle, remained at the scene. Authorities said McDonough was driving northbound in a gray Honda CR-V, made a U-turn at

Renovations set to begin for Sowers Middle School in H.B.

Navigating the honeycomb-shaped building at Sowers Middle School in Huntington Beach can get confusing.

Current Sowers principal Renee Johnson, in her third year, laughs when she talks about walking around the campus of the school that was built in 1973.

"Because of that honeycomb shape, everything opens up to everything else," she explained. "Sometimes you're just like, 'Oh, I didn't realize I was over there.' There's one room, honestly when I first started as assistant principal, I'm like, 'Where are these kids coming from?' I didn't even know that room was there."

That will all be changing in the coming months, as the Huntington Beach City School District campus undergoes a \$71million reconstruction project.

The district held a groundbreaking ceremony on the Sowers campus Tuesday afternoon, with remarks from Supt. Leisa Winston and Board of Trustees President Paul Morrow, among others.

The project will bring significant changes to the campus. The front office, currently located off Indianapolis Avenue, will be moved to the east part of the campus off Latern Lane.

"It's really designed, finally, to make sense for parents dropping off kids and [for] parking," said Morrow, who served as Sowers principal for 15 years before moving on to Marina High. "And our classrooms are going to allow windows and air conditioning, all of the things that kids need to feel comfortable

N.B. looks to buy property for new police HQ

The Newport Beach Police Department may move to Dove Street following City Council action Tuesday night that will allow city staff to begin the process of purchasing a 3.59-acre property for \$30.5 million to house new police headquarters sometime in the next decade.

With a 5-1 vote in favor of the purchase, the city will enter an agreement with AG Dove Owner, L.P. and begin escrow for the property at 1201 Dove Street.

Community Development Director Seimone Jurjis said Wednesday the city will have a 120-day due diligence period to review title documents and lease agreements, and to inspect the property.

The city will have roughly 30 days from the end of that period to determine if it wants to move ahead with the purchase.

"We want to make sure that we know what we're buying from an asset standpoint," Jurjis said. "Once we complete our due diligence, we have to make a decision. Is the property in a state that we want to purchase it? If it is, we move forward ... or if it's not, we have to make the decision to drop escrow or not."

About \$24.1 million of the purchase price would come from the city's existing budget surplus for the last fiscal year, \$5.5 million from the facilities financial planning fund



Body found near Costa Mesa apartment complex

A passerby found one person dead outside of an apartment building Costa Mesa Monday afternoon, police said.

A resident reported finding the body at a complex near Hamilton and Thurin streets at 12:44 p.m., Costa Mesa Police Sgt. Stephanie Selinske said. Investigators did not immediately find evidence of foul play.

The man was identified by coroner's officials as David Ryan Hall, 30, of Fountain Valley, Orange County Sheriff's Sgt. Scott Steinle said. Investigators had not verified his cause of death as of Tuesday afternoon.

A resident of the Costa Mirage apartments who declined to have his name published for privacy reasons said his neighbor was the one who discovered the body. The person who died was lying on the grass in a narrow space between an outdoor patio and a utility

"We thought he had just passed out at first," the resident said. "Later I heard the officer downstairs nudging the person and asking 'are you awake,' but they didn't say anything. Paramedics came and were here for about five minutes before they blocked the area off with yellow tape."

investigation before the body was taken by coroner's officials, who were working to notify the person's loved ones Monday evening, Orange County Sheriff's Sgt. Scott Steinle said. The area was reopened by 3 p.m., residents said.

demolition of the existing office building that sits on the property or the construction of a new police station. That still remains, at a minimum, 10 years out from the current date, he said, but the purchase is occurring now because of

the property's unique size. "It's about 3.6 acres. We were looking for something that was at least 3.5 ... and to find a property of that size that was contiguous; that's a big challenge," Jurjis said. "There's properties out there that are fully developed. You can try to purchase smaller properties and try to assemble it. But that could take a long time for us. The sale of this property happened to come up at the right time for us and the seller was interested in selling it to us."

City staff said the existing police headquarters, which shares a 4-acre parcel with Fire Station No. 3, was built in 1973. A needs assessment determined the department has significantly outgrown 49,284-square-foot facility, which is within 10 years of the end of its useful life.

The assessment determined the future facility, already included in the city's capital improvement plan to be completed in the next decade, will need to be at least 73,000 square feet to accommodate the patrol division and a firearms training and shooting range, according to a staff report.

Jurjis said the Dove Street property has a positive cash flow that will offset the cost of purchase. Real property administra-Wooding Lauren Whitlinger noted that between the time the property is purchased and the time the building is potentially demolished to make way for the new police department headquarters, it could generate roughly \$15 million in income for the "I remember eight years

ago, the first forum that we attended: They asked me the question of 'Where's the police station going?' I said, 'I don't know.' I was trying to be humble, but also I really didn't know. I actually think this is the best location, given the proximity to both sides of [Newport] Bay," said Mayor Kevin Muldoon.

Yet is was Muldoon who cast the lone dissenting vote. He said the timing could be better as it is his belief the real estate market is inflated and due for a correction.

Aggarwal is also accused of directing money from payments on the bogus invoices to personal bank accounts, prosecutors said.

He resigned from the company in January when officials began investigating the invoices, prose-

Aggarwal allegedly used at least six vendors to steal about \$2.6 million from KBS from Jan. 1,

2012, through Jan. 13, prosecutors said. He is charged with single counts each of mail and wire

you have for everyone's growth, from kindergarten all the way through graduation," she said Tuesday. "It's been remarkable and inspiring, and we're all going to miss you."

Barto is poised to assume a second term in Trustee Area 5, according to election figures provided Wednesday by the Orange County Registrar of Voters, which had her ahead of challenger Reina Shebasta with 64.6% of the votes and 6,303 ballots. Shebasta trailed with 3,449 ballots,

Incumbent Ashley Anderson similarly appears headed for victory in Trustee Area 7, where she leads with 2,634 ballots and 58.7% of the vote over two competitors — Kristen

Seaburn, in second with 26.9% (1,209 votes) and Vicky Rodriguez with 648 ballots, or 14.4%.

In the contest over Metoyer's trustee area 2 in Costa Mesa, Michelle Murphy has maintained a lead over Danielle Mills since the initial numbers were released on election night, earning 59.7% of the vote (4,372 ballots) as of Wednesday, compared to Mills' 2,952 ballots, or 40.3%.

Yelsey's district 4, which serves a handful of elementary schools in Newport Beach, will likely go to Lisa Pearson, a newcomer backed by Yelsey, who leads with 6,257 in her favor (57%) over two other candidates Barbara George, earned 34% approval and Kristen Nicole Valle, who

garnered 9% of the votes. With just 59,759 ballots left to be processed by the county Registrar of Voters on Wednesday, preliminary results indicate no winners among a slate of challengers backed by a local contingent of parental-rights advocates, organized as "Newport-Mesa Uncensored.

Although the group maintained a public Facebook page, where members challenged district policies related COVID-19 protocols, textbook and library book selection and programs centered on anti-discrimination, that page is no longer operable.

In her outgoing remarks Tuesday, Metoyer affirmed the value of local public schools.

"Everything we do is because of public education, which raises citizens to take care of the world when we're not in it anymore,"



she said. "I wholeheartedly stand by public education, and when you work at a district like Newport-Mesa, it's so easy to do that."

Yelsey noted her relationship with the district began when her three chilbegan attending dren NMUSD schools.

"It was really important for my husband and I that our kids go to public schools. And we wanted to help make them better, so I worked in the schools when my kids were there," Yelsey said.

"But once I got [on the board], there were so many wonderful things about this district I hadn't known as a parent," she continued. "Other than my family life events, this has been the most rewarding experience of my life.'

as they learn. It's going to be an amazing time."

Additionally, the Sowers campus will get a gymnasium, a STEM lab and feature exterior opening classrooms, natural lighting and large outdoor areas for gathering.

"I think the classrooms are really going to lend themselves to 21st century technology and learning,' Johnson said.

She added that currently, the Vikings' athletic teams

have to go to Dwyer, the district's other middle school, to compete.

Attendees at Tuesday's ceremony heard from another group that would benefit from the gymnasium space, as the Sowers choir performed a rendition of "Pure Imagination."

"We have such a great music program and such great athletics," Johnson said. "It's just going to be nice to have a building that's really going to showcase all of the kids' abilities and skills."

Johnson said the project is unique for her, as she was the principal at Perry Elementary before that campus was closed by the district in 2020. Now she has the opportunity to witness her current campus become revitalized.

The project, which has Studio W Architects as the architect and Construct 1 Corp. as the general contractor, will feature five AMS Gen 7 prefabricated buildings for 27 new classrooms overall. There will also be increased security, with perimeter fencing and a single point of energy.

The Sowers reconstruction will be funded largely by Measure Q funds (an estimated \$43 million) and the sale of Gisler School (\$23 million). Gisler was another middle school in the district before it closed in 1986.

Building is anticipated to be completed in late

"We are proud of the educational programs that Sowers currently provides to our students," Winston said. "To best prepare our students for high school and beyond, the campus needs to be reimagined to continue the legacy of educational excellence into the future. We are very excited to get this project underway. When completed, our students will have a state-of-the-art campus that will make an incredible impact on the education and lives of our students, staff and community for generations to

Sailors seal CIF title defense

IRVINE — "Next man up" has been the mantra all season for the Newport Harbor High boys' water polo team.

the CIF Defending Southern Section Open Division title would take a team effort. That truth manifested itself in very real ways Saturday afternoon as the No. 2-seeded Sailors took on top-seeded JSerra for the championship.

Two starters fouled out in the second half for Newport Harbor.

Next man up, as player after player provided big moments off the bench in the fourth quarter.

Junior Trey Smith scored on a post-up move, before senior left-hander Nick Kennedy provided a goal on a strong shot for a threegoal advantage.

When Newport Harbor needed defense at the end, another substitute provided it, with junior Jack Wright getting a key field block with 20 seconds left after JSerra brought goalkeeper Jack Halfer into the front court.

It all added up to another

championship in the top division for the Sailors, who earned a 10-9 victory before an overflow crowd at Woollett Aquatics Center.

The second straight title is the 14th CIF title overall for Newport Harbor (28-2).

"I'm so proud of these guys," said Newport Harbor coach Ross Sinclair, who has now won three Open Division championships (two with the boys and one with the girls) in the last three high school water polo seasons. "It's a gauntlet. There's no easy game. We had to grind against Huntington, we battled

against [Harvard-Westlake] and we had another amazing battle against JSerra. These guys are amazing. Relentless, resilient, every attribute you can name, these guys are it.'

UCLA-bound senior lefthander Ben Liechty scored a team-high three goals for Newport Harbor, matching JSerra junior Ryder Dodd for match-high honors. Newport senior goalkeeper Cooper Mathisrud made nine big saves, including one on a Dodd penalty shot with four minutes left in

Jackson Kollock's five touchdowns lead L.B. to road upset of La Quinta

LA OUINTA — A multihour commute awaited the Laguna Beach football team prior to its secondround game on Friday, so the Breakers did not wait around.

After catching an early bus ride to the Coachella Valley, the Breakers watched "Black Adam" at a movie theater, before their quarterback would deliver a near-supernatural performance.

Sophomore Jackson Kollock threw for 368 yards and four touchdowns, leading Laguna Beach to a resounding 41-16 upset win at topseeded La Quinta in a CIF Southern Section Division 9 playoff game.

Kollock, who also had a 3-yard rushing touchdown in the first half, completed 17 of 21 passes for 290 yards and three scores by halftime.

Senior wide receiver Jackson Rodriguez made seven catches for 114 yards and three touchdowns. Kollock completed passes to seven different receivers, six of them managing to pick up a first down through the air.

"They're amazing," Kollock said of his receiving corps. "Each one of them brings something different to the table. We got Rodriguez, who just is a

burner. He could beat anyone off the line, and even go up for jump balls.

"Ryner [Swanson], I love throwing to him. He's huge, can catch anything, run over a couple of people for us. [Aidan] Mulkay, he's shifty. Myles [Freeman] is shifty. ... We got so many guys. It's hard to keep track of them all."

As the top seed in Division 9 last season, Laguna Beach lost 38-7 at Claremont in the second round.

"When we went to Claremont last year, it was a long drive, late afternoon," Laguna Beach coach John Shanahan said. "We woke up as we were piling off the bus, and we never woke up, and that first quarter was disastrous.

"I think we're 5-0 or 6-0 at home in the playoffs as a staff, and we're 1-4 on the road, so we needed to change something. The model wasn't working, so we decided to come out here, go see a movie and relax, and try to have a different approach when

we went to the field." Laguna Beach (9-3) will play host to Riverside Norte Vista (9-3) in the semifinals on Friday at Guyer Field. The Braves beat Garden Grove 36-27 in their second-round

"It's just filling the role," Liechty said. "It doesn't matter who it is. It just matters what you're supposed to do, and do it to the best of your ability. I think that was a great situation to overcome, and I think we did that perfectly. Other guys were able to step up and fill that position."

JSerra (27-3) tried to respond, even after Kennedy's goal gave the Sailors a 10-7 advantage with 3:34 left. A Lions steal led to a counterattack goal by junior center Will Schneider. There was nothing fake about the championship plaque for Newport Harbor. The Sailors will now more than likely be the top seed in the CIF State Southern California Regional Division I playoffs, which start Tuesday.

They will approach that season-ending tournament with the same mentality as they have every match.

Next man up. That's the kind of attitude that gets a program to 14 CIF championships.

"It's an expectation to play at a high level, to train at a high level, to buy in at a high level and be committed," Sinclair said. "I don't mean it in an arrogant way, and I'm not putting crazy expectations on every single year, but kids come into this program knowing what they sign up for and the legacy that they have to uphold

"It's awesome. It's an amazing feeling."
