

New Mr. Irrelevant touches down in Newport

A crowd full of local movers and shakers packed into the Cannery Restaurant on the waterfront of Newport Bay on Monday, but on this night, the view was a close second to the man of the hour.

Those in attendance were there to participate in one of Newport Beach's most outrageous and beloved traditions of the last half century: Celebrating the underdog by honoring the last pick in the NFL draft.

Some surely wanted to dub the eatery a "Rams house" for the evening, as the Lowsman Banquet saw everyone trying to get a glimpse of and perhaps a moment with the Los Angeles Rams' Desjuan Johnson, the newest member of the Mr. Irrelevant

Johnson, a defensive lineman out of Toledo, became the 48th player to have the title of Mr. Irrelevant bestowed upon him after being taken with the 259th pick.

Flanked by family, Johnson sat at a round table on an outdoor deck overlooking the calm waters from which he had just arrived by boat. Before long, he was being roasted and toasted by a lineup of speakers.

Newport Beach officials presented Johnson with several gifts by dinner time. Fire Chief Jeff Boyles gave him a stuffed edition of a dalmatian, also known as a fireman's best friend. Police Chief Joseph Cartwright gave him a box of doughnuts, some sprinkled

with Rams' colors and others shaped like footballs. And of course, Mayor Noah Blom handed him the key to the city, which, legend has it opens, any lock within the city limits.

Standing next to the 6-foot-3, 252-pound Detroit Cartwright prefaced his jokes with, "Remember, we're friends now, OK, so you don't hurt friends," for a bit of lighthearted self-preservation.

"What do the Rams and the

post office have in common?" continued Cartwright, who professed that he did not write his jokes. "Neither of them deliver on Sundays.'

After the main course, it was time to hear from the football brethren. Four-time Super Bowl champion Jesse Sapolu, an offensive lineman for the San Francisco 49ers, and former Rams kicker Mike Lansford both remarked that they were "more irrelevant" than Johnson, having

been taken later in the 11th and 12th round, respectively.

With reverence to the late Paul Salata, who lived by the mantra of 'do something nice for someone for no reason," and created the Mr. Irrelevant award, Sapolu offered his own advice to the new Mr. Irrelevant.

"Here's the mindset that I want you to take, and I used that mindset when I felt disrespected,"

Newport Beach curtails public camping

An ad hoc committee tasked to evaluate city's homelessness services provided insight prior to ordinance's approval.

Camping on public property when shelter beds are available will be prohibited in Newport Beach, following a new policy approved Tuesday by the City Coun-

The panel unanimously approved a new ordinance as part of the recommendations it received from an ad hoc committee on June 13. The committee, which was first formed in 2019 and worked on and off over the next few years, was reestablished in March with Mayor Noah Blom and Councilwomen Robyn Grant and Lauren Kleiman. They were tasked with evaluating existing services addressing homelessness in Newport Beach and whether or not additional services might be

The approved ordinance prohibits sitting, lying, sleeping or storing of personal effects in areas directly impacting traffic or access to, specifically, cancer treatment centers, colleges, schools, day care centers, businesses, private property, firefighting, facilities,

Edison High School's principal announced her resignation from the position she has held for the past 10 years in a message sent to students, families and staff Wednesday morning, in the wake of controversy stirred by conservative outlets over a studentmade video celebrating Pride

Jennifer Judge will serve as assistant principal at the Huntington Beach Adult School, the educator wrote in her letter.

In a brief interview Wednesday, Judge told the Daily Pilot she was saddened to leave her role at Edison, but she was also excited to take on new challenges.

"It was such a hard decision to make," Judge said, sounding as though she was choking back

Memoir shares decades of gay man's life

Bob May was 70 years old, stuck at home during the pandemic in 2020 and playing card games in an all-gay online forum when one of the younger members — a man in his 20s posed an intriguing ques-

"What's the big deal with the Beatles?" the man, named Sam, asked the group.

The question surprised May, a Costa Mesa retiree who'd not only loved the Fab Four but considered them a cultural touchstone for those who'd been raised within the strict confines of the 1950s but felt called to something more expansive.

"They were basically the soundtrack of my life,' May, now 73, recalled in an interview Tuesday. "What the Beatles were was different from everything else that had come before that time."

When pandemic restrictions had receded somewhat, May and his fellow Beatles-loving friend Jim had a socially distanced sit-down with Sam and his friend, Trevor.


The topic of conversation began with the Beatles but quickly widened to include May's experiences as a closeted gay youth growing up in conservative Orange County in the 1960s, his being locked out of the house at 18 after his parents accidentally discovered his sexual identity and how he would come to learn via a Red Cross form letter he'd contracted the HIV virus after a blood donation.

"They had very little understanding of what my childhood was like," he said, adding after each anecdote he shared, his young friends responded with "Are you kidding?"

"All of a sudden I thought, I have a story to

The pandemic gave May the time and space to reflect on his life in a series of essays that would eventually be transformed into a memoir aptly named "Are You Kidding? A Life.

Initially submitted to on-demand self-publishing company IngramSparkin 2021, the

autobiographical work has since been made into a paperback and e-book format available through Amazon, GoodReads and Barnes & Noble's online

portal. May will make a rare in-person appearance Thursday at 6 p.m. at the Barnes & Noble Bookstore at Huntington Beach's Bella Terra shopping plaza on Edinger Avenue, where he will read excerpts from the memoir and sign copies for those who attend.

"I'm considering this the long-delayed launch I didn't have in 2021 because of COVID," said May, who's currently making "Are You Kidding?" an audio book. "Now seems to be the right time."

The book's 318 pages introduces readers to May, who grew up as the oldest of three siblings in a strict Southern Baptist household where the Lawrence Welk show was on TV every weekend and father Dick was constantly work-

May describes his book as "one gay man's humorous and mind-boggling remembrance of 70 years from Eisenhower to COVID-19" that includes his coming to terms with his sexual identity and pursuing acting while working for the AAA's Auto Club of Southern California, a career he held for some 35 years.

A self-professed "ham" and unapologetic extrovert, the author writes frankly about the AIDS pandemic, substance abuse and depression and his battle with the longterm side effects of lifesaving antiretroviral drugs.

'When this first started, [HIV] was a death sentence," May recalled of his diagnosis. "There was no therapy, there was no protection or knowledge. All I knew was people around me were dying like flies. I was scared.'

Nonetheless, he contin-

ued to work at the Auto Club while seeking acting jobs, chancing into a regular character spot on Gourmet Detective, an interactive murder mystery/comedy show, where he remained for 25 years.

Mack Gilliland, who was heading Garden Grove High School's drama department in the 1970s when May's community theater group used the stage to put on a production of "Christmas Carol," called his friend a wonderful character actor with great gifts and a penchant for bringing magic to the

The pair would meet several years later at an AIDS and HIV-related support group where their friendship blossomed. May eventually invited Gilliland to play piano with Gourmet Detective, a job he held for 10 years.

Today, the old friends describe themselves as Statler and Waldorf, the grumpy old-men Muppet

characters who sit in the balcony and heckle the productions below.

[Bob] is a dear person," said Gilliland, 81. "He's such a congenital extrovert, he can talk to anyone about anything and has no hesitations about sharing himself."

So, it was no surprise when the Diamond Bar resident learned about "Are You Kidding?" He even helped edit some of the chapters. Gilliland said the book paints a portrait of a young man growing up in fear — of homophobia and disapproval, being drafted to serve during wartime, the scourge of AIDS — and overcoming challenges to make a life for himself.

The Beatles, he said, provided a perfect backdrop to all of that.

'The Beatles were always a big thing, because that helped him articulate. to find his authentic self. The song 'We Can Work It Out,' especially hit a

thread with him. That's what pop music can do for young people — it can help them find themselves."

Although his memoir is beginning to gain some traction, May said he doesn't envision himself as an author. Instead, he sees himself as someone who had a story inside him and wanted to put it out into the world.

"I'm coming to the end of my life, and I think it's been an interesting life," he surmised. "I've learned a lot, been through a lot and have come out the other side pretty OK, and I think I should share that with others. That's my story.

Motorcyclist dies in H.B. single-vehicle crash

A single-vehicle crash in Huntington Beach left a man from Fountain dead Wednesday morning.

The man who died was riding a white Ducati Monster northbound on Main Street, Huntington Beach police said in a news release. Preliminary evidence suggest he

made an "unsafe turning movement" before he and his motorcycle crashed into a tree north of Orange Avenue.

Police were summoned to the area at about 1:30 a.m. They found the motorcyclist lying on the roadway.

He was taken to a hospital and later pronounced dead. He was described as a 33-yearold, and his name was withheld pending the notification of relatives.

The crash is still under investigation. Huntington Beach police asked anyone who might have witnessed it to contact traffic investigator J. Rounds at (714) 536-

While Sapolu advised Johnson that all he needed was an opportunity to make the team, he didn't miss his chance to take a dig at a new NFC West division rival. Sapolu said, "Rookies are allowed to make two mistakes a year," and the crowd guffawed when he made it clear he wouldn't mind if those miscues came in the weeks the Rams play

the 49ers. San Francisco quarterback Brock Purdy, who was last year's Mr. Irrelevant before leading the 49ers to the NFC championship game, sent in a video welcoming Johnson to the club. Former Rams quarterback Vince Ferragamo also presented him with a Rams watch.

Irrelevant Week reached its end on Tuesday. Johnson visited the Newport Beach junior lifeguards program, before heading over to Angel Stadium, where he witnessed a two-home run, 10strikeout performance by Shohei Ohtani.

The weekend was not without its own highlights. On Friday, Johnson went to Disneyland, clad in a jersey shirt with his last name

On Saturday, a few dozen people were on hand at 30th Street beach to see Johnson's first attempt at surfing. His uncle, Roland Stegar, got up on the board first, but Australian surfer Peter "PT" Townend ulti-mately graded them very closely.

"First thing is he's never even been in the Pacific Ocean," Townend said of the difficulty in getting up on a surfboard. "That challenge alone, to even jump in the water and even just walking out. ... It's only like 2 feet today, but even when a 2-foot wave hits you, you realize the power of the

ocean. "For the first-time experience, for him to go out there, he got one, a pretty decent one. That's an accomplishment right there in itself. It takes years. ... For them to get to their feet on the first day in the Pacific Ocean is a pretty serious accomplishment."

Johnson said he felt he got better and better with each pass at the waves.

son expressed how thrilled he was to share it with his family.

"Everything's been the best," Johnson said after getting out of the water. "I can't pick and choose one. Everything's been the best, as far as my family coming out here and just spending time with me, spending some quality time with my family. That's one of the best things that I was looking forward to, just seeing smiles everybody's on faces.'

Asked about the toughest part of surfing, Stegar's focus was on soaking up the beauty of the Newport coastline.

Seal Beach police arrest man on suspicion of child abuse

A Seal Beach man pleaded not guilty Monday to charges of child abuse and attempting to evade arrest by leading police on a pursuit that ended in Los Alamitos on Thursday.

Authorities responded to a welfare check for a young child without parents or guardians in the area of Heather Street and Guava Avenue in Seal Beach at 3:37 p.m. on June 22. After officers located the 4-year-old child, they identified visible injuries on the child's face and body and proceeded to call paramedics to transport the child to a local hos-

As paramedics evaluated the child's injuries, police said the alleged abuser was seen driving the neighborhood.

Officers attempted to make a traffic stop when the driver allegedly fled in his vehicle and led police on a chase through Garden Grove toward the northbound 405 Freeway. The chase was terminated after authorities could not determine his exact whereabouts.

The suspect, Cody Rohlfing, 25, was later involved in a traffic collision in Los Alamitos. He allegedly attempted to flee on foot from the scene, but was brought into custody with the assistance of Los Alamitos and Cypress police officers, and a Huntington

Beach police helicopter. Rohlfing, who is not biologically related to the child but lives with the child's mother, has been charged with felony child abuse and endangerment, evading a

peace officer and reckless driving, failure to stop at a traffic accident resulting in injury or death and a misdemeanor charge of resisting a public or police of-


Rohlfing is expected to next appear in court at the West Justice Center in Westminster on July 6. He is being held without bail, according to jail re-

public restrooms and bike paths.

It also prohibits unpermitted physical structures, regardless of shelter bedspace; camping on public property using camping gear without permission from the city; fires in unpermitted areas; lodging in public restrooms; usage of public fountains, drinking faucets, restroom sinks and sprinklers to wash dishes, clothes or bathe; leaving personal property unattended on public property; and injuring public property.

The city currently has a contract with Be Well OC, collaborates with nonprofit CityNet, and partners with the city of Costa Mesa in its homeless shelter. According to recent data collected by the city, there were about 41 unsheltered individuals in the city of Newport Beach in May.

"This is not something that's happened in the last couple of days, weeks or months. This has been a

process of years and years. These recommendations that came out of the ad hoc committee are a culmination of a lot of efforts within the city and we have the same frustrations that everyone [attending the meeting] does right now," Blom said. "Our goal right now is to find the best, most proactive way to help those that are out there while ensuring the quality of life that we're all looking

for." Kleiman said of the proposed measures, "In no way are we trying to shuck our responsibility to provide assistance as evidenced by the procurement of additional shelter beds and our partnerships with BeWell, CityNet and Costa Mesa."

Residents were overwhelmingly in support of the ordinance. Many of those commenting Tuesday night were emphatic that they wanted to help unsheltered people off of the streets, but that they also wanted other citizens and tourists to safely enjoy public amenities such as the Balboa Pier and Newport Pier.

"Based on recent court decisions, the city's municipal code provisions needed updating," City Atty. Aaron Harp said Wednesday. "This is especially true for regulations that protect public access and ensure sanitary conditions are maintained. The proposed ordinance is designed to align the city's regulations with the guidance that has been provided by the courts over the last few years."

Harp said the city does not expect a challenge to the new ordinance, which comes on the heels of a memorandum with the city of Costa Mesa and will expand shelter beds for Newport from 20 to 25. Five other beds meant for Costa Mesa could also potentially be allocated to Newport if they aren't in immediate use.

A second reading of the ordinance will come at the next City Council meeting on July 11 and the policy will be in effect about 30 days thereafter, according to Harp.

tears Wednesday. "I'm definitely going to miss all of the kids, my staff and everyone who was a part of the Charger family. I'm from this community, and it was an honor and a pleasure to serve it."

The move was unrelated to the reaction of some parents and conservative outlets to a student-made video celebrating Pride month, Judge said. A recorded exchange posted to social media involving students expressing displeasure while watching it and a teacher who threatens to punish them for acting out drew a firestorm of attention, as well as comments from local and county officials.

"That [incident] had nothing to do with it," Judge said of her transfer to a new position.

The video in question is a brief clip featured in an episode of Edison High's Bolt TV. At times, it depicts LGBTQ+ couples holding hands or touching their foreheads together. But it does not explicitly feature kissing or graphically sexual content.

"At Edison, we should make all students feel welcome here, no matter gender or sexual orientation," the video's narrator says over footage of LGBTQ+ students. "So if you are out and proud, closeted or even just an ally, be proud of who you are. Most importantly, don't forget to love each other. Happy Pride month."

Some parents, along with a collection of TV and internet pundits, found the video obscene and took issue



with the fact that students were threatened with punishment for expressing disapproval with it. They accused school officials of attempting to push a progressive agenda on youth.

"Rather than listen to his students, the teacher threatened them with supervision and to give them detention the following year," Huntington Beach Mayor Pro Tem Gracey Van Der Mark said during public comments at a Huntington Beach Union High School District school board meeting on June 13. "At no time was the teacher concerned with the students' visceral reaction as they watched video clips of couples in intimate positions and poses. In my opinion, it was not the students being inappropriate."

That meeting took place the night before fliers demonizing both the LGBTQ+ and Jewish communities were found on lawns and on the street in a neighborhood less than a mile away from Edison High School.

In response to that apparent hate speech, three liberal members of the Huntington Beach City Council brought forth a resolution specifically denouncing antisemitism, white supremacy and anti-LGBTQ+ hate. But during a June 22 meeting, Mayor Tony Strickland proposed a substitute motion, expanding the item to reference hate against Catholics, Christians, Black people, Latinos, Asians, Pacific Islanders, Native Americans, Indians,

Persians, Muslims, Hindus, Buddhists, Mormons and white people.

"I want to make it clear that there's more hate out there," Strickland said during the meeting. "Huntington Beach welcomes everybody."

Inclusiveness was ostensibly why the conservative majority of the City Council voted earlier this year to stop flying the Pride flag at public buildings in June. Supporters of the move said it was in the interest of fairness, because current law prohibits the city from displaying non-governmental

Orange County Board of Supervisors made a similar decision on Tuesday, June 6, based on essentially the same reasoning. It's unclear if any municipality in Orange County has ever been cited for breaking laws prohibiting the display of non-governmental flags.

and able to watch and enjoy the afternoon," she said. "That was pretty special."

Her parents watched her turn into a hero as the day unfolded.

Ilagan sank birdie putts on the final two holes, including a 25-footer on No. 18, to help Big Canyon edge host Newport Beach Country Club for the championship.

Big Canyon finished at 17under-par in the two best ball format, a stroke better than Newport Beach. It is the tournament-best 11th Jones Cup title for Big Canyon, the first since 2018.

Ilagan earned the inaugural Gordon Bowley Celebration Award for the tournament MVP, named after the longtime Jones Cup volunteer who died earlier this year. Golfers also wore "GB" pins in Bowley's honor.

Bowley would have enjoyed Big Canyon's heroics on the final hole. Ladies champion Olivia Slutzky also made a shorter birdie putt of about six feet on No. 18 to help secure the title.

"We all pushed each other, just to be comfortable and let it go," Ilagan said. "Put your best roll on it and see what happens, that's really all you can do. The whole team just did that throughout the whole afternoon. It was fun to see everyone get into that zone and hit quality shots."

Mesa Verde Country Club finished third at -11, followed by Shady Canyon in fourth at -9. Defending champion Santa Ana finished fifth at -6.

Ilagan had five birdies for Big Canyon, which tied for the team lead with senior men's champion Will Tipton. Men's champion Jordan Nasser and Slutzky each had three birdies, and team captain Robert Pang added two.

Pang said he was on cloud nine after the victory, giving a big hug to Nasser. He said Nasser is one of his best friends, and was on the USC men's golf team when Pang was an assistant professional at Los Angeles Country Club.

"It was a total team effort, just super, super fun," said Pang, who won the Jones Cup for the seventh time overall. "We enjoyed the walk in the park today. The energy was good, the teamwork was good. Wow. How do you actually put it into words what fun we

just had? What a way to enjoy five-and-a-half hours."

The back nine turned into a battle between Big Canyon and Newport Beach. The host club, which teed off last, got birdies by professional Andy Alderdice and senior men's champion Todd Roberts on par-three No. 17 to take a one-stroke lead.

But Big Canyon, the group directly in front of Newport Beach, responded with the two birdies on No. 18 to take back the lead. They then watched as Newport Beach missed birdie putts on the final hole, at least one of which it needed to make to force a playoff.

Newport Beach men's champion Blair Walsh, a former kicker in the NFL, saw his final putt veer just wide of the hole.

"I liked the read and it's kind of right edge," Walsh said. "I hit a similar putt in the club championship to win it, so I thought it had the same type of movement, but it really didn't ... Being competitive in a different sport was fun. I'm used to having a lot more people watch me, though. An NFL crowd is a different feeling than it is having people watching you play golf."

Team captain Robin Shelton and ladies champion AiLam Newkirk also contributed for Newport Beach, with Newkirk recording an eagle on the par-five No. 5. Alderice and Roberts had four birdies each.

Professional Mike Fergin made a team-best five birdies for thirdplace Mesa Verde, including two on the first two holes.


