# Newport Beach police fatally shoot motorcyclist

The California Department of Justice will investigate, as they do with any "officer-involved shooting resulting in the death of an unarmed civilian." The N.B. Police Department spokesperson said an active investigation is underway.

Police and the California Department of Justice are investigating the fatal shooting of a motorcyclist who died after a confrontation with Newport Beach Police Department officers during a traffic stop.

The shooting happened around 9:15 p.m. Thursday on Pacific Coast Highway, west of Superior Avenue. In a news release, Newport Beach police said the motorcyclist became "uncooperative" before at least one officer opened

He was taken to nearby Hoag Hospital, where he died as a result of his injuries. The man was later identified by the California Department of Justice; Orange County Coroner's officials confirmed that he was Geoffrey Stirling, a 45-year-old resident of Laguna Niguel.

"An active and ongoing investigation is underway. Further details will be released as they become available," police said.

State Atty. Gen. Rob Bonta's office on Friday announced the state DOJ's police shooting investigation team will independently review the incident, per the terms of a state law passed in the wake of the 2020 death of George Floyd in Minneapolis. California Government Code states that it applies to "an officer-involved shooting resulting in the death of an unarmed civilian."

# H.B. man already has a big heart. Now, he needs a kidney.

hawn Kortes is always the helper, and never the one asking for assistance. The Huntington Beach resident and his wife Jenny created the HB Quarantine Cuisine Facebook group during the coronavirus pandemic, an attempt to aid restaurant owners hamstrung by stay-at-home orders and dining restrictions.

More recently, Kortes made several trips north in the aftermath of the Los Angeles

area fires, delivering truckloads of food donated by local restaurants, along with other goods to be distributed during refugee ef-

"It's the littlest things," said family friend Courtney Winford, an assistant principal at Huntington Beach High School. "He's always there to help. I mean, he's helped me move I don't know how many times. He's that guy you can always count on."

Now, Shawn Kortes is the one reaching out and asking for help.

He has no choice. The 45-year-old knows it could literally be a matter of life or death. Kortes, who has polycystic kidney disease,

is searching for a living kidney donor. He was first diagnosed with the hereditary disease back in 2010. He saw the effect it had on his mother, Cindy, who passed away in

Things are getting more real for Kortes. He started peritoneal dialysis in January, an

# As another busy summer looms, Laguna braces for the impacts of tourists

Laguna Beach is gearing up early in preparation for an anticipated surge in visitors after traffic, trash and other impacts resulted in a summer of discontent for residents last year.

City officials addressed the public at a town hall meeting Thursday evening, the City Council chambers filled with residents interested in hearing and contributing to — the new plan of action.

"I think we started our messaging last year a little too late," City Manager Dave Kiff said at the outset of the meeting. "... As a result, we were probably not as prepared as we would have liked to have been for the visitors last

Kiff acknowledged limitations to the city's ability to lessen the impacts. He noted that parking rates - while increased periodically — cannot "charge what the

market will bear" because of controls in place by ordinance and the Coastal Commission. Beach access is also protected by the Coastal Act and the city's local coastal program.

"We rely on visitors — hotel bed tax, parking revenue, sales taxes to serve the residents," Kiff said. "I wish that were different, but it is a big chunk of our money. It's not a majority, but it is a significant chunk of our revenues that we use to operate the city."

From a traffic perspective, city officials are hopeful that an earlier start for the Summer Breeze trolley route will pay dividends. Trolleys will begin busing in people from a free peripheral parking lot at 16355 Laguna Canyon Road near the 405 Freeway on May 23, Kiff said.

Kiff also suggested that the messaging from Visit Laguna Beach needed to take a different

# Costa Mesa rejects cannabis shop permit

Officials overturned commission approval of a dispensary at 1912 Harbor Blvd.

Costa Mesa officials this week rejected a cannabis dispensary planned for a busy Harbor Boulevard retail center, after business owners and residents complained there is an over-concentration of pot shops in the neighborhood and called the applicant's moral character into question.

A City Council hearing Tuesday played host to a dispute between Keith Scheinberg, of Newport Beach-based RDK Group Holdings, LLC, and Jayne Flinn, who owns the Harbor Place shopping center directly south of the site, located at 1912 Harbor Blvd.

Scheinberg and his colleagues since 2021 have sought to open a 2,400-square-foot Green Mart in the former site of the King of BBQ, a restaurant nestled between Harbor Place and a strip mall to the north occupied by various restaurants, a boba tea shop, dentist and dog groomer.

Scheinberg finally got a chance to appear before the Costa Mesa Planning Commission in a Feb. 24 hearing at which commissioners narrowly approved a conditional use permit for the project in a 3-2 vote (with one recusal and one absence).

Seven days later, a representative of VMA Harbor Place Holding Co. appealed the decision on the grounds that RDK's plans for the dispensary were inadequate and that the retail shop was incompatible with surrounding businesses and would present traffic and parking issues.

VMA representative Kendra Carney Meher explained to the City Council conducting a de novo review Tuesday that Green Mart was closely situated to a church that hosts youth programs and a nearby apartment complex that, while zoned commercial, qualifies as a residence eligible for

A resident who declined to be named due to privacy concerns said she had just gotten home from dinner at the Winery and was in her second-floor bedroom when she heard what sounded like gunfire.

"All of a sudden they had the helicopters go in and they had the police sirens, then there was probably five shots, bop bop bop bop," she

She was among about seven members of the surrounding community who reported Friday having been unaware of the what had taken place the night before as they walked their dogs or watched their children play at Channel Park, just south of where the shooting happened.

Another recalled the sound of helicopters in the air until well into the evening. "It was after the airport was supposed to be closed," said the resident, who also declined to be named. "So I kind of knew something was up and went and locked all my doors and windows."

No officers were hurt during the traffic stop and shooting. The Newport Beach Police Department declined to release additional information Friday afternoon, citing the need to preserve the integrity of an ongoing investigation.

A law signed by Gov. Gavin Newsom in 2022 classifies body cam recordings as public information. In the event of a fatal police shooting, that footage must be released to the public within 45 days.

a 250-foot buffer spelled out in the city's retail cannabis ordinance.

"A compatible and harmonious relationship does not exist between the proposed use and the existing buildings, site development and uses on surrounding properties," Carney Mehr reasoned.

Others speaking in public comment shared their frustration with what they described as an oversaturation of cannabis shops in the immediate neighborhood. So far, Costa Mesa has approved 26 use permits citywide, and 13 shops are currently open for business, according to a city map displayed at Tuesday's meeting.

Of those, four are operating within one-quarter mile of 1912 Harbor Blvd., while two other shops within that radius, including Green Mart, are in the approval process.

"What is the appropriate

"What is the appropriate number of dispensaries any one neighborhood should shoulder?" asked a Bernard Street resident who identified herself only as "Kelly." "Maybe you all, when you walk your dog, pass two, three, four, five six — I can keep going — dispensaries. Maybe this is the Costa Mesa experience."

During the hearing, property owner Flinn cast aspersions on Scheinberg's character, particularly for what she alleged was a

"complete disregard for following city rules, guidelines and regulations," which she said she witnessed firsthand.

She described the two parties as having a turbulent past involving tenancy, ownership and alleged bad behavior, details of which are briefly recounted in public comments submitted for the Feb. 24 Planning Commission hearing.

Flinn said she owned a residential property on Newport Beach's 32nd Street adjacent to another residence where, she claimed, Scheinberg posed as a tenant and then rented out the unit as a venue for for-pay nightclub parties — promoted under the moniker "GatsbyOC" — and the production of adult films.

"I am requesting the council tonight deny the [use permit] not because I am confident it is only a matter of time until Costa

Mesa finds itself in a battle to remove an unruly and unlawful use, or because of a history showing a clear pattern of the applicant's disregard for local regulations, but because you as a council have already determined this is an incompatible use," Flinn told council members Tuesday.

Scheinberg acknowledged his historic conflicts with the property owner, calling it an "ironic coincidence" that their paths were crossing once more in a similar scenario. He said Flinn hired a private investigator to sit outside his personal residence and interview neighbors about his character.

"What she presented to you, the Gatsby, that's not me; my Instagram is completely separate," he said. "When they say I'm running a nightclub — it goes to an extreme and an extent that this appellant is willing

to go to to lie and kind of defame me at this point, to try to prevent me from opening this."

Citing the four years he's complied with the city's long processes for opening a dispensary, and having rented a commercial space throughout the interim, at a total cost of about \$500,000, Scheinberg urged the council members to uphold the Planning Commission's approval of Green Mart's conditional use permit.

"The council voted for the number of dispensaries that we were allowed to have, I just played by the rules," he said. "To pull the rug out at this point would be unfair. I've put so much time and effort and money into this. I've waited — I believe I deserve this opportunity to run a business."

Mayor John Stephens and Councilman Loren Gameros sided with the applicant, respectively putting forth and seconding a motion to uphold the Planning Commission's approval of Green Mart.

Stephens eschewed Flinn and Carney Mehr's claims that the cannabis shop fell within residential youth center buffer zones, stating that churches do not qualify for a youth center 1,000-foot buffer, while the law's 250-foot residential buffer was crafted last year during a revision of the 2021 ordinance, after application Scheinberg's was received. He briefly addressed the fairness of the situation and claims against Scheinberg's character.

"The carrying costs of these businesses, getting through the process — almost a four-year odyssey — is a lot. It takes personal character and it takes personal capital to go through," Stephens said. "It's a bummer that it takes so long to go through the process, but it did, and I think there should be some

credit given for that."

But Councilwoman Arlis Reynolds, in a substitute motion, suggested overturning the commission's approval of the project, finding Green Mart not substantially compatible with surrounding uses and potentially detrimental to public safety and injurious to nearby properties.

In addition to being located in a pedestrian priority zone, she said the proposed location fell within several other family-serving businesses and could possibly impede the success of those businesses.

Mayor Pro Tem Manuel Chavez acknowledged the area is already too saturated with retail cannabis options.

"While I sympathize with the applicant, and I understand the effort they put in, I cannot in good conscience move forward seeing there's going to be four cannabis shops within a [quarter-mile] radius. For me, that over-concentration is a big factor, and residents spoke to that factor."

eight-hour process that he undergoes every night at

In four two-hour cycles, a special solution is used to filter the blood inside his body. He compares it to an oil change for a car. But the equipment is bulky, making any travel plans diffi-

"The longer I'm on dialysis, the sicker I'll get, and that's where you start getting a lot of other complications," Kortes said. "The idea is to get people to test to see if they can be a donor. The less time I'm on dialysis, the better. I'm still young, I have kids, I'm still healthy."

Kortes, who works as a manager and server at 25 Degrees bar in downtown Huntington Beach, wants to be able to provide for Jenny and their 6-year-old daughter Charli, who doesn't quite understand yet what Daddy is going through. He also has a

17-year-old stepson, Logan Gray, a junior who plays for the Huntington Beach High football team.

Shawn Kortes was recently put on a National Kidney Foundation wait list, but that's only for cadaver organs and the wait can be years. That's time that Kortes is not sure he

His blood type is Onegative, which means he can only receive a kidney donation from another person with O-type blood.

Shawn first met his wife created

in high school — he went to Huntington Beach, she went to Marina — and they reconnected some two decades later. They've gone through the ups and downs together after getting married in 2018.

Jenny, who works as a personal trainer, saw her mother die in March 2019, just a few months after Charli was born. She had already lost her father when she was a senior at Marina.

Then, Cindy's death created a bigger void.

"It's just been like one thing after another for them," Winford said.
"Shawn's the first person to help out anybody in need, myself included. They're just such positive people, giving people and loving people. They're definitely ones that don't deserve to be going through this, and I hate saying that, because no one deserves it. But they definitely don't deserve it, you know?"

Shawn transitioned from

approach. John Zegowitz, who is assisting the organization with a rebrand and awareness campaign, spoke to a plan to connect tourists to the local lifestyle.

Zegowitz said the mission will include "leading guests" to engage with the area in a way that is aligned with and respectful of the local community and the environment.

Community input is beincluding sought, ing through a resident survey on tourism impacts currently being circulated on the city website.

Zegowitz shared some of the comments fielded so far, saying, "Obviously, residents are feeling that their world and quality of life is compromised, right, overrun by those who just don't care. Visitors tend to lack understanding or respect for the community's values, leading to trash, traffic, noise, tensions and damage

to already challenged environmental resources."

The lodging establishments, who pay a self-assessment to help fund tourism-related initiatives through the tourism marketing district, recognize the environment and culture of Laguna Beach are their "greatest amenity," Zegowitz said.

"They want to be part of protecting it, and they want to make sure that it remains that beautiful amenity of theirs," Zegowitz said. "Curating and educating the right kind of visitor to raise the quality and experience for guests and the community alike by inspiring protection of what makes Laguna unique, that is something that we're really going to focus on, as well. The opportunity is to connect a different mindset by better representing Laguna as an environmentally- and creatively-driven place. If we can keep pulling those things forward, we're pulling our culture for-

ward."

Laguna Beach police officers made 284 arrests for driving under the influence of alcohol or drugs last year, Police Chief Jeff Calvert said. In January, the police department began notifying businesses when a DUI arrest could be connected to the alcohol-serving establishment.

Part of the DUI arrest, the officers ask, 'Where did you last drink?" Calvert said. "We have taken that information, and we're actually sending a notification letter to the business. The owners don't know what they don't know. Well, now they know. We're telling them the date and time of arrest, and also, the bloodalcohol level of the person that was arrested."

The 284 DUI arrests represent a 21% increase from 2023, said Calvert, who added that 238 of the arrestees were visitors. Of the notifications sent out following those arrests, 61 of the 83 letters were delivered to local businesses.

Other vehicle-related fig-



ures included over 22,000 parking tickets, close to 1,700 speeding infractions, and 340 loud exhaust cita-

Additional quality-of-life matters saw the department write 649 citations for drinking in public, 236 for dogs off a leash, 200 for smoking in public.

Laguna Beach will have nine park rangers in the field to deal with quality-oflife issues this summer, Calvert said. The city operated with seven park rangers last year. The program began in 2022.

Calvert expects to have a total of five motor officers including a traffic sergeant — within four to six months.

City messaging will strike a different chord than that of Visit Laguna Beach, Kiff said, describing it as "more enforcement-oriented."

"Heavier on the don't and no's," Kiff said. "There'll still be some stewardship messaging, but we'll continue to start publicizing numbers of folks who get ticketed. ... I think people need to know it's happening, but you'll see this, especially on social media.'

working in the oil and gas industry to helping out restaurants, finding himself with plenty of time during the pandemic after he got furloughed and laid off. He would go to different restaurants in town, come home and write positive

**HB Quarantine Cuisine** has kept the name and remains an active Facebook group, currently with slightly less than 13,000 members.

"It worked pretty well, I think," Shawn Kortes said. "We got a lot of feedback from a lot of business owners saying 'Thanks for helping us keep the doors open, keep the employees paid.' At the same time, it was pretty fun. We were all sitting around looking for something to do. The whole world was shut down, and I got to go eat food and write stories, have some fun in the process. I

got to meet a lot of really cool people and made a lot of new friends throughout

Huntington Beach.' Some people talk about the "aloha spirit" in Huntington Beach, and the Kortes family seems to possess it. Jenny's brother even lives in Maui, with another setback for the family happening as he lost nearly everything in the

2023 wildfires there.

The water is no longer friendly for Shawn, who can't go in the ocean anymore after a catheter was put into his gut on Jan. 2 for the dialysis. It took about six months of testing through UC Irvine to have his name put on the National Kidney Foundation

"I can totally see it occa-

sionally on Shawn's face, on the bad days," said Damion Loukas, another close family friend. "It's like, man, this just really, really sucks. But Shawn being Shawn, he's head down, feet moving forward and trying to keep the best outlook possible. I think he definitely dives head-first into the community, into his friends, into his family. He's trying to soak up as much time as he can, while he can."

There's a voucher program, Shawn Kortes said, which offers more hope to his situation.

"Say [an interested donor's] kidney isn't a direct match for me, but they're still willing to donate," he said. "They can donate to somebody else on my behalf, and I get a voucher which kind of bumps you up and gives you a front-of-the-line pass. With a voucher, I can get a kidney within like six months."

Jenny said his spirits have improved lately, even with the difficult dialysis.

"I think he saw hope with the fact of being on the list, and finally being able to tell more people about his story," she said. "I think it's making him more comfortable."

Shawn, of course, immediately disagreed, again thinking of his significant other before himself.

"Not really," he said, looking her way. "You're going to have to deal with it for the rest of your life."

Jenny was quick with her own answer.

"I know," she simply replied. "I'm still here."

So is Shawn, hoping a friend or even a stranger can make a decision that will lead to a match that prolongs his life.

"It's hard for me, because I never wanted this to be part of my story," he said. "If I die one day, I want people to talk about all of the things I did in the community, the things I did to help people, that kind of stuff. I never want people to talk about how I got sick, a 'poor Shawn' kind of thing."

He has to keep looking to the future. Many people don't show symptoms of polycystic kidney disease until they turn 30, and it's still years until Charli becomes an adult and can be tested for it.

Those are years Shawn wants to be there, to see her do things like learn how to drive and graduate from high school.

He now knows that it's OK if it takes help to get

"He's still smiling," Winford said. "We were just there on Sunday for dinner, and he's still Shawn. I think for him, it's about the bigger picture of donating and how to help more people than just him. That's who

Nguyen, a senior, and Tran, a junior, charged into the Ojai semifinals last year before losing a close threeset match to a team from Claremont.


The Marina duo then won the Surf League doubles title before earning the CIF Southern Section Individuals title, becoming the first Vikings tennis players in history to do so.
