# O.C. headed for a viral winter

Hospitalizations spiked 72% since officials released data one week ago, according to the latest OCHCA report.

County health officials are bracing for what looks like another winter coronavirus surge as the number of residents hospitalized with COVID-19 has continued to climb since Thanksgiving weekend, reaching levels not seen since February.

And as Los Angeles County officials consider the wisdom of returning to an indoor mask mandate, one UC Irvine professor said he believes Orange County denizens who want to avoid becoming infected this holiday season should do the same.

season should do the same.

The Orange County Health
Care Agency reported Thursday
388 infected patients were being
treated, with 48 individuals in
intensive care, a 72% increase in
hospitalizations since officials
released data one week ago and
nearly 250% jump over one

month earlier.

And that's just COVID-19 — the flu and respiratory syncytial virus, or RSV, are increasing the burden placed on hospital emergency and intensive care units. On Nov. 1, Orange County officials declared a health emergency, claiming infections had pushed pediatric hospitalizations and daily emergency room visits to peak levels.

Andrew Noymer, an epidemiologist and UC Irvine associate professor of population health and disease prevention, told City News Service circumstances seemed to portend a pernicious winter ahead.

"We're back to [COVID] levels not seen since last winter, the tail end of the Omicron wave, and we're heading into another winter wave," he said Thursday.

# Winter Fantasy returns to the Sawdust Art Festival

he grounds at the Sawdust Art Festival have come to life once again, as the Laguna Beach festival is in the midst of its 32nd annual Winter Fantasy event

# Contract awarded for Newport Beach park expansion plan

Construction will begin as early as next month on the expansion of access to Sunset Ridge Park, following approvals of a \$10.5-million contract between the city of Newport Beach and Reyes Construction, Inc.

Conceptual plans for the project were approved in 2019. The project will add 65 parking spaces and a pedestrian bridge

that spans Superior Avenue, allowing the connection of Sunset View Park to its larger sister park,

Sunset Ridge Park.

Sunset Ridge Park opened in 2014, but is underutilized as the 13.5-acre park lacks onsite parking. Permitting constraints from the state Coastal Commission prevented the construction of a parking lot at the park.

# Rain returns to Orange County this weekend

#### **BY ERIC LICAS**

Inland portions Southern California will experience the brunt of a storm this weekend, but valleys and coasts in Orange County should still receive around an inch of rain.

Showers beginning Saturday should build into steady, at times heavy rainfall on Sunday before tapering off Monday, according to the National Weather Service. Orange County is expected to see more precipitation than the amount it received last week, but not as much as what came down from a storm powered by an atmospheric river at the beginning of November.

No mudslide warnings were scheduled for Orange County, but traffic and other issues related to flooding in low-lying and urban areas may still occur over the weekend, NWS meteorologist Stefanie Sullivan said. She also advised keeping an eye out for falling trees, branches and wind-blown debris.

"It doesn't take much to uproot a tree with roots

that might be too shallow," Sullivan said. "And gusts are always knocking down palm fronds."

The NWS issued a highwind advisory effective Sunday between 6 a.m. and 10 p.m. Gusts may reach speeds of 30 to 35 mph during that period, Sullivan said.

A cool down will accompany cloudy, wet and breezy conditions early next week. Saturday highs of 60 degrees in Laguna Beach, 61 degrees in Huntington Beach, 62 degrees in Newport Beach and 63 degrees in Costa Mesa and Fountain Valley were expected to drop to the mid-50s by Monday.

At inland mountain ranges in San Bernardino and Riverside counties, falling temperatures will help bring the snow level to as low as 3,500 feet above sea level by Sunday evening, according to forecasts. Up to 2 inches of snow may hit the ground at that height, and as much as 2 feet of powder may cake elevations above 7,500 feet.



Sunset View includes a 64-space parking lot that's used by its visitors as well as beachgoers.

Pedestrians regularly cross Superior Avenue, which curves and has four travel and three turn lanes that connect to Pacific Coast Highway. According to traffic studies made a few years ago, the Superior-Coast intersection was seeing 48,000 vehicles daily on Coast Highway and 21,000 to 24,000 on the Superior-Balboa Boulevard legs.

The studies also recorded a daily count of 600 pedestrians — 470 of whom crossed Coast Highway

and 90 cyclists, almost half of whom crossed the high-

Thus, the bridge and the additions to Sunset View's parking lot, built by Caltrans in 1989, to expand access to Sunset Ridge Park.

Senior civil engineer Andy Tran noted Sunset View's passive park area will also be expanded as part of this project.

The project, carrying a total estimated cost of \$14.7 million, is expected to be completed in May 2024. The costs includes planning, the construction contract and a contingency. Public works director Dave Webb noted the project has been in the pipeline for a while and costs are higher because of inflation and supply chain issues.

Councilman Brad Avery said he sees multiple benefits to the project and considers it forward-looking.

"The Banning Ranch will happen and this will be a really good access point to reach Banning Ranch," Avery said. "We're taking care of a lot of things here and I think a line item of each benefit, what it's going to mean to our residents."

Avery said the bridge would not only benefit the safety and access of pedestrians, but that it would also improve traffic in the summer.

"I tend to be positive about projects because when you look back almost invariably five years, 10 years; you go, 'Wow, it's a good thing we did that

then because of what it would entail now.' Not only just cost, but permitting and life just gets more complicated. I think we have the money," said Avery.

"There's a lot of grant money here and I believe we should strike on this and look toward a future that's going to be much better in this particular area for multiple reasons for residents that want access to the beach, sport parks and Banning Ranch," he added.

# Marina tops Ocean View for nonleague win

Marina High has created plenty of chances through its first four boys' soccer games of the season, but finishing them hasn't been simple, and the Vikings' difficulties were apparent in the first half of Friday afternoon's nonleague against visiting clash Ocean View.

Fourteen shots, eight of them on frame, with nothing to show for it.

Things came together after halftime, with a pair of David Hallworth free kicks prodding Marina toward an emphatic 3-0 triumph, another step, it is hoped, toward a first winning campaign in eight years.

Quinn Hartman's glancing header from Hallworth's serve gave Marina (1-2-1) the advantage four minutes into the second half. Ryan Patterson, making amends for a missed penalty kick in the first half, put away a loose ball in the 55th minute, and Dominic Ortenzo added the third from Ryan Spielman's feed on a quick counterattack 15 minutes later.

"We've been able to create opportunities, we've just been struggling to put them in the back of the net," Marina head coach Gabriel Lucatero said. "To see them actually get some in the second half was great. Hopefully, we continue to build on that."

They'll have to do so to emerge from the tough Wave League after missing the CIF Southern Section postseason by one point last year, and Lucatero believes his team, with greater club experience, is capable of that and perhaps

Marina might scored three in the first half, but Seahawks defender Jesse Gomez got in the way of Tomaslav Steele's close-range shot in the eighth minute, Vanson Vu fired wide off a rebound at the left post in the 30th minute, and Patterson's penalty kick in the 38th minute failed to challenge goalkeeper Jayden Trujillo.

Patterson made up for it after Hallworth's free kick from 36 yards caromed off Steele's back and onto his

"Missed opportunity, the penalty kick. Working on placement under pressure," Patterson said. "But great ball from David. He keeps playing perfect balls and out attackers are getting their heads on them."

Ocean View lacked the tactical awareness required to stay with the Vikings, but head coach Lucas Kim thinks his team can take some strides forward after ending a 52-game winless streak — dating to January 2020 — with Wednesday's 2-1 comeback victory over
