## Traffic to return to second block of H.B.'s Main Street

City Council members pass item that will end expanded outdoor dining and retail and let vehicular traffic resume.

Huntington Beach will reopen the second block of Main Street to vehicular traffic, ending the expanded outdoor dining and retail that has been in place since early in the coronavirus pandemic.

The Huntington Beach City Council voted to reopen the second block on a split 4-3 vote Tuesday night, after hearing input from dozens of residents and receiving 29 emails on the agenda item.

The item was brought forward by Mayor Pro Tem Gracey Van Der Mark, who was joined by Mayor Tony Strickland and Councilmen Casey McKeon and Pat Burns as yes votes. Councilmembers Dan Kalmick, Natalie Moser and Rhonda Bolton were the no votes.

Restaurant owners have until March 1 to remove the expanded dining operations from the street, and parking meters will be re-introduced for the second block as well.

Van Der Mark acknowledged that things could change again. Long-term plans to revitalize downtown and Main Street are in the works, though they were paused by the council at its last

meeting on Dec. 20 until more feedback could be received.

For the time being, however, the restaurants and retail shops will have to get out of the street and make way for the cars.

"Gracey stuck her neck out and walked every single business the last few weeks to talk with them, reach out to them, leave

## Officers arrest suspect in H.B. shooting

Investigators suspect a Norwalk man arrested on Tuesday may have been responsible for a shooting in Huntington Beach that left one person wounded earlier that day.

Scott Lucas Catalano, 30, was taken into custody at about 7 p.m. Tuesday, seven hours after gunfire on the 15000 block of Huntington Village Lane sent one person to a hospital, Huntington Beach police said in a news release Wednesday.

Officers found Catalano in his vehicle in Bellflower and took him into custody. He was booked in the Huntington Beach jail on suspicion of attempted murder, assault with a firearm and resisting arrest, according to online records.

Catalano and the man who was shot were known to each other, but authorities did not go into the detail about the nature of their relationship. Further information about the shooting and updates on the condition of the victim were not immediately released.

## OCMA to close for art rotation, finishing touches

For the first time since its Oct. 8 grand opening, the Orange County Museum of Art will temporarily close to visitors next week through Feb. 14, as staff rotate exhibitions and contractors complete finishing touches on the \$94-million building.

OCMA Chief Executive Heidi Zuckerman said crews would begin moving out works from the inaugural multimedia works featured on opening day, which have been seen by as many as 85,000 visitors from all 50 states, Puerto Rico and 20 countries.

Shows are typically staggered, but the change-up will be bigger.

## Min eyes congressional seat in coastal Orange County

State Sen. Dave Min officially tossed his hat into the ring Wednesday for California's 47th Congressional District, joining challengers former Rep. Harley Rouda (D-Laguna Beach) and former state Assemblyman Scott Baugh in 2024.

The district, which after redistricting in 2020 now includes Irvine, Huntington Beach, Costa Mesa, Newport Beach and Laguna Beach, is represented by Rep. Katie Porter (D-Irvine), who recently secured her third term in the 2022 election. Porter beat Baugh with 51.7% of the votes, according to data reported by the Orange County Registrar of Voters' Office.

Porter earlier this month announced she is seeking Sen. Dianne Feinstein's seat. Feinstein, who at 89 is the oldest sitting

senator, is not expected to run for reelection but has previously stated she intends to serve the remainder of her Senate term.

With Porter stepping out of the next congressional race, Baugh quickly announced his 2024 bid

for the 47th District, along with former Rep. Harley Rouda.

Min currently represents the 37th state Senate District, which includes much of those same cities

## Newport Coast property on 'trophy lot' sells for \$30.6M

In what is so far the most expensive real estate sale of 2023 in Orange County, an undisclosed buyer has purchased an estate in Newport Coast for \$30.6 million in a transaction that closed Jan. 4.

The property, located at 1 Pelican Crest Drive, sits on a 31,651-square-foot lot behind gates. It features seven bedrooms, eight full bathrooms, three half bathrooms, a chef's kitchen, dual offices, a main floor guest suite, a foyer, a private gated circular motor court, a 13-seat movie theater, wine cellar, entertainment bar and lounge, dance studio, gym and massage room in addition to other amenities like its "resort-style" pool, elevator and a seven-car garage.

It also features details like onyx slab flooring and

Cristalo slab counter tops. At three stories high, the home encompasses 13,437 square feet.

Most notable are the property's expansive views, which stretch to San Clemente Island, Catalina Island and Palos Verdes, according to listing agent Paul Daftarian with Luxe

Real Estate, who held the listing alongside agents Michael Balliet and Jenn Chen. Compass agents Rob Smith and Michael Franco represented the buyer. Compass declined to comment on the sale.

"The view, I can't tell you

# BEAR JOINS LAGUNA BEACH POLICE AS LATEST K-9 UNIT

The Laguna Beach Police Department has a new member in its K-9 unit, as officials announced the addition of Bear, a 52-pound, 2½-year-old Belgian Malinois, to the department's ranks on Tuesday.

Police Cpl. Priscilla Angeloni will serve as Bear's K-9 handler. The partners were introduced to each other last week.

After the completion of a six-week training program, Bear will join Rudy, also a Belgian Malinois, on Laguna Beach's police force, allowing the department to have a K-9 unit on patrol seven days a week. Authorities said it will mark

the first time the department has had two K-9 teams within its ranks simultaneously.

The training, which will take place at Adlerhorst International in Jurupa Valley, focuses on drug detection, locating wanted or missing persons, and the apprehension of uncooperative suspects who pose a threat to the public.

"Corporal Angeloni and K-9 Bear are a fantastic match and have already bonded as partners," Laguna Beach Police Chief Jeff Calvert said in a statement. "They will make an excellent addition to the K-9 program, and coupled with Cpl. McGuire and his partner K-9 Rudy, these two teams

will be an added layer of protection to the Laguna Beach community."

Angeloni, who joined the Laguna Beach Police Department in 2016, graduated from Cal Baptist University with master's degrees in forensic and clinical psychology. She currently serves as a field training officer and drug recognition expert instructor.

Calvert has referred to the department's K-9 teams as a force multiplier for the law enforcement agency and for the community's safety. The department lost K-9 Ranger to cancer in 2021.

this time around since the museum opened with five exhibitions. Some of what's been featured will stay a little longer, while others will undergo a rotation of works to showcase different pieces within the same collection.

Zuckerman said Wednesday the closure will also allow for the completion of

some smaller building projects that weren't 100% done when OCMA opened in October, a subject that has drawn jeers from some in architectural circles.


"The building when we opened was more than 99% finished. And I guess the less than 1% may have been emphasized somehow, but it was never anything significant, and it never impacted visitors' experiences," she added, describing

ing veneer fixes and realignments complicated by supply chain delays.

"We are definitely using [this time] as an opportunity to do some finishing touches."

Work crews had accomplished some of the smaller tasks during Mondays, the one day each week the museum is closed to the public, but leaders are hopeful all the work will be fully done by the time OCMA re-

opens in February.

Meanwhile, the change-out of the art will make room for new exhibitions coming to the museum after it reopens its doors on Valentine's Day, including a solo show by Daniel Arsham, "Wherever You Go There You Are," which explores the artist's concept of fictional archeology through sculpture, architecture, drawing and photography.

Museum staff will also be rotating works within the exhibition "13 Women" which debuted on opening day as a tribute to the founders of the Balboa Pavilion Gallery, OCMA's earliest iteration, more than 60 years earlier. Pieces in "13 Women, Variation II" will run through Aug. 20.

In June, OCMA will debut "Feels Like Home" — a collection of works from painter Alice Neel including intimate portraits of the artist's home, children, animals and extended family of friends — and "A Guest, A Host, A Ghost," a sculptural and installation-based works by Chinese artist Yu Ji that reflect on the relationship between the body and its environment.

Zuckerman said while some of the unfinished work on the building may have been visible, OCMA leaders made the decision to move forward with the Oct. 8 grand opening in the spirit of making art accessible to more viewers.

"My personal mission is to connect people to art and artists and make their lives better," she said Wednesday. "It's not that I didn't care the building wasn't done when we opened, that's just what's most important to me."

"To the average visitor, the building looks perfect, and it's such an incredible gift to be free for the first 10 years," Zuckerman added. "People are just delighting in the museum — it's supremely contagious."





enough. A view is normally beautiful and it makes you feel good, but the views from this house make you emotional," Daftarian said Thursday. "You can see all the rolling hills of the golf course [of Pelican Hill Resort], the actual coastline ... it's three or four views in one."

The property had been listed for close to a year, initially priced at \$45 million.

"We strategically priced [this property] on the higher side. It's a trophy lot and probably is one of the best single lots. It's one lot, oversized, ... has some of the most breathtaking views, but we knew we had to price it high to make the buyer feel like they were getting a good deal," Daftarian said. "We had no idea we were heading into a transition market with interest rates doubling and buyer sentiment changing."

"Recession wasn't even a word we thought of when we listed the property. It was like when you're going to the beach, expecting it to be sunny and then it's stormy. Stormy isn't bad, but you're used to the sunshine."

Of the pie-shaped lot, Daftarian noted that it was uniquely situated to be extremely private. From either the yard or the house

itself, neighbors can't be heard, he said.

"People who want to buy a home of this caliber, they want the best," Daftarian added, noting that the gross cost of the sale, which included some of its furniture, was around \$33.9 million — the highest gross on-market sale in Pelican Crest.

According to Zillow, other properties in that neighborhood were valued from \$8.1 million to \$19.4 million. Realtor.com reports houses sold in Newport Coast tend to average \$5 million for a listing price, with the aver-

age sale closing at around \$3.3 million.

Still, 1 Pelican Crest Drive is a far cry from one of the most expensive properties being sold in Newport Coast. Another property at 46 Deep Sea, whose listing is still active, was listed at \$62 million, and 6 Midsummer, also still active, is listed at \$69.8 million. The all-time price record in Orange County was set in Newport Coast with the sale of a \$61-million mansion in 2020.

along with Laguna Woods, Lake Forest, Orange, Tustin and Villa Park. Min was elected in 2020 over former state Sen. John Moorlach.

In his announcement for his seat, Min said, "I began my career holding

Wall Street accountable during the financial crisis and protecting families from foreclosure.

"In the state Senate, I have fought for bold and aggressive legislation to improve the lives of the constituents I represent, challenging politics as usual. I'm proud of the record I've built on the environment, gun violence prevention, women's reproductive rights, the economy and fighting hate, and I look forward to making the case to voters why they should elect me to the House of Representatives."


