Newport Harbor staying strong in the face of a player's unexpected loss

Newport Harbor High senior Parker Chavez was umpiring a youth baseball game when he got the life-changing news.

This was a normal way for Parker to spend his weekends. It appeared to be a typical Saturday in late February.

Then, it wasn't. Not by a long shot.

His uncle texted Parker and told him that he needed help fixing his truck. When he got faceto-face with his nephew, he delivered the reality in much more devastating words.

Parker's father, Paul Chavez, had died while on vacation in Cabo San Lucas, Mexico. He was just 43 years old.

"It's still an actual nightmare that none of us are going to wake up from," said Taryn Chavez, Paul's wife and mother to Parker

and his younger sister, Teagan. Nearly a month later, Parker is in the middle of his senior season with the Sailors baseball team. The squad is looking impressive. Newport Harbor beat rival Corona del Mar 1-0 on Wednesday for the second time in as many days, improving to 6-1 overall and 2-0 in the Sunset League.

The Sailors go for the Battle of the Bay series sweep on Friday at their home field. Parker, who typically plays first base, will be behind the dish at catcher as last year's No. 1 pitcher, fellow senior Lucas Perez, takes the mound.

On the diamond is where the team is supposed to be on most days. But on Sunday, Parker's teammates found themselves at a different kind of park, Marina Park in Newport Beach, for Paul Chavez's celebration of life.

Every single player was there to support Parker. They brought flowers for Taryn and shared upbeat stories. Paul had coached some of them when they were

younger, coming up through the Newport Harbor Baseball Assn. "It's definitely one of the coolest brotherhoods I've ever witnessed," Taryn Chavez said. "Without them, I don't think

Costa Mesa plan for housing lines up

Officials have eyed the 2.66-acre parking lot for senior housing since the Costa Mesa Senior Center opened in 1992.

Officials this week unanimously supported granting entitlements for a 70-unit affordable senior housing complex on the parking lot of the city-owned Costa Mesa Senior Center, a project that would be overseen by a nonprofit housing developer.

It's a proposal that's been wending its way through City Hall for the past several years, but a vision that's been in the pipeline since 2008, when city leaders first identified a portion of the 2.66-acre parcel, located at 695 W. 19th St., as an ideal place to house people 55 and up.

Not only would residents of the complex be able to access programs and services at the center, but they would be in close proximity to transit hubs that could help get them to nearby shopping and amenities.

For those reasons and more, the site has been eyed for potential senior housing since the center opened its doors in 1992 and

Newport Harbor team sweeps Battle of the Bay

A swimmer can compete in two individual events and two relays in a high school dual meet, allowing for a considerable amount of points to be earned.

Still, it takes a big team effort to get past the 85point mark and clinch the

Newport Harbor used its depth to sweep the Battle of the Bay meet at rival Corona del Mar on Tuesday afternoon. The Sailors girls won, 95-75, while the boys were victorious by a 99-71 score.

Newport Harbor, which beat Edison last week to open Sunset League competition, improved to 2-0 in league in both genders.

The Sailors girls won just one individual event and one relay against CdM (1-2 in league), but that 200vard freestyle relay win helped shift the momentum in the middle of the meet. Newport Harbor's "A" team was disqualified as a swimmer left the blocks early, but the depth shined through.

The Newport Harbor "B" team of Sophia Verdugo, Kennedy Fahey, Italia Molina and Harper Price still ended up winning the race. And the Sailors' "C" team of Addison Ting, Sadie Ricks, Kylie Robison and Malia Cottriel touched sec-

Despite the disqualifica-Newport Harbor gained 10 points from the event, took a 12-point lead and did not look back.

"When one of our teammates is down, you just have to step up and come together as a team," said Price, one of two Newport girls' water polo seniors out for swimming along with Caitlin Stayt. "You can push through the hard times and work really hard and be consistent in practice. Something like that [DQ] can happen, and if you all come together you can still succeed and do great."

Stayt finished second in both the 200 individual medley and 100 backstroke. Sailors senior Ariana Amoroso, a talented club swimmer committed to Cal Poly San Luis Obispo, won the backstroke in a minute flat and was second in the 50 free.

Molina and Ricks — both freshmen — and sopho-more Madison Mack all earned top three finishes in both of their individual events to help guide the Sailors to victory.

CdM's three girls' club swimmers, seniors Alex Milisavljevic and Nikki Lahey and sophomore Sofia Szymanowski, were all double event winners. Milisavljevic won the 200 and 500 freestyle, Lahey the 50 and 100 free and Szymanowski the individual medley and 100 breaststroke.

Milisavljevic, bound for the University of Chicago, won the 500 free in 5:10.66 but said she'd like to be sub-five minutes by the end of the season. She's accomplished that twice in club swimming, but never in high school.

"It's always fun compet-

ing against Harbor,' she said. "The rivalry's fun. definitely depth. It's kind of hard, we have to be really strategic about who's swimming what, especially since we only have three girls' club swimmers. The senior water polo girls are stepping up a lot this season with the relays and stuff, which we appreciate."

A water polo senior, Didi Evans, won the girls' butterfly event for the hosts.

On the boys' side, Newport Harbor used double event wins by senior club swimmer Aidan Arie and junior boys' water polo player Connor Ohl to come out on top.

Arie won the 200 freestyle (1:44.35) and IM (1:57.09), while Ohl captured the 50 and 100 free in quick times of 20.91 and 47.10.

Arie has always enjoyed the teamwork between club swimmers and water polo players. He grinned as Newport Harbor freshman Mateo Micheloni-Creazzo had a big celebration after touching first to win the open boys' 400 free relay.

"You don't really get that

with swim kids, just water polo kids," Arie said. "It's so fun ... The swimmers just think about their times, and he was just thinking about winning.

Ohl said he never went under 21 seconds last year in the 50 free without a technical suit on, so he's already ahead of that pace this season. The Sailors swept the top three spots in the 50 free, with Ohl, Dash D'Ambrosia and James Mulvey. All three are water polo players.

"It's amazing," Ohl said. "It just shows the pure power and strength of water polo players. We can do everything. We can play water polo and we can swim

Mulvey won the butterfly event for the Sailors, with Tyler Jameson capturing the 500 free.

CdM out-touched Newport Harbor to win the medley relay, though the Sailors won both freestyle relays. The Sea Kings (0-3 in league) also got individual event wins from Henry Chang in the backstroke, and Will Weir in the breaststroke.

has been included in various iterations of the housing element section of Costa Mesa's general plan since 2008.

But only now, with Irvine developer Jamboree Housing Corp. at the helm and the funding commitments coming in, is the plan becoming shovel ready. It's estimated that construction could start in November and wrap by September 2027.

Members of the Costa Mesa City Council approved Tuesday, in a 7-0 vote, splitting the Senior Center lot into two separate parcels and a master plan update recognizing the project's eligibility for a density bonus under state affordable housing laws.

The vote also sanctioned a disposition and development agreement, along with an affordable housing agreement and an annual ground lease of \$1 for the next 99 years. The city would also defer \$700,000 in impact and development fees and provide another \$1.5 million in federal housing-related funding now, allowing Jamboree to pay those back as loans.

City Atty. Kimberly Hall Barlow explained why the city opted for a ground lease, as opposed to selling the property to a private developer who would build out the project to the

city's specifications. "It's not really surplus

land — it's the land the city has targeted for decades to be developed specifically for this purpose," she said. "With this long term and a qualified, quality developer like Jamboree, it gives us the option in 100 years, when none of us are here anymore, to have the city take over the project if it becomes necessary."

Jamboree's plan specifies about half the units would be for seniors earning less than 60% of Orange County's average median income, roughly calculated at \$88,400, while the remainder would be for very-low and extremely low-income seniors and those at risk of homeless-

Under a contracted provider, residents could receive case management, mental health counseling, food assistance and en-

richment activities While a few citizens at Tuesday's hearing shared concerns about the inconvenience of 22 months of construction activity for seniors at the center, a reduction in parking or even too many parking spaces at the site, affordable housing advocates spoke on the need for more living options for seniors.

Former Costa Mesa mayor and now County Supervisor Katrina Foley addressed the council, recalling her early support for including the site in the city's housing element and reaffirming the county's investment of \$13.5 million in funding and vouchers toward the project.

"I voted on having this site be housing at the Senior Center, and 17 years later here we are," Foley said, sharing that seniors considered to be extremely low income only earn about \$33,150 annu-

"These are people who are in our community, they've invested and they want to stay local, but they cannot afford to live here, so let's get seniors into the Senior Center housing development. I know the community will be grateful.'

Council members roundly approved moving plans forward, acknowledging the many years of outreach, analysis and refinement the proposal

underwent. "This project centers seniors in the middle of our community, where they're going to continue to have opportunities to continue to be involved in our community," said Councilwoman Arlis Reynolds. "We've done a lot of tweaking, but every tweak has made it a little bit bet-

City Manager Lori Ann Farrell Harrison agreed.

'I'm just really proud of all the work that we've all done here collectively this thing has been in the housing element since 2008 and we got it done," she said. "It's been a push to get us here, and this is a fantastic moment."

CdM's Douglass wins Eric Hulst race in Laguna Trophy Invite

BY ANDREW TURNER

After a breakthrough cross-country season, Corona del Mar senior Max Douglass says he is running straight into the unknown, finding out with everyone else what he is capable of as he continues his ascent.

Douglass laid waste to his prior personal-best time in the 3,200 meters on Saturday, when he dropped below nine minutes for the first time in winning the Eric Hulst Invitational, the featured race in the Laguna Beach Trophy Invitational.

The Sea Kings' star distance runner raced to the finish line, flexing his muscle and shouting in celebration after clocking in at 8 minutes 59.28 seconds. The race produced the fastest two times in the state so far this season. Trabuco Hills senior Dylan Jubak completed the eight laps in 9:06.09 to take second place.

"This was a mystery race for me because I've never been in this kind of shape said Douglass, before," whose time is currently third in the nation. "The two-mile [event], I haven't had too much experience running it. I ran it a couple times last season, but I ultimately wanted to focus on the mile.

"I opened up my season with a 4:15 [in the 1,600] and a 1:56 [in the 800 at the Irvine Invitational] on tired legs, so I was looking at this race. My PR was 20 seconds slower than what I ran today from last year."

Corona del Mar coach Bill Sumner said Douglass does everything asked of

He said the impact large public gatherings can have on the nearby economy may not be felt immediately, especially in areas that typically don't draw as many visitors as the pier and Newport Cen-

"Sometimes it is very difficult to understand the connection between an event that you feel takes things away," Blom said. "... I do think sometimes it's nice to remind people of districts in our city that still exist. And I think that sometimes is part of the crux of being all the way down the peninsula."

[Parker] maybe would be as strong. They are really special kids, and parents. That goes hand in hand. They're such good kids, because their parents are such good people."

A few weeks before the ceremony, Sailors coach Josh Lee called Parker's teammates in on a Sunday. It was Feb. 23, the day after Paul Chavez died, and the team was just one game into the season. The players and coaches discussed how to be there for their teammate and friend.

It reminded Lee, a bit eerily, of when Orange Coast College baseball catcher Jordan Watanabe died at age 20 in 2009. Lee, who was playing baseball at OCC at the time, was called to a special Sunday team meeting by late longtime Pirates coach John Altobelli.

The Pirates went on to win their fourth state championship.


"Even though we won that year, the most important thing was life and brotherhood and family and loving each other," Lee said. "I remember as a teenager, probably only 6 months older than Parker at the time, how impactful that was for me."

Lee said last month's meeting with his own Sailors players weighed heavily on him

on him.

Altobelli, along with his wife and daughter, lost his own life in the 2020 helicopter crash that also killed basketball superstar Kobe Bryant, his daughter Gianna and four other people.

"I wanted to make 'Alto' proud with how we can frame to teenagers how important love and support is

right now," Lee said. "I was very lucky to have someone like him in my life, and I hope that all of us as coaches and players can be that level of support for Parker as he goes through something even more traumatic than losing a teammate, losing his father and his best friend."

Paul Chavez and his own father, who was recently diagnosed with cancer, have been regulars at the Sailors baseball field. Taryn said she still isn't sure exactly what happened to her husband.

Taryn, Paul and a large group of friends were in Cabo San Lucas to celebrate Taryn's 40th birthday. Paul was getting over a cold and had a lingering cough, but his condition deteriorated on the vacation.

Taryn said she woke up the day after her birthday to Paul saying, "I can't breathe." He ended up passing away at the Nobu Hotel. Though the autopsy said he died of a heart attack, she isn't sure.

"To me, it just seemed like whatever virus he got, his throat closed and he suffocated," Taryn Chavez said. "He died in my arms. It was really traumatizing."

Support has come in other forms, too. A Go-FundMe for the Chavez family started by a friend has raised more than \$130,000.

Taryn, a Newport Harbor alumna herself who owns a local dance studio, said that Parker has handled the situation exceptionally well, almost seamlessly stepping into that role of man of the house.

"[My dad] really taught me a lot of things throughout my life," Parker Chavez said. "It's a role that I had prepared to take on 20 or 30 years from now, and I'm taking it on now. I'm glad he taught me those lessons very early, because now I have to apply them, and I can apply them very well to stay strong for both my mother and my sister."

The team has dedicated its season to Paul Chavez and has been coming up clutch. Five of the Sailors' six victories have been by a single run.

Over the last few weeks it's been different, though. He said the Sailors have never been closer.

They no longer see one of their biggest fans at the ballpark, but they still feel Paul Chavez's spirit.

"It's very good to have my teammates here," Parker Chavez said. "I think we've got a great thing going." Taryn, suddenly cast into

a role of a single mom of two teenagers, would agree. She feels the love.

"They've always had a great friendship, but it's definitely on another level," she said. "It just feels like they're doing it for Paul. It's pretty cool to watch, and be a part of."
