County officials support fentanyl bills

Pending state legislation would boost penalties for dealers, demand accountability from online platforms.

Orange County lawmakers and people close to victims of an ongoing opioid epidemic rallied Friday behind two bills in the California state Assembly that would increase jail time for people convicted of selling fentanyl and require proprietors of social media platforms to retain records that might enable authorities to track dealers down

Assembly Bill 955 would raise the penalty for the possession of fentanyl for sale from between two to four years in jail to a threeto nine-year sentence. AB 1027 would require social media companies that wind up facilitating untraceable marketplaces for illicit drugs to keep records of communications on their platforms that would be accessible to law enforcement investigating drug dealers.

"The reality is that dealers don't need to lurk in dark street corners or remote parking lots. Now they are connecting with our kids on platforms like Snapchat, Instagram, Facebook and WhatsApp," Assemblywom-an Cottie Petrie-Norris said during a news conference Friday.

Both proposed bills were introduced by Petrie-Norris and brought up for discussion by assembly committees Thursday. An altered version of AB1027 was pushed forward to another round of debate. If it proceeds past that point, it may be brought to the

Assembly floor for a vote. AB 955 was held back for further review. Petrie-Norris said she was "disappointed by the outcome of those hearings.

She was joined Friday by friends of young people who died as a result of fentanyl poisoning and Orange County Dist. Atty. Todd Spitzer, Supervisor Katrina Foley and representatives of

Mallard, shot by arrow, gets second chance at life

A lucky duck waddled into the water at TeWinkle Park in Costa Mesa on Friday afternoon.

The mallard in question had been shot with a mini-crossbow gun, police said, and had a dart arrow lodged in its neck that protruded from its cheek.

But after a just more than a month of rehabilitation at the Wetlands & Wildlife Care Center in Huntington Beach and two surgeries, the drake was ready to take flight again.

"He healed pretty fast," said Debbie McGuire, executive director of the Wetlands & Wildlife Care Center. "I think it was still fresh. The longer they're out there when they're injured, the more debilitated they get. He had an infection, but it wasn't a raging infection ... He was really lucky that it didn't hit any vital tissue because he would not have made it."

The mallard was first observed near a lake in Newport Beach on March 25 but was still able to fly at that time and escaped capture. It was found the next day at Kaiser Elementary School in Costa Mesa and taken into the

Michelle Saldana, a veterinary technician at the Wetlands & Wildlife Center, was on duty when the mallard came in.

"Even in recovery he was very calm, very good eating habits the whole time," Saldana said. "We just feel really happy that he's out here now.'

The investigation into the crime is still ongoing, Newport Beach Police Department Animal Control Officer Nick Ott said, adding that NBPD is the lead agency investigating.

Tritons pass first CIF test at Bolsa Grande

GARDEN GROVE - Pacifica Christian Orange County lacked a little of its usual power heading into its CIF Southern Section bovs' volleyball playoff opener Thursday evening. It hardly slowed the Tritons down.

Matthew Macpherson, forced by an ailing shoulder to alter his approach, winningly emphasized other aspects of his game as opposite Christian Hahne and fellow outside hitter Hudson Reynolds took command at the net in a straight-sets Division 3 victory at Bolsa Grande.

It didn't come easy the Garden Grove League champions provided a real fight in the first set and dominated much of the second — but the 25-22, 27-25, 25-19 triumph and the toil it required provided Pacifica Christian added determination heading into its secondround showdown, on Saturday evening, against topranked St. Margaret's, last year's Division 4 titlist.

"That absolutely helps the confidence," Pacifica Christian coach Evan Fredericks said. "St. Margaret's is a good team. They're definitely going to give us a run for the money. The good news is we have home-court advantage, so we're excited to face them on our court."

Pacifica Christian (20-4) will need more than it showed Thursday. The Tritons labored with their passing and were inconsistent at times with their service, which helped Bolsa Grande (16-11), like Pacifica Christian a Division 4 quarterfinalist a year ago, build a six-point lead midway through the second set — and reach set point before faltering.

Pacifica Ultimately,

Christian's advantages in height, experience and quality — were too pronounced, and several big performances, Hahne's most of all, carried it past the first round for the third successive season.

Macpherson, the Tritons' captain, provided a foundation. His right shoulder had been bothering him all week, so he aimed to rely on his "backrow skills and ... blocking" while "trying to shoot a little bit more and take it easy, but still try to get kills for the team." He ended up with 13, most on deft placements.

Macpherson's subtlety at the net contrasted with Reynolds' ferocity on the left and Hahne's wherewithal on the right, among other spots. Reynolds, a sophomore, also had 13 kills, plus six blocks, and Hahne worked through some rough stretches to play galvanizing roles all three sets, dominating pivotal sequences in each. The senior left-hander led Pacifica Christian with 14 kills, half of those in the last set as the Tritons romped to a 7-2 lead and pulled away after a brief Bolsa Grande push; he punished the Matadors in duels at the net, with cross-court shots and with lunges to turn errant or opportunistic balls into points.

"Hudson was amazing,"

Fredericks said. "If we gave him the ball, he was going to put it away. ... And when Christian plays his game, nobody can keep up with

Hahne gave Pacifica Christian command of the first set with a searing fourserve sequence, three aces and a fourth delivery the Matadors batted about unsuccessfully, and had three kills in a six-play stretch, two on tips, as the Tritons surged ahead through a 13-4 run.

When Bolsa Grande replied with four straight points, for a 25-24 lead, senior middle blocker Brendon Booth stepped up, finishing a Callen Bray set to stave off set point, then blocking Minh Le to restore the lead. Pacifica Christian prevailed when the Matadors hit wide of the antenna.

Bolsa Grande's grit kept it close most of the way, and outside hitter Brayden Huynh's resourcefulness caused havoc. He teamed with junior setter Andy Vo and finished with 11 kills.

"At least it was a close 3-0," Matadors head coach Rebecca Wagner said. "I was very proud of them to keep it that close. If it's 25-16, 25-15, it's, 'Oh, they crushed you.' I'm happy they got to 20s, and that second game was really close.

"We are the Garden Grove League. We under-

stand we're not the tops, but we still surprise some people, and they tried their best."

St. Margaret's (27-5), which swept Downey, will be a far fiercer challenge.

"We have to have a nearperfect game [to beat them]," Fredericks said. "We have to have a game where we stay up the whole time, we don't get down on ourselves, we don't dig ourselves a hole like we did in the second set. It will be a battle, and we'll have to battle for every point, but if we're able to band together and stay above, we'll be OK."

Barons victorious in first playoff match since 2013

IRVINE — The Fountain Valley High boys' volleyball program is enjoying the type of season it has not had in a decade, and for her part, Barons coach Rebecca Cheltenham wants her team to soak it all in.

After earning a straightsets win in their first CIF Southern Section playoff match since 2013 on Thursday, the Barons heard from Cheltenham that she wants to see her team show how much it wants to win.

from Coming vaunted Sunset Conference, which saw four teams qualify for the Division 1 playoffs, the Barons were tasked with creating their own energy, something they may have to continue doing until the stage gets bigger.

Fountain Valley cruised to a 25-20, 25-22, 25-20 sweep of host Portola in the first round of the Division 3 playoffs, led by 16 kills off the right hand of outside hitter Curtis Harp-

The Barons will play host to Marmonte League champion Newbury Park (22-12-1) on Saturday at 2:30 p.m. in the second round.

"If we're all on and we can keep our serves in and play our game, what I think we're capable of is actually winning this thing," Cheltenham, the

first-year coach of the Barons, said. "It's just one team at a time, one point at a time, one set at a time. Just kind of keeping that mindset, it's really just focusing on one team.'

Harper provided the setclinching kills in each of the first two sets. He said there's reason to believe this year because the Barons are working toward the same goal.

"I think this year, we just got a solid team that's been together, and we have a lot of chemistry together," Harper said. "As a whole, we all want the same thing, and none of us are slack-

Fountain Valley (21-6), the second-place team in the Wave League, could be set up to make a run in the section playoffs. There is a success story to follow for teams that have come out of the Wave League since the Sunset Conference was split into two four-team divisions.

In a similar situation, Marina went on to win the Division 4 title in 2021 after qualifying as the secondplace team out of the Wave League.

Opposite Joseph Nguyen had 11 kills for Fountain Outside hitter Thomas Ho pounded out nine kills, and middle blocker Colin Harper had four kills and two blocks. Jovanni Dang distributed

Noah Luper stood out



for North Hills League champion Portola (14-17), a school that was founded in 2016. The Bulldogs' setter had 25 assists and seven kills, effectively running the middle with Neo Er-

landsson (14 kills).

"We made the adjustment right away on the setter, just calling out where he was, knowing that he was front row, what he liked to do, tip that ball

over," Cheltenham said. "We started to make that adjustment, which helped, and then we realized that they were setting the middle pretty much every ball, especially if he was on one side of the court. I felt we slowed down their middles quite a bit halfway through the second set."

Irvine and Costa Mesa in urging state officials to continue progress in combating a persistent crisis.

"In 2021 in Costa Mesa we had 204 fentanyl poisonings," Costa Mesa Police Chief Ron Lawrence said. "That's an average of 17 a month in my little city. In 2022 we had 171."

"Between 2018 and 2023 our Costa Mesa police seized 283 pounds of fentanyl and 522,000 fentanyl-laced pills," he added.

Speakers at Friday's conference also news championed the distribution of Narcan, a brandname version of the opioid inhibitor naloxone. It is a nasal spray that immediately counters the effect of the drug and helps a person experiencing an overdose to start breathing

noises coming from the

bathroom downstairs. "She went down to see her son, a 22-year-old, making gasping noises and didn't know what was going on," Green said. "She dug through her backpack and gave her son the Narcan, and he is alive today because of that."

Holding back tears, Green added, "This is not somebody else's kid. This is your child, this is my child."

"This is not about an overdose," Costa Mesa Mayor John Stephens said. "This is poisoning by people who are dealing these drugs on social media and murdering our children.'

MacArthur Boulevard onramp to SR-73 closed

The northbound MacArthur Boulevard onramp to the SR-73 will be closed part of this weekend as construction continues on the freeway's bridges.

The closure will begin at midnight Saturday and continue through 5 a.m. Monday.

Caltrans spokesman Nathan Abler said Thursday the closures are because of an ongoing construction project intended to preserve the service lives of 10 bridges along the freeway.

This closure is expected to be in force for 55 hours, which Abler noted was for the safety of the workers while they replace the approach slabs to the bridge. As a detour, Caltrans is rec-

ommending drivers continue on MacArthur Boulevard, turn left onto Jamboree Road, then right onto Bristol Street to reach an onramp to the SR-73.

The SR-73 spans much of southern Orange County and begins in Costa Mesa, off of the 405 Freeway and ends at Interstate 5 in San Juan Capistrano.

There will be electronic changeable message signs to notify drivers of the closure, though work will be subject to potential changes because of traffic incidents, weather, availability of equipment and materials or constructionrelated issues, according to Caltrans officials.
