A chef was appointed to the Huntington Beach City Council Tuesday night, after things reached a boiling point in the pot the council chambers has be-

Celebrity chef Andrew Gruel was unanimously appointed to a seat on the council, taking the seat vacated by Tony Strickland after he won the special election to represent state Senate District 36.

Gruel was sworn in by council member Gracey Van Der Mark.

In his comments after taking his seat, he called Huntington Beach the greatest city in the nation

tion.

"Everything that we do here is obviously emblematic of a movement to be able to focus on local politics, but also represent true American values, family freedom, etc.," said Gruel, 44. "A lot of people probably look at my position and say, what the heck does a chef know about all that stuff?" He explained that cutting waste is inherent to chefs. "That's what I do."

The two-hour meeting did not lack for drama, with police taking

Chloe Sathienvantanee lights up whenever her family takes her to the beach, and can't help but dash toward the water. Sometimes that worries her mother, Christina Sathienvantanee.

"We've been to Huntington Beach, and the waves were gigantic," the third-grader's mom said. "...She's a little fearless, so when she sees the water she just runs toward it, not thinking about how big the waves are."

So they were grateful to be among more than 40 Whittier Elementary families to enroll their kids in a pilot for an afterschool swimming and water safety class taught at the Newport-Mesa Family YMCA. It began in January, and now Chloe

# Two enter race for NMUSD seat

A petition garnered enough signatures to override the appointment of Newport Harbor High PTA President.

An occupational therapist and a businesswoman declared themselves candidates in a special election to fill a vacant seat on the Newport-Mesa Unified School District's board of trustees, the Orange County Registrar's office confirmed Monday.

The special election scheduled for June 10 will determine who becomes the NMUSD trustee representing families in Area 5, which covers neighborhoods served by Newport Elementary, Ensign Intermediate and Newport Harbor High. The term for that position ends in December 2026, and it became vacant after former school board member Michelle Barto won her bid for a seat on the Newport Beach City Council in November.

In January, the board voted 4-2 to appoint Newport Harbor High Parent Teacher Assn. President

### Nicklaus delights crowd in return to Newport

PGA great Jack Nicklaus was the guest of honor for the Hoag Classic's Breakfast with a Champion.

Jack Nicklaus may have competed just once on the senior circuit in Newport Beach, but the golf great received a reception fit for a royal as the star attraction of the Hoag Classic's Breakfast with a Champion.

A ballroom full of people leaned on every word shared by Nicklaus, who spent more than an hour in conversation with Hank Adler, the chairman emeritus of the Hoag Classic, on Tuesday morning at the Balboa Bay Resort.

Their talk, while eventually getting around to golf, strayed off the beaten path. Nicklaus, who combined longevity and talent to win a record 18 major championships over a span of 25 years on the PGA Tour, has been celebrated as a family man, golf course designer and philanthropist.



### Proprietor and patriarch of Newport Rib Co., lived 'Big'

Francis Albert Ursini wasn't particularly large in stature, but everyone who knew and loved the longtime Newport Beach resident and original proprietor of Costa Mesa's familyowned Newport Rib Co. called him Big Fran, or sometimes just Big.

That was just the way he lived, says eldest son John Ursini who, like other members of the close-knit Italian family, started working alongside the family patriarch as a youth and now puts in full-time hours at the Harbor Boulevard restaurant, which turned 40 last September.

Whether tossing out drunken roustabouts who came around after bar sessions, or guarding the Kiwanis' fireworks stand overnight each July 3 with a baseball bat in hand, serving as a CIF football referee for more than 50 years or restricting excess napkin usage at the annual AYSO Pancake Breakfast, his modest 5-foot-5-inch physical frame belied the enormity of his social stature.

"As small as he was, he acted big," his son recalled Wednesday. "People would say, 'Don't mess with Big.'"

Last Friday, while recovering at Hoag Hospital from emergency surgery to repair an aortic dissection and seeming to be on the

mend, the elder Ursini's heart simply stopped, his son reported Wednesday. He was 86.

Since then, family members' phones have been ringing off the hook as friends and associates from Big Fran's many intersecting social circles call to offer condolences or share memories.

"'One of a kind' is something that's coming up a lot in phone calls," said John Ursini, the eldest of three children Fran had with wife Karen, whom he met in junior high and married in

"My dad, he ran his own show — he was his own guy. He just operated from such an old-school simplicity, I guess.'

Born on May 21, 1938 in Chicago, Fran Ursini lived and worked in Illinois before moving to Costa Mesa with Karen and a young John in 1965 to escape harsh Midwest winters and to be nearer with his parents, who'd previously moved to Southern California.

When his father, Nick Ursini, purchased the Surfer, a hamburger stand at the corner of 22nd Street and West Oceanfront in Newport Beach, he took a job there and ran the place from 1965 to 1978, offering work to local youth and his own children.

"He quietly and unas-

sumingly loved hiring kids," John Ursini said, recalling his father both at work and in volunteer roles with youth sports organizations and the Kiwanis Club.

He would go on to run other local businesses, including Hadley's (which is now Pipeline, run by daughter Laura and son-inlaw Jerry), a roller skate rental shop, a Togo's, Pizza Station, the Sub Station and the Patio Cafe.

But in the 1980s, after crossing paths with an old friend with whom he used to sell Johnson's Wax, Fran Ursini partnered with fellow entrepreneur Rich Penjoyan in 1984 to open the business that would become a beloved institution — the Newport Rib Co.

Originally located on Newport Boulevard, the restaurant was joined in 1992 by the Naples Rib Co. in Long Beach. Seven years later, the flagship restaurant moved to its current location at 2196 Harbor Blvd. in Costa Mesa, where it went on to support numerous organizations philanthropically.

John Ursini said the business, and the life his father built around it, represented the realization of a dream to live and work with loved ones and give back to the community members who, through their patron-

A giant in the game, the 85-year-old's family has reached those proportions. Nicklaus and his wife, Barbara, will have been married for 65 years in July. They have five children, 24 grandchildren and seven great- grandchildren.

Nicklaus has received the Presidential Medal of Freedom, the Congressional Gold Medal and the Lincoln Medal. He reflected on an honor bestowed upon him by his alma mater, when he "dotted the i" in the Ohio State marching band's halftime show.

"They honor somebody every game, and it's usually one of their members," said Nicklaus, who mentioned Bob Hope among those outside the band who had served in the role. "... It was a great honor to be there. Now, I've been out in front of a gallery of 25- to 30,000 people, but that gallery was 106,000. I kept walking out there ... to be honored, and I just said [to myself], 'Please don't trip over that white line."

Jack and Barbara, both of whom attended Ohio State, helped launch 100% TBD-BITL, an initiative to provide scholarships for members of the band. "We're very proud of that," Nicklaus said. "Every

standing member of the Ohio State University band is on scholarship." The couple decided long ago that if they were ever in

they wanted to be able to benefit the lives of children. The Nicklaus Children's Health Care Foundation has raised more than \$200

million since it was established in 2004, providing for pediatric healthcare services in South Florida. Miami Children's Hospital has been rebranded Nicklaus Children's; it has treated children from every state and more than 120 countries.

Nicklaus' father, Charlie, was a three-sport athlete in baseball, basketball and football at Ohio State. In his youth, Nicklaus also tried a wide variety of sports. As Nicklaus was consid-

ering what sport to stick with, he got a vote of confidence from Woody Hayes, the Buckeyes' legendary football coach. Hayes walked into Charlie's drugstore as a customer when the latter fielded his opinion on the matter.

"[Hayes] says, 'Your son's a good athlete, but he's got a sport he does pretty well at," Nicklaus recalled. "He said, 'You keep him as far away from my sport as you can.'

Whatever passion Nicklaus pursued, he followed through on it. Golf had its

merits for a young boy that wanted to control how far he could go.

"I'm a decent baseball player, but I couldn't go to the park and wait for 15 kids to come on a hot summer day when I can get up in the morning, go to the golf course at seven o'clock...and come home at dark and play all day long," Nicklaus said. "The other kids, half of them never showed up anyway. I finally figured out that whatever I wanted to do, it was going to be because of my own effort and not because [of] somebody else. That's why, I think, I gravitated to an individual sport."

The walk back in time also included discussion of Nicklaus' friendship with Arnold Palmer, the journey to the top of the major championship leaderboard and his final major title in the 1986 Masters. Nicklaus' six Masters titles remain the most for the tournament, one more than Tiger Woods has earned.

## Arrest made in Huntington Beach shooting Sunday night

An arrest has been made after two people were wounded in a shooting Sunday night at a Huntington Beach apartment complex.

Raul Bustillos of Huntington Beach, 27, was arrested after investigation by the Huntington Beach Police Department Major Crimes Unit and Special Investigations Bureau, Huntington Beach Police Department spokeswoman Jessica Cuchilla said.

According to the HBPD been charged with attempted murder, assault with a firearm on person and driver/owner allowing a discharge from vehicle.

The incident is believed to be gang-related, and detectives are actively investigating the possibility of additional suspects.

The shooting was reported about 8:50 p.m. Sunday in the 7800 block of Mandrell Drive, near Koledo Lane, Cuchilla told City News Service.

Two adult males were arrest log, Bustillos has wounded and taken by ambulance to hospitals treatment, Cuchilla

Kirstin Walsh to fill the position. But a petition garnered enough signatures to override that decision and call a special election.

The Orange County Department of Education and the Registrar's office declined to release a copy of the petition, citing laws protecting the privacy of those who signed it. The identities of the party or parties responsible for filing and circulating the document were also not subject to disclosure via public re-

cords requests. Walsh is one of the two candidates in the race. The other is Andrea McElroy, a businesswoman who had also been considered in January for appointment to the seat, earning votes from Krista Weigand, president of the school board, and board member Lisa Pearson.

McElroy did not immediately respond to requests for comment from the Daily Pilot.

"Our schools also need to focus on fundamentals over Sacramento's culture wars," McElroy wrote in one paragraph of her public campaign statement. "We must limit the indoctrinating efforts of programs like ethnic studies curriculum."

In her statement she did not specify any roles she

may have take on in support of NMUSD, but during her interview with the school board in January for the Area 5 seat, she mentioned having been a volunteer as the parent of a student who had since graduated from the district.

In a March 9 Facebook post announcing her campaign that was visible to her followers, she wrote that families expect "safety, transparency and a strong educational foundation.' Barto as well as Newport Beach Mayor Joe Stapleton and Mayor Pro Tem Lauren Kleiman have endorsed McElrov's bid for a seat on NMUSD's board, according

to her statement. Walsh had not announced any endorsements as of Tuesday. She told the Daily Pilot during an interview Friday that running for public office is a relatively new experience

for her. She had held the Area 5 trustee's seat for about five weeks before the petition ousted her from the board. At that point, Walsh asked district officials if she could simply relinquish her position in order to spare taxpayers the cost of putting on a special election.

"I was torn because I felt I was a really good fit for this," she said. "But if it's going to cost the district half a million dollars, knowing that our kids need that money, no way. That's ridiculous.

But the events that set

NOTICE IS HEREBY GIVEN that on March 25, 2025, the City Council of the City of Laguna Beach adopted Urgency Ordinance No. 1713 titled "AN INTERIM ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LAGUNA BEACH, CALIFORNIA, AMENDING ITS ZONING CODE AND LOCAL COASTAL PROGRAM BY REPEALING AND REPLACING CHAPTER 25.17 OF THE CITY OF LAGUNA BEACH MUNICIPAL CODE REGARDING ACCESSORY DWELLING UNITS AND JUNIOR ACCESSORY DWELLING UNITS TO COMPLY WITH RECENT CHANGES IN STATE LAW WITH CERTAIN MODIFICATIONS; AND FINDING THE ACTION TO BE STATUTORILY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT UNDER SECTION 21080.17 OF THE PUBLIC RESOURCES CODE" on the following 5-0 vote: AYES: Jones, Kempf, Whalen, Orgill, Rounaghi, NOES: None: ABSENT: None, ABSTAIN: None.

Full text of Urgency Ordinance 1713: WHEREAS, the City of Laguna Beach, California ("City") is a municipal corporation, duly organized under the constitution and laws of the State of California; and WHEREAS, the California Coastal Act ("Coastal Act") is a comprehensive scheme governing land use planning for the state's entire coastal zone; and WHEREAS, as part of its enactment, the Legislature made several findings related to the Coastal Act's purpose: (1) the coastal zone "is a distinct and valuable natural resource of vital and enduring interest to all the people"; (2) that "permanent protection of the state's natural and scenic resources is of paramount concern"; (3) that "it is necessary to protect the ecological balance of the coastal zone"; and (4) that "existing developed uses, and future developments that are carefully planned and developed consistent with the policies of [the Coastal Act], are essential to the economic and social well-being of the people of this state...." (Pub. Res. Code §§ 30001(a), (d)); and WHEREAS, the Coastal Act further provides that: "scenic and visual qualities of coastal areas shall be considered and protected as a resource of public importance. Permitted development shall be sited and designed to protect views to and along the ocean and scenic coastal areas, to minimize the alteration of natural land forms, to be visually compatible with the character of surrounding areas, and, where feasible, to restore and enhance visual quality in visually degraded areas.... (Pub. Res. Code § 30251); and WHEREAS, the Coastal Act is "interpreted liberally to accomplish its objectives" and relies heavily on local governments "[t]o achieve maximum responsiveness to local conditions, accountability, and public accessibility. . . . " (Pub. Res. Code § 30004(a); Pub. Res. Code § 30009). The Coastal Act requires local governments to develop local coastal programs ("LCPs"), comprised of a land use plan and implementing ordinances, to promote the Coastal Act's objectives. (Id., see also Pub. Res. Code §§ 30001.5; 30500–30526.) Once the California Coastal Commission certifies a local government's program, the Coastal Commission delegates authority over coastal development permits to the local government. (Pub. Res. Code §§ 30519(a); 30600.5(a)-(c)); and WHEREAS, the City has authority over coastal development permits by virtue of the California Coastal Commission's January 13, 1993 certification of the City's LCP. The Coastal Act allows the Coastal Commission to specify, by regulation, those classes of development which involve a risk of adverse environmental effect and require coastal development permits. (Pub. Res. Code § 30610.) Through its certified LCP, the City has the authority to specify those classes of development which involve a risk of adverse environmental effect and require coastal development permit; and WHEREAS, as recognized by the Coastal Commission, the City's LCP is comprised of a Land Use Plan and an Implementation Plan. The Land Use Plan consists of several planning documents, including, but not limited to, the Coastal Land Use Plan Technical Appendix ("Coastal Technical Appendix") and the General Plan's Land Use and Open Space/Conservation Elements. The LCP's Implementation Plan is comprised of numerous resources, including, among other things, Laguna Beach Municipal Code Title 25 (Zoning Code), Title 22 (Excavation and Grading), and Title 16 (Water Quality)., The documents that collectively comprise the City's certified LCP are publicly accessible on the City's website (linked in footnote 2, below); and WHEREAS, within the Land Use Plan, the Coastal Technical Appendix contains a descriptive text and evaluation of coastal problems and issues; the Land Use and OpenSpace/Conservation Elements set forth actual solutions or responses to these issues in the form of City policies. (Coastal Technical Appendix, at p. 2); and WHEREAS, among other things, the Coastal Technical Appendix addresses the importance of visual and scenic resources. It identifies that the principal focus concerns property situated adjacent to the major transportations system in the City (i.e., Laguna Canyon Road and Pacific Coast Highway) since it is along those roadways that a majority of residents and non-residents view the community and have visual access to scenic corridors. The Coastal Technical Appendix also identifies that the scenic qualities symbolic of Laguna Beach represent one of the community's more valuable resources; the uncluttered hillsides and open space areas offer residents and visitors relief from urbanized and physically confined areas which separate Laguna Beach from development occurring elsewhere in the county. It further identifies that these visual and scenic resources can be protected through design considerations and land use controls. (See Coastal Technical Appendix, at p. 54 ["With proper design considerations and land use controls, the visual impact of new development can be minimized and accomplished in a manner compatible with the natural landscape."]); and WHEREAS, the City's Land Use Element explains that by designing and siting new development to protect natural and environmentally sensitive resources, such as areas of unique scenic quality and public views, to protect visual compatibility with surrounding uses, and to minimize natural landform alternations, the City is implementing Goal 7 to protect, preserve, and enhance the community's natural resources and Goal 10 to ensure that proposals for new development are sufficiently evaluated to protect natural resources. (See Land Use Element Policies 7.3 and 10.2); and WHEREAS, the City's Open Space/Conservation Element recognizes that the "scenic quality of the local landscape remains high today because significant portions of the hillsides and coastline continue to function as natural open space" and "the scenic value of the hillside and coastal areas is especially important because they are so visible to residents and visitors alike." (Open Space/Conservation Element, at pgs. 17, 33). The Open Space/Conservation Element further recognizes that "Inlew development and/or remodels should not be of a scale that would significantly diminish natural open space areas in a manner out of character with existing proportions. The scenic value of even large natural areas can be diminished when its visual continuity is disrupted by "islands" or "peninsulas" of manmade intrusions. (ld., at p. 34.) The Open Space/Conservation Element requires the City to attempt to preserve natural hillside open space in large segments that are visually continuous and physically undisturbed and to evaluate whether new development in a particular area or type of feature is necessary or desirable for open space use and, if so, what type and degree of regulation is practical and feasible. The Open Space/Conservation Element mandates the following policies to protect visual resources: (1) 7-A: Preserve to the maximum extent feasible the quality of public views from hillsides and along the city's shorelines; (2) 7-K: Preserve as much as possible the natural character of the landscape (including coastal bluffs, hillsides, and ridgelines) by requiring proposed development plans to preserve and enhance scenic and conversation values to the maximum extent possible. . . .; and (3) 7-M: New development along Pacific Coast  $Highway shall\ preserve\ existing\ views\ where\ feasible\ and,\ where\ topography\ allows,\ new\ development\ shall\ be\ terraced\ below\ the\ grade\ of\ Pacific\ Coast\ Highway;\ and\ preserve\ existing\ views\ where\ feasible\ and,\ where\ topography\ allows,\ new\ development\ shall\ be\ terraced\ below\ the\ grade\ of\ Pacific\ Coast\ Highway;\ and\ preserve\ existing\ views\ where\ feasible\ and\ where\ topography\ allows,\ new\ development\ shall\ be\ terraced\ below\ the\ grade\ of\ Pacific\ Coast\ Highway;\ and\ preserve\ existing\ views\ where\ feasible\ existing\ views\ existing\ views\ where\ feasible\ existing\ views\ existing\ existing\ existing\ views\ existing\ views\ existing\ existing$ WHEREAS, in recent years, the Legislature has approved, and the Governor has signed into law, numerous bills that amended Government Code sections 65852.2 and 65852.22 to impose new limits on local authority to regulate accessory dwelling units and junior accessory dwelling units (collectively "State ADU Law"); and WHEREAS, notwithstanding this legislation, State ADU Law provides that it "shall not be construed to supersede or in any way alter or lessen the effect or application of the Coastal Act of 1976. . . ." (Gov. Code § 66329.) The California Department of Housing and Community Development's ("HCD") ADU Handbook advises that State ADU Law applies in the coastal zone, but "do[es] not necessarily alter or lessen the effect or application of Coastal Act resource protection policies." Accordingly, HCD opines a local government could, for example, impose stricter setback or parking standards in the coastal zone "if required by a local [c]oastal [p]rogram." (HCD's July 2022 ADU Handbook, at pgs. 15-16, 27-28); and WHEREAS, the City's regulations governing the approval of ADUs and JADUs are provided in the City's LCP, specifically Chapter 25.17 (Accessory Dwelling Units and Junior Accessory Dwelling Units) of Title 25 (Zoning) of the Laguna Beach Municipal Code; and WHEREAS, on November 16, 2021, the City Council adopted Ordinance No. 1665, which identified self-contained accessory dwelling units as subject to the coastal development permit application process; and WHEREAS, the City most recently updated Chapter 25.17 to comply with State ADU Law via LCP Amendment No. 21-8239, which was certified by the Coastal Commission on September 7, 2023; and WHEREAS, in 2024, the California Legislature approved, and the Governor signed into law, Assembly Bill 2533 ("AB 2533") and Senate Bill 1211 ("SB 1211"), which further amend State ADU Law and come into effect on January 1, 2025; and WHEREAS, the City Council intends to harmonize the City's responsibilities under the LCP and Coastal Act (as set forth above) with its obligations to approve the development of ADUs in accordance with State ADU Law, including AB 2533's and SB 1211's changes to state law; and WHEREAS, Government Code Section 65858 provides that, without following the procedures otherwise required prior to the adoption of a zoning ordinance, an urgency measure in the form of an interim ordinance may be adopted by a four-fifths vote of the City Council for the immediate preservation of the public peace, health or safety; and WHEREAS, Government Code Section 65858 further provides that suchan urgency measure shall be effective for only 45 days following its adoption, but may be extended beyond the initial 45-day period, following compliance with that Section, for an additional 22 months and 15 days; and WHEREAS, on December 10, 2024, the City Council found that there was a current and immediate threat to the public health, safety, or welfare based on the passage of AB 2533 and SB 1211 because the City's existing ordinance would not comply with the legislation if the City did not adopt Urgency Ordinance No. 1707, and the City Council therefore adopted Urgency Ordinance No. 1707 under Government Code Section 65858 and 36937 and WHEREAS, since the adoption of Urgency Ordinance No. 1707 on December 10, 2024, staff has continued to proceed with the process for local adoption of Ordinance No. 1708 that will then be transmitted to the Coastal Commission for review and certification as an amendment to the City's LCP. An amended ordinance revised in response to public comments and direction from the City Council is being presented for its first reading by the City Council on March 11, 2025; and WHEREAS, Government Code Section 65858 provides that, without following the procedures otherwise required prior to the adoption of a zoning ordinance, an urgency measure in the form of an interim ordinance may be approved by a four-fifths vote of the City Council to protect the public from a current and immediate threat to the public health, safety, or welfare; and WHEREAS, California Government Code Section 36937 provides that an ordinance takes effect immediately if the ordinance is for the immediate preservation of the public peace, health or safety, containing a declaration of the facts constituting the urgency, and is passed by a fourfifth vote of the City Council; and WHEREAS, the City Council finds that there continues to be a current and immediate threat to the public health, safety, or welfare based on the passage of AB 2533 and SB 1211 because the City's existing ordinance will not comply with this legislation if the City does not maintain an urgency ordinance that complies with current state ADU law. There is also a current and immediate threat to the public health, safety, or welfare because the City's ADU regulations are part of the City's LCP, and the Coastal Act requires that the Coastal Commission review and certify an ordinance amending the LCP before it becomes effective. (Pub. Res. Code. § 30514(a): see also LBMC Section 25.07.026(E).) The duration of the Coastal Commission's review and certification process can vary, and, in some instances, has taken numerous months. The City Council desires to ensure that the City's coastal resources are protected during the pendency of the Coastal Commission's review of a non-urgency ordinance; and WHEREAS, the City is authorized by law to adopt an interim ordinance that is effective immediately upon adoption without Coastal Commission certification when the ordinance does not conflict with the Coastal Act and does not authorize a use other than that designated as permitted in the LCP. (Conway v. City of Imperial Beach (1997) 52 Cal. App. 4th 78, 88-89.); and WHEREAS, the City's interim ordinance, consisting of Urgency Ordinance Nos. 1707 and 1709 and this Ordinance, address a residential use consisting of ADUs and JADUs—which is an already allowed use within the City's certified LCP—and merely reorganizes existing development standards, previously certified by the Coastal Commission, and further restricts development standards—to further protect coastal resources—in line with the state ADU law (including the most recent Legislative updates by AB 2533 and SB 1211) and Coastal Act; and WHEREAS, staff issued a written report to the City Council on the progress to alleviate the condition which led to the adoption of Urgency Ordinance No. 1707 on January 14, 2025 to support Urgency Ordinance No. 1709; and WHEREAS, City staff met with Coastal Commission staff on January 14, 2025, regarding the provisions of Urgency Ordinance No. 1707, at which meeting the Coastal Commission notified the City that certain changes in the urgency ordinance resulting from AB 2533 and SB 1211 are not authorized to be made via an interim ordinance without Coastal Commission certification, and therefore, some of the modifications from AB 2533 and SB 1211 have been removed from Urgency Ordinance No. 1709, but will remain in the regular ordinance proposed for Coastal Commission certification; and WHEREAS, on January 14, 2025, the City Council held a public hearing on an amended Urgency Ordinance in accordance with law and adopted Urgency Ordinance No. 1709 under Government Code Section 65858 and 36937, which extends Urgency Ordinance No. 1707 for 22 months and 15 days subject to modifications; and WHEREAS, on January 14, 2025, the City Council also directed staff to return with a modified ordinance to address public comments and direction from the City Council: and WHEREAS, City staff has evaluated public comments and direction from the City Council, and has returned with this Ordinance to implement certain modifications; and WHEREAS, City staff provided notice of a public hearing on this Urgency Ordinance in accordance with law; and WHEREAS, all legal prerequisites to the adoption of the

NOW, THEREFORE THE CITY COUNCIL OF THE CITY OF LAGUNA BEACH DOES ORDAIN, AS FOLLOWS:

SECTION 1. Incorporation. The recitals above are each incorporated by reference and adopted as findings by the City Council.

SECTION 2. CEQA. Under California Public Resources Code section 21080.17, the California Environmental Quality Act ("CEQA") does not apply to the adoption of an ordinance by a city or county implementing the provisions of Article 2 of Chapter 13 of Division 1 of Title 7 of the California Government Code, which is California's ADU law and which also regulates JADUs, as defined by section 66313. Therefore, adoption of this Urgency Ordinance is statutorily exempt from CEQA in that it implements

SECTION 3. Urgency Findings. Given the foregoing, the City Council hereby finds that there is a current and immediate threat to the public health, safety, and welfare based on the City's need to protect coastal resources during the pendency of the Coastal Commission's review and certification of Ordinance No. 1708. The Coastal Commission's review and certification process can vary, and, in some instances, has taken numerous months. The Legislature has mandated coastal resources be considered and protected as a resource of public importance. (Pub. Res. Code, § 30251; see also Pub. Res. Code, §§ 30001(a), (d) [(1) the coastal zone "is a distinct and valuable natural resource of vital and enduring interest to all the people"; (2) that "permanent protection of the state's natural and scenic resources is of paramount concern"; (3) that "it is necessary to protect the ecological balance of the coastal zone"; and (4) "existing developed uses, and future developments that are carefully planned and developed consistent with the policies of [the Coastal Act], are essential to the economic and social well-being of the people of this state..."].) Maintaining an urgency ordinance – as amended by the City Council – effectuates the foregoing and protects the public health, safety and welfare by enabling the City to review and approve ADUs in a manner that harmonizes its coastal resource protection responsibilities under the LCP and Coastal Act with its obligations to approve ADUs

SECTION 4. Publication. The City Clerk is directed to certify to the adoption of this Urgency Ordinance and post or publish this Urgency Ordinance as required by law.

SECTION 5. Custodian of Records. The custodian of records for this Urgency Ordinance is the City Clerk and the records comprising the administrative record are located at 505 Forest Avenue, Laguna Beach, CA 92651.

SECTION 6. Severability. If any provision of this Urgency Ordinance or its application to any person or circumstance is held to be invalid by a court of competent jurisdiction, such invalidity has no effect on the other provisions or applications of the Ordinance that can be given effect without the invalid provision or application, and to this extent, the provisions of this Urgency Ordinance are severable. The City Council declares that it would have adopted this Urgency Ordinance irrespective of the invalidity of any portion thereof

# Sage Hill falls in final minute

The Lightning surrendered a late lead in the CIF State Division I girls' basketball final on Friday in Sacramento.

The Sage Hill girls' basketball team was on the precipice Friday evening of bringing home the program's second state championship.

But four free throws in the final minute quelled a late rally by Sage Hill, which fell to Concord Carondelet 51-48 in the CIF State Division I final at the Golden 1 Center in Sacramento.

Sophomore guard Kamdyn Klamberg's layup, the product of a steal and assist from junior guard Amalia Holguin, with 64 seconds remaining lifted the Light-

ning to a 48-47 advantage. It marked Sage Hill's first lead since late in the third quarter, when freshman wing Addison Uphoff drove left to give the Lightning a 34-31 edge. Carondelet took a 42-34 lead in the opening minute of the fourth quar-

ter on a basket by sophomore wing Janel Nevares, as the Cougars capitalized on multiple offensive rebounds on the possession.

Junior forward Layla Dixon sunk a pair of free throws with 45 seconds left in the game to retake the lead for Carondelet (30-6). Junior forward Olivia Smith also made two free throws with 13 seconds to go, leaving the Lightning in need of a three-pointer on the last possession.

Leah O'Toner received the ball on a dribble handoff from Uphoff. The freshman point guard took the shot from the top of the arc with three seconds left. The potential game-tying three went long.

"They fight all the way through, and that's why we're able to erase the eight-point lead," Sage Hill coach Kerwin Walters said in a phone interview. "... We were one stop and one rebound away from, I think, sealing the game, but unfortunately, we didn't get that. Carondelet hit bigtime shots, and unfortu-

nately, that's how it went. Tough way to lose, but it happens. I think they're going to be resilient."

Carondelet claimed its second state title in five appearances. The Cougars won their initial state championship game appearance against Troy in 2004, before dropping the next three - to Troy (2006), Brea Olinda (2009) and Mater Dei (2010). Carondelet competed in Division II in its previous four state finals.

"It's been a long time since this school's been back," Carondelet coach Kelly Sopak said in an oncourt interview after the game. "I told them eight minutes for the rest of their life. It's just really fun."

Holguin had a game-high 21 points to go with five rebounds, four steals and three assists. Klamberg added 13 points and five rebounds. The backcourt duo, which accounted for all of the Lightning's scoring in the first half, also combined to make six of 12 attempts from the three-point line.

Sage Hill (23-12) struggled from the free-throw stripe, however, making an

abysmal four of 14 foul shots (28.6%).

When the Lightning made runs, the Cougars had the answers, particularly as sharpshooters. Junior guard Sophia Ross, sophomore wing Phoebe Weaver and senior forward Ryan Rodriguez each made two three-point shots, part of a nine-for-24 shooting performance (37.5%) for Carondelet from distance.

Notably, the Cougars also closed quarters. They scored the last four points of the first quarter, the final five points before halftime, and eight unanswered points to end the third quarter. Clutch free throws in the final 45 seconds swung the result in Carondelet's favor.

"This is what I put my energy towards, this is what I really put my life towards," said sophomore forward Celeste Alvarez, who had a team-leading 11 points and 14 rebounds for Carondelet. "This means everything to me. ... We couldn't ask for a better end to the season. This is our last game. I came on this court, I wasn't going to lose."

Freshman center Eve Fowler had four points, nine rebounds, four blocked shots and two steals for Sage Hill. Uphoff chipped in with eight points, six rebounds and a block. Junior forward Alyssa Cuff provided two points, four rebounds and three assists

Sage Hill, the Pacific Coast League champion and a CIF Southern Section Open Division qualifier, was seeking its second state title in four years. The Lightning beat Fresno San Joaquin Memorial to capture the Division II crown in 2022.

"Carondelet hit shots at the right time, at the right moment, especially when we stormed back," Walters said. "They hit good shots. We didn't finish a couple putbacks, we didn't finish our free throws, and that's the way the game goes.

"I think this was a big, huge step for [our team] in terms of being here and getting here. Just talking with them, they're eager to try to get back here next year. They're very determined to right the wrong that they feel right now."

Ashley Anderson told the Daily Pilot at the event.



"Please don't do that again, OK?" he said. "That's disturbing, that's not in proper decorum. I'll mute you again if you start saying

asked the council to hold a special election to fill Strickland's seat rather than appoint someone, although the city charter gives the council the power to appoint.

The last time there was a vacancy, the council appointed Rhonda Bolton in 2021 to replace Tito Ortiz. At the time, conservatives sought either a special election or the appointing of Van Der Mark, who was the first runner-up in the 2020 election.

Gruel's new seat is up for reelection in 2026.

According to the meeting agenda, Gruel was one of three candidates who council members had suggested to City Manager Travis Hopkins for the open seat, along with Valentina Bankhead and Planning Commissioner Ken Babineau.

Bankhead and Babineau both made public comments Tuesday night during which they asked that they be removed from consideration.

Gruel was mentioned publicly as a strong choice by former city attorney Michael Gates at his goingaway party at the Huntington Club on March 1, with Gates inviting Gruel to join him and the council mem-

Gruel, who opened his first restaurant in Huntington Beach in 2011, has four children with his wife Lauren. He has been known for his philanthropy.

He offered up his restaurant in Sunset Beach as a hub during the Southern California fires earlier this year and delivered supplies. During the pandemic, the then-Slapfish owner started a fund to aid restaurant workers.

Gruel also has a large following on social media and sometimes appears on Fox

News. He has been largely critical of California Gov. Gavin Newsom.

He said he appreciated the passion and charisma from the residents, calling it inspiring and saying he talks to hundreds of restaurant guests every day to hear what they're passionate about.

'We hear about the high level, really media-friendly topics that get everybody worked up," he said. "But at the end of the day, a really great city like Huntington Beach is, it comes down to, is the drinking water clean? Did your car get broken into when you went out to your car this morning? Are there potholes in the street? Are the parks safe? Do the kids have a place to play? Are the schools fun?'

In an interview after the meeting, he reiterated that working on fundamental topics like those was what excited him about his new role.

"If anyone wants to go through all of my stuff, you'll probably never hear me utter the four letters," Gruel said, a reference to 'MAGA.'

"Chris Kluwe said something tonight [during public comments] about transparency. I'm really looking at this as I'm representative of the entire city. If anybody wants to know how I distill people's opinions into actionable policy, or whatever you want to call it, I have nothing to hide. I'm a registered Libertarian. I'm very unique."

Nicklaus played the local PGA Tour Champions event in 2004, when it was known as the Toshiba Classic.

the stage for the election cannot be undone. So. Walsh will be fighting to win her seat back.

"Service, not politics, is core to who I am," she wrote in her public campaign statement.

Walsh has been volunfor NMUSD teering schools for the past 13 years. During that time she said she often found herself speaking out on behalf of her fellow parents, despite her dislike of being in the spotlight. She said she never aspired to become a public figure, but serving from a leadership position in her brief tenure as a trustee felt like a natural, organic outcome of all the work she has done to support the district so far.

Walsh described herself as an independent who believes leaders should take multiple viewpoints into account and make decisions based on facts

rather than ideology. She told the Daily Pilot she was not focused on stirring conflict with state lawmakers over mandated ethnic studies curriculum and other controversial issues.

"I'm not burning my bra and running down the street," Walsh said. "I'm not some crazy liberal."

She said one of her priorities would be maintaining and modernizing some of the district's older facilities. Another is campus safety, and she ap-plauded the previous board's approval for the installation of AI-assisted surveillance cameras that monitor schools and automatically notify authorities during an emer-

Both Walsh and Mc-Elroy have voiced support for early career education for youth interested in pursuing trades or other career pathways instead of going to college.
