Howald named Newport citizen of the year

He will be honored at a dinner in November alongside last year's winner, Joe Stapleton.

It was while attending a Friends of Newport Beach Animal Shelter meeting in City Hall earlier this month that Walt Howald was taken by surprise by a flock of individuals who showed up to announce he'd been named citizen of the year.

"I was very surprised and I'm still surprised," Howald said in a phone interview Thursday about the news he received during that Sept. 2 meeting. "There's so many people that have received this award. I'm just amazed. I appreciate it very much. I'm honored by it and I'm just humbled, frankly, because I just was. I love Newport Beach and where I can pitch in, I want to and I have and I will.'

Howald will be honored at a dinner in November alongside last year's winner, Joe Stapleton. Winners are selected by a committee of past awardees, who met in late August to consider candidates for this year's award, according to Newport Beach Chamber of Commerce president and chief executive officer Steven Rosansky.

Rosansky and past citizen of the year honorees were the ones who surprised Howald with the news.

The award dates back to 1949 and is meant to honor residents that are respected and admired by community members for that individual's respective contributions to New-

"Walt certainly checks all the boxes of what we would expect in a citizen of the year," said Rosansky in an interview. "He has long-standing service in the community and is someone who's devoted to making Newport Beach a better place."

Howald is currently a commissioner on the Newport Beach Parks, Beaches and Recreation Commission, a member of the Friends of OASIS board and a treasurer for the Friends of the Newport Beach Animal Shelter.

He also served as an elected trustee of the Coast Community College

O.C. Vector Control launches air strike against mosquitoes

Since being introduced last year, drones have improved efforts to control the insects in Orange County's sensitive wetlands and habitat areas.

A quiet Thursday morning outside Huntington Beach's Harriett Wieder Regional Park hardly discloses the carnage that is about to unfold, as two Orange County Mosquito and Vector Control District employees ready a drone for combat.

Roughly 20 pounds of a granular substance is poured into a metal cannister affixed to the body of the aircraft. It contains VectoBac GS — a bacteria strong enough to stop mosquitoes larvae from ever reaching adulthood.

With the flick of a switch, the drone powers on and begins its ascent over a nearly 3acre portion of the north end of Wieder Park, located near 1,400 acres of undeveloped wetlands preserved in the Bolsa Chica Basin State Marine Conservation

The device is the newest tool in an arsenal designed to control mosquitoes and the diseases they carry, particularly West

Nile virus, according to district spokeswoman Lora Young.

Young said the district began using drones in 2019 to surveil areas workers could not access on foot, including environmentally sensitive wetlands and areas with

Last year one aircraft was outfitted with larvicide and now, well into the 2021 mosquito season, it makes appearances at Wieder Park, Costa Mesa's Fairview wetlands. the San Joaquin Marsh near UC Irvine and water recycling basins in Santa Margarita when trap counts are high.

Air drops have a few advantages over the gas-powered backpacks typically used to perform applications in hard-to-reach areas, which tend to be much noisier.

'The technology allows us a more efficient way and more environmentally sensitive way to provide that same application without having to go into brush or disrupt

Surf City Marathon holds extra meaning this year for Kathy Hess

Kathy Hess has run more than 50 marathons, but not one of them has meant as much as Saturday morning's planned Surf City Marathon in Huntington Beach.

Hess, 62, was diagnosed with Stage 4 pancreatic cancer on Sept. 7, 2018. Back pain triggered a trip to the doctor, and tests revealed the cancer.

Before the cancer, Hess would go running three or four times a week. But in the early parts of her more than two years of heavy chemotherapy, she could barely get out of bed at her home in the South Coast Metro area of Santa After more than 2 years of treatment, Santa Ana pancreatic cancer survivor can't wait for Saturday.

Hess credits her Christian faith with getting her through the darkest days. She was put with a trial group through UC Irvine and Dr. Farshid Dayyani.

Hess also credits the support of her family, including her husband Gil, brother Phil Kos, sister Val Schepens and son Brad. She kept her job at Boeing through her chemotherapy, keeping her days productive.

"When this journey started, I never felt, 'Why me?' " Hess said. "I felt, 'What can I do to be stronger? What can I do to let

others know about hope and what faith is?'

Hess was in a wheelchair for a while, and she lost her hair during the chemotherapy. But through the journey, Hess started running again. She participated in the "Run for a Claus" 5K at UC Irvine in late 2019, and again at the Surf City Marathon 5K in February 2020.

In June 2020, Hess' test results revealed no more cancer, a moving moment for the whole family. And when this year's marathon

Pacific Wine and Food Classic canceled over **COVID-related doubts**

Bad news for Orange County's epicures. The Pacific Wine and Food Classic is canceled for the second year in a row, according to an announcement made by organizers Thursday.

The weekend-long food festival was initially scheduled to return to the Newport Dunes Waterfront Resort for the weekend of Oct. 23 after a yearlong hiatus as a result of the COVID-19 pandemic.

This year's cancellation comes from similar uncertainties.

The Orange County Health Care Agency reported 296 new cases of the coronavirus Thursday in addition to nine new deaths. Area hospitals have reported at least 432 cases and 132 of those cases currently in intensive care units. The Delta variant continues to be the dominant variant in Orange County and across the state, but cases have begun to plateau and trend downward.

Still, officials have raised some concern about a potential rise in cases following the Labor Day weekend, though there isn't a clear correlation yet present in

"Organizing the event begins as soon as fall the year prior," said Pamela Waitt, president of the Orange County Restaurant Assn. and founder of the festival. "The call [to cancel] was a collection of

any habitat," Young said. "With the drone, we can fly overhead and treat all the water sources we see."

The drone flies in routes preprogramed into its navigation system but operators, who've been FAA certified to fly the craft and have logged practice hours for the district, can release the larvicide on demand.

Young said this year's mosquito season, which typically runs from March through October or November, has been relatively quiet. As of Sept. 3, no dead birds had tested positive for the virus, and no cases of human infection have been reported in Orange County so far this year.

"Right now, it's looking like it's going to be a pretty low West Nile virus year," Young said. "Our mosquitoes are a different concern."

OCMVCD has reported 22 mosquito samples have tested positive for West Nile virus, including nine in Anaheim, six in Fullerton, four in Cypress, two in Buena Park and one in La Palma, according to district figures.

As populations of Aedes aegypti mosquitos, which proliferate in the daytime and can spread West Nile, continue to rise year after year, the county's Vector Control District reminds residents to eliminate standing water from their homes wherever they may find it.

Dr. Wesley Smith named NMUSD superintendent

Dr. Wesley Smith — an educator and administrator with 24 years of experience in California's public education system — has been selected as Newport-Mesa Unified School District's next superintendent, district officials nounced Thursday.

A former executive director for the Assn. of California School Administrators (ACSA), Smith has served for eight years in positions at the state and federal level, in addition to 13 years as a school site or district leader. He is currently an adjunct professor in USC's doctoral program and held similar titles at Shasta Community College and National University.

trustees approve Smith's contract during a Tuesday board meeting, the new superintendent will officially begin working on Oct. 18. He would replace Interim Supt. Hank Bangser, employed since Aug. 3 on a not-to-exceed \$48,248 contract following the departure of previous Supt. Russell Lee-Sung.

"Hiring a superintendent is one of the most important roles of a school board, and I am pleased that our board unanimously agreed that Dr. Smith would be the best to lead our district to greater success," NMUSD Board President Karen Yelsey said in a statement Thursday.

"[He] has the experience

and established leadership qualities that our stakeholders and we, as a board, were looking for — we are excited to welcome him into the Newport-Mesa community," she continued.

In their comprehensive search for a new district leader, trustees sought input from various stakeholder groups, who resoundingly indicated they wanted a leader who'd worked both as an administrator and an instructor, had demonstrated proven student achievement, communication strong skills and success at community building.

Smith previously served as superintendent of Morgan Hill Unified School District, a position he took in 2009. In three years under his leadership, the district increased its Academic Performance Index by 29 points — an accomplishment that helped him earn Santa Clara County's

Superintendent of the Year Award from ACSA in 2013, the Morgan Hill Times re-

Before that position, he served as superintendent, assistant superintendent and principal of Cascade Union Elementary School District in Shasta County. Smith wore several different hats before that, working as a teacher of English, Spanish and English language development. He's also coached football and baseball.

District officials praised Smith's fiscal stewardship, indicating he successfully maintained a balanced budget amid funding cuts and declining enrollment during the Great Recession, while providing staff resources to continue to meet student needs. He also served on the board of the Fiscal Crisis Management and Assistance Team, which provides management assistance to K-14 agencies.

Smith earned his bachelor's degree in English from Brigham Young University before going on to earn a master's from Claremont Graduate School and a doctorate in Educational Leadership from the USC Rossier School of Education in 2005.

District representatives did not provide information on what Smith's starting salary would be were his contract approved.



Increased suicide rates among young people demand our attention

riday is Suicide Prevention Day. It's a time to raise awareness about mental health and the importance of reaching out for help, without stigma or shame, for ourselves or our loved ones.

During the worst waves of the COVID-19 pandemic, when business and school closures caused unemployment, financial strain and isolation, millions experienced anxiety and depression for the first time; while for others, those conditions worsened. The Center for Disease Control and Prevention found that between April and June 2020, more than 40% of adults reported feeling anxious or depressed, an increase from the same period in 2019.

OUR CHILDREN ARE VULNERABLE

The rate of suicide among young people also spiked last year. A CDC study published in June 2021, found that in May 2020, emergency department visits for suspected suicide attempts began increasing among children ages 12 to 17.

The California Department of Health reported that the number of suicides among SoCal youth 18 and under rose in 2020. In Orange County, 11 young people took their lives, surpassing the four-year average of eight suicides. In Los Angeles County, 27 young people killed themselves, surpassing the four-year average of 23.25 suicides.

Last year, Waymakers, which operates crisis shelters and other programs serving vulnerable youth throughout Orange County, supported many children already struggling with mental illness, isolation, loneliness or bullying, who became especially vulnerable to heightened stressors after losing the support systems and routine of school because of the pandemic.

Add to that, some families were

forced to move in with other people to survive; and still others lost their homes outright. The resulting stress and conflict caused by such immense pressure on the family was too often too much. As a result, hospital beds were at capacity with young people who attempted suicide, and Waymakers Youth Shelters were full, with a long waiting list for beds throughout the pandemic.

WHAT CAN WE DO **TO HELP PREVENT SUICIDE?**

The American Foundation for Suicide Prevention offers some of the warning signs people who take their lives often show:

- talking about suicide, feeling hopeless, having no reason to live, being a burden, feeling trapped, unbearable pain;
 - abusing alcohol or drugs;
- withdrawal from activities; • isolation from family and friends:
 - sleeping too much or too little;
- giving away prized possessions; mood changes like depression, anxiety, irritability, shame, agita-

tion or sudden relief.

If you observe any of these behaviors, please seek help immediately by calling the National Suicide Prevention Lifeline at (800) 273-8255. It's confidential and free.

While the suicide statistics and close-to-home tragedies are reminders that suicide is a public health crisis, there is hope. The Suicide Prevention Resource Center provides factors help protect people from suicide:

- connection to friends, family and community;
- coping and problem-solving
- developing positive self-esteem or a sense of purpose.

Another step toward prevention is the signing of the National Suicide Hotline Designation Act of 2020 into law. The act creates a three-digit number to replace the current 10-digit number for the National Suicide Prevention Lifeline. Starting in 2022, people will be able to dial 222 to seek help.

When parents, teachers and community members recognize warning signs, it's possible to help young people make their way through seemingly overwhelming challenges to a place of stability. At Waymakers, we work to strengthen and support at-risk youth and their families by intervening during times of crisis and by providing support through our Shelter Programs: Huntington Beach Youth Shelter at (714) 842-6600 or Tustin Youth Shelter 24-hour referral line (714) 714-0780.

Together, we have the power to create a culture of encouragement and safety for teens and make a difference in turning these statistics around for future generations.



Mesa Verde dominates for second straight Jones Cup win

It is certainly an advantage to have a scorching hot player at the Jones Cup community golf tournament.

Last year, Mesa Verde Country Club's Kim Izzi made nine birdies to help her club earn a victory at its home course.

This year, it was another member of Mesa Verde who stepped up to the challenge.

Professional Mike Fergin seemingly couldn't miss. At one point, he hit an eagle and three straight birdies in a four-hole stretch on Thursday at Big Canyon Country Club

Mesa Verde cruised to its second straight victory in the two-best-ball format, with a team score of 15-under par.

"It's a lot of fun for us," Mesa Verde team captain Heidi Wright-Tennyson said. "It was supposed to be here last year, and we hosted during the pandemic. It was so much fun to have something positive happen during the pandemic. Then to come over here and win back-to-back is just fantastic ... Host Big Canyon and Shady Canyon tied for second with a seven-under par team score, followed by Santa Ana (-5) and Newport Beach (-2) country clubs.

Fergin had six birdies and an eagle at hole No. 2 during his individual round of 65 for Mesa Verde. Ryan Knapp, the men's club champion playing in his first Jones Cup, also had six birdies to aid Mesa Verde's cause.

Izzi, team captain Heidi Wright-Tennyson and senior men's champion Eric Woods chipped in

one birdie each for Mesa Verde, which recorded its only bogey that counted at hole No. 7.

The teams all started on the back nine. By No. 7, Mesa Verde had its eighth Jones Cup victory in the bag. Only Big Canyon has more, with 10 wins.

"It was a good team effort," Fergin said. "We all blend together, we all have a good time, so that's what's important too. Everyone contributed."

Fergin, who has been a part of each of the five Mesa Verde wins at the Jones Cup since 2010, said he hit a good drive on the par-five No. 2 that left him about 160 yards into the flag.

"It was a perfect eight-iron," Fergin said. "I hit it maybe just a little thin, but it was a good yardage. It went eight feet past the hole, and I made a putt."

Knapp said he had fun playing in front of his grandfather, Gordon Bowley, who has been a volunteer helping put on the Jones Cup since the beginning. Now 30 years old, Knapp added that he had caddied in a Jones Cup when he was still in college.

"I was caddying on a winning team, now I'm part of a winning team," Knapp said. "Moving up the ranks. I'm just trying to keep up with Mike, to be honest with you. It was a very fun day. The course was in great shape; the greens were incredible."

Taylor Wood, the men's club champion, led host Big Canyon

with four birdies. Men's champion Eion Middaugh and ladies club champion Kelly Ly each had three birdies for Shady Canyon.

Big Canyon captain Robert Pang made sure to congratulate all of the Mesa Verde players after the host club, which was the last to tee off, exited the ninth green to conclude play.

"When you hear someone tearing it up like [Fergin], you're really happy for them," Pang said. "Kim did it last year. When people play that well, you're happy for them. The outcome is what it is. We didn't play well enough. We didn't make putts and they did."
