he Huntington Beach Academy for the Performing Arts last put on a production of "Singin' in the Rain" in 2010. HBAPA Musical Theatre director Tim Nelson remembers it well. Kyle Selig, who played the lead role of Don Lockwood, has gone on to become a big Broadway star.

'What's so great is that now we're at a point where almost every show in New York has somebody from our school in it," said Nelson, in his 28th year with the academy.

It's now the current high school crop's time to shine. "Singin' in the Rain" returns to hits main stage of the historic Huntington Beach Union High School District Auditorium for six total shows over the next two weekends, starting Friday night.

The stage adaptation of Gene Kelly's acclaimed 1952 musical, written by Betty Comden and Adolph Green, is a favorite of Nelson's. He's directed it several times, including at two different dinner theaters in

Pride graffiti appears outside library

Rainbow images pop up after Huntington Beach institutes new flag rules. limits access to certain subjects in kids' books.

Huntington Beach police are investigating graffiti that was left at the Huntington Beach Central Library over the weekend.

Some community members have been reading restricted children's books outside of the library each Sunday afternoon for the last four weeks, in protest of the conservative City Council majority's direction to restrict those books and create a parent/guardian advisory board.

Wendy Rincon was arriving for what has been dubbed the Banned Books Story Hour on Sunday shortly after 12:30 p.m. As she and her husband drove up, they noticed a large LGTBQ+ Pride rainbow flag sprayed in the intersection, with the words "We Belong" written in red underneath it.

Closer to the library's entrance, another Pride flag was tagged on a building post.

"I didn't appreciate that," said Rincon, who calls herself an LGBTQ+ ally. "We were there helping and trying to support our librarians, and that just goes against what we're trying to do as a community by supporting our library. Our library is under attack, our librarians are stressed out. The last thing that anyone needs is tagging on our library."

Huntington Beach Police Department spokesperson Jessica Cuchilla confirmed the vandalism incident was reported Sunday afternoon and that detectives

were investigating.

Measure B passed in Huntington Beach last week, amending the city charter to limit flags flown on city property to government and military flags, plus the POW/ MIA flag and sometimes the Olympic flag. Adding more flags

Aquatic needs set waves in motion

With pool-sharing costs with the high school off the deep end, Laguna Beach eyes pursuing a city-owned facility.

After three decades of brokering the joint use of a 25-meter swimming pool at Laguna Beach High School — and subtly balancing the aquatic needs of children, students and adults alike — city leaders are looking to change lanes.

The Laguna Beach City Council on Tuesday agreed to pursue the option of constructing a city-owned pool facility that

would accommodate a wide range of water-based lessons and activities, rather than sharing space and facilities with Laguna Beach Unified School Dis-

Although a location has yet to be determined, officials estimate a new 25-meter pool with the required parking, staffing and infrastructure would cost at least \$13 million and come with

an annual \$692,000 operating

Such a move would not only give the city more leeway to create and offer public programs, from lessons and recreational swim hours to lifeguard training and possibly SCUBA certification, but could increase the city's ability to generate more

Laguna City Council votes to keep mayor's seat as is

Laguna Beach City Council approved Tuesday an array of cleanup changes to city law, chief among them how the positions of mayor and mayor pro tem will be selected.

The first reading of the revisions passed unanimously during the March 12 City Council

meeting with little discussion from the dais and none from the public during the hearing.

In addition to other changes, including language clarifying that disruptive behavior by members of the public at council meetings could result in removal and a misdemeanor, the

Newport Beach exits League of California Cities over Prop. 1

The League of California Cities will be absent at least one member this year after the Newport Beach City Council voted 5-2 to not renew the city's membership with the organization, citing differences in the League's position and support of policies that did not match Newport's.

According to the League of California Cities, Newport Beach has been a member for as long as records are available. As an organization, it has served as an advocacy group since 1898 to expand and maintain local control at the city level. Regional public affairs manager Connor Medina said the

city has been one of the most engaged and active cities in Orange County. The loss of it as a member, he noted, was not insignificant for that reason, and he called attention to the fact city staff and Councilwoman Robyn Grant have had active roles with the organization.

The matter of membership was

brought up by Mayor Will O'Neill in late February for a study session item. Council members pointed to a difference of opinion between the city and Cal Cities

over ACA 13 and Proposition 1. The latter, which is on track for approval statewide, appears to have been rejected by Orange County voters, with 58% of ballots cast. The proposition would authorize the issuance of \$6.4 million in bonds in order to direct funding toward supportive housing, treatment facilities and mental health systems to address the state's homelessness crisis.

In September, the state Legisla-





to the list, including the Pride flag, would require unanimous City Council approval.

The flag issue has been discussed heavily for more than a year, as the council majority approved a similar ordinance in February 2023. Rincon said she understood the anger behind the

vandalism, if not the action. She questioned whether the tagging was the work of an LGBTQ+ ally. On the other side of the political spectrum, she said some conservatives have accused allies of "planting" the vandalism so that they could clean it up quickly and be seen in a favorable light.

"It gives everyone on both sides a chance to point fingers at one another, which just continues to inflame the divisiveness of Huntington," she said. "It serves no purpose for the greater good. It's not going to help me understand their side any more than it would help them understand our side. It might have made the person and people who did it feel good in the moment, but ultimately it's not going to solve the underlying policy

issues that are happening in this city."

Pride at the Pier founder and executive director Kane Durham describes his group as a queer political advocacy nonprofit. When he heard of the vandalism at the library, he sent a call out via the Pride at the Pier Instagram page for help.

"We spent like \$200 to get cleaning supplies and spent several hours scrubbing with eco-friendly chemicals, to scrub all the paint off," said Durham, a transgender male. "I'm glad that we did. We are not here for rhetoric that claims that queer folks are the bad guys in this community."

About 15 to 20 people spent hours Sunday trying

to scrub the paint off, Durham said. Workers from the city

Public Works Department went out Monday morning to paint over the vandalism, Cuchilla said.

Durham said vandalism on the library was not supported — "the library is not our enemy" — and that his organization is using civic engagement to relay its message.

"The actions of the council majority have suggested an intent to keep queer people from being visible in Huntington Beach, and that is never going to happen," Durham said.

Burglar climbs tree to access 2nd floor of home in Newport Beach

A recent burglary at a Newport Ridge home left Newport Beach police officers believing someone had accessed the home by first climbing a hillside behind the property.

The burglary is lieved to have taken place between 3 a.m. on Feb. 17 and 11:40 p.m. on March

9. Investigators believe the burglar climbed a tree to access the house's second-story balcony after entering the backyard.

Once on the balcony, the person shattered a glass door and stole watches, cash, a wallet, personal documents and gift cards from the master bedroom and closet.

It also appeared the

burglar tried unsuccessfully to remove a safe.

This Newport Ridge burglary is one of two recent residential break-ins using a hillside access point reported this year, police said, with the other having taken place at a residence in the Broadmoor Sea View Community on Feb. 28.

In the February inci-

dent, more than one person accessed the backyard through a hillside behind the home, police

suspects were identified as wearing dark clothes, hoodies and masks. One was wearing a backpack.

HBPD arrests 3 women suspected in fleeing with \$3K in goods at CVS

Huntington Beach police on Monday arrested three Anaheim women on suspicion of organized retail theft, after they allegedly entered a CVS store and stuffed more than \$3,000 of merchandise into large bags before fleeing in

Jessica Cucilla, a Huntington Beach Police Department spokeswoman, said officers were called to the 100 block of 5th Street at around 12:30 where a reporting party described witnessing the incident of shoplifting, as the three suspects allegedly grabbed items before exiting the store toward the parking lot.

"The reporting party provided a good description of the vehicle, and officers were able to locate the vehicle," Cuchilla said Tuesday. "They conducted a traffic stop on the vehicle and arrested the three individuals."

Three suspects —18year-old Maria Parnica, Daniela Ciuciu, 25, and 19year-old Maria Hornea, all residents of Anaheim were arrested and booked on charges of grand theft shoplifting and organized retail theft with the intent to sell, exchange or return.

An image posted to HBPD's social media accounts Tuesday showed some of the items recovered, including a giant shoulder bag filled with

makeup and other beauty products and pharmacy

Cuchilla said while it is still unknown whether Monday's theft was committed by a known organized theft outfit or was simply an isolated incident, the actions of the suspects fit the description of California's penal code enough to qualify for such

The code defines organized retail theft as when an individual acts in concert with others to steal merchandise from a merchant's business with the intent to sell, exchange or return the stolen goods or works in concert with two or more people to purchase said stolen items with a similar intent. It also applies to those who act as agents to steal from a merchant as part of an organized plan.

"It could be based on the evidence and how they stole the items — they weren't being discreet or maybe they were just filling up the bags," Cuchilla explained. "It doesn't necessarily mean they are a retail theft group."

ture voted to put ACA 13 before voters. It calls for an amendment to the state Constitution that, if approved, would foil a business-led effort to make it harder to pass new taxes. It would ensure that a simple majority of statewide voters cannot restrict the will of a supermajority of voters in a local community. It is expected to appear on the ballot in the November election.

Cal Cities voted to support both ballot measures in December.

The annual fee to mainmembership \$24,800, according to city staff. Medina said the city's dues were not put toward the league's political action committee, CitiPAC, and did not contribute to any funding in support of Proposition 1.

Councilman Weigand, who was one of two votes to stay in the League alongside Grant, said he felt the cost of membership wasn't significant when dropping it meant Newport Beach would be losing a "seat at the table and we don't get an ability to shape any of those policy discussions — \$25,000 really isn't that much for some of the stuff [Medina] had mentioned the return on investment."

"It's easy for us to say, 'Let's pull the plug because there are certain things we don't agree with,' and I certainly am one of those persons who is upset at some of the rhetoric that the League has, and I think it's frustrating for us to see, but I think there's a greater investment here for a very minimal cost that the city puts into it."

O'Neill said he liked the local chapter of the League and those involved, but his thoughts on whether the city should stay or go circle back to Proposition 1.

"The reason it's been so hard to stomach and accept as we're working this through is that the League of Cities knew that Prop. 1 was bad. They knew it was bad for cities," O'Neill said, pointing to a series of paragraphs included in the December news release announcing the Cal Cities board of directors' support for the two ballot mea-

The Dec. 6 statement reads, "Cal Cities maintained a support position on both measures for most of the year. However, lastminute changes to AB 531 taken just one week before the end of the legislative session generated concerns among cities. As a result, Cal Cities withdrew its support. These amendments allow for by-right approvals

selection of a mayor and mayor pro tem by way of a council majority vote was codified.

Both positions were outlined as one-year terms until a successor is named.

'We've always done it that way," Laguna Beach Mayor Sue Kempf said after the meeting. "Most of the time, we elect a new mayor. We've had some extraordinary circumstances lately with COVID — most cities have — and that was difficult to navigate."

Councilman George Weiss voted for the revisions, even as he disagreed how mayors are currently selected.

"I think that the policy is wrong, but I didn't want to object to the other changes that were included and throw out the baby with the bathwater," Weiss said after the meeting. "We should go back to rotating the positions. That's the fair thing to do."

The issue proved more contentious when Weiss introduced a proposal in November to rotate council members into the posts, which he argued were ceremonial.

Some residents in support of his proposed policy change claimed it would cure the appearance that some elected officials were purposefully being shut out as well as honor the will of the vot-

"All of you were elected by all of us," Michelle Manda said. "You are disenfranchising a very large number of residents [by] not [allowing] everyone to get a chance at being mayor or mayor pro tem.'

Since 2018, Councilman Bob Whalen had held the title all but one year, including three successive

sponse to the coronavirus pandemic.

Resident Chris Quilter supported the status quo and claimed Weiss just wanted to be mayor.

"I find it rather offensive, the insinuation that somehow the fact that Bob has been mayor many times is somehow suspicious," he said. "There is nothing wrong with the tradition we have.'

Weiss thanked residents who agreed with his proposal but noted that he didn't solicit their supportive statements.

"I think it's fair, I think it's democratic," he added. "I would also probably agree to an elected mayor position every two years, if we could do that as an alternative. But I think not rotating it is not the right thing to do."

Prompted by the debate, Councilman Alex Rounaghi asked City Atty. Megan Garibaldi about what city law said about

terms during the city's re- mayoral selections. Garibaldi responded that the municipal code did not spell out specifics but that state law compelled the

council to select the post. Weiss' proposal failed for a lack of support by his fellow council members.

The ordinance council members approved Tuesday night added clear-cut language about the appointments.

In December, council members voted to have Sue Kempf serve as mayor with Weiss abstaining.

Rounaghi became mayor pro tem by a unanimous vote during that same meeting.

previously Kempf served as mayor in 2022.

of unlocked and locked behavioral health facilities, sober living homes, and recovery housing.

"While existing law generally requires by-right approval of these facilities in residential areas, Proposition 1 would also apply this approval process to office, retail, and parking zones. The Cal Cities Board directed staff to engage in the regulatory process and pursue legislation to address these concerns while also supporting Proposition 1."

O'Neill said to his council colleagues, "Every time for eight years when we've been trying to work through this issue, we haven't gotten anywhere near the amount of regulatory help to try and rein this in, and now we've got a proposition that's passing by 29,000 of votes as of [Tuesday night], out of

millions of ballots cast. Literally any position that could've been not just support but opposed to this would've been helpful for cities like ours throughout the state deal-

ing with this issue." O'Neill said the issue of sober living homes comes up routinely in meetings with local residents, and he feels it's "unfathomable" for the organization to support the proposition while knowing it would impact cities like Newport Beach.

He said it was possible the city might only take a year off from the organization to see what it looks like in the next year, but it was not reasonable to remain at this juncture.

revenue than under the current joint use agreement with LBUSD, authored in 1994.

That arrangement has the city paying 70% of the operating costs and roughly 65% of the cost of instructors, with the rest being picked up by the district. In 2023, the city spent \$522,000 to use the Laguna Beach High pool but generated just \$158,700 in class and program fee revenue.

Meanwhile, the school district has priority for using the facilities and free rein of the pool from 1:30 p.m. to 6 p.m. on school weekdays, meaning citybased youth water polo teams and after-school swim lessons run from 6 to 9 p.m. The two uses cannot be combined.

The discussion over building a city pool comes not without a bit of duress. Laguna Beach Unified officials in December approved designing and building a \$19-million, 50meter pool at the high school campus, which they hope to complete by late 2026.

"They would not negotiate with us on size," said Mayor Sue Kempf, who sits on a council ad hoc committee convened in October to consider pool options. "They voted on a 50meter pool and they plan to build a 50-meter pool they were very clear.'

Construction at LBHS would require closure of the jointly used facilities, and plans for the new pool do not include a kids' pool or shallow lanes for very young swimmers, vital aspects of the city's aquatic programming.

Council members Tuesday considered three options — going in with Laguna Beach Unified on the new pool at a cost of \$9.5 million to \$13 million, knowing it cannot accommodate city programs, building a new community pool somewhere else, or doing both and paying for

a standalone and joint-use pool.

Whalen, who serves with Kempf on the ad hoc committee, said the group's been talking with members of Sensible Laguna, an advocacy group formed in response to a \$150-million facilities master plan floated last March by Laguna Unified School District, which they say was drafted without adequate public input.

Supported by 2,000 "concerned parents, coaches, water polo players, tennis and pickleball players, swimmers and many others," according to its website, the group contends a 35-meter pool would be more appropriate for the high school.

Members are urging the city to build a community pool at one of several locations, including the city's 3.9-acre Lang Park and the 6.5-acre Laguna Beach Community & Recreation Center, the former site of the St. Catherine of Siena Parish School.

Several residents spoke during Tuesday night's meeting, with some siding on a new joint-use agreement for LBUSD's 50-meter pool for the sake of expediency, since a school district does not need to seek city entitlements and permits to build on its own property.

"This item is about seizing an opportunity being presented," said resident Julian Harvey, a former marine safety lieutenant and member of the U.S. Water Polo team. "The most cost effective alternative is a partnership with the district in the construction and joint use of a 50meter pool."

Most speakers, however, supported a city-owned pool, balking at the school district's offer to make the city pay up to \$13 million for a new joint-use facility that it ultimately would not

"It's \$13 million give or take either way, but one we will own and one we will not," said resident Jacquie Schaefgen. "So do we pay \$13 million for their pool, or do we pay \$13 million for a pool that may meet the needs of all community members?"

Councilman George Weiss said although the city has been a committed partner with the district since 1994, officials were given no say in the plans for a new pool.

"Placing pressure on us to say take it or leave it doesn't sit well with me," he said. "If we controlled a pool for 15 hours a day, we could have more programs than we had at the school's pool and collect more fees for those services."

Councilman Mark Orgill requested the project be placed into Laguna Beach's own facilities master plan and moved to the top of the priority list to speed up the long process ahead, estimated to take from three to five years after a location has been identified.

Ahead of a unanimous vote, Whalen said he and Kempf would continue to hold discussion with Sensible Laguna on possible locations for the amenity as well as options for interim pool use during any future construction.
