Police return product seized in raid

Se7enleaf owners see return of nearly \$1M in cannabis-related goods nearly a month after settlement with city.

After obtaining a court order for the return of nearly \$1 million in product seized during a Sept. 7 raid on two Costa Mesa legal cannabis businesses, the owners of Se7enleaf finally received the goods during a delivery Thursday.

Costa Mesa police and city employees trucked more than 100 pounds of cannabis flower, boxes of oil cartridges and vaporizers along with documents, devices and security equipment held in police storage to Se7enleaf's Cadillac Avenue facility.


The hand-off comes nearly a month after owners Michael Moussalli and Matteo Tabib reached a settlement agreement with the city, whose attorneys had been mounting an offense against what they believed was illegal commerce taking place at the site.

Temporarily detained by police during the raid and present Thursday, Tabib said the delivery came after a week of wrangling, attorney emails and discussions with police.

"They didn't like that they had to return the stuff," he said.

'Let's go!': Jaidee leads after first round at Hoag Classic

Thongchai Jaidee had a hot start on Friday at the Hoag Classic golf tournament at Newport Beach Country Club.

"Sizzling" might be a better way to describe a front nine that included five birdies and an eagle at hole No. 3 for the Thai pro.

"You're seven-under after nine?" a fan asked Jaidee's caddie incredulously as the caddie zoomed down the path in a golf cart at No. 10. "Let's go! Oh, my God!"

Jaidee cooled off somewhat but still did enough to grab the first-round lead at the PGA Tour Champions event.

He carded a nine-under par 62, matching his best round on the Champions tour and taking the outright lead by a stroke.

"If you play a low score, the golf course is fantastic," Jaidee said. "Today was not very difficult, and the wind is not very strong. I mean, this is my fourth year here, I know a little bit about the course."

English golfer Paul Broadhurst and Irish standout Padraig Harrington are both a shot behind, at -8. Spaniard Miguel Angel Jimenez is in fourth place, at -6.

The first round was played under partly cloudy skies, though some rain is in the forecast for both Saturday and Sunday. Tee times

Saturday have been moved up about an hour. A bogey on par-four hole No. 16 was the

only hiccup for Jaidee, who hit all 18 greens in regulation. He's had a long-term back injury and recently took a three-week break from golf but said he's feeling good heading into the weekend.

Broadhurst is off to a quick start this season on the PGA Tour Champions, with two top-10 finishes in his first four events. His round included birdies on four straight parfour holes, from Nos. 9 through 12.

"I guess that was probably the easiest 63

I've had," Broadhurst said. "When I got the wedge in my hand, I hit it really close."

He said his round was fairly stress-free until he bogeyed the par-three 17th hole.

"I didn't play a great bunker shot and just lipped out from 5 feet," Broadhurst said. "That happens toward the end of the day on poa annua greens, they get a little bit crusty. I

Museum fetes woman behind 'the noisiest chips in the world'

In honor of Women's History month, three grandsons of Laura Scudder, the woman behind the eponymous food brand famous for its potato chips and peanut butter, addressed a membersonly event at the Balboa Museum Thursday night.

The museum was packed to hear John, Craig and Kent Scudder share not only their grandmother's accomplishments but their memories of her.

"I'm interested in hearing the whole Scudder family story as told by the three brothers," said Balboa Island resident Dennis Bress, one of the crowd enjoying the festive party held in advance of their talk. Another resident of the island, Lisa Jimenez, concurred with Bress, adding that she wanted to support the Scudder family legacy and to acknowledge women's accomplishments.

To her grandsons, who are now all in their 70s, she was "Madre," while to everyone else she was Laura Scudder, creator of the crunchy snack that carried a marketing slogan pronouncing them "the noisiest chips in the world."

"They didn't like that they were wrong, and they didn't like that they were embarrassed and that nobody was charged. They gave no consideration that me and Michael and our employees' lives are not in a good place right now."

Co-founders of Se7enleaf, Tabib and Moussalli are collectively majority owners of the retail dispensary High Seas Cannabis boutique, located at 1921 Harbor Blvd., which opened to friends and family Wednesday ahead of an April 1 grand open-

Store owners had been waiting for a cannabis business permit, a final step delayed as city prosecutors and police processed the aftermath of the raid and an earlier inspection that discovered High Seas-branded product at a local cannabis delivery that had been co-packaged by Se7enleaf.

Moussalli maintains the company was testing the marketplace ahead of the dispensary's opening and not doing anything illegal. Since it opened in Costa Mesa after voters approved Measure X in 2016, Se7enleaf has engaged with the city's chamber of commerce and even helped inform the 2020 retail cannabis ballot initiative Measure Q.

"In many ways we're still treated as the stepchildren of businesses in the city," said Moussalli, who says he has never engaged in black market cannabis op-erations. "We just want the same basic opportunities and rights as businesses that are regulated

in the same ways as ours, like liquor stores.'

Costa Mesa city leaders are undergoing a review of the city's retail cannabis ordinance, considering amendments that would establish a buffer between dispensaries and residential properties and cut back on costly employee badge requirements.

During a public hearing Tuesday, Costa Mesa Police Chief Ron Lawrence told the City Council since

January 2022, the department has logged a total of 48 calls for service from cannabis businesses, though a majority of reports pertained to security alarms and suspicious in-

while he appreciated the council's reconsideration of laws that have proven to be onerous for operators, there is still a ways to go.



and became the first female attorney in Ukiah, although she never practiced. In 1920, the couple then moved to Monterey Park where they ran a gas station. The station was attached to a brick building and, in 1926, Laura decided to use the building to manufacture potato chips, later adding peanut butter and mayonnaise to her line. She became a widow in 1928.

At the time she started her business, potato chips were sold in barrels or tins, which didn't keep them fresh. Laura, wanting to preserve quality, taste and freshness, discovered the advantages of wax paper to improve potato chip packaging. The process began when she asked her female employees to take home sheets of wax paper and hand iron them into the shape of bags that could be sealed, allowing customers to enjoy crisp chips. Competitors later picked up on her idea.

Notably, Laura Scudder was also the first company to place freshness dates on its food products.

"I was about 10 years old, and I asked if I could take her to lunch. I had just received my first wallet, and I had \$5," John said. 'We went to a real swanky restaurant and we looked at these long menus, and I could see my \$5 evaporating very quickly."

When young Johnny ordered a hamburger, Madre did the same, respecting his modest means.

"She was over 70 years old and she was so sweet she didn't want to embarrass me," said John, who lives on Balboa Island. "And we iust sat there together the two us and we had our hamburgers.'

during the Great Depression. Laura faced her share of obstacles. When she searched for a policy to insure a delivery truck, she was told by male insurance agents that a woman would not reliably pay premiums. A female insurance agent got the job done and insured the company's fleet as it grew.

By 1953, with 1,000 employees, she had cornered 50% of the potato chip

Laura, who died March 13, 1959, at the age of 77, earned a well-deserved place in history as a pioneer for her many accomplishments that paved the way for women in business. But it was her deep devotion to her family and to those who worked for her that forever endeared a place in their hearts. So much so that when she sold the company in 1957 she ended up settling for less money to an agreeable buyer in order to secure jobs for her employees.

"Being the youngest of the four Scudder brothers, I had the shortest period of time to get to know Madre before she became ill," recalled Kent Scudder. "However, there are memories that still stick with me, most of these were at her 50-plus acre ranch/farm in La Puente.

'We went there for Thanksgiving one year, and I remember bolting through the front door, trying to get ahead of my brothers, and I ran through the living room and dining room and into the kitchen and was swallowed up in Madre's apron as I tried to wrap my arms around her to hug her, and she giving me an even bigger hug. I can still smell the turkey and the stuffing that was roasting in the oven."

His brother, Craig, chimed in, "She was a really good cook, and we still use her dressing recipe today."


