In-N-Out double-doubles down in Huntington Beach

Hungry patrons in Surf City now have another In-N-Out Burger for all of their doubledouble, "animal style" fries or shake needs.

The popular fast food franchise opened its second Huntington Beach location on Thursday at 7902 Edinger Ave., across the street from the Bella Terra outdoor mall.

In-N-Out No. 387 was formerly a Wells Fargo bank and has been in the works for about two years.

The new restaurant opened early Thursday, by about 9 a.m., and foot traffic picked up significantly as the lunch rush neared. Regular



Fentanyl tossed during police pursuit

Costa Mesa police on Tuesday arrested two individuals suspected of evading police and possession of fentanyl for sale, after a traffic stop led to a pursuit during which a suspect tossed three bags containing 30,000 pills from the vehicle.

Spokeswoman Roxi Fyad said the incident took place shortly before 5 p.m., when an officer attempted to pull over a 2016 Ford Edge for failing to stop at a stop sign and making an unsafe turn in eastside Costa Mesa.

Instead of yielding, the driver allegedly engaged officers in a lowspeed chase that crossed city boundaries into Newport Beach. At one point in the pursuit, three plastic bags were thrown from the window of the moving vehicle, CMPD reported.

"The passenger threw the bags out while the driver was evading the police," Fyad said Thursday.

When officers retrieved the bags, they discovered several smaller bags containing approximately 30,000 multicolored "rainbow" fentanyl pills.

Newport Beach police officers assisted in initiating a high-risk car stop on the city's Dover Drive, at which point the occupants were ordered to exit the vehicle.

Although three people were in the car at the time of the incident, only two suspects — Oscar Mercado-Arriaga, 49, of South Gate and Natalie Contreras, 37, of Gardena — were taken into custody and booked at the Costa Mesa jail on suspicion of felony evading and possession.

Both suspects were being held Thursday on \$500,000 bail and were scheduled to appear in court that day, according to an online inmate locator maintained by the county sheriff's department. Information on the third occupant of the vehicle was not immediately available Thursday, but Fyad clarified that person was not arrested.

hours are from 10:30 a.m. to 1 a.m. five days a week, and a half-hour later on Friday and Saturday nights.

"We have so many loyal customers down here that take great care of us, and they have for decades," said In-N-Out Chief Operating Officer Denny Warnick, who was in Huntington Beach for the opening. "We're thrilled to be here. When we first came to look at this particular site, [we liked] its proximity to a great intersection, proximity to the freeway. It fit in nicely with our other restaurants in the area."

The location is the second In-N-Out in the city, joining one near the corner of Beach Boulevard and Talbert Avenue. Trista Wilson, a 10-year veteran of the company, is managing the new restaurant, which has about 80 employees.

There is one drive-through lane, indoor seating for 54 guests and a covered patio with outdoor seating for 30 guests.

THE NEW In-N-Out Burger is located at 7902 Edinger Ave. in Huntington Beach, across from Bella Terra. The location was formerly a branch of Wells Fargo bank.

Indoors was the way to go on a windy Thursday morning. Huntington Beach resident Sixto Ramirez stopped in with his wife Sandi and ordered a double-double burger with no cheese, no onions and light spread.

"My usual," he said. "We drive through here all the time. I'm like, when is it going to open? When is it going to open? I wanted guest No. 1 [on my receipt], but I ended up with No. 32." Sandi predicts the location will be a popular one with their children, ages 17, 14 and 12.

"We know that every time we pass by, they're going to want something from here," she said with a laugh.

Many residents have expressed concerns about the added traffic near an already busy intersection. The parking lot is deep, which

Trial begins for former H.B. man accused of three rapes in 1990s

Two decades ago, a 57-yearold Huntington Beach man raped a 9-year-old girl and a woman jogger in south Orange County and years later assaulted the 12-year-old daughter of his live-in girlfriend, a prosecutor told jurors Wednesday, while the defendant's attorney said the real culprit was her client's identical twin.

Kevin Michael Konther is charged with two counts each of rape and forcible oral copulation of a victim and single counts each of forcible lewd act on a child and lewd or lascivious acts with a minor, all felonies. He also faces a sentencing enhancement for multiple victims.

"It was dark. She was alone and she was almost home," Deputy Dist. Atty. Juliet Oliver said of the 9-year-old girl as she returned from a walk to Sav-On, where she bought a notepad and mechanical pencils, on Oct. 21,1995. The girl was grabbed at about 6:40 p.m. after she had convinced her mother to let her go to the drugstore to buy a magazine, Oliver said. She was dragged into a wooded area in Serrano Creek Park in Lake Forest.

"Don't say anything or I'll stab you," the attacker told the girl, according to Oliver.

"Her attacker put his hand on her mouth and forced her into an embankment," Oliver said. Even though she said she was 9 years old he continued attacking her, the prosecutor said.

He forced the girl to take off her clothes and raped her, Oliver said. He demanded she tell him her address and warned her if she told anyone he would "hurt her," Oliver continued.

After she was raped the girl ran home nude, covering herself with the notepad and pencils, Oliver said. She told her mother what happened and authorities were called but sheriff's deputies could not find a

Laguna receives donation for Pride lifeguard tower at West Street Beach

When Laguna Beach reached an agreement to assume control of the beaches in South Laguna from the county of Orange, Laguna Beach Pride expressed interest in having a rainbow-decorated lifeguard tower stationed at West Street Beach.

Those plans received a boost Tuesday, as the City Council ac-

cepted a \$10,000 donation from residents Steve Chadima and Mark Porterfield to go toward its installation.

"We just thought it was a very clever way to celebrate the fact that that beach has been a haven for LGBTQ people for a long time now," Chadima said. "It just seemed like a great way to acknowledge that and celebrate it."

Chadima and Porterfield, who

have been together for 37 years, have contributed to other efforts around town, including an artistdesigned bench at the end of Mountain Road commemorating what was once the Boom Boom Room, a gay bar with a dance scene where they met. The bar closed in 2007 and the "Boom Boom Bench," a creation by

GIRLS' BASKETBALL Seahawks falter at Segerstrom, tie for second in league

SANTA ANA - The Golden West League girls' basketball race got tighter at the top, even if it did not happen in the way Ocean View might have hoped on Wednesday night.

Segerstrom rallied from a double-digit deficit to beat visiting Ocean View 55-46, forging a tie for second place between the teams with three games remaining.

Ocean View (18-7, 5-2 in the Golden West League) and Segerstrom (16-8, 5-2), who may well have needed help from each other to challenge for the league title, received help from an unexpected source. Fourthplace Westminster upset league-leading Godinez 60-51 at home.

As a result, the Seahawks still have a chance to control their own destiny, that opportunity to draw even atop the standings coming Friday at Godinez (16-9, 6-1).

"Our goal and what we consider a successful season will be a league championship and to make CIE,"

Ocean View coach Ryan Hasegawa said. "Then we have our goals below that."

Behind a hot start from beyond the arc, Ocean View jumped out to a 21-10 lead after the first quarter. Sophomore guard Angelina Bado made a trio of three-pointers in the opening period.

Segerstrom dug in defensively the rest of the way, forcing turnovers that led to fastbreak opportunities while limiting Ocean View's chances on the offensive end. Junior wing Berlin La Rue, junior forward Faith Ledesma and sophomore guard Claudia Solis converted two field goals apiece in the second quarter, as the Jaguars cut their deficit to 31-28.

The suffocating defense of Segerstrom held Ocean View to six points in the third quarter — all scored by Bado. Sophomore guard Stephanie Valenciano finished a layup through contact with 4:44 on the clock in the third quarter, giving the Jaguars a 36-35 lead they would hold onto.

she "didn't see him again until about a mile later" when he emerged from some bushes, jogging behind her.

Crime Lab had worked up a DNA profile of the 9-yearold victim's attacker and when investigators compared evidence in that case they found a match in the woman's suspect, Oliver said. But they still had no name of a suspect. In 2018, the cold case was reopened and Sgt. Jason Perez of the Orange County Sheriff's Department took the DNA evidence and uploaded it to a genealogical website, where he found some cousins related to the suspect, according to court records.

Investigators collected evidence from a forensic medical exam and created a composite sketch of the suspect from the girl's description.

On June 2, 1998, a 31year-old woman was jogging in Mission Viejo on a trail near El Toro Road and Marguerite Parkway when she saw a man running parallel to her, Oliver said.

"She saw the male come down and almost cut her off," Oliver said. The man sprinted ahead of her and

"He came out of the bushes and started yelling" at her, Oliver said, adding that the attacker dragged the victim down into an embankment and raped her.

The victim "thought that was going to be the end of her life," so even as he pressed his hands around her neck she attempted to talk to him to calm him, Oliver said.

When the man finished attacking her he ran off, leaving her clothes in a pile, Oliver said.

The woman could not find one of her shoes and decided to leave it so it would provide investigators a precise location of the crime scene when they found it, Oliver said. The

From there, Perez and FBI investigators narrowed down suspects to Konther and his identical twin, according to Stephen, court records.

Perez collected trash

and the daughter of his live-in girlfriend in 2003. The daughter, who was 18 or 19 at the time, said she was accosted in 1999, Oliver said, adding that Konther, his girlfriend and the girl lived together in Huntington Beach and Highland.

"The defendant would walk into her room naked and stand uncomfortably close to her," Oliver said. "She would pretend to be asleep ... On many of these occasions he would pull down her clothes and stare at her."

As investigators were trying to determine which brother had assaulted the victims they arrested both and put them together in the same vehicles where

Beach, she added.

"There is no shock, there is no sorrow" from Kevin Konther, Oliver said, but his brother was outraged and "very upset" about police arresting him and kicking in his door.

Kevin Konther "knew exactly why he was arrested," Oliver said. "You will hear him describe how he knows because it was DNA .. He just hopes it's not related to the 9-year-old girl."

Defense attorney Jessica Ann Sweeny of the Orange County Public Defender's Office said, "Kevin didn't do it. He's not guilty."

She added, "I'm confident what you will not hear from in this case is from Stephen.'

When investigators

He did so in the belief it would "exonerate him," Sweeny said.

The defense attorney said a "disgruntled ex-girlfriend" is the source of allegations about the third victim.

When the twins were growing up, Stephen was "treated better" and Kevin was the "black sheep," Sweeny said.

Stephen Konther went on to a career in a hospital and Kevin was a garage door repairman, Sweeny said.

"Kevin was not the one who committed these crimes — Stephen did," Sweeny said.
