# Marina stuns top seed to advance to CIF final

## Reward in fatal freeway shooting climbs

It stands at \$500,000 for information leading to the arrest and conviction in the death of Costa Mesa 6-year-old Aiden Leos.

As the search continues for those responsible for the death of Costa Mesa 6-year-old Aiden Leos, the Costa Mesa City Council approved its own contribution to the reward being offered for aiding in that ongoing investigation.

At its meeting on Tuesday, the council unanimously approved a \$50,000 contribution to the reward money for information leading to the apprehension of a suspect and conviction in the case.

The total reward posted for information that leads to an arrest and conviction in the fatal freeway shooting case has climbed to \$500,000, Orange County district attorney spokeswoman Kimberly Edds confirmed Friday.

The apparent road-rage inci-dent that took Aiden's life occurred in the northbound lanes of the 55 Freeway in Orange on May 21 between 7:55 and 8:15 a.m.

Authorities have said that a male suspect in the passenger seat of another car fired into the back seat of a vehicle driven by Aiden's mother, and the driver of the suspected vehicle was female.

The suspected vehicle has been described as a 2018 or 2019 Volkswagen Golf SportWagen that has a sunroof and does not have tinted windows

Aiden had been on his way to a kindergarten class in Yorba Linda at the time of the incident. Mesa Mayor John Costa

points.

Racklin, in his 10th year as Marina coach, said the team chemistry is the best it has been in a decade.

"Every kid on this team could walk and ride their bike to this school," Racklin said. "No transfers, none of the [stuff] that comes with that. We did it with homegrown kids; that's the most important thing.'

Aguirre scored 13 of his points during a first-quarter blitz that saw Marina surge to a 26-12 lead. But by halftime, Shalhevet (20-3) had trimmed its deficit to just four points.

"We knew they were good and they were going to start hitting shots,' Aguirre said. "They've got some good guys over there. I think we boxed out and rebounded really well, and that's what got us the game.'

The second half was tense. A three-pointer by Shalhevet's Uzi Mermelstein gave the visitors their first lead, at 64-62, with 3:45 left.

It was tied in the final two minutes, but Marina scored six straight points for a 72-66 advantage. The last two points came after Shalhevet coach Ryan Coleman was called for a technical foul with 1:03 remaining


