Team aims for a strong finish in racing season

hallenges confronted the crew of the Blitzen from day one in their inaugural year competing in the Newport Harbor Yacht Club's racing season. Their halvard broke during the opening day race in May, sending the wind-catching kite propelling their boat from Long Beach Harbor to Newport Pier tumbling into the ocean.

"There was no hesitation between this team," Blitzen's owner Brett Scott said. "Everyone grabbed the kite and in 20 seconds it was up and flying

She has been sailing since she was 5. But her first year at the head of a team has taught her a lot about managing schedules, the personalities aboard the boat and finances, she said.

Whenever something breaks it adds up, so I'm definitely not doing this for the money," Scott said with a laugh. "Don't take investment advice from me. But we've really bonded as a team, and I think that's our greatest achievement."

Heated contest for city clerk in H.B.

Regina Blakenhorn and Lisa Lane Barnes are engaged in contentious run to replace retiring Robin Estanislau.

For the first time in more than eight years, Huntington Beach voters will seat a new city clerk when the general election is held in November.

Current City Clerk Robin Estanislau is retiring, and two candidates - Regina Blankenhorn and Lisa Lane Barnes — are vying for a four-year term.

The first couple of weeks of the campaign have already proven contentious.

Barnes hired an attorney to challenge Blankenhorn's ballot designation of "city executive coordinator." Her team argued that this was misleading, since Blankenhorn held that position in the city of Tustin — not in Huntington Beach.

The ballot designation is very important, and when you use the word 'city' ... it implies that you work in that city," Barnes said. "Your ballot designation cannot be misleading, and that is misleading.'

The issue did not require litigation. On Monday, Estanislau agreed to reject Blankenhorn's initial ballot designation and change it to her second alternative "municipal executive coordinator."

Blankenhorn said she re-

Randall Preserve gets state boost

\$600K grant will help stewards of the open space plan for its future.

State officials awarded a \$600,000 grant on Thursday to develop plans for the future preservation of Frank and Joan Randall Preserve.

The 387-acre space just east of the Santa Ana River and north of Pacific Coast Highway is near the borders of Huntington Beach, Newport Beach and Costa Mesa. The former oil-field is considered one of the last undeveloped plots of coastal real estate in Orange County, and is a habitat for burrowing owls, fairy shrimp, peregrine falcons and other wild-

Kontrapunktus to tap into spirituality of music

Chamber music originating from the Baroque period will be played in downtown Laguna Beach tonight, when Kontrapunktus makes its return to Orange County.

The nine-piece orchestra of promising young musicians will perform inside the sanctuary at Laguna Presbyterian Church,

where it first appeared in 2017. Back in those days, Kontrapunktus experienced a few obstacles. At least locally, the group dealt with relative anonymity and a showtime that was less than ideal. The performance took place in front of a couple dozen people on a Sunday after-

Since that day, Kontrapunktus Executive Director Raymond Jacobs says, the turnouts in Laguna Beach have been outstanding. Jacobs said the attendance, as well as the time slot, are a sign of how far they have come.

Kontrapunktus is nearing the end of its current string of shows, during which the chamber music orchestra is performing music from composers Georg Phil-Telemann and Johann Sebastian Bach.

Notably, the performances tend to take place in houses of

when asked about the selection in venues. "During the Baroque era, the clergy were a major influence on society at large. Most people were almost required to go to church every Sunday. It wasn't necessarily a subculture. I think it was more of a culture where even the most prolific composers were involved in some capacity in working with the clergy, Bach being principal among them.

"Bach basically dedicated his whole life to writing choral music, sacred music, as it's now called. I try to find atmospheres that bring out the spirituality of the music, for people to feel a greater connection with the music in that environment."

The musicians performing on Saturday night will include Cameron Alan-Lee (concertmaster), Leonard Fu (first violin), David Chang (second principal violin), Haesol Lee (violin),

Cassia Drake (viola), Ethan Moffitt (double bass), Osheen Manukvan (cello), Keika Mori (harpsichord) and Aubree Oliverson (vi-

Presbyterian, Laguna which was founded in 1917, will be the site for an official recording performance of the current production, "Bach and Telemann: Collegium Musicum."

The sanctuary was completed in 1928, and the

chancel upon which the musicians will be playing was expanded in 1948. Restoration efforts for the sanctuary were finished in January 2010. That project included a resurfacing of the chancel with Jerusalem limestone.

Various features help set a tone, including four the-matic stained-glass win-dows. The Ferris Window, which looks out toward 2nd Street, was donated by the children and grandchildren of Sylvanus and Sabra Ferris, who established the founding congregation of the church by hosting bible studies on their front porch in the 1890s.

There are also the Four Gospel, the St. Paul and the Good Shepherd windows.

"I think what our church provides is a much more intimate setting," said Beth Pinney, an associate pastor for Laguna Presbyterian. "It seats probably 300 [people on the ground floor]. They've had 250, maybe, in there, which is even bigger than an audience would typically be for chamber

musicians."

Pinney pointed to the history of the church and its congregation, noting that it has had an appreciation for art and divine creation. Plein air painter Anna Hills was among the members when the church was formally organized in 1917, according to church records. Hills' influence remains in the sanctuary via the color palette of the windows.

Given that history, Pinney says that is reason enough to support young artists in a variety of mediums.

"If I take you around to show you the paintings that the church has, you could go back and just listen to the excellent music that has been created by this congregation over years, it's really astounding," Pinney said. "I think that's the connection. I think we love good art, we love wonderful, exceptional music.'

Truly Pizza has truly enjoyed a successful first year.

In June, the Dana Point restaurant was one of only two in Orange County named on 50 Top Pizza's list of the 50 Best Pizzerias in the USA, and its Champion Cheese Pizza, designed by pizzaiolo Sergio Balderas, took home the Best Traditional Pizza award at this year's World Pizza Championship in Italy.

On Monday night, a cluster of hopeful diners crowded the host stand hoping to get a table on Truly's lemon-tree-shaded patio. Earlier in the day, the pizzeria's owners announced plans to open a second location in Laguna Beach next year, expanding on the success so evident a few hours later.

Los Amigos takes flight in season opener

GARDEN GROVE — Los Amigos hit the ground running in its season opener, leaving little doubt of the outcome after the first quarter against Santiago on Thursday night.

The Lobos found the end zone four times in the opening period en route to a 46-7 rout of the Cavaliers in a nonleague football game at Michael A. Monsoor Memorial Stadium.

"The expectation is high because it has to be," Los Amigos coach Romel Guess said. "When you're led by as many seniors as we're led by, we're kind of putting all our eggs into this basket this season to make a run. We know we needed to start tonight."

Senior Isaac Galindo rushed for 91 yards and three touchdowns, scoring twice in a first quarter that saw the Lobos jump out to a 26-7 lead.

Senior Raul Cruz, who had 95 rushing yards and two touchdowns, sprinted across the goal line from 33 yards out to open the scoring for Los Amigos (1-0).

After Ozzy Granados tied it up with a 59-yard dash to the end zone for Santiago (0-1), the former Garden Grove League rival of Los Amigos, Galindo would convert back-to-back offensive plays into touchdowns. Both came on redzone carries, the second immediately following a special teams miscue with the punt team on the field for the Cavaliers.

"It is pretty fun," Galindo said. "It's a lot to handle, coming from maybe seven carries a game, but it's nice.

I'm really looking forward to taking over this offense."

Senior wide receiver Chris Flores worked for yards after the catch on his first three grabs. After Jayvin Le converted a fourth-and-5 with his legs, the junior quarterback took a deep shot, and Flores came down with it in double coverage. The duo connected on a 3-yard touchdown on the next play, giving Flores five catches for 102 yards with four seconds left in the first

"I just saw the ball up there," Flores said of his downfield catch that set up a touchdown. "I'm trying to give [Le] a good look, and he's giving me a good

Le threw for 176 yards and a touchdown without committing a turnover. The Edison transfer also carried the ball eight times for 45

Amari'e Maddox, a junior transfer from Long Beach Jordan, had four catches for 52 yards.

Los Amigos, which matched its season-high scoring mark from a year ago in a 46-14 win at Bolsa Grande, accumulated 283 rushing yards. An offensive line anchored by right tackle Aaron Barba and left tackle Jesus Contreras also included center Bryant Merida, and Steven Cortes and Issacc Vergera at the guard positions.

Guess called the offensive line the "catalyst" for the Lobos, adding that all

five starters had at least three games of starting experience on the line coming into the season.

"I like defense, but I was always an offensive player," said Barba, who is a junior. "For motivation this year, I think we have a great team. We can make it far."

Hector Arroyo capped the scoring with a goal-line run in the final minute.

Los Amigos won its third consecutive game over Santiago. Prior to that, the Cavaliers had won five in a row against the Lobos from 2017-2021, which came on the heels of a seven-game winning streak in the series for Los Amigos from 2010-

The Lobos played their first game on campus last season. Los Amigos will host Yermo Silver Valley on its turf field on Friday, Aug. 30. Los Amigos athletic director Chris Sandro said next week's football game is the only one scheduled to take place on campus this fall.

Costa Mesa 35, Magnolia 0: Sophomore running back Gavin Garza rushed for 220 yards and two touchdowns, as the Mustangs blew out the Sentinels in a nonleague game at Handel Stadium in Anaheim.

Costa Mesa (1-0) won a season opener for the first time since 2019, when the Mustangs earned a 21-18 victory over Santiago.

Junior quarterback Andrew Waiss threw a touchdown pass to junior tight end Caden Oliver. Waiss scored a rushing touchdown.

Costa Mesa will take on Estancia in the Battle for the Bell rivalry game on Aug. 30 at Jim Scott Stadium. It will be the season opener for the Eagles.

The countywide reorganization for football broke up the Orange Coast League, placing Costa Mesa in the Tango League and Estancia in the Sigma League.



spected the decision.

"Executive coordinator is my job title, and I work for a city," she said. "I thought it made sense. They said it was misleading, that people would think I was appointed to something or that I worked in Huntington Beach. I was like, everyone Googled me already and found out I worked for Tustin."

For the record, Barnes' ballot designation lists her as "businesswoman/Huntington Beach commissioner."

Blankenhorn has been an executive coordinator for Tustin for 11 years, providing support to its city manager and city council in their dealings with the public and outside agencies, including media, while ensuring that policies and procedures are adhered to by the council

A 25-year resident of Huntington Beach, she was previously an instructor in the Coastline Regional Occupational Program. She's currently the chairperson for the Enterprise Corp. for the Coast Community College District, a for-profit

Barnes corporation that operates the swap meets at Orange Coast and Golden West colleges.

Blankenhorn, who said she was listed as No Party Preference for years before recently registering as a Democrat, believes her experience in municipal government sets her apart. "I want to make sure that a person

who's in there is experienced, because that person is going to be a department head and they're going to have to lead that department and staff," she said. "It's not just a matter of conducting city council meetings. The city clerk is the elections official, and they're also the records

Among Blankenhorn's endorsements are the city clerk of Laguna Beach, Ann Marie McKay.

Blankenhorn said that when she found out that Barnes was the only one running at the time, she decided to throw her hat

'I didn't know her name," Blankenhorn said. "I just knew someone was running that was a Realtor in town and had absolutely no municipal government experience. I thought that was wrong. As a resident myself, I would not want to have an inexperienced person in that position. So that's why I decided to run."

Barnes countered that she directly serves the City Council in her current role as a Community and Library Services Commissioner, a position to which she was appointed by Councilman Tony Strickland in 2022.

Her background is is business. She said she previously worked for a global chemical manufacturing company before settling in as a local real estate agent two

"It's always been one of my goals to be deeply involved with my community," said Barnes, who has lived in Huntington Beach for a dozen years. "When I was working corporately, I did a lot of travel, and that really prohibited spendi-5

ng as much time as I would like to within our community. When that changed and I became a Realtor, it was a great opportunity for me to really anchor

myself in the city and just become in-She sees becoming the city clerk as an extension of that. As to Blankenhorn's contention that she is unqualified, she noted that she's proud to be on a commission that advises the City Council on

what to do with Huntington Beach's 78 parks, five libraries and one golf course. Barnes said she has conservative values. She has endorsements from the Republican Party of Orange County, Mayor Gracey Van Der Mark, Mayor Pro Tem Pat Burns, City Atty. Michael Gates and state Sen. Janet Nguyen, whose District 36 includes Huntington Beach.

"I'm embedded in the fabric of this community," Barnes said. "I've never met [Blankenhorn], I've never seen her at a City Council meeting. I've never seen her at a city event in Huntington Beach, because she's in Tustin.'

As the conductor of municipal elections, the city clerk could see increased importance in Surf City in future years.

In March, Huntington Beach voters approved Measure A, which means the city could require voter identification, provide more in-person voting locations and monitor ballot drop-boxes starting in 2026. Weeks later, California Atty. General Rob Bonta and Secretary of State Shirley Weber filed a lawsuit in Orange County Superior Court, arguing that Measure A was illegal and preempted by state law.

Blankenhorn said she'd be ready to go on day one if elected.

'When I don't know something, I'm going to have my staff to help me, guide me and direct me," she said. "And I'll have other city clerks that I can turn to. I know city clerks.'

Barnes also believes she is qualified, adding that the livelihood and well-being of the community were important to her. When I became involved, I loved it,"

she said. "I absolutely loved it, and I wanted to do more for our community ... I believe I am the best candidate."
