## Laguna Beach extends application deadline of its grant program for bars and restaurants

#### BY LILLY NGUYEN

Laguna Beach announced Wednesday that it is extending the application deadline for local bars and restaurants to apply for its "LB Cares" program, which will provide a one-time grant to businesses impacted by the COVID-19 pandemic.

The new deadline for applica-

tions is Jan. 19 at 5 p.m.

City Council members unanimously approved the appropriation of \$1.4 million from the city's reserves in December in an effort to provide relief for those facing financial hardship.

The LB Cares program provides one-time grants of \$5,000 to restaurants and bars. Local retailers that have had to close in

light of current health protocols can receive \$3,000 and those operating at a reduced capacity can receive \$2,000.

Grants are given on a firstcome, first-served basis.

To qualify, businesses must be compliant and pledge to remain in compliance with current California and Orange County health orders, be located in Laguna Beach and have a business license saying so and confirm that they have experienced economic hardship due to the pandemic.

Restaurants and bars must have also been ordered to transition to takeout or delivery only, or closed completely.

The grant program is not ac-

## Classic car cruise held in memory of H.B.'s Daniel 'Dano' Patten and Tommy Simpson

It was the kind of classic car cruise that Daniel "Dano" Patten would have loved to film.

More than 100 cars drove down the streets of downtown Huntington Beach on Wednesday night, cruising through the fog down Pacific Coast Highway Avenue Warner Brookhurst Street.

The only thing missing was "Dano."

Surf City Classics car club held a memorial ride starting at Lake Park to honor Patten as well as another late member, Tommy Simpson.

Patten, was a well-known Huntington Beach-based videographer who shot video of car shows and other Surf City events for his "Dano Live" YouTube channel, which has more than 10,000 subscribers. He died on

iff's Department said Patten, 66, was filming an illegal street race in Carson when two cars crashed

into each other and went into the crowd. He died at the scene, poThe following day, Simpson, 72, another Surf City Classics club member who lived in Huntington Beach, died after a battle with Parkinson's disease. He left behind his daughters, Renic and Airyn, as well as three grandchil-

"We're going to do this every year for Dano and for Tommy," said Brian Almas, an Irvine resident who is the president of Surf City Classics. "Dano was loved by everybody coast to coast, Ventura to San Diego. But at the end of the day, this is where he hung his hat up. When the cameras went off, we were his family."

Almas said the club will be giving out the "Sweetest Ride" trophy once a month in Patten's

# **Patient** count still climbing at O.C. hospitals

The Orange County Health Care Agency Thursday records 2,701 new coronavirus infections, 29 deaths.

Nearly 14 days after the Christmas holiday — when Orange County health officials anticipated an untold number of residents would participate in gatherings despite a regional stay-athome order — hospitalizations for COVID-19 continue to climb.

Orange County health officials on Thursday recorded 2,701 new cases of coronavirus and 29 deaths, bringing the countywide cumulative case count to 177,733 and pushing the fatality rate to

Area hospitals reported treating 2,251 individuals for COVID-19, 22.3% of which - or 502 individuals — were being cared for in intensive care units, according to the Orange County Health Care Agency.

The county's seven-day average of new cases stands at 67.8 per 100,000 residents. Another 31,915 tests were issued Thursday, bringing the cumulative number of tests issued to 2,179,658 and accounting for a seven-day average testing positivity rate of 17.1%.

On Wednesday, former Orange County Supervisor Michelle Steel, sworn into office Sunday in the U.S. House of Representatives, announced she has tested positive for the coronavirus, according to a statement.

"At the advice of the Attending Physician, and to protect the health of my colleagues, I will be quarantining," Steel said in the statement.

Meanwhile, the OCHA has rolled out a plan outlining the order in which county workers and residents will be able to receive the coronavirus vaccine. Health officials explain the county is currently vaccinating those designated as belonging to a multitiered "Phase 1A.

## Laguna **Beach City** Manager Pietig to step down

Laguna Beach City Manager John Pietig is stepping down.

The announcement came Thursday that Pietig, who has been with the city for two decades, will be retiring in June. The notice comes in advance for staff to prepare for the transition between city managers, the city said in a statement. The exact date has not yet been determined.

Officials said Pietig has served as the city manager for a decade and, prior to that, was the city's assistant manager for another 10 years. He started his career in local government with the city of Riverside, where he was for 10 years, as a budget director and was a deputy city manager in Alhambra for two years before he was offered a assistant city manager position in Laguna Beach.

Pietig was appointed to his current position in 2010.

"The city of Laguna Beach is an extraordinary place," Pietig said in a statement. "Our community is involved, aware and very engaged."

Together, with the City Council

## Newport City Hall closes again to public starting Monday

Newport Beach City Hall is closing again.

The city announced Thursday that it would be shutting down City Hall to the public starting Monday out of concern for the health of city employees and members of the public as COVID-19 cases continue to climb in Orange County. City officials said City Hall would remain closed through the end of January.

Data from the Orange County Health Care Agency reported that there have been a total of 2,502 cases in Newport Beach. Countywide, there are now 177,733 cases as of Thursday.

This is the third time that Newport Beach City Hall is closing in response to the pandemic.

The first time it closed was in March at the start of the statewide stay-at-home order issued by Gov. Gavin Newsom.

It reopened in May, then closed again in July, when cases increased. City Hall reopened for a second time in October.

All city services will remain available through phone, email and drop-offs and pickups.

Those applying for planning, building, public works or fire permits can leave applications in a designated drop box outside City Hall, Bay C. Plan checks and revisions can be submitted for review by email or by the drop box.

The cashier's office will also accept payments online or residents can leave payments in a designated drop box in front of Bay A.

The city also announced Thursday that it would be suspending its recreation classes until further notice.

Participants that registered for a winter class will receive credit for future

classes or may request a refund. The city's community centers, which includes the OASIS Senior Center, remain closed to the public.

The ActiveKids and Marina Park Preschool childcare programs will be unaffected by the closures and outdoor youth sports organizations will still be allowed to operate under current state guidelines. City parks, trails and sport courts will remain open.

The Newport Beach Public Library is also open at 20% capacity.





ian blowouts. "I never took a vacation for 24 years I went without taking vacations," said Olmedo, an Estancia High School graduate. "I had to provide for my kids, and I did it through the beauty

salon, just doing hair." Her son, Daniel Schantz, recalled growing up in the shop as the business expanded from two chairs to five and new stylists came on board. He recalled the salon as his personal childhood playground and a mainstay for Olmedo, who managed to raise three children on her own.

"That shop has been her bread and butter," Schantz said. "She was taught by the best and she truly is a hidden secret in Costa Mesa."

A steep rent increase in 2009 forced Olmedo to relocate to a small storefront in an alley off Costa Mesa's Harbor Boulevard and reopen under the name Hairsculptor.com. Specializing in blowouts, keratin treatments and wavy bal-

ayage styles, the salon has served more than 95,000 clients and has garnered high praise on *Yelp.com*.

All that came to a screeching halt in March, when businesses were forced to close as the coronavirus pandemic spread throughout California. And after forgiving rental payments owed her by her own stylists, to the tune of about \$3,500 a month and with scant revenue coming in.

The salon owner has sought assistance through a small business loan and state grant program. Last week, Olmedo said she ap-

despite some minor reprieves, like a brief flirtation with outdoor haircuts this summer, a successfully built business is now barely surviving.

A regional stay-at-home order issued by state health officials in December restricted the operations of many business sectors in Southern California but mandated the total closure of salons like Hairsculptor

Now, Olmedo said she must pay a mortgage on her Santa Ana home as well as rent for the shop, even

plied for Costa Mesa's new bridge grant program, which aims to support restaurants and personal care businesses, and is waiting for a determina-

"This is cancer — when you're not working, it's like cancer, money going out the door," she said. "The loan helped me but there's no money coming in, so this is going to run out."

Feeling the pain of his mother's financial situation Schantz, an out-of-work union carpenter, launched a GoFundMe campaign to

help raise funds for Hairsculptor.com.

It's the internet version of a Hail Mary pass in football - the hope a past client or philanthropist will understand the struggle is real and do what they can to help a local business live on but at least it's some-

thing. "At first, I was embarrassed to try something like this, but I felt I needed to do something for my mom. I'm afraid she's not going to be able to pay rent," Schantz said. "All you can do is just try and hope there's someone out there who's generous, anyone who can help."

As of Thursday night, Schantz's GoFundMe page has secured one \$20 dona-

Personal care services, which include most by-appointment operations like massage businesses, barbershops and nail salons, have been among the hardest hit during the COVID-19 pandemic.

To help those enterprises, and local restaurants forced to subsist on takeout traffic, the Costa

Mesa City Council last month approved taking nearly \$2 million from a declared disasters reserve fund to implement a new grant program for local business owners.

"The one thing businesses do not operate well in is inconsistency," Dan Inloes, the city's economic development administrator, said in a Dec. 15 council meeting. "Over the past nine months we've had to be versatile and flexible in dealing with a pandemic this inconsistency is really at the heart of what's injuring specifically these two types of business."

A self-described worka-

holic, whose family came to Costa Mesa from El Salvador in the 1960s and instilled in her a sense of pride for a job well done, Olmedo is down but not out. She will continue to look for loans and other assistance that will help the salon stay afloat.

Closing the business is just not an option.

"I'm an optimistic person. I see the light at the end of the tunnel," she said. "The vaccine is on its way, and I'm hopeful for that. I think we're going to open up soon."



Russell De Bie of Huntington Beach admired Patten's work ethic.

"He was everywhere, and it was kind of like a friendly feeling," De Bie said. "If you didn't know anybody, and let's say you just went downtown for breakfast? You knew you would run into Dano, almost anywhere you go downtown. Any car event, he was just always there."

A public memorial service for Patten isn't planned, Almas said. He encouraged people to donate to the Huntington Beach youth shelter in Patten's memory. "He gave us memories
