

# Newport-Mesa grads celebrate end of high school with parade

It was quiet Wednesday morning at the intersection of Irvine Avenue and 15th Street.

Joggers crossed. People sat on the sidewalk with foldable chairs, some holding balloons and signs with pictures of faces known to their communities but not to passing strangers. Cars moved through the intersection, rumbling past the houses and condominiums that line the street that passes Newport Harbor High School.

But then came the fire truck. Then the Noble Cause Foundation's military vehicles, Costa Mesa Police Department vehicles, Costa Mesa Mayor Katrina Foley and, finally, the Newport-Mesa Unified School District's class of 2020. seemed to disappear on the horizon.

"The kids lost so much. I think the most important thing is with a virtual graduation, the only thing that you really have is just an online experience, but it's not a very personal experience," Karen O'Mahony, a parent of a Newport Harbor graduate, said. "Tomorrow would have been their actual graduation day."

O'Mahony, along with Matt Eimers and dabout 20 other parents organized a car parade for graduating seniors that would take be them through a route that began at Newport Harbor High School and would end at Estancia High School in Costa Mesa. The Newport Beach procession, O'Mahony said, would stop at Costa Mesa High School, where its participants would then "hand off" to the next fleet. Eimers and O'Mahony joked that they wanted to include a large, prop diploma in

the hand-off, but they ran out of time. Organization for the celebration began at the beginning of June, and notice of it spread largely by word of mouth.

"We just wanted to do something more," O'Mahony said.

O'Mahony said she and others tried to appeal to the school district for a drive-through ceremony similar to those held by other local districts.

District officials did not change their plans but said high schools plan to celebrate with an informal, in-person event later this summer if state and local regulations allow for it.

# Suspect arrested in fatal crash

A Newport Beach man was apprehended in Montana in connection with a head-on collision that killed a women on the 73 Freeway last year.

The suspect in a wrong-way collision that killed a woman last year on the 73 Freeway has been arrested by U.S. Marshals after being declared a fugitive.

Luke Burnicle Fitch, 24, of Newport Beach was arrested June 11 in Whitefish, Mont., on suspicion of murder and assault with a deadly weapon, the California Highway Patrol said Wednesday.

Investigators say Fitch was behind the wheel of a southbound Mercedes-Benz on June 5, 2019, when he entered the northbound 73 near Birch Street in Newport and struck a BMW head-on.

The BMW's driver, 64-year-old Arda Gulesserian of Corona del Mar, died at the scene. The woman's nephew identified her to KTLA as Arda Melikyan and told the station she ran a company called VW Thing Parts & Restoration Specialists with her husband in Garden Grove.

A Lexus then collided with the Mercedes, but nobody in the Lexus was hurt.

Fitch was seriously injured. CHP officials said around the

## Youth sports practices allowed to resume

Huntington Valley Little League President Tim Stone finally felt a sense of normalcy for a few brief moments Tuesday evening.

Stone got out on the field to practice with his Minor A Division USC Trojans for the first time since the novel coronavirus pandemic struck in mid-March.

He said Huntington Valley is the first of the leagues in District 62 to resume practicing, after the Orange County Board of Supervisors announced Monday that youth sports practices could reopen with social distancing protocols in place.

"I got out cones 6 feet apart from each other," he said. "I told the kids, 'This is what 6 feet looks like. Notice, you put your arms out and you can't touch anybody.' That's how I started the practice, and we had a gas. I had fun. With the pain and agony of everything we've gone through, it was like, finally it's here."

The county has not released a timeline for games starting again, however. Stone said that many Huntington Valley Little League parents are unsure if they want to wait until late July or early August, when vacations may be planned.

"We don't want to force people to come back to play," Stone said. "We're trying to offer some activities for the summer, when everything has been taken away from these kids ... [but] there's a lot of people that can't deal with the uncertainty. We may have to close again before we can play games." Costa Mesa National Little League player agent Stephanie Joyce said that the league was waiting for guidance from the county, but Monday's announcement was "not good news."

"Returning to practice is great, but a Little League season is about games," she said. "We practice so that we can play games. What we've heard from the city is that the earliest we could get back on the fields was July 6, because we're in a joint use agreement with the city, our league and the schools. We have to get permits to be on the field, and we don't have permits right now because everything's closed down."

Joyce said Little League's re-

The coronavirus continues its spread through local nursing homes, passing 1,000 known cases among residents while more facilities claim outbreaks.

The Orange County Health Care Agency reported 1,003 cumulative cases across area nursing homes Wednesday of the virus that causes COVID-19. That's among 9,197 total infections overall.

Orange County Emergency Medical Services said 29 of the county's 71 skilled nursing facilities had outbreaks, defined as at least two resident diagnoses within the last 14 days, as of Tuesday, the most recent day available. The county reported 26 outbreaks on June 2, and 23 on June 1.

And deaths from the virus increased by 10 Wednesday, to 243 total. Seven of the new deaths were in nursing homes, where 124 have now died in total.

## **CLASS OF 2020 GRADUATION** Estancia High Eagles class of 2020 takes flight with watch parties

The Estancia High School Eagles with the class of 2020 took flight Wednesday, celebrating years of friendships, hardships and accomplishments as they collectively participated in a virtual commencement broadcast from their respective homes.

The ongoing coronavirus pandemic did little to dampen the spirits of the more than 650 viewers who tuned into the virtual event, which made use of prerecorded speeches, performances and live-cam peeks into the homes of students and families as they watched.

Among the virtual audience members was senior Michael Finicum, 18, who viewed the livestream broadcast in a small athome watch party alongside mom Dawn — not exactly the magnificent sendoff he'd imagined.

The pair participated in a May 26 demonstration outside Newport-Mesa Unified School District headquarters in a plea to school board members to organize some kind of in-person ceremony, as opposed to a prerecorded broadcast. When district officials cited health and safety concerns among the reasons for sticking with the broadcast, several parents began organizing grassroots efforts on their own.

One — a districtwide parade for all graduating seniors — drew hundreds of participants, including Costa Mesa city officials, from Newport Harbor Elementary School to Estancia. Finicum and his friends rode in a decorated Jeep representing their school.

"We wanted a moment that we could all remember, where we could all be together," the teen said of his participation in the protest. "[The broadcast] is an attempt for Estancia to try and show their appreciation for their students, and that's really the best they can do."

In remarks made from his home, Estancia Principal Michael Halt offered three pieces of advice for soon-to-be graduates.

"Continue to challenge yourself by always working to the best of your abilities, love with all your heart and vote in every election," he said. "These three simple things I'm convinced are the keys

## Bryant pilot said weather 'should be OK,' NTSB says

The night before Kobe Bryant's fateful final helicopter trip, the broker arranging the former Lakers star's flight to Thousand Oaks expressed concern to the pilot that "weather could be an issue.'

The next morning, on Jan. 26, the pilot, Ara Zobayan of Huntington Beach, assured the broker and Bryant's personal drivers that the weather conditions "should be OK," according to text messages made public on Wednesday by the National Transportation Safety Board.

An hour and half later, Zobayan, Bryant, his daughter Gianna and six other people on board the helicopter were killed when the craft plunged into a fogshrouded hillside above Calabasas. Bryant and his daughter lived in Newport Coast.

The text message exchanges are among the findings in 1,700 pages of documents released by federal regulators Wednesday. The documents draw no conclusions about the cause of the crash and will be followed by a final report.

A preliminary report in

February said there were no signs of engine failure, meaning the chopper didn't lose power before it hit the hill. The NTSB noted that videos and photos from the public "depict fog and low clouds obscuring the hilltops." The preliminary report repeatedly noted that the pilot had struggled with a low cloud ceiling.

A witness on a mountain bike trail told investigators that the area was "surrounded by mist" and that he heard the sound of a helicopter and saw a blue and white chopper emerge from the clouds, passing from left to right.

time of the crash that the Mercedes was speeding on the freeway at more than 100 mph before slamming into the BMW, and troopers were investigating whether Fitch intentionally sped into the northbound lanes. Troopers also said witnesses called authorities shortly before the crash to report a silver Mercedes that was driving erratically on city streets.

"Based on the way he drove onto the freeway, we have to treat it as if it looks like an intentional act," CHP Sgt. Todd Kovaletz said at the time.

According to Orange County Superior Court records, a warrant was issued for Fitch's arrest on June 4 on one count of murder

This puts 11% of coronavirus cases and 51% of related deaths in nursing homes, where typically elderly people in frail health live in close quarters. With Wednesday's update, about 12% of nursing home coronavirus patients have succumbed. That compares to a fatality rate of about 1.5% among the general population diagnosed with COVID-19 and not living in nursing homes.

In other general coronavirus metrics Wednesday, reported hospitalizations were at 328 with 131 in intensive care, while estimated total recoveries increased to 4,414.

The county also reported 1,134 additional tests over Tuesday, bringing Orange County to 193,405 total tests given. Daily updates are preliminary and subject to change as the county receives new information.

"They're all so anxious," Martinez said. "Everything's difficult, but we're trying to take all of the precautions they're asking us to ... Really, coaching becomes that much more essential. You have to be that much more prepared and ready, in all

sports, not only football. Those that really have a program will still be successful. Those that don't, it's going to be tough. You have to make sure everything is well-organized. Once they give us the go, you're not going to have that much time."

Prime Volleyball Club director Jessica Papell said her club began individual and small group training this week. The club is based in Laguna Niguel and Ladera Ranch but has drawn athletes from Newport Beacharea schools, including Sage Hill alumni Jade Blevins and Amiyah De'Long, now at Cal and Stony Brook University, respectively.

"It's nice to get back in the gym with them on a limited basis," said Papell, also the girls' volleyball coach at San Juan Hills High. "We're trying to offer a bunch of summer training, to kind of make up for the training the kids missed over the last three months."
