Charitable giving made easy

Bright red Giving Machines at Pacific City, the first in Southern California, allow visitors to donate 30 different items in support of a variety of charities.

Three Giving Machines opened during a launch event mall in Huntington Beach. They'll be there through Dec. 17, when they move to Dana Point Harbor from Dec. 19 through Dec. 29.

Lawsuit filed against voter ID proposal

A former Surf City planning commissioner says a potential charter amendment in H.B. violates elections code.

Plenty of people have questioned a proposed Huntington Beach charter amendment that will be on March's primary ballot that would require voters to show identification.

One Surf City resident has now taken it to court.

Mark Bixby filed in Orange County Superior Court last week challenging the potential amendment, which he says would violate both the California Constitution's right to vote and the California Elections Code.

Bixby, a former Huntington Beach planning commissioner, publishes the Surf City Sentinel.

"Imposing a Voter ID requirement in city elections is not just a terrible idea that will undermine confidence in local elections, but is a clear and blatant violation of the state constitution, the state elections code and basic funda-mental rights," Bixby said in a statement. "The City Council has ignored state officials, public interest groups and its own residents in proposing this measure. What is worse is that there is no basis for this requirement. De-

Homicide victim likely related to suspect

Accused in of killing H.B. 48-year-old woman on suspicion resident, 78, once had the same last name.

A woman whose body was discovered inside a Huntington Beach home the morning of Nov. — prompting the arrest of a 17

of murder — has been identified, officials reported.

Orange County Sheriff's Department spokesman Sgt. Mike Woodroof said Tuesday the coroner's office had identified the decedent as Sondra Lee Pettner, 78, of Huntington Beach.

The listed homeowner at 6032 Tyndall Drive, where the incident took place, Pettner appears to be related to suspect Christine Ann Lamphier, a self-described nurse taken into custody by Huntington Beach police.

Lamphier is being held in jail on \$1 million bail and is scheduled to appear in court on Dec. 12 for an arraignment and bail review hearing. Prosecutors allege her offenses involved "great

bodily harm, threat of great bodily harm and other acts disclosing a high degree of cruelty, viciousness and callousness.

Court records indicate that Lamphier has also gone by the name "Christine Ann Pettner." An online genealogy site references an April 1996 wedding cer-

Sewage spill shuts down Laguna coastline

An estimated 94,500 gallons of sewage resulted in closure from Laguna Avenue to Blue Lagoon on Wednesday.

A sewage spill amounting to an estimated 94,500 gallons resulted in the closure of a significant portion of the Laguna Beach coastline on Wednesday.

Orange County Health Care Agency officials opted to close the beaches from Laguna Avenue to Blue Lagoon in response to the spill. The decision was made by the agency's environmental health division.

The incident occurred due to a "break in a force main sewer line," per the agency. Laguna Beach public works had been performing routine maintenance on the line overnight.

"It's an aging sewer system,

Pro-Palestine rally draws dozens to Laguna Beach

A pro-Palestinian rally drew a crowd of 80 to 100 demonstrators to Main Beach on Sunday, authorities said.

The demonstration took place between 3:30 and 7 p.m.

Laguna Beach police at the scene made one arrest on suspi-

cion of assault and resisting and delaying an officer, Lt. Jason Farris said.

One of the demonstrators held a sign with the likeness of the flag of Palestine, inscribed with the words "end genocide."

In its meeting on Oct. 24, the Laguna Beach City Council adopted a resolution condemning acts of terrorism against Israel and urging both sides to end the humanitarian crisis.

The council took the action following the Hamas attacks on Israel on Oct. 7, which left at least 1,200 people dead.

Mayor Bob Whalen noted there have been two pro-Palestinian rallies in the city this

month, including one on Nov. 12 and the latest on Sunday.

Whalen said he did not believe the demonstrations were related to the resolution, noting that there had been similar rallies elsewhere in the county. He added that Main Beach often sees

Suspect in Fountain Valley stabbing, 23, charged with murder

The victim of a purported stabbing either late Thanksgiving or early Friday was identified by Fountain Valley police as 32-year-old Lorenzo Carreno of Santa Ana.

In an initial statement Friday, authorities said they responded to calls of a possible stabbing in the area near Edinger Avenue and Newhope Street at 12:33 a.m.

Upon arrival, police discovered the victim, Carreno, with multiple stab wounds and delivered first aid before transporting the victim to a nearby hospital. He later died of his injuries, and police identified David Michael Mac-Donald as a suspect in the matter.

MacDonald, 23, of Huntington Beach, was arrested at the scene. Authorities said MacDonald self-reported the incident to the police.

Court records Tuesday indicate that MacDonald is charged with murder and faces an additional sentencing enhancement for personally using a deadly weapon, but he has not yet entered a plea. Police said the incident appears to be isolated, and there is no ongoing danger to the public. A makeshift memorial had been placed along the sidewalk due west of Karen Avenue near the intersection of Edinger Avenue and Newhope Street. It included a cake marking a 33rd birthday, candles and flowers. Carreno would have turned 33 on Monday, according to authorities.

spite claims by election deniers, there has been no documented voter fraud in Huntington Beach, and yet the City Council majority has continued to lie to the public about voter fraud and come up with illegal schemes to suppress the vote."

The city's charter has not been changed since 2010. The council held four special meetings regarding charter amendments this fall and came up with three possible amendments that will be decided by the city's voters in March.

Charter Amendment Measure 1 states that Huntington Beach may require voter identification for elections, provide more in-person voting locations and monitor ballot drop boxes for municipal elections beginning in 2026.

The crux of Bixby's petition for writ of mandate against Huntington Beach City Clerk Robin Estanislau and Orange County Registrar of Voters Bob Page, filed on Nov. 22, is that requiring voter IDs violates state law and exceeds the city's authority, while also resulting in discrimination against senior citizens, voters with disabilities and minorities. recent protest on the social media platform TikTok showed a bus in which some of the protesters had arrived being towed. Additional vehicles displayed Palestinian flags as they drove past.

California," said Bixby's attorney, Lee Fink, in an interview Tuesday. "It is not a municipal affair ... and the city has just plunged ahead with it. I assume that they've been expecting to litigate this, and so now it's upon them."

The formal argument in favor of Charter Amendment Measure 1, written by Mayor Tony Strickland and Mayor Pro Tem Gracey Van Der Mark, states exactly the opposite. It says that the state's constitution gives charter cities like Huntington Beach the power to govern their own local elections.

"It is crucial for our democracy that voters have faith in our election results," the argument reads. "That trust in the outcome of elections comes into question when we can't always be certain who is voting."

Thirty-six states request or require voters to show identification at the polls, but California is not one of them.

"What we have, despite all sorts of imagined harms, is that there's never been any serious issue of in-person voter impersonation that voter ID would solve," Fink said. "It's all ginned up outrage that's false." Bixby's suit actually seeks to throw out the second

Fire & Ice Festival kicks off at the Dunes

This year the annual lighting of the bay at Newport Dunes Waterfront Resort & Marina looks a little different. The opening night celebration that kicked off the holiday season the day after Thanksgiving added the Fire and & Ice Festival for the first time.

"It was really fun. I'm glad they decided to implement the rink this year,' said Wegner. "The Christmas music adds to the fun of it.

During opening night, skaters of all ages and abilities enjoyed the rink in part thanks to the skating aid accessories like Bobby the Seal and Tommy the Reindeer.

Among the 2,700 attendees was Laguna Beach resident Kristie Hensley, who brought her two daughters, Kendal, 8, and Charli, 6. "I'm so excited

about it, this is our first time here," said Hensley. "I get emails from the Dunes, and I booked the ice-skating tickets online a month ago.'

As for the "Fire" festivities, portable fire pits are scattered throughout the facility with "S'more kits" available and accompanied by hot chocolate. and so we go in and do these kinds of routine maintenance repairs all the time," Mark McAvoy, the city's director of public works, said in an interview with KTLA on Wednesday. "We tend to do them at night when the system is at its least use, and unfortunately, equipment failure caused this spill to happen."

Mayor Bob Whalen said the sewer line was "fully repaired, shut down and cleaned up" by 8 a.m.

Whalen recalled a 1.4million-gallon wastewater spill that originated from the city sewage system in 2019, and he was glad to hear that the more recent incident was "fairly minor by comparison."

Laguna Beach reached a \$1.5-million settlement agreement with the San Diego Regional Water Quality Control Board following the larger spill that oc-curred over Thanksgiving weekend four years ago.

County health officials have closed off the impacted waters to swimming, surfing and diving until water quality testing

shows that "acceptable standards" have been met.

"I strongly urge Laguna Beach residents, visitors and tourists to heed the warnings of public health experts and avoid the beach," Orange County Supervisor Katrina Foley said in a statement. "I am monitoring the situation to ensure we protect public health and our beaches.

"The Health Care Agency will continue testing the water to determine when the beach is safe to reopen.'

proposed charter amendment, regarding which flags can fly on city property. Fink said the full language of the two amendments themselves was not posted for public examination until Nov. 21, the second-tolast business day of the public examination period required by statute, due to a claimed clerical error.

Huntington Beach City Atty. Michael Gates said Tuesday that he doesn't believe that would be an issue because the 10-day period could start Nov. 21 and still conclude before the Registrar of Voters deadline.

Gates added that he disagrees with Fink and that cities do have local authority that trumps state regulation. The argument is similar to one he made in a federal housing case, which was dismissed earlier this month, though the City Council voted 4-3 to authorize Gates to appeal to the Ninth Circuit.

"All you have to do is gather information about what other cities are doing for their elections, and you see that so many cities have their own sets of rules,' Gates said. "Having voter ID and requiring voters to show ID, as a proof of residency or proof of being registered to vote, it's basic and

it's permissible under the law ... There's a lot of saberrattling and tough talk out there about how what Huntington Beach is attempting to do is illegal, but nobody has offered any proof under the law that what we're preparing to do is illegal."

But Fink said that a voter is clearly defined by state law.

"The city would have to administer an election itself, separately, and you're talking about having a county and statewide election at the same time," he said. "It's a huge cost, and it's a huge confusion. You're supposed to vote twice in November? That literally goes against everything we've ever been taught about democracy, and yet that's the system that the city would have to create in order to implement this unlawful concept."

Fink said that Bixby is seeking an expedited schedule for the current lawsuit.

Fink represented Bixby and former Mayor Connie Boardman when they filed suit in June to stop Surf City from beginning the payment of a multimillion-dollar settlement with Pacific Airshow operator Code Four. That suit was ultimately unsuccessful.

Sisters charge into CIF Individuals semifinals

Huntington Beach High senior Yen Nhi Huynh-Nguyen and junior Le Nhi Huynh-Nguyen looked to some special supporters in the stands as they neared the finish line Wednesday afternoon.

Oilers girls' tennis teammates Cecelia Pham, Jolie Wang and Cora Garrard cheered and displayed homemade signs at the CIF Southern Section Individuals Tournament.

The Huynh-Nguyen sisters just grinned. They appreciated the support.

"I love them a lot," Yen Nhi said after the match. "Usually, they don't come to Individuals but they came to the pre-qualifiers [last week]. They asked my coach if they could come, and she cleared it with the athletic director so they could come."

The team atmosphere is not so common at CIF Individuals. But the Oilers are a close-knit bunch, and the sisters are in the midst of what could be a historic run.

They easily won their round of 16 and quarterfinal matches Wednesday at Biszantz Family Tennis Center to book a spot in Thursday's semifinals. Yen Nhi and Le Nhi beat Rihana Ford and Mia Humiston of Brentwood 6-0, 6-1 in the round of 16, then downed No. 4-seeded Cassie Blakey and Ava Min of Palos Verdes 6-2, 6-2 in the quarterfinals. They will play top-seeded Haley Tran and Chloe Vu of Mater Dei in the semifinals Thursday at 11 a.m., with the title match to follow.

No Huntington Beach High girls' tennis singles player or doubles team has ever made a title match at the CIF Individuals. The oldest Huynh-Nguyen sister, Cindy, was part of the Oilers' only team CIF crown in 2018.

Yen Nhi and Le Nhi, the Surf League doubles champions, look like they could be title contenders this year. For Yen Nhi, making the semifinals was a bit of a breakthrough as she lost in the singles quarterfinals the last two years.

"We played well together today," she said. "[Playing together] was a last-minute decision. We thought we would both play singles, but it's my last year. If she wants to play singles next year, then she can play singles. Since I'm a senior, we might as well play doubles."

The Mater Dei semifinal opponent will be formidable. Vu won last year's CIF doubles title with graduate Natalie Lynch, while Tran got to the quarterfinals with partner Athena Wardy.

"I think it'll be a good match," Yen Nhi Huynh-Nguyen said. "They're both really solid players. They hit strong, they serve strong and they're good in volleys."

Wednesday. Lew lost there to Natalie Kha of Ayala, 6-1, 6-0.

Kha, a left-hander, played aggressively and the Palomares League champion dictated the action.

"I felt like I couldn't really be on defense," Lew said. "Whenever she got me off the court, I would hit a defensive ball back and she would just hit a winner off of it. Even if I hit a deep, defensive ball she could just smack a winner."

Still, it was a nice run for Lew, who finished third in the Surf League singles tournament but eventually got into CIF Individuals as an alternate. Last year, she missed much of the season with a right wrist injury.

The machines are on the ground floor of Pacific City, near the giant Christmas tree, and will operate from 10 a.m. to 8 p.m. each day.

"We get to come together and be able to impact the world," said Tia Stokes, a social media influencer who attended Tuesday night's ribboncutting ceremony at Pacific City. "Moms, we don't even have to think what we need to do for service for the holidays. We just have to walk right over there, right? Make it a tradition with your families to give back to these amazing foundations that are out there to help us serve our world today.'

Each of the machines has cards with pictures of items that represent different charitable gifts — from therapy dogs and wool blankets to groceries and safe birth for a mom. The cards also identify the charity that will benefit. The machines accept

credit and debit cards, and the gifts cost as little as a few dollars each. When the purchase is made, the card drops and is held in the machine to show what donations have already been made.

Local organizations with gifts in the Giving Machines include Children's Hospital of Orange County, the Pacific Marine Mammal Center, To Ukraine with Love, the Ocean Institute and the Boys & Girls Club of Central Orange County. UNICEF, Church World Service and WaterAid are the international charities with cards in the machines.

The machines are sponsored by the Church of Jesus Christ of Latter-day Saints, which will handle any associated costs and ensure that 100% of the money donated goes to the benefiting nonprofits. Santa Claus himself made



the first purchase at Tuesday's event, purchasing one of every item in one of the machines for more than \$1,700.

"The nice thing is, you can pick whatever resonates with you," said Pacific Marine Mammal Center CEO Glenn Gray, adding that the center has items from fish and "healing seals" to camp and educational benefits in the machines. "That's what's beautiful about our organization and the way it's represented here — there's something for everybody to pick from."

Tuesday's ribbon-cutting ceremony was emceed by longtime Los Angeles television anchor Chuck Henry. Huntington Beach Mayor Pro Tem Gracey Van Der Mark briefly addressed the crowd, which also heard music from country music artist Cosette Smith.

Smith knows the importance of giving to the local organizations firsthand. She said she had her first son during the coronavirus pandemic but had to take him to CHOC when he had laryngitis and food poisoning at just two days old. "They took amazing care of us, and they saved my son's life, really," she said. "I'm grateful to be here today to give back in some way."

Stokes, whose five children and husband also were present at Tuesday's event, also dealt with adversity during the pandemic. She was diagnosed with acute myloid leukemia in 2020.

"When the world was shut down, I kissed my kids goodbye and went to the hospital to fight for my life," she said. "I call it an opportunity — not an obstacle, not a trial, but an opportunity — because it gave me the chance to be able to spread light in such a different time. The world came to me. People impacted my life ... Together, as a community here, we get to turn around and give it back to those who are in need today."
