# Judge allows job title on H.B. ballot

An O.C. Superior Court judge dismissed a petition challenging Scott Field's designation on the November ballot.

Former Huntington Beach Deputy City Atty. Scott Field will be able to list that deputy attorney job designation on the ballot as he runs for city attorney this fall, an Orange County Superior Court judge ruled Wednesday.

Judge Craig Griffin denied a petition for writ of mandate filed by former Huntington Beach planning commissioner Michael Hoskinson.

Hoskinson had filed the suit against Orange County Registrar of Voters Bob Page on Aug. 19, requesting that he remove any reference to Field's prior title from his ballot designation. He claimed that Field listing himself as deputy city attorney, despite being retired for several months, violated the spirit of the election rules.

But Griffin disagreed in a brief virtual hearing.

"Because [Field] held the position of city of Huntington Beach deputy attorney at some point during the time period from Jan. 1, 2021, to Dec. 31, 2021, he was entitled to use that title on his ballot designation," Griffin wrote in his ruling.

Hoskinson's lawyer, Matt Price, had argued that Field last served as deputy attorney in May 2021, around the time that Field and former deputy attorney Neal Moore settled a \$2.5-million age discrimination case against Gates

# Initiative to spur Costa Mesa development, housing to go before voters as Measure K

An effort to exempt certain commercial and industrial corridors in Costa Mesa from the mandates of a 2016 initiative requiring voter approval for development projects seeking an excess of entitlements will appear on the November ballot as Measure K.

Supporters claim the new measure will remove some of the hurdles that have historically stood in the way of building projects that could have increased the city's housing stock.

Opponents, including a contingent of residents who worked to pass the voting requirement six years ago, warn opening the floodgates to developers without an established mandate of affordability will do little to help the housing crisis.

Voters will be asked in November which course to take, meaning both sides have two months to make their cases before the pub-

# Witness testifies in 2019 H.B. homicide case

Witness testimony says defendant involved in Huntington Beach shooting owed the victim \$60,000 in debt.

A former criminal justice student accused in a shooting in Huntington Beach that left a man dead three years ago owed about \$60,000 in gambling debt to the victim, according to evidence and testimony presented in court Thursday.

Dennis Tri Gia Dang faces one count of murder in connection with the killing of Fountain Valley resident Linh Ho. Ho was 48 when he was found lying wounded in the parking lot of a strip mall at the corner of Warner Avenue and Magnolia Street on Oct. 20, 2019, and later died at a hospital.

The victim ran a sports gambling operation and Dang worked as a middleman for him, said 34year-old Midway City resident Casey Ngo, a longtime friend of the defendant who took the stand on Thursday, during the second day of the murder trial.

Ngo had been arrested as a suspect in the case but later provided a statement to investigators and has not been charged in Ho's homicide.

Dang was attending UC Irvine at the time. In a recorded statement played in court, he said he was managing the bets of several gamblers who owed money to Ho.

# Vanguard University welcomes new V.P. of academic affairs and provost

The crowd remained standing for a moment Thursday morning, listening to Ryan Hartwig speak.

"I'm feeling a bit overwhelmed at the moment," he said, before noticing the Vanguard University faculty and hundreds of students present were still on their feet after he was introduced.

"Oh yeah, you can sit down," he added with a

smile before going into his speech. "If I've learned anything over the years, it's that God writes the best stories.'

The latest chapter for Hartwig was celebrated Thursday. He was installed as Vanguard's new vice president of academic affairs and provost.

In his new role, Hartwig, 44, serves as the chief academic officer for the private Christian university. He will provide leadership for all faculty and academic services and programs, including the undergraduate college, graduate and professional studies, academic centers and institutes, the

registrar and library. Hartwig reports directly to Vanguard President Michael Beals.

Hartwig, who began serving in his new position in June, was most recently the dean of the School of Humanities and Social Sciences at Colorado Christian University. He also worked an administrative role at Azusa Pacific University.

"There's a real poising for growth as we move forward," he said in an interview following the installation. "It's kind of fun for me. It feels like my arrival and my appointment here kind of coincides with some really cool institutional momentum that's

The victim held the defendant responsible for those debts, which totaled about \$60,000, Ngo said.

Dang became noticeably distraught in the two weeks leading up to the shooting and was asking friends for loans, Ngo testified. The morning before the killing, the defendant received a text instructing him to pay by Sunday, according to the defendant's recorded statement. It included the phrase "... or else you can't blame me for what happens you," the witness, to roughly translating from Vietnamese, recalled.

Orange County Deputy

Dist. Atty. Janine Madera noted there were no explicit threats of violence in any of the messages Dang received about the debt and Ho was a friend of Dang's father.

"I couldn't imagine Dennis doing anything to him [Ho] and him doing anything to Dennis because they had a good relationship with each other," Ngo said Thursday.

Dang asked Ngo to accompany him that October Sunday to a meeting with Ho at Pho Lovers, a Vietnamese restaurant near the scene of the shooting. He was supposed to pay off the debts but only had about \$2,000 at the time, the defendant said in his recorded statement.

According to the testi-

mony, Dang changed clothes at his home and collected a black bag containing the money he planned to give Ho, and then drove with Ngo to the meeting location. They parked the defendant's white Toyota Camry in the back lot of the shopping center.

The defendant was seen in footage recorded by multiple surveillance cameras getting into Ho's silver Cadillac Escalade at about 12:10 p.m. Over the next 60 seconds, a bright flash is seen from the interior of the SUV before Dang exits the SUV and bolts toward his car.

While this was taking place, Ngo had moved to the driver seat of the Camry and had fallen asleep. He was awakened by the gunshot, then saw Dang running toward him. The defendant told his friend to "just go" and changed clothes again in the car as they drove to Ngo's home. Following the shooting,

Dang told Ngo that Ho "was tripping on me, and I shot him," the witness said. "I remember telling him

he's an idiot," Ngo added. As the defendant and witness fled the scene of the shooting, Ho was seen stumbling out of his Escalade moments before col-

lapsing onto a patch of grass in the parking lot in footage shown in court Thursday. Several members of the victim's family who were present as the video was played left the room in

tears before it ended.

A single bullet casing was found wedged into the passenger seat of the Escalade, and a round was found behind a punctured interior panel near the driver-side door, Corrie Stark, a forensic investigator with the Orange County Crime Lab, during testimony. said However, no firearm was found in the vehicle or during a search of the suspect's home, Huntington Beach Police Detective Jason Burton said from the stand Thursday.

The defendant's state of mind at the time of the shooting may be a key factor in deciding the outcome of this case, Judge Richard King told attorneys during a brief break in proceedings

on Thursday. Madera repeatedly noted that Dang never stated that he feared for his physical safety, and Ngo said he appeared "worried," "distraught" and "not all there" that morning but not fearful. However, defense attorney Ricardo A. Nicol argued that the defendant's actions showed that he was "obviously scared," even if he never explicitly said so.


Dang's trial resumes Tuesday at 2 p.m. in Department C45 of the Superior Courthouse in Santa Ana. It is expected to conclude by either the end of next week or the beginning of the following week.



# Local authorities to boost patrols, DUI checkpoints for Labor Day weekend

As people flock to the beaches this holiday - which coinweekend cides with the start of Pe-local police agencies are beefing up their patrols and preparing checkpoints to catch drivers who are under the influence of drugs or alcohol.

In Newport Beach, police conducted a DUI checkpoint on Aug. 18 and reported Friday that seven of the 602 vehicles that passed through were cited by motorcycle officers for a variety of vehicle coderelated charges.

Two individuals were arrested on suspicion of driving under the influence. The drivers of 162 of those 602 cars were contacted, assessed and provided education on driving under the influence.

happening right now, too." Vanguard has its largest incoming undergraduate class ever, with 650 new students roaming the halls. Vanguard senior director of external relations David Vazquez said that 53% of the incoming class is Latino, and first-generation college students comprise half the class.

"I feel like it's a new start," Martinez said. 'We're the biggest incoming freshman class and it's

Police Department's traffic division, said it's difficult to ascertain how often officers are called for DUIs but noted they happen all over the city.

"We get called on a regular basis as people report drivers who they believe may be under the influence based on their driving," said Wolik. said "Sometimes it is just distracted driving, due to either cellphone use [or] inattention. It could be that someone is tired or distracted by others in the vehicle.

"We take driving under the influence very seriously here in Newport Beach and we work very hard to get impaired drivers off the street," Wolik continued. "When we do checkpoints ... we try to cover the entire city so that people don't know where or when it's coming.'

Wolik said that from

really cool just seeing everything start, just a fresh start.'

Beals said it's important to stay connected with the neighborhood in which Vanguard is situated.

"We look at ourselves as educating our region," he said. "We look to match the demographics of our region, and accessibly and affordability are critically important to us."

Beals said the university underwent a nationwide search to find its new vice president of academic affairs. He was not on the search committee, though he did make the final decision on Hartwig, who is a married father of four children.

Vanguard, which held its first day of the 2022-23 school year on Monday, January through the end of July 2021 there were 96 DUI-related collisions reported in Newport Beach. During that same period this year, 98 such collisions were recorded.

Wolik confirmed there would be additional patrols out this weekend to look for drivers suspected of driving drunk or under the influence of drugs.

The same is true in the neighboring cities of Huntington Beach, Costa Mesa, Fountain Valley and Laguna Beach, according to their respective police departments.

Costa Mesa police said checkpoints are typically determined by data showing incidents of impaired driving-related crashes.

Authorities say the point of checkpoints is not to cite or arrest but to educate.



# lic. Officials recently posted information on Measure K to the city's website, including arguments for and against the plan that will be

printed and disseminated to voters ahead of Election Day. A City Council ad hoc committee on housing drafted the ballot language for the measure as well as

supporting arguments, in which they claim the earlier initiative, Measure Y, made it costly, difficult and risky for anyone to build new affordable residential units.

"Housing has been a primary issue we've been discussing since the first meeting of my first term," said Councilwoman Arlis Reynolds, who served on the ad hoc committee. "Doing nothing is not an option. We're here to repre-

sent the people of Costa Mesa, and 50% of people are concerned about housing, so we've got to address it.

Members of the political action committee "Costa Mesa First," who wrote Measure Y and put it on the ballot in 2016, said citizens at the time were fed up with the council approving housing projects that impacted neighbors and cost too much for residents to afford.

"We were trying to give input to the City Council and were basically ignored," longtime resident and Y co-author Cynthia McDonald said Thursday. 'Now, we're six years down the road and some of the dissatisfaction is still there." Too few affordable hous-

ing units have been built in recent years - on that, both sides agree. But while council members blame the stringency of Measure Y, its authors point to the

city's failure to pass a housing ordinance requiring housing projects to include low-income units.

Measure K's language says the initiative will encourage the development of affordable housing for working and middle class families, while revitalizing commercial areas.

"We can address the current housing needs and start to invest in the way Costa Mesa residents really want us to," Reynolds said of the measure.

But Jay Humphrey, a former City Council member (1990-1994) who helped pass Measure Y, says while the ballot language makes reference to building projects that comply with a council-adopted affordable housing ordinance, such an ordinance doesn't yet exist.

# Newport Harbor shows resilience in five-set defeat to Orange Lutheran

RANCHO SANTA MARGARITA — Familiar faces can be found all over the court for the Newport Harbor High girls' volleyball team.

After earning the top seed in the CIF Southern Section Division III playoffs and making a run to the quarterfinals last season, the Sailors believe they have the pieces to put together a memorable season.


The Trinity-Sunset League Showcase is one way the Sailors planned to test themselves in battle, and Newport Harbor acquitted itself well in a showdown with Orange Lutheran.

Senior outside hitter Anabel Kotzakov had a team-leading 19 kills, but Newport Harbor fell to Orange Lutheran 25-20, 19-25, 27-25, 17-25, 15-11 on Thursday in the showcase event at Santa Margarita High.

Senior outside hitter Paige Buzzerio had a match-high 21 kills for Orange Lutheran (9-3). The Naval Academy commit, now 18, celebrated her birthday with a five-set victory for the second straight season. The Lancers also beat Foothill in a five-setter on her birthday the season prior.

"One of the things we're working on is our demeanor because we tend to have a lot of ups and downs," Buzzerio said. "In that third set, we were up by a lot, and then we kind of started to dip. I think that's one of the biggest takeaways because we just need to stay composed the whole time."

Buzzerio and Kotzakov traded blows — each picking up five kills in the first set — but it was

the Lancers that claimed the early advantage after the first game.

A seven-point run with Tegan Glenn at the service line bolstered Newport Harbor in the second set, helping the Sailors draw even at a set apiece.

Height in the front row paid dividends for the Lancers in the third set, four blocks staking Orange Lutheran to a 22-16 lead. The Sailors rallied behind the play of Drue Coberly and Laine Briggs. Coberly had consecutive service aces to cut the deficit to 23-20, and Briggs also had backto-back kills to stave off set points. Kotzakov dropped in a roll shot to tie the score at 24-24. Senior outside hitter Londyn

Giles, who finished with 11 kills and three aces, provided two kills after that point to help the Lancers close out the third game.

"I just think it's a great opportunity for us to play a private school," Briggs, a Pepperdinebound outside hitter, said of competing in the Trinity-Sunset League Showcase. "I think it's a fun opportunity. The drive down here is insane, but it's worth it. It's really fun."

Again, Newport Harbor (4-2)

answered after falling behind, the Sailors easily claiming the fourth set with balanced contributions. Senior middle blocker Malia Thorne and Briggs each had four kills in the set, while Kotzakov added three kills and her lone ace of the match.

Newport Harbor coach Andrew Mabry said the Sunset Conference is full of tough teams, adding that the Sailors want chances to measure themselves against top competition.

"That's what this group has shown the whole season so far — a lot of resilience," Mabry said. "It's one of our themes. That's something that we're talking about every day, and we're showing it.

"Sometimes, you put that work in, [and] you're not always rewarded with the result right away. Many times in that match, we fought our way back and continued to push and try and fight for a result."

Unable to keep the momentum, Newport Harbor dropped the fifth set and the match. Sophomore opposite Makalin Goehring, who had four total blocks, figured prominently in the Lancers' fortunes, supplying three kills and a block in the final frame.

Junior middle blocker Zoe Gaa had seven kills and a block for Newport Harbor. Coberly finished with 31 assists and five aces, while Glenn tallied 16 assists, three aces and two kills.

Lilly Underwood handed out 20 assists for Orange Lutheran, and Naila Ia had three kills and two total blocks.


