The wait is ogre: 'Shrek the Musical' comes to local stage

A new production company will host six shows beginning Thursday night at Huntington Beach High School.

Collin Higgins has been in youth theater since he was 5 years old.

After graduating from Dwyer Middle School, the incoming Huntington Beach High freshman was looking for a production to perform in. He and a couple of friends had acted in the Marina High production of "Matilda" in February.

But some of his usual performance troupes were no longer raising the curtain.

'With COVID, some of the smaller theaters have shut down and never come back," said Higgins' mother, Kelly Scotten. "He wanted to do something this summer, and he's been working with this team of directors for six years. I thought that the cheerleaders can do a junior cheer camp, basketball teams do junior basketball, so why can't we do a youth theater program to raise money for the high school theater program at Marina?'

Marina Youth Theatre was formed last spring. Three months later, the group is ready for its first production.

"Shrek the Musical" (music by Jeanine Tesori and book and lyrics by David Lindsay-Abaire) debuts Thursday night at Huntington Beach High, and continues with six shows through the weekend. Tickets are available on tix.com or at the door.

As Scotten intended, the money raised will be earmarked to support the well-regarded Marina High program.

Nonprofit rewards aspiring young investors

The Youth Investors Corp. nonprofit has grown rapidly since Huntington Beach native Dylan Jin-Ngo founded it three years ago.

More than 650 Southern California children have now participated in the free, five-week educational course that stresses financial literacy.

The final week of the fourth and largest session concluded Wednesday — and one local participant walked away a bit richer.

Phoenix Noguchi of Huntington Beach, 12, was surprised at the Huntington Beach Central Library as one of three \$500 grant recipients for this year's summer program.

The program, which includes a simulation stock market aspect, expanded to Santa Barbara County this summer. The partnership with the Huntington Beach Public Library was also

Private jets are focus of initiative at JWA

'Fly Friendly' aims to promote good actors in effort to reduce noise. environmental effects of noncommercial flights.

A new effort at John Wayne Airport aims to make the skies a little friendlier for the environment and for nearby Orange County residents by incentivizing private jet operators to take quieter routes and engage in sustainable practices.

Airport officials joined with county leaders in a news conference Wednesday to announce the launch of "Fly Friendly," a datadriven initiative that will monitor and score participants on their flight behaviors and engagement in community efforts related to sustainability and aviation im-

"Fly Friendly is an education and outreach program designed to minimize noise and environmental impacts from general aviation, or private use, jet aircraft," airport director Charlene Reynolds said. "[JWA] will celebrate operators demonstrating the highest level of commitment to this program through an awards initiative.

Orange County Supervisor Lisa Bartlett, whose District 5 shares part of JWA's territory with District 2, represented by Katrina Foley, explained several officials and aviation industry associations collaborated in a working group to develop the campaign. She encouraged private jet operators to volunteer for the program.

"It's important for the pilots to remember that when they fly in and out of John Wayne Airport, they're not just landing at the airport, they are entering our beautiful community," Bartlett said.

Arrests made in N.B. street racing operation

Officials stopped 206 vehicles and cited 177 with alleged violations.

Three people were arrested over the weekend as part of a joint traffic enforcement operation in Newport Beach, according to a news release issued by police offi-

The Newport Beach Police Department collaborated with the Seal Beach, Huntington Beach, Laguna Beach, Santa Ana police departments and the California Highway Patrol. Two referees from the California Bureau of Automotive Repair also participated in the operation, which was aimed at street racing and vehicles with loud or modified exhaust systems.

Officials reported 206 vehicles were stopped, and 177 of them were cited for vehicle violations. About 16 were inspected on site by the California Bureau of Automotive Repair, and one was cited for exceeding 100 mph.

Lt. Eric Little of the Newport Beach Police Department's traffic division said officers have seen an increase in the number of vehicles either street racing or with loud exhaust systems on the road since the onset of the pandemic



Pedestrian struck by car Tuesday in Huntington Beach in critical condition

A pedestrian is in critical condition after being struck by a vehicle Tuesday night near Beach Boulevard and Talbert Avenue.

Huntington Beach Police Department spokeswoman Jessica Cuchilla said an emergency call was logged at 10 p.m. regarding a collision between a vehicle and a pedestrian.

The car — a silver Chevrolet Spark — was traveling southbound on Beach Boulevard on a green light when the pedestrian was allegedly crossing the street against the signal.

The pedestrian, whom police have not identified. was transported to a local hospital and remained there as of Wednesday afternoon.

Cuchilla said officers shut

down all southbound lanes on Beach Boulevard between Newman and Talbert avenues.

Those lanes were reopened shortly after midnight Wednesday morning. Cuchilla said an investi-

gation on the collision is ongoing, but alcohol does not appear to be a factor.

F.V. police arrest 1, seize guns, drugs, cash from Orange home

A 30-vear-old resident of Orange was arrested Aug. 11 after Fountain Valley police officers investigating largescale drug trafficking in Orange County executed a search warrant of his home and discovered drugs, guns and cash, officials reported.

Jonathan Jeffrey Rosslow was arrested at his home and booked on suspicion of possessing drugs for sale and a weapons violation, Fountain Valley Police Sgt. Robert Cortes said Tuesday.

Cortes, who oversees the department's Crime Suppression Unit, said officers

learned of Rosslow while investigating illegal drug sales in Orange County. They obtained a search warrant of his residence and executed that warrant Thursday.

Multiple illegal drugs seized from the property including ketamine, ecstasy, LSD, psilocybin and Adderall — are thought to have an estimated street value of more than \$20,000, according to a news release issued Tuesday by the Fountain Valley Police Department.

A 12-gauge shotgun, a .45 caliber handgun and \$81,002 in cash were also collected from the residence. Cortes said Tuesday both firearms were legal.

"They were legal firearms registered to Mr. Rosslow. We seized them based on the facts of the investigation," he said.

Rosslow, whose occupation is listed as landscaper, was booked into jail and is being held on \$100,000 bail. He is scheduled to appear in court on Tuesday, according to an online inmate locator maintained by the Orange County Sheriff's Department.

"In Newport Beach, we haven't seen a large number of street races or takeovers but do have a large number of loud vehicles with modified exhausts," Little said in an e-mail Wednesday. "This can affect the quality of life of our residents and visitors and we field numerous complaints from the community"

Little noted that street takeovers have happened in

other neighboring Orange County cities, including Santa Ana and Costa Mesa. He didn't elaborate on any major hot spots for such takeovers, noting that car clubs tend to meet at different locations and travel together.

The individuals arrested Saturday face different charges, including evading a peace officer and possession of a loaded firearm; one was an unlicensed driver with warrants.

Dosier, who are an incoming senior and junior, respectively, at Huntington Beach High.

They take turns playing the two versions of Fiona, ogre and princess.

Doody said he's part Scottish, which helps with his role, and he's spent months perfecting the accent made famous in the movies by Mike Myers.

"I mean, it's Shrek," said

Doody, adding that he played one of the three pigs and a guard in a "Shrek' production when he was a sophomore at Edison. "Everyone knows Shrek, everyone loves Shrek. I kind of grew up with Shrek."

Christensen has previously directed in school plays, including Marina, so she said it was natural for her to come back and help with the new organization.

Since rehearsals started in May, the kids have been working three days a week including Saturdays all summer to prepare for the show.

"They've worked so hard that we feel very comfortable coming into show week," Christensen said. "It's time for us to be in the space so they can get accustomed to not performing in a small dance room, especially with the dragon."

Even with the long lead time, they faced some obstacles. When the actor who played the dragon dropped out last week, Lexy Rocha was there to answer the call. Nathan Andreas, an incoming freshman at Huntington Beach High, plays the wisecracking donkey.

Several of the high school actors, including both female leads, also participate in the Huntington Beach Academy for the Performing Arts.

This one, because it's children's theater, it's a little bit more loose," Dosier said. "It's equally fun for everyone. All of the kids feel included, and the older kids feel like they can get their stuff done. It's a different experience, but it's just as great of an acting program."

Dosier added that Shrek

was the first show she ever did in the sixth grade. She was in the ensemble as the ugly duckling.

'I've always loved this show and the characters," she said. "It's funny because it's the same costumes that my first production used. It's like I got to step into the role of the lead that I looked up to when I was in sixth grade ... It's literally a dream. It's surreal."

Melgoza said the show has really come together in the last week and said she hopes it is entertaining for people of all ages.

"Many people live in close proximity to the airport and are very sensitive to the noise from incoming and departing aircraft."

Foley explained when John Wayne officials sat down with local elected officials and community members in 1985 to draft a settlement agreement imposing annual passenger caps, curfews and other restrictions on commercial flight operations, the process did not include general aviation travel, such as private business or single-engine flights.

Traffic and noise generated by such flights have since then been on the rise, potentially creating new impacts to residential communities situated under the airport's flight path.

Foley showed a flight path map indicating a specific departure route that, when traveled, pushes jet engine noise away from residential areas and out

over the Pacific, where fewer effects are felt. While its use is recommended, many private jet pilots do not know about it.

"The Fly Friendly program fills the gap where the settlement agreement does not apply to general aviation," she said at the county press conference. "It is really focused on educating our pilots."

The program scores operators who sign up in multiple categories. While data systems will determine quietest departures and rate nighttime noise reduction, other categories such as "environmental stewardship and sustainability" and "most engaging" — will track pilots' involvement in community efforts, like local meetings about aviation impacts and environmental advocacy campaigns.

Jet operators who modify aircraft for noise reduction, purchase quieter crafts or fly in accordance with prooutlining cedures quietest general aviation departures and other noise abatement guidelines will receive "points."

the first time the program was publicly accessible.

"It highlights a huge step in our mission of ultimately working side by side the public sector to truly maximize our impact," he said.

Phoenix, headed into the seventh grade at Mesa View Middle School, said she enjoyed the program.

"I was already trying to invest my money into stocks, but I didn't know how to professionally do it," she said. "I needed some help."

One of her most successful and interesting stocks in the simulation was Google, whose parent Alphabet, company, carried out a 20-to-one stock split on July 15.

"She clearly has a thorough understanding of the stock and bond market, and personal finance," Thimons said. "She finished the stock competition in 18th place, but that does not accurately reflect her performance throughout the summer. She was a leader here at the library.

"I look forward to one day hiring [Phoenix] to work at my hedge fund. Or, more realistically, [Phoenix] hiring me to work at her hedge fund."

CdM outlasts Sage Hill to win 5-set showdown

A five-set thriller served as an early test of the constitution of two Newport Beach-based high school girls' volleyball programs, each taking turns to turn the tide in a tilt with several twists.

Corona del Mar emerged victorious Tuesday, spoiling Sage Hill's home opener with a 17-25, 25-18, 25-11, 24-26, 15-7 win over the Lightning.

With libero Jordan Prince serving to start the fifth set, the Sea Kings rattled off 10 consecutive points to all but clinch the match. Prince dropped in two service aces during that stretch, both coming via short serves.

"I think Jordan ... stepped up a lot because she hasn't had the opportunity to play, in Hawaii or all season basically, so I think it was pretty cool for her to just step up," Sea Kings junior outside hitter Reiley Murphy said.

Murphy had a team-leading 14 kills and five aces to lead CdM (4-5), which returned to action after beginning the season in Hawaii at the Ann Kang Invitational, a tournament won by Manhattan Beach Mira Costa. She said the team's bonding activities on the trip included going to the beach and kayaking.

Edison also competed in the season-opening tournament in Hawaii, going 1-7 with a win over La Jolla Country Day.

Opposite Reese Olson

had a well-rounded performance for CdM in Tuesday's crosstown, nonleague matchup at Sage Hill, supplying eight kills, 14 assists, four aces and two total blocks. "Reese does a lot for us,"

said CdM coach Bailey Humes, who also spent three seasons as an assistant coach at Sage Hill. "She's one of the players that stays on the court the whole time. She's a huge offensive threat for us. She's been running a really good offense for us, too.'

Outside hitter Paige Carillo added seven kills, including one that leveled the contest at a set apiece. Sabrina Baker produced five kills and a block, Hailey Shaw had four kills and a block, and Sofia Bonanno chipped in with three kills a block. Kaela Hiramoto also distributed 12 assists for CdM.

Sage Hill (0-1) took the opening set, getting three kills from both freshman middle blocker Cydnee Bryant and senior outside hitter Sophie Wang, as well as three aces from freshman setter Soraya Dennis in the game.

The response was swift from CdM, which jumped into the lead by convincingly taking the next two sets. With Bryant in the rota-

tion to start the fourth set, Sage Hill established a 7-2 advantage as the Lightning started down the comeback trail. The Sea Kings drew even at 9-9, and the Lightning had to make some plays without Bryant in the front row to extend the match.

A service error allowed Sage Hill to stave off a match point, and two points later, an ace by Wang sent the fight to the fifth and final set.

"We trust the six people that are on the court to put up a good block and to be disciplined on defense and make plays," Sage Hill coach Dan Thomassen said. "I think when they got advantage of us is when we started to try to do too much, and our hitters were going for too much. We're still building that trust and cutting down on mistakes."

Bryant had 14 kills and two blocks to pace the Lightning in both categories. Outside hitter Brooke Thomassen contributed 10 kills, four aces and 11/2 blocks. Freshman opposite Amber Wang had five kills, and sophomore middle blocker Claire Casey had three aces and 1½ blocks. Dennis finished with 25 assists and five aces.

Corona del Mar and Sage Hill will both compete in the Tesoro Tournament, which will begin Friday with the finals taking place on Monday.

"We're going to learn a lot about different lineups, but Cydnee's an immediate impact player," Dan Thomassen said. "We want to get her the ball when she's in and use her as a decoy to set other people."
