Raider Nation set to descend on Costa Mesa

Officials announce the Las Vegas Raiders may train this summer at the Jack Hammett Sports Complex, vacated last year when the L.A. Chargers moved its headquarters to El Segundo. The City Council weighs the agreement Tuesday.

A new NFL team could soon be coming to Costa Mesa's Jack Hammett Sports Complex, after city officials announced Friday they were in talks with the Las Vegas Raiders over use of the facility as a 2024 summer training camp.

The Costa Mesa City Council on Tuesday will discuss in its regular meeting the possibility of brokering a one-year agreement regarding the Fairview Road complex, recently vacated by the Los Angeles Chargers, who'd trained there since 2017.

"Costa Mesa is proud to be one of only two cities in the country to host an NFL team's summer training camp in a publicly owned facility," City Manager Lori Ann Farrell Harrison said in a release Friday. "Jack Hammett is a treasure and we are excited to potentially have a new NFL team training here."

Under the proposed agreement, the Raiders would pay the city \$165,000 in rent and would agree to make an estimated \$600,000 worth of improvements to fields at the 14.5-acre facility, the release indicated.

The team would agree to estab-

lish a junior training camp for kids ages 6 to 12, provide 100 tickets for local students to attend an NFL game in Southern California and would make a donation of \$10,000 to a local youth sports team.

Additionally, outdoor weight training equipment would be donated to nearby Costa Mesa High School, while a new mobile recreation van would be made available for use by programs in underserved areas throughout the city.

Starting in mid-July, the team

Jay Nova Sanchez is at that age, almost 11 months old, where Mom and Dad like to try to prompt a first word out of their infant.

"Bananas, blueberries, pumpkin," Mikey Sanchez of Fullerton said Wednesday afternoon, encouraging his first child. "Say 'Mama.' No, not today?"

Jay just smiled, unwilling to oblige, at least for now.

That's perfectly fine. The presence of a healthy child says a lot by itself.

Megan Sanchez gave birth to Jay via Cesarean section on June 16, 2023, at 1:48 a.m. He was born more than three months prema-

His birth weight was about 500 grams — 1 pound, 1 ounce. After birth, the micropreemie was whisked away to the neonatal intensive care unit (NICU) at Hoag Hospital Newport Beach.

"We came every single day," Megan Sanchez said. "We would sit with him, sing with him, read him books. Eventually, we did get

Laguna Beach seeks input on canyon

The city will meet with the community Tuesday regarding improvements for a busy corridor of Laguna Canyon Road.

Laguna Beach city officials plan to meet with community members on Tuesday to discuss the priorities going forward for Laguna Canyon Road.

A stakeholder meeting will take place from 6 to 7:30 p.m. at the Laguna Beach Community and Susi Q Center, which is located at 380 3rd St.

Laguna Canyon Road is one of three major roadways that lead in and out of the city, providing access to the coastal community from the 405 freeway. Vehicular traffic also comes into town on Coast Highway, via Newport Beach from the north and Dana Point from the south.

The corridor, also known as State Route 133, is heavily utilized. Cyclists, drivers, pedestrians and those who take public transportation can all be found in a 2.5-mile stretch between El Toro Road and Canyon Acres Drive.

City officials are seeking public

Costa Mesa, without coach, exits CIF playoffs

Costa Mesa's softball team celebrated its first league championship in 21 years a week ago.

The Mustangs suffered a season-ending defeat to visiting Pasadena Mayfield 7-3 on Thursday, and they were surely left wondering what had happened to their head coach.

Coach Doug Deats was absent from the game, and school and Newport-Mesa district officials declined to comment when asked for more information on the matter.

In a phone interview after the game, Deats stated that he was placed on administrative leave the day of the game.

"At noon, I was called into the principal's office, and I was put on administrative leave," Deats said Thursday evening. "I have no reason why I'm on administrative leave. They didn't give me a reason. They just said I was under investigation. I asked if I could at least talk to the team, and I was refused the opportunity to talk to the

Deats, an economics teacher who has also been involved with the baseball and football programs in his 31 years at Costa Mesa High, said he felt bad that the players did not have a familiar face in the dugout with them for their postseason contest.

"Whether we would have won or not, if we didn't win, I should have had the opportunity to talk to those kids and explain what a great year they had and everything they accomplished," Deats added. They haven't won a [league title] in 21 years. ... It's always hard in playoffs because most of the time, you lose your last game. That's championship softball, and the kids are sad, and they are hurting."

Costa Mesa (14-6), the Coast League champion, surrendered four runs in the third inning to fall behind 5-1.

Sydnie Pulido doubled and scored in the second for the Mustangs. Victoria Rios scored on a two-out double by Jaidyn Soldin in the third. Isabella Gonzalez

doubled and came home on an infield single by Rios in the fifth, capping the scoring for Costa Mesa.

Rios, the center fielder, also threw out a runner at the plate for a double play in the top of the fifth.


Todd Young, the school's athletic director, served as acting head coach for the Mustangs.

"They were just tickled pink, so excited," Young said of the feeling around the school after the Mustangs secured a rare league championship. "Just a great feeling. They were loving it. I wish we could have built that momentum into playoff wins, but it didn't work out.'

Costa Mesa Mustangs are making a surprising playoff run

The Costa Mesa boys' volleyball team has furnished a deep playoff run behind a belief in each other when few others did.

Coach Tan Nguyen is encouraging the Mustangs to stick together as they attempt to send the program to its second CIF Southern Section final.

Prior to the Mustangs' quarterfinal match on Thursday, Nguyen said he walked in and wrote the words, "Don't believe the hype," on the board, a phrase that would resonate with any underdog.

Junior outside hitter Dimitri Downs had 20 kills, and Costa Mesa defeated Pomona Ganesha 27-25, 25-16, 25-17 for its second consecutive home triumph in the postseason.

"Don't believe in the hype," Nguyen repeated. "But underneath, I wrote, 'Put in the work, put in the passion, you'll get there.' That's what I wrote, and that's what I told the boys. All that extra stuff on the outside just affects your ability to work. You can just put in the work, put in the maximum effort. Whatever comes from there, comes from there."

For the second time this week, unranked Costa Mesa (16-9) emerged victorious from a trying first set. The Mustangs also had to go past regulation to secure the opening set in their upset of No. 3-seeded Palmdale Knight on Tues-

Downs misfired on his first three swings against No. 6 Ganesha (28-5), but he delivered pivotal contributions late in Game 1, erasing two set points with kills. Junior outside hitter John Luong followed with one of his 11 kills to give the Mustangs their first set point, which they converted on a hitting error by the Giants.

"I just know I have to have good confidence in myself," Downs said. "I know that I'll just keep swinging, and if I stay confident in myself, I'll hit it hard. I trust myself, and I trust my team. I trust my setter to kind of put it up and give me an opportunity to make myself improve from those mistakes.'

Costa Mesa travels to No. 7 Riverside Poly (24-9) for its semifinal match on Saturday. The Mustangs' only prior appearance in a section championship game came in 2006, which ended in a four-set defeat to Santa Monica in Division III.

Senior opposite Chris Rivera had a team-leading 19 digs and two blocks assists. Junior setter Adam Menendez spread around 43 assists to go with two service aces. Senior middle blocker Justin Foreman had nine kills and two block assists, junior outside hitter Kurt Mateo had five kills and 11/2 total blocks, and senior reserve Nam Le chipped in with two aces.

"It's going to take dedication, it's going to take us playing all on point, it's going to take us doing everything we can, but I honestly think we got it because we're a special bunch," Foreman said of what needs to be done for the Mustangs to reach their first CIF final in 18 years. "I think we've got a lot of potential and a lot of power on our team."

Sophomore outside hitter Jaden Delgado-Matsuda paced the Giants with 14 kills. Senior outside hitter Isaac Carranza and senior middle blocker Eric Galvez each had seven



The improvements include new stairs and walkways, along with onsite bike racks. A bluff will feature native drought-tolerant plants. A new lifeguard tower

overlooking Moss Cove has also been added.

Construction took approximately eight months and the project cost \$1.77 million. State Sen. Dave Min (D-Irvine) secured \$1.225 million in state funding to go toward the improvements.

"Thanks to the funding secured by Senator Min, the Moss Street beach access has undergone a transformative vation," Laguna Beach Mayor Sue Kempf said in a statement. "The up-graded features, including redesigned stairs, walkways, and a new lifeguard tower, not only enhance accessibility but also preserve the natural beauty of our coastline."

The Fairview Road facility has been used as an NFL training site since the former San Diego Chargers relocated to Los Angeles in 2017 and were in need of a training area closer to Los Angeles

Under that lease agreement, the team had the option of remaining at Jack Hammett for up to 10 years. But in 2022, Chargers owners broke ground on a new corporate headquarters and training facility on a 14-acre property in El Segundo, closer to Los Angeles' SoFi Sta-

dium. Work on that site is anticipated to wrap sometime this summer, according to the team's website.

Costa Mesa Mayor John Stephens said Friday he was pleased to welcome the team and their loyal fans — dubbed Raider Nation — to the City of the

"The Raiders and Costa Mesa share a commitment to excellence, and our partnership will greatly benefit the community," he said in Friday's statement, thanking Newport-Mesa School Unified School District and Costa Mesa High for their involvement in the endeav-

Restaurant returns after hotel's \$5M renovation

When Lorea restaurant reopens today at Huntington Beach's Paséa Hotel & Spa, executive chef Scott Rackliff has only one hope: that guests who eat at the land-to-sea-driven restaurant are still thinking fondly about their dining experience the next day.

Lorea is a California coastal-inspired restaurant with a land-to-sea-driven menu with Rackliff and chef de cuisine Stefan Pierce at the helm, and one way the team at the renovated space is working to create those lasting memories is with a massive slice of carrot cake. The four-layer spiced cake studded with golden raisins and dressed in cream cheese frosting and candied heirloom carrots isn't meant to be finished in one sitting.

"We want people to be eating the cake the following afternoon, still thinking about Lorea," said Rackliff.

Paséa Hotel & Spa at 21080 Coast Highway in Huntington Beach underwent a \$5-million renovation of its food and beverage program that transformed not only the hotel restaurant but all on-property dining. Lorea's 1,372square-foot indoor space has plenty of natural light with an open-air feel and a 77-foot-long stone bar. Lo-

cal artist Chris Trisnan has hand-painted the dining room's community table, and the ocean front patio offers additional seating with a fire pit and outdoor

The menu is designed to not only be approachable but interactive and shareable too. Parker house rolls, laminated like croissants, are presented with a lit melting candle made of Turkish chili-lime butter that softens under the flame for spreading. The Pavlova dessert is presented tableside with a dry ice "smoke" that floods the diner with the scent of lime and mint. Rackliff said those touches are inspired by his time as a cor-

porate chef for chef and restaurateur David Burke. "We want people to have

fun while they are eating, said Rackliff.

Pork belly wraps, for example, are served with all the components arranged on a plate. Slices of tender pork belly braised in mirin, gochugaru and tamari are fanned out with shavings of salted cucumber, purple ninja radish, pickled heirloom carrots, bib lettuce and chili crunch on top. Guest build their own wrap, and the portion is designed to share.

"It's so customizable," said Vincent Savignano, director of food and beverage. "If you don't like the radish or you are not into the pickles, you can really make it your own."

A selection of steaks includes a 10-ounce prime hanger from Durham Ranch or a 6-ounce filet from Double R Ranch, with your choice of sauces Savignano said are interchangeable,

chimichurri or L-1 sauce, a tangy house-made steak sauce inspired by A-1.

There is seafood too. Scallops are served with maitake mushrooms and peas just blanched so a little bit of crunch remains, but also a pea puree and with fresh pea tendrils curling around the plate. It's a set Rackliff anticipates will change up with the seasons.

"After spring, we will get into summer squash," Rackliff said.

Mixologist Miguel Sandoval has created a menu of bespoke cocktails to accompany the menu, like a Fizzy Lizzy, a variation on a Ramos Gin Fizz but made with smokey mezcal in place of botanic-forward gin.

The hotel's revamp has also refreshed Treehouse on PCH, the hotel's rooftop lounge and popular latenight spot, that boasts a more open layout now to maximize views of the Pacific Ocean.

"The spaces offer a unique setting and vibe, creating the laid-back luxury experience that Paséa is known for," said Savignano.

Besides the carrot cake there are other memorable desserts, like the chocolate soufflé cake, which is baked fresh and served with chocolate sauce, dulce de leche, chocolate pearls and whipped cream.

"It takes about 10 to 12 minutes to cook, so in the time that we are baking this, we send out a bowl of the beaters covered in cake batter," said Rackliff. "Its the best part of waiting for your cake to bake - licking the beaters."

With the generous portions, Rackliff and and his team don't anticipate guests will finish everything, but they are making sure Lorea is good until the last bite, even if that last bite happens at home the next day.



leaving Lincoln in 2020. He started holding geography bees at the Orange Unified School District in the early 2000s, inspired by a professor who always had timelines and maps that better contextualized conversations they had about history.

Students are given the material shortly after returning from their winter vacations. Studying for and participating in the bee is voluntary, but students are tested on the material beforehand to make sure they're ready to compete. Those with the highest scores in earlier tests get to participate in the event, which often includes more than one student from each class.

Seventeen students competed Thursday, and Pardoen said as many as 23

have participated in the past.

The contest is designed for fifth- and sixth-graders, meaning that some students who competed last year were able to participate again this year.

Sixth-grader Nathan Gorman defended his title as champion this year. The 12year-old said he shared his title with three other students who entered middle school last year, but he managed to come out on top for 2024.

"The exhilaration that I experienced made me want to come back [and compete]. I really love history and geography, so it's a fun thing for me to do," Nathan said, prior to the start of the bee. "It's kind of one of the few chances that you actually get to [learn geography] other than taking a specialized class in high school or college. It's a really exciting opportunity to be able to learn this stuff early on, so you can have more of a global view instead of individual countries.'

Nathen Mercer, who came in second, said he felt geography was important because people can use it their whole lives, even in small ways.

'Even if it's just traveling or, like, even more upcoming geography bees like
