O.C. athletes sign or commit to continue playing their sports in college.

High school athletes have not been able to play their sport for the better part of a year, but with the arrival of winter signing day on Wednesday, local student-athletes celebrated making plans to do just that as part of their college experience.

It was a big day for water polo in Costa Mesa, with both high schools in the city sending players on from their pools to fouryear college programs.

The Costa Mesa boys' water polo team had four signees in attackers Gavin Fisher (Santa Clara) and Will Harrington (Iona), utility player Alexander Luckett (Concordia) and center Anderson Todd (Brown). Mustangs water polo coach Cody Serrano, a 2009 graduate of Costa Mesa, said that he and his twin brother Dustin had a vision of helping more of the school's athletes move on to the next level when they returned to their alma mater as coaches in 2014. Serrano said that it was "amazing" to have four athletes able to sign or commit together, and he added that the group was rich in experience.



H.B. loses housing case with state of California

The lawsuit had challenged 4 recent housing laws it said unconstitutionally take land zoning out of local hands.

The city of Huntington Beach has lost a lawsuit against the state of California seeking to be exempted from recently passed housing bills, including Senate Bill 35 and SB 1333, and will not appeal the decision.

Huntington Beach's lawsuit, filed in January 2019, had alleged that the housing laws, specifically SB 35, sought to "create a system where the state controls how, where and when housing is built in every city in California. SB 35 essentially creates unconstitutional authority for the state to 'rezone' local land use in a city for its (ill-conceived) political purposes."

SB 1333 closed an exemption for charter cities like Huntington Beach so their housing elements would not have to match their general plans.

Los Angeles Superior Court Judge James C. Chalfant ruled on Jan. 28 that

Huntington Beach schools return on-campus for hybrid learning

As coronavirus case rates continue to drop in Orange County, students in Huntington Beach have made their way back to campuses for the first time in weeks.

Huntington Beach Union High School District marked the start of the second semester Tuesday with a return to a hybrid learning model. Students had been distance learning exclusively for about a month, since Jan. 4.

Huntington Beach City School District and Ocean View School District also returned to their hybrid models on Monday.

"It was wonderful to see them return in their hybrid schedules, returning and learning in classrooms with their teachers," OVSD Board of Trustees President Patricia Singer said. "It's always good to have the kids back in their classrooms ... We're happy to see that the [COVID-19] rates go in the right direction, and we're committed to keeping in this hybrid schedule and consistency as long as possible."

Huntington Beach Union High School District, which is home to about 16,000 students, includes Huntington Beach, Edison, Fountain Valley, Marina, Ocean View and Westminster high schools, as well as one continuation, alternative and adult school.

In the current hybrid model, which is optional, HBUSHD students are split into two teams. Everyone is online-only Monday, while Team 1 is on campus Tuesdays and Wednesday and Team 2 on Thursdays and Fridays. Therefore, all students will be on campus twice a week.

"We are thrilled to have our students back on campus," Edison High Principal Jennifer Graves said in an email. "Having students and staff on campus brings an energy that has been missed. Our hope is that with COVID numbers continuing to decrease, more students choose to return to campus."

At Fountain Valley, Principal Morgan Smith said that staff arrived early Tuesday in anticipation of students coming back on campus.

"We gave air high-fives, pointed students in the right direction and thanked them for making our days brighter," Smith said in email. "Schools just don't feel the same when schools are not here ... We made the rounds to visit classrooms and let our staff and students know we are happy they are back, to have hope, and that each day will be better than the next."

Huntington Beach City School H District Supt. Leisa Winston said I the staff and students she saw s Monday seemed happy to be I back, adding in an email that the district is also expanding opportunities in its distance learning program for families who are not comfortable returning.

Families indeed have a choice if they want to return to campus.

Huntington Beach parent Brooke Hampton said her son Logan, a seventh-grader at Sowers Middle School, is on campus four days a week and enjoying it. But her older children, Tyler and Jillian, a junior and freshman respectively at Edison High, had a less enjoyable experience being back on campus Tuesday and Wednesday.

Brooke Hampton said she wrote an email to a guidance counselor Wednesday requesting a move of Tyler and Jillian out of the hybrid model and back into solely distance learning. She said Jillian, a straight-A student, had a rough week during finals week last week. She has invested in outside tutors for her children. "I'm practically paying for private school just to make sure that my kids can get decent grades and stay where they need to be," Brooke Hampton said. "I know everybody's just trying to do their best under these circumstances, but it's scary to know that they're not necessarily getting the education that they need. The first go-



headed to Hospital Road. Cox said she fell in love with Atria Newport Beach and just last week moved into it, joining 25 other residents. Though she's relieved she doesn't have to cook anymore, Cox admitted that the real reason she moved there was to socialize with people outside of her family — an issue made all the more pervasive with the arrival of the COVID-19 pandemic.

She said she'd felt isolated and used to have people coming to visit all the time, but that ended with the onset of the pandemic.

Allowing seniors to socialize and live their lives independently while keeping them safe and healthy — during a pandemic and otherwise — is the focus of Atria Newport Beach, a task that is aided by the "wearables" that are given to all the residents and members of the residence's 60-person staff for contact tracing.

"It's kind of like a smartwatch," said Sarah Laloyan, Atria Senior Living senior vice president of operations. "Touchless door entry, touchless access to any of our amenities so the resident doesn't really have to touch doorknobs. That's so important with disease management and infection management today in our COVID world.

"That's the concern with all of our families and our residents: how's Mom going to be safe? We've really taken every measure to make sure our residents are safe with the touchless technology ... and everything's really set up very techsavvy, which is different because you don't really find that in senior housing," said Laloyan. "This is the senior living

of the future in the sense that it feels like we knew this was going to happen pre-pandemic," she added.

Each device can also detect if a resident has fallen, and seniors can push the button on the device three times to call for assistance

by on-site care staff, opening a two-way radio channel for the resident and staff to communicate during a medical emergency.

It also helps track habits to create a baseline for caregivers, which Atria Newport Beach Executive Director Ben Rodny said staff can use to note any abnormal behavior in residents.

Visitors are also given a device, but on a lanyard for similar purpose of contact tracing in the event someone should test positive living or working in or after visiting Atria Newport Beach.

The project first began development in 2018 and received its certificate of occupancy in January.


Laloyan said the team performs an assessment on a potential resident to make sure they are able to provide adequate care. A physician's report is also required. Once those are cleared, then the move-in date is scheduled. Incoming residents must test negative for COVID-19 and then, upon move-in, are put under a special status for 48 hours before they are tested again. Laloyan said that much of the technology in use was planned and accounted for prior to the pandemic, but COVID-19's arrival helped Atria tune into what was important to protect the seniors not only from the coronavirus but other diseases.

In total, Atria officials said the project spans about 77,000-square-feet and will have cost about \$70 million once the north building is refurbished for additional apartments and memory care.

The senior living community offers a number of amenities, including a fitness center, yoga studio, salon and spa, movie theater, game room, courtyard garden, dining options and a library.

Visitors are temperaturechecked at the door and must answer a series of

Orange The County Heath Care Agency re-

those bills, as well as SB 166 and Assembly Bill 101, do apply to Surf City.

"[The] city's argument that funding is the primary issue behind the lack of low-cost housing merely focuses on a probable lack of success and does not mean that the housing bills are not narrowly tailored," Chalfant wrote in his decision. "In contrast to [the] city's generalized claims of overbreadth, [the] state and intervenors persuasively argue that the specific statutes amended or adopted in the housing bills are narrowly tailored because they permit local discretion to the extent feasible. The housing bills are reasonably related to the issue of statewide concern for insufficient low-cost housing and are narrowly tailored to address the issue."

The Huntington Beach City Council voted 5-2 against appealing the judge's ruling in a closed session Monday night, City Atty. Michael Gates announced. Mayor Pro Tem Tito Ortiz and Councilman Erik Peterson were the dissenting votes.

"We didn't want to appeal because there's no path to victory in our minds and there's no point in suing," said City Coun-cilman Mike Posey, one of the votes against appealing the ruling. "SB 35 and SB 1333 don't apply to Huntington Beach anymore ... [because] our housing element is now compliant.

Posey, who is on the regional council for the Southern California Assn. of Governments, said in his mind the lawsuits that were filed in January 2019 against the state are now moot.

Gov. Gavin Newsom requested the state file a lawsuit against Huntington Beach, also in January 2019, alleging the city was defying a state law that required cities and counties to set aside sufficient land for housing development. In September of that year, Posey introduced an agenda item to the City Council seeking to use SB 2 grant funding toward the city's efforts to

build a homeless navigation center.

At the time, Posey said, the city didn't have a housing element that was compliant with the California Department of Housing and Community Development. "So city staff ... zeroed in on six or seven sites that would accommodate our very low-income housing shortage, which was 413 units. That was also approved by the Council, which subsequently got the housing element recertified, which also got the Gavin Newsom v. Huntington Beach lawsuit dismissed in January of 2020.'

Huntington Beach has lost its appeal on the Regional Housing Needs Allocation numbers for the new cycle, which runs from October 2021 through October 2029. The city will most likely have to zone for 13,337 new residential units in that time period to maintain housing element compliance.

The city anticipates using a \$500,000 Local Early Action Planning (LEAP) grant to hire a consultant to meet those numbers.
