

# Jury convicts man of murdering woman found buried at family's mobile home

A jury found a Huntington Beach man guilty Tuesday of murdering a homeless woman who was buried in the yard of his family's mobile home in 2022.

Anthony Padilla was convicted of second degree murder in connection with the death of Gina Marie Lockhart. She was living on the street in the area of Beach Boulevard and Slater Avenue and was last seen three years ago on either June 29 or 30.

None of the over 30 witnesses brought forth during trial were able to testify to the victim's whereabouts in the hours leading up to her death. There appeared to be no prior connection between her and Padilla. Prosecutors did not suggest a motive for her killing.

Reports of a foul odor at the nearby Maple Ridge Mobile

# Kluwe arrested at H.B. council meeting

Former NFL player approached dias after commenting against a MAGA plaque proposed for the Central Library.

Huntington Beach resident Chris Kluwe was arrested during Tuesday night's Huntington Beach City Council meeting after moving toward the dais following his public comments.

Kluwe, a former pro football punter, has long spoken out about social issues.

He attended Tuesday's meeting to protest a proposed MAGA acrostic plaque outside of the Central Library for the library's 50th anniversary, as he did at the Community and Library Services Commission meeting a week before.

This time, his comments ended with, "I will now engage in the time-honored American tradition of peaceful civil disobedience."

the dais where the City Council was seated. He was subdued by several officers and carried out of the council chambers.

Kluwe, 43, started approaching

Kluwe did not fight the arrest, putting his hands behind his back and going limp. "I made sure I warned the offi-

cers I was going to the ground," Kluwe said in an interview with the Daily Pilot on Wednesday. "Then I told them, 'I'm going to stay limp, you guys got to carry me out of here."

Kluwe said he was held in the

### Hoefer named Ocean View School District's new superintendent

Julianne Hoefer was advised that if she wanted to become a school superintendent, she should not take an interim position.

Yet, there she was last summer, moving into an interim role in the Ocean View School District after Supt. Michael Conroy retired for the second time.

"At home, I was called the duct tape," she said with a laugh. "It was a leap of faith."

Hoefer emerged from the interim role even more convinced that the role was for her. The district Board of Trustees felt the same way.

She was appointed the new Ocean View School District superintendent at the board meeting on Feb. 11 by a unanimous vote of 4-0, with Trustee Morgan Westmoreland absent.

The appointment of a new superintendent comes after a contentious election cycle, after which Gina Clayton-Tarvin was reelected to the board and Keri Gorsage was also elected.

"I really believe the board did it right," Hoefer said in an interview with the Daily Pilot. "They waited for the election to conclude before identifying someone. Some districts would have pushed that decision through, because those five wanted to make the decision and ensure that it was who they wanted. I've seen that in other districts, and ours really trusted the voters to weigh in and make their selections.

"In many ways, I feel like I have the support of not only the board, given it was a unanimous vote, but the community as well. That's who they selected, and



then that board made that decision [to appoint] me." Hoefer, 55, is a Seal Beach resident. She has been with the district, which features 10 elementary schools and three middle schools in Huntington

Beach, Fountain Valley,

Midway City and Westmin-

ster, since 2018. Her new contract runs through June 2028 and features an annual salary of \$327,000, with the same salary increases provided to other certificated district administrators. She also receives an allowance of \$500 per month for district-related car expenses, as well as a \$2,000 annual stipend for possessing a doctoral degree.

"Clearly, this board is unanimous in thinking that you are the right candidate for this position," Board President Patricia Singer said at the Feb. 11 board meeting. "The board believes strongly that we've seen a really strong, compassionate leader in the last months since you took over in August. You've ensured that we're moving forward ahead, but you're being innovative, you're being kind. There's a balance that I'm hearing from a lot of our staff members, with great work expectations but also ensuring that they feel heard, supported and loved for."

Hoefer has a bachelor's degree in child development and master's de-

gree in school administration, both from Cal State Fullerton, as well as a Ph.D in urban education and public school administration from Claremont Graduate University.

She said she loves the Ocean View School District staff and students. She added that she knows plenty of parents as well from her visits to school sites when she was assistant superintendent of educational services, a position she held from 2018 until she was promoted to deputy superintendent of human resources last March.

"Public education is under attack," she said. "Folks think you're crazy for wanting to be a superintendent. Even internally, they're like, 'Do you really want this job?' And the answer is resoundingly every time, 'Absolutely.' I felt like all along that my job is to keep this community together, because the community represents diverse perspectives. In the middle are students, and how do we keep our community united in doing right by our children?"

The district has considered school closures in recent years, in the face of continued declining enrollment. In November 2023, the Board of Trustees voted to consolidate Spring View Middle School, while leaving three other elementary schools that were considered for consolidation — Golden View, Circle View and Village View, all in Huntington Beach

open.

More recently last August, the district's 7-11 Committee recommended that the district sell two of the 26 sites it owns. They included the Crest View site at Beach Boulevard and Talbert Avenue in Huntington Beach, a 13.8acre site that includes Walmart and other businesses, and the 10.9-acre Pleasant View site near Warner Avenue and Magnolia Street.

The board has yet to take action on these recommendations; Hoefer said assistant superintendent of educational services Keith Farrow is doing research based on them.

Hoefer noted that the district has many innovative programs, including the farm at Golden View Elementary, a guide dog program started at Hope View Elementary and a culinary arts program at Vista View Middle School, to name a few.

"How do we keep those programs intact, because that's what keeps us spe-cial?" she said. "People want to talk about the past and school consolidation, [but] I want to talk about how we keep our programs alive and what is a better tomorrow ... Every decision needs to be made with a focus on what the impact is on students. I think we have to be disciplined. We're going to have to say no to some good stuff because we want to say yes to the important things.'

city jail for about four hours before being released late Tuesday night, adding that he was cited after being arrested for disrupting an assembly.

Kluwe commended the Huntington Beach Police Department's handling of the situation but said he felt something had to be done to amplify his concerns. During his comments before approaching the dais, he was critical of several Make America Great Again policies, calling it "explicitly a Nazi movement."

"I want our elected democratic officials to start engaging in civil disobedience," Kluwe said Wednesday. "People need to be aware that what's going on with this administration is leading us down a really dark path. Right now, no one is willing to step up and do that. So, if I want to ask them to do it, then I have to be willing to do it too."

City Council member Gracey Van Der Mark said she was afraid for a few seconds as Kluwe walked onto the platform in front of the dais, before she saw him turn around and put his hands behind his back.

"He wanted his five minutes of fame, and that's what he got," she said.

She said that Kluwe's comments are an insult to Jewish people who support President Trump and called Huntington Beach a "beautiful conservative city."

"It is OK for us to have our beautiful conservative city," she said. "We respect everyone. We're not out there attacking people who don't think like us, we're not out there running across and trying to intimidate people who don't agree with us ... The city of Huntington Beach has always been conservative, and they tried to change that, and we're just taking it back to the way it was. If I wanted to live in a liberal city with liberal values, I would have stayed in Los Angeles."

Kluwe said he sees a sense of resigned anger in many public comments made during council meetings.

"People are speaking out because that's the American thing to do," he said. "You're a public citizen, your voice should be heard. But it's very disheartening when your elected officials are not listening to your voice ... It is profoundly un-American to do what this council is doing, and I think there are a lot of people in this community that get that. At a very visceral level, what we are seeing is not how America is supposed to work."

#### SYMPHONY OF FLOWERS PASSES UNANIMOUSLY

Also during Tuesday night's meeting of the Symphony of Flowers, an orchestrated light show, is coming to Central Park as the panel unanimously approved it.

The show will be staged in the northeastern portion of Central Park East, at the same location where the Revolution and Civil War days are staged each year. The council heard residents voice concerns about potential issues with disrupting the park's ecosystem, though an addendum to the final master environmental impact report of recreational uses for Central Park found that the show would have no impact or a less than significant impact in several environmental areas.

Der Mark, was also unanimously approved by her colleagues.

The new design features a large eagle on the left side. It still features the MAGA acrostic with the words "Magical, Alluring, Galvanizing, Adventurous," though now they are on the bottom instead of in the middle. Below that, it reads, "Through hope and change, our nation has built back better to the golden age of Making America Great Again," combining presidential slogans of Presidents Obama, Biden and Trump.

#### LIBRARY PETITIONS ELECTION DATE TO BE DETERMINED

The panel did not make a final

decision on an election date for two library initiatives, one seeking a repeal of the parent/guardian children's book review board and the other seeking to require voter approval before library operations can be outsourced. Councilman Tony Strickland

said the council would work with staff to come back within 30 days with a resolution to call for an election.

The two options are to call for a special election or put the initiatives on the general election ballot in 2026.

#### VIGLIOTTA APPOINTED CITY ATTORNEY

Longtime Assistant City Atty.

she died.

Michael Vigliotta was appointed as city attorney on a unanimous vote. He is replacing Michael Gates, who took a post at the U.S. Justice Department.

Vigliotta, a Huntington Beach resident, had left to be the city attorney in Orange in 2023. Now he will step in to continue Huntington Beach's fight with Sacramento on voter identification, housing mandates, sanctuary state laws and other issues.

"I don't have a speech, but thank you for the confidence," Vigliotta said to the council members.

Homes led to the discovery of Lockhart's body on July 17. She had been hogtied with a pair of shoelaces and decapitated.

The latter likely took place after she died, according to forensic experts. They were unable to identify any broken bones, bruises, scratches or other injuries indicating a struggle on her partially decayed body. Her cause of death was not con-

clusively determined.
Padilla's sister, Lolita Guevara, told police she saw him digging a roughly 5-foot-wide hole in the yard on July 10. Later that day his mother, Rosario Cendejas, confronted him as he was carrying bags with blankets that appeared to be covered

with bloodstains and maggots. He fled when she called the police.

Officers initially dismissed the smell as coming from a dead animal and advised the residents to deepclean the area. When Cendejas attempted to tidy up the shed she found women's clothing that was too small for anyone living with them, Vans shoes that were missing laces, long hair that

was still attached to a piece of someone's scalp and a large knife with blood on it.

Lab tests later determined that Lockhart's blood was on the blade and Padilla's on the handle.

Prosecutors alleged Padilla used the knife to cut off the victim's head, destroying any signs of strangulation on her body in the process. However, defense attorneys noted that there was no physical evidence confirming Lockhart's cause of death. She had been hospitalized for seizures and alcohol poisoning numerous times in the month before

Padilla's defense attorney argued that Lockhart could have died of natural causes and added that a warrant for Padilla's arrest was active at the time, which is why he decided to hide the body

instead of reporting it to authorities.

"You don't go to those lengths and do that," Janine Madera, senior prosecutor for the Orange County district attorney's office, countered during closing statements. "You just don't, unless you're hiding a murder"

## Costa Mesa class to teach the nuts and bolts of bike safety

#### BY SARA CARDINE

Costa Mesa city officials were looking to create a comprehensive bicycle safety education program in 2023 when they collaborated with the L.A. area nonprofit Walk 'n Rollers to develop a program for schools and the greater biking community.

Working together under a \$150,000 professional services agreement, the team created a roughly one-year pilot program that would bring bike safety classes to students in about 20 school campuses and offer workshops where adults and kids could sharpen their bike skills and know-how and get free helmets, equipment and

Those offerings, which have already reached thouwill continue throughout the 2024-25 school year in accordance with the City Council-approved contract. But a crucial third component of the plan — the one that will effectively extend the temporary pilot into an ongoing city program — is just beginning to take shape.

A Smart Cycling Class, being held this Saturday from 9 a.m. to 4 p.m. at the city's Balearic Community Center, is designed to help those interested in bicycling learn the intricacies of bike safety and about possibly becoming certicycling instructors L|E|S | I|N|K|S | S|C|O|P|E|D

through the League of American Bicyclists.

Brett Atencio Thomas, Costa Mesa's active transportation coordinator, said while anyone of any skill level is welcome to attend the free class, the idea is to take the city's bike education program from something led by an outside nonprofit to a curriculum run by the city and resi-

"This is basically a trainprogram," the-trainers Thomas said Wednesday. 'We don't want to say at the end of the school year, we're done. We want to walk away with something where we can keep going."

Participants of the daylong course will be brought up to speed on the rules of the road, sharpen their onbike skills, enjoy a group ride and learn more about the rise in use of electronic bicycles.

Students may also complete an optional on-site exam that will allow them to then enroll in one of a series of seminars held by the League of American Bicyclists to become certified League Cycling Instructors (LCIs) capable of participating in future school-based programs and community workshops in Costa Mesa.

Once certified, instructors can even come back and help lead future Smart Cycling Classes held by the city, Thomas said.

"This leads in the direction of getting people trained in the ability to train other people to ride bicycles," he added. "We want LCIs here in the community to keep this program going.'

Emiley Davis, so vibrant on the Mustangs' left flank, stepped up for the fifth. She fired to the right. Maynard dived to her left, making the stop simple.
