ELECTION 2022

O.C. voters weigh in on city races

Preliminary results were released shortly after 8 p.m. Tuesday, but the true results may not be available for days.

Although results will be filtering in for weeks, election season is officially over.

Voting centers across Orange County closed at 8 p.m. Tuesday, and preliminary results were released for local, state and federal races. As was the case with the 2020 presidential election, the final verdict for the election is not expected to be in until all mail-in ballots, which continue to be received by the Orange County Registrar of Voters, are tabulated. Any ballot postmarked by Nov. 8 will be counted.

Roughly 1.8 million county residents are registered voters and, as of Tuesday night, it appeared 24.3% of voters showed up to cast their ballots this election.

Here are the preliminary results for city council races and ballot measures in the Daily Pilot's coverage area as of 8 p.m. Tuesday:

COSTA MESA

Gray skies and the threat of rain did little to deter local voters in Costa Mesa, who lined up outside the new Norma Hertzog Community Center Tuesday to cast ballots on the very last day possible.

Opened to the public in July 2021 and named for the city's first woman council member and mayor, the center was one of 181 vote centers in Orange County and among six Costa Mesa polling sites.

Making sure to vote before the rain descended, World War II veteran Charles Pursley and wife Jo arrived at the community center bright and early. Having served in the Army's 82nd Airborne Division in Europe, Pursley, 95, believes voting is a privilege and so makes sure to come out each election cycle.

"We're both pretty conservative," the Costa Mesa resident said, identifying himself as an in-

Newsom, Porter take strong leads in state and national elections

O.C. Registrar of Voters issued early results on area voters' choices, including contested race between Rep. Michelle Steel and challenger Jay Chen.

It looks as though Gov. Gavin Newsom will be sticking around for another term, according to early results Tuesday night.

As of Tuesday night, Newsom held the lead over Republican challenger Brian Dahle. In Orange County, early results are indicating that Newsom has 54.2% of the votes compared to Dahle's 45.8% — a roughly 35,625 difference.

In other contested races throughout Orange County, Rep. Katie Porter (D-Irvine) looks to be holding ground in the race to represent the 47th District against com-

petitor Scott Baugh. Porter is reporting in at 57.5% while Baugh is reporting 42.3% of the votes. Districts have recently been redrawn on the state level, and this district now includes Huntington Beach, Costa Mesa, Irvine, Newport Beach and Laguna Beach.

In the 45th District, which includes Fountain Valley, Westminster, Garden Grove in addition to some cities in Los Angeles County, the heated contest between Republican Rep. Michelle Steel and Democratic candidate Jay Chen has come to a head with Steel eking out a tentative lead over Chen with 50.2% of the votes. Chen follows closely behind with 49.8%.

O.C. Registrar of Voters offers look at early results in local school board races

Newport-Mesa Unified, Fountain Valley, Huntington Beach City, Huntington Beach Union High districts had strongly contested races.

Among other decisions Orange County voters considered Tuesday was the question of who will be entrusted to run local school districts.

Races took place in the Newport-Mesa Unified, Fountain Valley, Huntington Beach City, Huntington Beach Union High school districts and the Coast Community College District for a number of different seats on each respective board. No race was held this year in the Laguna Beach Unified School District.

Amy Calacci, 39, came to the Hertzog Community Center with 8-month-old

daughter Elliott and 4-year-old son Reese, who got to wear his mom's "I Voted" sticker on the way out. The Costa Mesa resident, who tends not to vote along party lines, said she was particularly interested in education matters.

"School board issues are important to me and how things are funded in this state," said Calacci, who has an older daughter with a disability who is a kindergarten at Newport-Mesa Unified School District's Woodland Elementary School. "I like the way things are going for her now. They've actually been incredible so far."

Authorities release new rendering of possible 2013 homicide victim

Investigators seeking the identity of a possible homicide victim found nine years ago in Newport Beach learned he was of Chinese descent and released an artist's rendering of his face Tuesday, hoping someone might recognize him.

The man was found by fishermen in waters about a mile from the coast on Christmas Eve, Dec.

24, 2013, Orange County Sheriff's Sgt. Scott Steinle said. He was wearing a black, medium-sized Champion brand sweatshirt, size 11 Asics running shoes and a Timex watch.

"Due to the condition of the body, the Orange County Sheriff's Department is investigating this as a homicide," Steinle said.

The state the man was found

Newport bay channels reopened following weekend sewage spill

Several Newport Beach bay channels, closed over the weekend by a sewage spill, were reopened Monday afternoon following testing by the Orange County Health Care Agency.

Swimmers, surfers and divers were allowed back in after a sewage spill that Orange County Sanitation District officials said was attributed to a

forcemain leak.

Orange County Sanitation District spokeswoman Jennifer Cabral said the organization was notified Friday at 9:45 p.m. by the Newport Beach Police Department that a resident had called in what looked like a broken sprinkler in the parkway. It smelled like sewage.

OCSD crew responded and determined that there was a

Man struck and killed in Beach Boulevard crash Monday ID'd

Huntington Beach police are investigating a fatal crash that took place early Monday on Beach Boulevard, when a vehicle struck a pedestrian in the northbound lanes, just north of Slater Avenue, according to officials.

Officers were called to the location at 2:30 a.m. and found the pedestrian deceased in the roadway, according to a news release issued Monday. Orange County Sheriff's

spokesman Sgt. Scott Steinle said the county coroner's office identified the victim as Michael Klassen, 30, of Laguna Niguel.

The driver of a gray Jeep Compass, a 50-year-old Fountain Valley man whose name is not being released to the public, remained on scene and cooperated with police, the release stated.

Investigators believe the Jeep was traveling northbound past the intersection when it struck the man, who had been in the

northbound lanes at the time of impact. It does not appear that drugs or alcohol were a factor in the collision, police reported.

The crash is being handled by HBPD's Multidisciplinary Accident Investigation team. Anyone who may have witnessed the collision or the events leading up to it is asked to call traffic investigator Doug Demetre at (714) 536-5670.

LBDP arrest Lancaster man on suspicion of DUI, stalking

Laguna Beach police have arrested the same Lancaster man for the second time in roughly a week.

Gabriel Stinnett, 19, was arrested on Sunday on suspicion of driving under the influence and felony stalking, according to a news release issued by the department Monday.

Police contacted Stinnett at the Jack in the Box at 1201 S. Coast Highway at approximately 10 p.m. after an employee called the department and expressed concern that Stinnett was intoxicated, based on his interaction with the employee, Laguna Beach police Lt. Tim Kleiser said in an email.

An officer then spoke with Stinnett while he was in the drive-through lane of the restaurant.

"The officer observed signs of alcohol intoxication on Stinnett and conducted field sobriety tests on him," Kleiser added. "Based on the totality of the officer's investigation, Stinnett was placed under arrest for DUI."

Additional results of the DUI investigation were not disclosed since the case has not been adjudicated in court.

Stinnett had been taken into custody on suspicion of child annoyance by Laguna Beach police on the night of Halloween after he allegedly attempted to lure a 13-year-old boy into his

van with an offer of candy. He was released on Wednesday, Nov. 2, county jail records show.

Authorities said that the felony stalking arrest emanated from a separate incident, but for the protection of the child, no further information was shared.

An ongoing investigation is being conducted by the Laguna Beach Police Department's detective bureau. Police are asking anyone who has had interactions with Stinnett or with knowledge of the matter to contact Cpl. Fred Yeilding at (949) 464-6687, or by emailing fyielding@laguna-beachcity.net.

Rain drenches O.C., evacuations issued near recent burn scars

Showers that began overnight across Orange County were expected to grow in intensity Wednesday afternoon, prompting the evacuation of residents living near areas scorched by wildfires in recent years.

The storm passing over Southern California had dumped between .5 to 1.5 inches of rain on portions of coastal Orange County by 2:30 p.m. Tuesday, according to data from automated rain gauges shared by the National Weather Service. It was expected to persist through the night, before eventually tapering off on Thursday.

"The final heavy band should be pushing through around rush hour," National Weather Service Meteorologist James Brotherton said Tuesday.

The downpour raised the risk of mudslides in mountain regions, especially near the burn scars left by the Bond fire in 2020. Nearby

residents in Silverado Canyon were issued a mandatory evacuation order effective 9 a.m.

A reception center for displaced residents was set up at the Norman P. Murray Community & Senior Center, 24932 Veterans Way in Mission Viejo. Those with small pets were welcome to leave them in the care of OC Animal Care at their shelter in Tustin, at 1630 Victory Road. Owners of larger animals were invited to drop them off at the OC

Fair and Events Center at 88 Fair Drive in Costa Mesa.

Orange County Public Works crews were seen stacking sandbags on rain and mud-covered streets in Silverado Canyon Tuesday, the last day to cast ballots in the 2022 midterm election. A voting center in that area as well as all parks and trails across Orange County were closed due to wet, muddy conditions. The possibility of hazardous debris flows led to road closures at the canyon en-

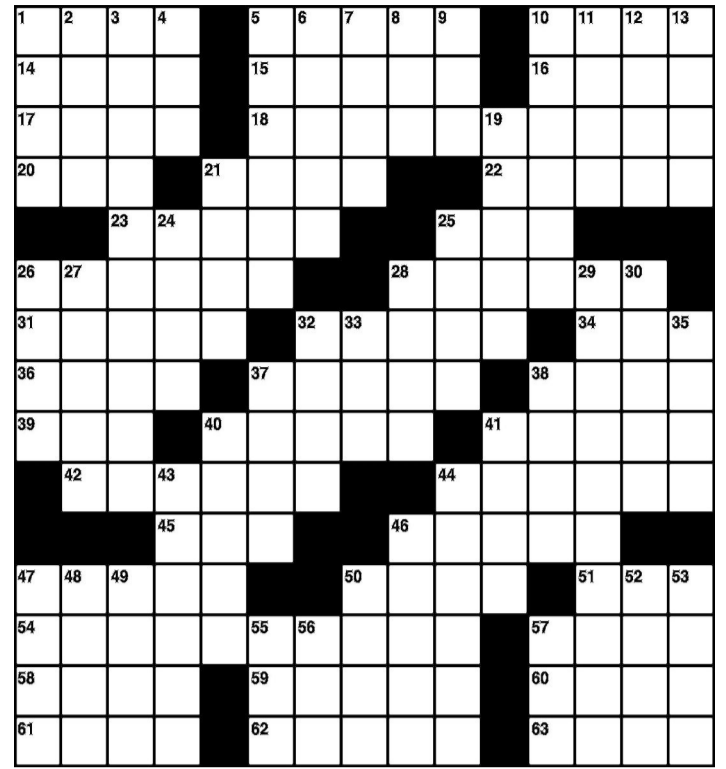

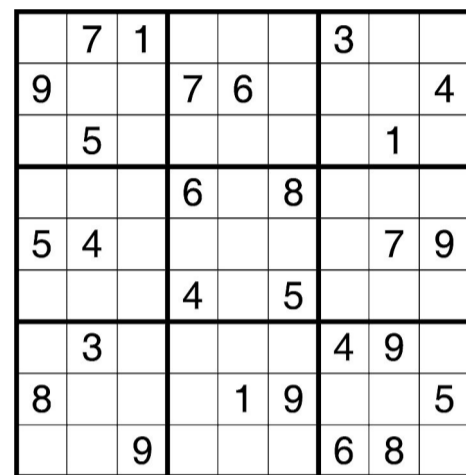

trances of Silverado, Williams and Modjeska Canyons, Orange County Sheriff's officials said.

After the storm passes on Thursday, Orange County residents can expect dry weather through the rest of the week, Brotherton said. By Friday, meteorologists expect highs of 66 degrees near John Wayne Airport, 68 degrees in Fountain Valley, 65 degrees in Huntington Beach, and 64 degrees in Laguna Beach and Newport Beach.

The storm this week came early in Southern California's rainy season and brought much-needed water to a region struggling through chronically dry conditions, Brotherton said.

"But it will take more than one storm to wipe out a drought," he said.

sewage leak, and immediately switched the sewage from one forcemain to the other.

"We have two 16-inch forcemains in that area," Cabral said in an email. "Once the sewage was switched to the other forcemain, the leak stopped. The spill was reported, contained and cleaned up within a few hours."

Cabral said the spill was estimated at 10,615 gallons. The district will conduct an assessment of the pipeline in which there was the leak to determine what repair will be required, she added.

The closure affected the water in all west

Newport Bay channels between 33rd and 43rd streets, as well as the bay water area east of the Newport Boulevard Bridge to the Lido Isle bridge, along with the projection of Pacific Coast Highway and Tustin Avenue.

Bacteria levels up and down the Orange County coast were labeled "yellow" during Tuesday's rainstorm on ocbeachinfo.com, meaning the bacteria levels exceeded state health standards and may cause illness. Beaches were no longer labeled "red," however, their designation when ocean water is closed due to sewage or contaminated water.

in also made it difficult to determine his ethnicity, Steinle said. Investigators initially thought he might have been white or Latino.

But in 2021, a sample from one of his bones was submitted for advanced DNA analysis, OCSO officials said in a news release. That revealed that he was primarily of Chinese descent.

Based on that information, a new rendering of his face was created and has been distributed to the public. He is depicted grinning with brown, almond eyes, furrowed by his smiling expression. He had lightly tanned skin, short dark hair and a somewhat slim build in the image released on Tuesday.

Orange County Sheriff's officials hope someone might recognize the man so they can notify who he was and learn his loved ones.

Unified School District are up for election. Only two of those races include incumbents, current board president Michelle Barto and school board member Ashley Anderson.

Barto and Peterson are currently maintaining their leads in each of their trustee districts. Barto is reporting in with 70.2% of the votes in District 5 over

fellow candidate Reina Shebesta, who holds 29.8% of the votes. Anderson, meanwhile, has taken the lead over two other candidates, Kristen Seaburn and Vicky Rodriguez, with 64.4% of the votes. Seaburn and Rodriguez are reporting in with 21.2% and 14.4%, respectively.

In Trustee Area 2, Michelle Murphy is leading the race with 66.9% of the votes. Candidate Danielle Mills follows with 33.1%. Meanwhile in Trustee Area 4, Lisa Pearson currently holds the lead with 62% of votes as compared to fellow candidates Barbara George with 28.4% and Kristen Nicole Valle with 9.5%.

FOUNTAIN VALLEY SCHOOL DISTRICT

The Fountain Valley School District is not divided up into individual trustee districts.

The top three vote-getters of the six candidates are elected to the board, and voters are asked to pick up to three candidates for their ballots. Those three currently appear to be Sandra Cran-

dall, Dennis Cole and Megan Irvine.

Crandall, an incumbent, was first elected to the board in 2010. Crandall holds the most votes with 21.7% cast in her favor. Cole accounts for 16.7% and Irvine, 16.5%.

They are followed by Phu Nguyen, 16.4%; Eileen Maeda, 15.7%; and Trisha Rintoul, 13.1%.

The district presides over seven elementary schools and three middle schools.

HUNTINGTON BEACH CITY SCHOOL DISTRICT

There were only two seats up for election in the Huntington Beach City School District with incumbents Diana Marks and Paul Morrow running to hold onto their seats in Trustee Areas 4 and 5.

Both Marks and Morrow currently appear to be holding the majority of the votes as of Tuesday evening. They currently hold 63.4% and 64.2% of the votes respectively.

Competitors Autumn Digiovanni and Julie Norton hold 36.5% and 35.8% of the votes in their trustee areas, respectively.

dependent voter who cares about the economy and the abortion issue. "We wanted a change in both the federal and state government." "I'm really afraid of the way we're going," Jo Pursley, 88, agreed.

A Spanish teacher who taught the language to English and native Spanish speakers in New Mexico, Long Beach and South Central Los Angeles, Charles Pursley said he's concerned about public school education. Voting, he said, is the best way to make your voice heard.

"Regardless of your preferences, you should vote," he said.

Two seats are at the center of this year's race for City Council, in addition to the at-large mayoral position in Costa Mesa.

The mayoral race, which is up every two years, is currently being led by incumbent John Stephens, with 61.5% of the votes cast, according to early results. Stephens, who was first elected in 2016 and was directly appointed to replace former Mayor Katrina Foley, is followed by candidate John Moorlach, a former county supervisor and state senator, who had 38.5% of the votes in the early returns.

In Districts 3 and 5, City Council incumbents Andrea Marr and Arlis Reynolds are on trend to hold onto their seats. Ballots in favor of Marr and Reynolds account for 54.2% and 70.3% of the early votes, respectively. Competitors John Thomas Patton and Jorge Miron had 32.4% and 13.4% of the votes in District 3, while in District 5, candidate Robert Dickson received 29.7% of the votes.

Incumbent Councilman Manuel Chavez ran unopposed in his district.

Costa Mesa also has a proposed ordinance on the ballot — Measure K — which seeks to address the course of future development and housing within the city. If approved, it would exempt certain commercial and industrial corridors from an existing rule that would require voter approval of projects that exceed the city's general plan and zoning code.

As of Tuesday night, 7,418 residents had voted in favor of the measure.

There are 61,664 voters in Costa Mesa.

FOUNTAIN VALLEY

A steady trickle of people cast their ballots at Freedom Hall at Mile Square Park in Fountain Valley, a voting center that typically sees less traffic than the other three in the city, resident Anthony Thompson, 48, said. That's why he chose to vote in person

there on election night. He said he was in just a few minutes.

"Everyone's talking about election security this year, but I have full faith in the system," the client services manager for a marketing firm said. "I think they do a good job."

In Fountain Valley, three of the five City Council seats were on the ballot.

Fountain Valley is not divided into council districts, so all 13 candidates running for a seat vied in the same race. Voters were asked to select up to three candidates. The three front-runners will be the ones sworn in in December. Currently in the lead are Fountain Valley School District board member Jim Cunneen is leading with 3,530 of votes; incumbent Patrick Harper, with 3,255 of votes; and incumbent Kim Constantine, with 3,217 of votes.

They are followed by Steve Nagel, with 2,752 votes; Cindy Cao, 2,630; Alicia "Rudy" Huebner, 2,060; Michael Mau, 1,453; Glenn Bleiweis, 1,230; Darrel Mymon-Brown, 1,080; Eugene Murray, 732; Nancy Dugay, 487; Shaun Diamond, 394; and Dwight Shackelford, 339.

There are 37,619 voters in Fountain Valley.

HUNTINGTON BEACH

In the battleground of Huntington Beach, 18 candidates competed for four of the seven seats on the dais. No incumbents were on the ballot as currently sitting members — Mayor Barbara Delgleize, Mayor Pro Tem Mike Posey and Councilman Erik Peterson — will all term out this year and Councilwoman Kim Carr is seeking a seat in the state Senate.

Early results indicate the four front-runners of that race are Pat Burns, with 11.8% of votes, Tony Strickland, with 11.8% of votes, Gracey Van Der Mark, with 10.4% of votes, and Casey McKeon, with 10.4% of votes.

They are followed by Gina Clayton-Tarvin with 9.5%; Kenneth Inouye, 8.8%; Jill Hardy, 8.6%; Oscar Rodriguez, 8%; Brian Burley, 4.7%; William "Bilby" O'Connell, 3.2%; David Clifford, 2.7%; Vera Fair, 2.6%; Mike Vogler, 2.2%; Bobby Britton, 1.9%; Gabrielle Samiy, 1.6%; Amory Hanson, 0.7%; Jeffrey Hansler, 0.7%; and lastly Robert Reider with 0.4% of the votes.

Additionally, City Atty. Michael Gates garnered 58.1% of the votes against competitor Scott Field with 42% of the votes counted as of Tuesday.

The city also had a number of measures on the ballot this year. Measures M and N sought to amend the city charter and delineate the responsibilities of the

city clerk, treasurer and attorney. Measure O would permit the taxation of commercial cannabis businesses within city limits, and Measure L would allow the council to construct restrooms or replace existing equipment and infrastructure that does not exceed 10% of its footprint and height without voter approval.

As of Tuesday night, roughly 22,067 residents are in favor of Measure O, but it's a closer margin for Measures L and N. Measure M is currently leaning squarely against those amendments with 19,265 voting against it. The "no" votes currently have it for Measures L with 51.3% and "yes" votes for N with 50.6%.

Roughly 133,000 voters reside in Huntington Beach.

LAGUNA BEACH

In what has been a heated race in Laguna Beach, seven candidates are fighting for a seat on the five-member board. As in Fountain Valley, council representation is not divided into districts. The top three vote-getters will be elected and sworn onto the dais in December. Voters will be able to choose up to three candidates.

Incumbent Sue Kempf, with 21.6% of the early votes was just behind leader Alex Rounaghi, who garnered 22.2%. Incumbent Peter Blake appears poised to be ousted from the dais, having garnered only 9% of the early vote.

Mark Orgill, who received 14.7% of the early votes, might be filling the third seat. He is followed by candidates Jerome Pudwill with 12%; Ruben Flores with 11.3%; and Louis Weil with 9.4%.

Longtime Councilwoman Toni Iseman bowed out of the race this year.

Also on the ballot for Laguna Beach residents this fall were three ballot measures — Measures Q, R and S. Measure Q would establish an overlay zoning district and require voter approval on major development projects. Measures R and S deal chiefly with the city's hotels. Measure R would facilitate the creation of a hotel development overlay zoning district and require voter approval for hotel development projects. Measure S focuses on creating a minimum wage and establishing workplace standards for hotel employees.

Laguna Beach voters appeared to be overwhelmingly against all three measures with the "no" votes

lodged holding majorities of more than 60% of the ballots cast so far.

About 18,000 people are registered voters in the city.

NEWPORT BEACH

Standing among Costa Mesa denizens lined up at the community center were Newport Beach residents Karen and Gary Swanson, who came out because the location was listed on their ballot books as the nearest polling center.

Karen Swanson has been voting since the '70s and said she feels it does make a difference. This cycle, she chose to focus on council candidates who campaigned on platforms of slower growth, public safety and preserving the quality of life in the city, casting votes for Erik Weigand and Joseph Stapleton.

"I care about keeping Newport Beach not developed too much, when it comes to who's going to be on the [council]," she said, adding that in addition to reading her voter information guide, she looks to see which endorsements candidates have received.

"I usually look at the police and fireman, who they endorse, because of crime and homelessness," she added. "We'd love to see a change of direction, but we'll see what happens."

Eight candidates are running for four open seats on the Newport Beach City Council.

Three sitting councilmembers will be terming out this fall and only one incumbent, Councilwoman Joy Brenner, ran for reelection. In addition, one of the races was uncontested. Candidate Robyn Grant will be taking on the seat for District 4.

In District 1, Joe Stapleton is leading the race with the current majority of the votes at 59.6%. Fellow candidate Tom Miller followed with 40.3%. In District 3, the race was a toss-up for who will be elected between three candidates — Planning Commissioner Erik Weigand, Jim Mosher and Amy Peters. Weigand is currently leading the race with 54.1% of the votes.

Trailing behind is Jim Mosher with 30.2% of the votes and Amy Peters with 15.7% of the early votes cast.

Meanwhile in the lone reelection race, Brenner is ahead of Planning Commissioner Lauren Kleiman with 52.7% of the votes and Kleiman with 47.3%.

About 61,000 voters live in Newport Beach.

NORWALK — The Marina High girls' volleyball team made a post-season run that even they could not believe had come to fruition.

After an extended absence from the CIF Southern Section playoffs, the Vikings found themselves on the biggest of stages, and that is when the carriage turned back into a pumpkin on a Cinderella story.

Sherman Oaks Buckley had the answers in serve receive, paving the way for the Griffins to earn a 25-21, 25-23, 25-19 sweep of the Vikings on Saturday in the Division 5 final at Cerritos College.

Buckley (21-2), the Liberty League champion, won its second title in program history. The Griffins also won the Division 8 title over Capistrano Valley Christian in 2017.

"I told this team from the beginning, 'We are the dominant team. We are the better team, but the better team doesn't always win,'" Buckley coach Otis Glasgow said. "As long as we focus on our fundamentals and we execute on the things that we've been doing in practice, that's the team when we play together."

"It was beautiful. We were clicking on all cylinders, even when we were making mistakes."

The Griffins had more opportunities to play in system, allowing for more aggressive swings from junior middle blocker Sophia Wolfson, a Brown University commit, and junior outside hitter

Buckley's back-row passing had junior setter Charlotte Reff running the offense from the top of the net. Sophomore outside hitter Tate Drageset was a standout in serve receive.

"The biggest thing ... when I

first saw the first bit of film on Marina was they have a really good jump serve," said Glasgow, who added he personally was jump serving to his team in preparation for the Vikings. "That's not something you see in the girls' game a lot. ... Our serve

"This is a lot of people's dream to play in a place like this with everyone watching and playing in such a great game," Vikings senior setter Jordan Packer said, admitting that the pressure of the moment was felt by her team. "We're all so blessed to have the opportunity to be playing in playoffs."

Senior outside hitter Dominique Vadeboncoeur had 13 kills and two blocks to lead Marina. Senior outside hitter Jalissa Costa added five kills and four service aces, and junior middle blocker Lyndsey Wessel chipped in with four kills. Packer, often on the run in the match, delivered 27 assists to go with four aces. Junior outside hitter Jenna Zaffino also had two blocks.

Marina's best opportunity of the match saw the Vikings take a 19-15 lead in the second set, but it slipped through their fingers. Drageset had the ace that closed out the set.

"We've been in matches with spotlights, but we hadn't been challenged so it didn't really matter," Marina coach Jake Nuneviller said. "This is the first time that we were pushed in a game that was important, and I don't think we responded to that as well as we maybe could have."

Beach and Newport Beach:

5TH SUPERVISORIAL DISTRICT

County Sup. Katrina Foley is holding the lead in the race to represent District 5 on the Orange County Board of Supervisors. The district represents Costa Mesa, Newport Beach, Laguna Woods, Irvine, Aliso Viejo, Laguna Hills, Laguna Beach, La-

guna Niguel, Dana Point, San Juan Capistrano, San Clemente and some unincorporated land. Foley is maintaining a lead of 56.8% over state Sen. Patricia Bates, who is reporting just 43.3% of the votes.

36TH STATE SENATE DISTRICT

Democrat and Huntington Beach Councilwoman Kim Carr is falling behind to state Assemblywoman Janet Nguyen. Nguyen currently represents the 72nd Assembly District but

moved to run for the state Senate this election cycle. Carr currently has 47.6% of the votes and Nguyen has 52.4%.

The district includes Cerritos, Garden Grove, Fountain Valley, Huntington Beach, Newport Beach, Laguna Beach and San Clemente.

70TH STATE ASSEMBLY DISTRICT

In the race for the 70th State Assembly District, which includes Westminster, Garden Grove and

Fountain Valley, Westminster Mayor Tri Ta appears to be leading the votes with 27,787 of the ballots counted in his favor. But, Ta is holding a slim margin over competitor Diedre Thu-Ha Nguyen, who is following behind with 27,642 of the votes — a difference of just 145 votes.

72ND STATE ASSEMBLY DISTRICT

With the seat to be vacated by Nguyen, Newport Beach Councilwoman Diane Dixon faced off against

Democratic candidate Judie Mancuso in the 72nd State Assembly District, which includes the coastal cities of Huntington Beach, Newport Beach and Laguna Beach. The race in this assembly district is also fairly close, with Mancuso currently holding the lead with 50.1% of the votes and Dixon not far behind with 49.9%.

73RD STATE ASSEMBLY DISTRICT

Meanwhile, in the 73rd State Assembly District, As-

semblywoman Cottie Petrie-Norris is charging ahead of competitor Steven "Steve" Choi with 60.1% of the votes. Choi is reporting in with 39.9% of the ballots cast for this district. The 73rd State Assembly District is currently represented by Assemblywoman Laurie Davies (R-Laguna Niguel).

This district includes the cities of Costa Mesa and Irvine.
