LOCAL ELECTIONS

7 vying for two seats on F.V. City Council

Candidates elected in November will serve four-year terms.

Two of the five seats on the Fountain Valley City Council are up for grabs in the Nov. 3 election. Those seats belong to Mayor Cheryl Brothers and Councilman Steve Nagel, who will not seek reelection.

Fountain Valley City Clerk Rick Miller confirmed that seven candidates have successfully filed papers and been qualified to run for City Council.

Elected candidates serve four-year terms.

Here is a quick look at the candidates running, in alphabetical order:

Cheryl Brothers (incumbent): Running on a platform of fiscal stability, Brothers was first elected to the council in 2002. Brothers served on Fountain Valley's Parks Commission for nine years and on the City Planning Commission for six years. The 46-year Fountain Valley resident has said police, fire and city services should continue to be prioritized.

Ted Bui: Bui runs a small business, Express Merchant Business Loan LLC, that provides loans to other small businesses and he is a case manager for Arlington Law Office. In his candidate statement, Bui said that he plans to prioritize public safety, including supporting police officers and

O.C. public relations professionals forced to pivot during pandemic

The word "pivot" is one that has been used a lot to describe how people's roles have changed during the novel coronavirus pandemic.

Costa Mesa resident Allison Olmstead prefers the word "hustle." That word perhaps more accurately describes what Olmstead and other public relations professionals have had to do since March.

Olmstead, the CEO and founder of TO Media Co., has several national-level clients and has needed to get creative in finding the best way to serve them.

"You have to hustle," she said. "For us, getting stories in the press is difficult right now, because everybody's talking about COVID. It's been challenging in one way, but at the same time it's been awesome, because it's allowed us to be way more creative."

"We've had to take what we do and expand our role. In traditional PR, you would get stories in 'earned' media. Now, we've added all these different layers to it for our clients, which is why we have copywriters and social media people."

Olmstead also has become familiar with the word "teamlancing," which refers to several freelancers with different specialties

coming together to help serve a client. A big part of her team has been Irvine resident Jane Gillespie, who specializes in public relations on a more local level in Orange County. They work together to serve Villa Real Estate.

"Normally, we would be pitching for ourselves, but now both of us have been offering and marketing ourselves as a team," said Olmstead, 47.

"You have access to a bigger, broader team if you need other experts, like Christopher Luu with the copywriting for example, or if

Police's arrest of woman in \$16 cab ride dispute costs Newport \$360K

Newport Beach has agreed to pay \$360,000 to settle a wrongful arrest suit stemming from a 2016 incident involving a declined credit card for a \$16 cab ride.

The case brought by Ashley Watts unfolded on June 26, 2016, when Watts took a taxi back to her Newport Beach apartment after drinking at a nearby hotel, according to federal court documents. Her credit card was declined for the \$16.70 charge, and the taxi driver called police to help him collect his fare.

Not long after, Newport Beach police Officers Christine Maroney

and Monica Aguilar slammed Watts into a wall and took her to the ground after she told them they couldn't enter her apartment and arrested her for theft.

In an August 2019 hearing before a three-judge panel of the U.S. 9th Circuit Court of Appeals, Judge Ryan Nelson questioned how the incident escalated.

"Who in the world arrests an individual for failing to pay cab fare?" he asked Anthony Taylor, the lawyer representing the officers. "How in the world did this happen? This just seems to me to be strange at a minimum."

UCI Health opens new Newport location

In Newport Beach this week, UCI Health opened its new Newport Beach location at 2161 San Joaquin Hills Road.

The facility focuses on disease prevention and health management through "[consideration of] all aspects of a patient's mind, body and spirit."

A brief ribbon-cutting ceremony was held Tuesday evening, but the facility officially opened on Monday. UCI staff and guests were guided on a tour of the 7,000-square-foot building on the corner of San Joaquin Hills Road and Avocado Avenue.

It includes 14 examination rooms, three treatment rooms and one room for procedures. University officials said that the medical center would be holding a virtual open house for the facility on Sept. 1.

It will employ 13 nonprovider staff members, with about five providers working through the week.

"We're very excited about this new site in Newport Beach," said cardiologist Shaista Malik, associate vice chancellor for integrative health at the Susan and Henry Samueli College of Health Sciences. "We have a very unique collaboration of integrative health alongside cutting-edge medical care. We are going to have acupuncture, nutrition, massage, yoga and mindfulness."

Malik said that the services will be offered along with integrative programs in pain management, cardiology, gastroenterology, neurology, dermatology and sports medicine along with concierge primary care that will be delivered by trained pro-

viders. "This allows us to really tailor and personalize a patient's care because we are able to use advanced diagnostics to figure out what treatment plan works best for that patient," Malik said. "So, it's not a one-size fits all. It's really personalized care that incorporates all the treatment, incorporates all the root causes of illness and that includes nutrition, exercise, sleep, stress management and emotional well-being. This is very, very unique."

Dr. Ailin Barseghian, who specializes in preventative cardiology and integrative heart health, said in a statement that the approach at the Newport Beach center is focused on the "whole person," meaning that patients would be treated for immediate

Fountain Valley fire chief makes pitch for full-time EMS manager

The Fountain Valley Fire Department went before the City Council on Tuesday night to present its case for the hiring of a full-time emergency medical services (EMS) manager.

A part-time position was first created in 2014, Fountain Valley Fire Chief Ron Cookston said, owing to a significant increase in the number of calls the department fielded per year. In a study session, Cookston indicated that the department's call load was about 2,500 in 1995 and has increased to 7,000.

The position acts as the Fire Department's prehospital care advocate and liaison. Vital duties of the EMS manager included quality assurance and improvement, as the presiding nurse would create an educational curriculum to enhance the knowledge of the paramedics.

Additionally, the EMS manager participated on county and state committees. Cookston said that was important because it helped to "keep our paramedics informed on all of the responsibilities that come up and change as state and federal law changes."

As the city has dealt with the coronavirus pandemic,

the value of the position was only further accentuated.

"The COVID-19 crisis identified how important our EMS manager is," Cookston said. "The EMS manager position itself solely helped educate and protect every department in our city during this crisis."

But the position could offer even more to the community if the city assumed full control. Fountain Valley fire personnel has assumed the most vital duties of the position after the most recent EMS manager, Shelley Brukman, took a job to pursue pediatric education, Cookston added.

Fountain Valley had entered into an agreement with Huntington Beach on a 75%-25% split of the salary for the EMS manager, with the latter city paying the lesser amount, but Cookston said that with a larger staff, Huntington Beach is able to fulfill its EMS needs without the arrangement.

With a full-time EMS manager available, Cookston believes that the position would be able to provide additional services to the community.

The Fire Department wants to incorporate public education programs, help

skilled nursing facilities on fall prevention and assist in COVID-19 prevention.

Public education for schools and enhanced hospital relationships would also be a priority.

Councilman Patrick Harper said that the fire chief will return at a future meeting to provide more details on the position.

"In the past, there has been difficulties with part-time staffing, so hiring a full-time person is the best option to recruit a person of the requisite skill level," Harper said with regard to the prospective hiring of an EMS manager.

Cookston was encouraged by how the council received the presentation.

"The EMS manager position just provides incredible education and opportunity for our community," Cookston said.

"We're a small town of two [fire] stations that is very busy and runs a lot of calls. We're very excited to be working with the council to keep this important position a part of our team."

Council members also voted to approve the purchase of new vehicle-extrication equipment for the Fire Department.

you need someone to pull together a pitch or a press release. They trust us with the brand, and so they trust us with our team too. We've done all of the back-end work to find the right person for them."

Luu is a Fountain Valley-based copywriter who is the evening editor for the InStyle website. He also has a job as a digital content manager in the travel industry, but he's currently furloughed from that position.

He said the partnership with Olmstead has been key as he tries to survive.

"We've all had to try to take on more or do things that we normally wouldn't do before," Luu said.

"I never would have said that I was a copywriter, because when you're in a school and you're a journalism person, you say that you're a journalist. You don't want to work as a copywriter. But now, it's just like give me the money. I'll do anything, as long as I get paid."

COVID-19 continues to impact Orange County. There were 18 deaths due to the respiratory disease reported Wednesday by the Orange County Health Care Agency, bringing the cumulative death toll to 833.

Also Wednesday, there were 295 positive tests received, which puts the cumulative case count of the coronavirus, including deaths, at 44,507.

There were 5,282 new tests reported, and 565,386 tests have been issued to date.

Gillespie has a few shopping mall clients, including the Triangle in Costa Mesa and Kaleidoscope in Mission Viejo. She has worked with Marcie Taylor, who specializes in social media and digital marketing, to help promote stores at both locations.

"In times of a recession or economic uncertainty, a lot of companies tend to

cut back on PR or marketing efforts first," said Gillespie, 53.

"That's one of the first budget items to go, but I think a lot of savvy companies realize this is really the time that they need to keep pushing ahead and elevate or expand on their marketing and PR efforts. We can fill that role, we can be very flexible and we can be really nimble. What's good about the 'teamlancing' concept is the freedom and the flexibility not just for us, but the team that we're able to create for the client."

Taylor recently moved to Santa Ana but has done much of her public relations work in Huntington Beach, including as the founder and publisher of *SurfCityFamily.com* and her work on the annual "Surf City Surf Dog" contest, which she said was recently canceled for 2020.

For many of the restaurants at the Triangle, ever-changing rules regarding dine-in options have made PR professionals even more valuable.

"One of the first things we had to do was coordinate the messaging about being closed," Taylor said.

"From there, we brainstormed with our client, trying to see what we could do when the rules were set out. Usually, when you're trying to drive people to your mall or

restaurant, you would do it with live events ... but we had to pivot toward something virtual or take-out. We've been working hand in hand with that, and the main way people are now communicating is all digital, so that's made it more crucial for us to work together with messaging."

Those coming into public relations from college also are seeing opportunities. Costa Mesa resident Devyn Copeman is an incoming junior at USC who has worked for Olmstead this summer on things like putting together press books and news releases.

Corona del Mar High School graduate Sydney Alacano also recently graduated from the University of Colorado Boulder with a degree in public relations.

"It's nice to know that we have [teamlancing] as an option," Alacano said. "I'll be looking for a job, but it's encouraging to know that I can use this as a little side hustle."

There's that hustle word again. Olmstead wouldn't have it any other way.

"Lately I've been working out of the garage with the garage door open," she said. "I feel like I'm a part of the world, instead of being inside."







Newport Harbor High's Olivia Giolas commits to USC

Olivia Giolas saw her first in-person college water polo game before the novel coronavirus pandemic hit.

The incoming Newport Harbor High School senior went to the Barbara Kalbus Invitational Tournament at UC Irvine in late February saw rivals USC and UCLA do battle. The Trojans won 9-7, and Giolas was more than impressed.

"Everybody was involved, whether they were on the pool, whether they were on the bench, the coaching staff," Giolas said. "Everybody was unified together ... It's really the place that I want to be."

Giolas said she has verbally committed to play women's water polo at USC. Giolas, who plays center for the Sailors, said that she was also considering UCLA and Michigan, but in the end she chose the cardinal and gold.

This law will finally permanently and fully fund the Land and Water Conservation Fund, which provides much-needed funding to restore our parks and public lands by addressing severe maintenance backlogs. President Trump casts doubt on the election

No two ways about it, Orange County, Donald Trump is a threat to American democracy.

Why? Because the nonsense he is peddling — that the authenticity of mail-in ballots cannot be validated and therefore the results of the November election will not be legitimate — goes to the heart of what separates us from most of the world: the right and freedom to vote.

Forget the fact Republicans from Fullerton to San Clemente have promoted the use of mail-in ballots for years. I am troubled by two issues directly tied to what the president is saying.

First, does this mean the results for all O.C. elections — from school board to city council, from state office to Congress — also will be in jeopardy; and second, will this give Kentucky's Mitch McConnell, Iowa's Joni Ernst and Arizona's Martha McSally the ammunition they need not only to question the outcome of their hotly contested races this fall but to maintain the GOP majority in the Senate?

House Speaker Nancy Pelosi says Mr. Trump's attempt to cast doubts on November's election is really about voter suppression. True or not, this is hardly new.

What is new about the president's repeated, unsubstantiated remarks is this: COVID-19 and a sinking economy are wreaking havoc on his bid for reelection. And because neither is likely to change course between now and Nov. 3, the only strategy left is for him to fan the flames of fear.

During his first inauguration address in 1933, President Franklin D. Roosevelt told a weary nation, "The only thing we have to fear is fear itself." If only this were true today.

symptoms, but doctors and nurses will also be looking at patients' health history and lifestyles in depth to devise a treatment plan.

"We assess nutrition and fitness, as well as sleep patterns and any possible stressors — such as whether someone is going through a divorce or a difficult time on the job — to see if there's an underlying cause," Barseghian said. "We might also try acupuncture, which studies show can lower blood pressure if a regular regimen is

maintained."

Nasim Afsar, chief operating officer for ambulatory care at UCI Health, said Tuesday that the Newport Beach center expects over a hundred patients to the new site in its opening week.

"At UCI Health, we make a daily commitment to stop at nothing to meet and exceed the expectations of every member of our community," said Chad Lefteris, CEO of UCI Health, in a statement. "Our multidisciplinary clinical care teams provide world-class primary and specialty care driven by the discovery and innovation of Orange

County's only university health system."

"UCI once again is on the forefront of providing medical services and support for our community," Rep. Harley Rouda (D-Laguna Beach) said. "We are thrilled to have them here in Newport Beach opening up this facility."

The university said it would also be breaking ground on a 168,000-square-foot outpatient center on Jamboree Road in 2021. It is anticipated for completion by late 2022, pending approvals.

Nelson said the officers should have used discretion, a sentiment reflected in the resulting filing the court released in October: "Can a declined credit card for a \$16.70 cab fare result in a [federal civil rights] action? One would think not. But here we are."

According to court documents, Maroney escorted Watts to her apartment to get cash for the driver, but she objected to their entry when Maroney and Aguilar started to follow her inside.

That's when Maroney said she would just take Watts to jail, and the two officers pushed her against a wall, kicked her legs out from under her, applied their body weights on top of her and put her in handcuffs.

Watts spent the night in jail. The Orange County district attorney filed charges, but
