Another couple files lawsuit against clinic

At least 12 couples claim Ovation Fertility's negligence led to the destruction of their embryos.

One more couple came forward in a lawsuit filed last month alleging a Newport Beach fertility clinic of negligence and fraud after an apparent laboratory error resulted in the destruction of their fertilized embryo.

The couple, identified only by the initials R.N. and E.K in a new lawsuit filed Aug. 6, are at least the 12th to make such claims against Ovation Fertility since April. They say their embryos were killed after hydrogen peroxide instead of a sterile solution was used to clean the incubator their fertilized eggs were stored in.

Representatives for Ovation could not immediately be reached for comment. The Tennessee-based company was founded in 2015 and runs 22 facilities across the country.

Attorneys representing the latest couple to sue the company say R.N. underwent hormone therapy, frequent testing and paid thousands of dollars with E.K. for

Newport Harbor tops CdM, takes lead in Sunset League

Girls' flag football has experienced growth that rivals the pace of play of the game itself.

Tentative agreements were approved with the district's two employee unions, offering 7% raises and benefit enhancements.


Newport-Mesa Unified officials unanimously approved two tentative agreements with the school district's teachers and classified employees unions on Tuesday, offering 7% salary increases and other benefit and workplace enhancements for the 2024-25 school year.

The pay bump, retroactive to July 1, also applies to members of the superintendent's executive team, school administrators, directors and confidential employees not represented by bargaining units.

All told, the newly negotiated



Artist G. Ray Kerciu led movement to save Laguna Art Museum and won

Laguna Beach artist G. Ray Kerciu — who spoke truth to power in the Civil Rights-era south and helped save the Laguna Art Museum from a takeover in the 1990s — died peacefully in his home Aug. 25 at age 93, according to his wife, Mihae Park.

Those who knew him recalled Kerciu as a passionate activist willing to stand up for his beliefs and skilled at rallying the community to a cause, yet humble enough to step back after a victory and let others lead.

"He was willing to go to battle when something didn't seem right," said Julie Perlin Lee, executive director of the Laguna Art Museum. "And when he had the right people in place, he passed the mantle and moved on — he was very much a fixture in our community."

Kerciu is also remembered as a prolific and versatile creator who worked in many different media including, in later years, an iPad that provided a new canvas for the nonagenarian's ever-expanding expression.

A celebration of life to honor the artist's life and work is planned for Sept. 28, from 4 to 6 p.m., at the Laguna Art Museum, located at 307 Cliff Drive.

Barbara McMurray, a neighbor and contributor to the Laguna Beach Independent, interviewed the celebrated artist for a profile coinciding with his 90th birthday on Oct. 24, 2023.

Her piece details a life centered around art, activism and adventure, from his birth in 1933

BOYS' WATER POLO Newport Harbor sprints to South Coast tourney title

The final of the South Coast Tournament was played across the bay at Corona del Mar High School on Saturday.

Newport Harbor's aquatics complex on campus is being renovated, and expected to reopen next fall.

For the Sailors boys, that has meant morning practices at Estancia High School. The girls are practicing at Costa Mesa High, Newport Harbor coach Ross Sinclair said.

Sinclair said it's been a sort of Rubik's Cube for him to organize, but his players are doing fine.

"I think it was a little adjustment at first, and I think they're in a nice little groove now," he said.

No kidding.

Newport Harbor romped to the South Coast Tournament title, topping rival ISerra 14-6 on Saturday in the title match to snap the Lions' 40-match winning streak that dated to 2022.

Junior Kai Kaneko led with five goals, three on penalty shots, for the Sailors (9-0). Emerging junior center Geoff Slutzky added three goals, along with two exclusions drawn and two penalty shots drawn.

Senior attacker Weston Hartel scored twice and had a match-high five steals, while senior defender Lucca Van Der Woude, a transfer from Studio City Harvard-

Westlake, also scored twice. Junior Dash D'Ambrosia and freshman Caruso Polenzani added goals for the winners. Junior standout Connor Ohl, who returned recently from injury, did not score in the final but had two steals and drew several exclusions.

Newport senior goalkeeper Luke Harris made nine saves and set the tone early, stuffing a point-blank power play shot by JSerra in the opening moments of the match.

"It's a good group," Sin-

clair said. "They're together, they're around each other. It's a good vibe for this group, good camaraderie. Obviously, if you put it together and have some success it makes it a lot of fun as well. For us, it's how can

we get better from this?" The Sailors led just 4-3 late in the second quarter after Porter Birdsall, who led JSerra (7-1) with three goals, scored on a penalty shot. But Newport used Kaneko's power play goal, then a quick drawn exclusion and goal by Slutzky, to

take a 6-3 advantage into halftime.

Newport Harbor then scored the first four goals of the second half, opening a 10-3 advantage on another power-play strike bv Kaneko. After competing for the U.S. Cadet national team in Malta this summer at the World Aquatics U16 Water Polo Championships, he has come into the high school season a more confident player.

"That tournament was really fun, getting to play new roles and see how I

could shoot," Kaneko said. "I think mindset-wise, it's carried on here for sure. just being more relaxed in the water helps a lot, and having fun too."

Newport Harbor and JSerra have met in the last two CIF Southern Section Division Open title matches, with the Sailors prevailing in 2022 and JSerra last year. Saturday's result was the Lions' first loss since that 2022 CIF title match

Newport Harbor made the final by blitzing Harvard-Westlake 17-6 in the semifinals earlier Saturday. Ohl had a team-best four goals, while junior lefthander Mason Netzer scored three.

The Sailors are deep and will get deeper. Senior center/defender Santino Rossi and senior left-hander James Mulvey, transfers from Mater Dei and JSerra respectively, will become eligible on Tuesday after serving their sit-out period.

But the Sailors also know that JSerra has some key transfers coming eligible as well.

"[Winning the South Coast Tournament] feels great, but it's still early in the season," Slutzky said. 'They're going to get better, we're going to get better. We're going to see each other a lot this season. They're going to get their guys back, we're going to get some new guys.

It'll be fun."

CDM PLACES EIGHTH IN SOUTH COAST TOURNAMENT

Host Corona del Mar finished eighth in the tournament after a pair of close losses Saturday.

The Sea Kings couldn't hold a three-goal lead and fell 12-10 to Mater Dei in a fifth-place semifinal, before falling 14-13 in suddendeath overtime to Miramonte in the seventh-place match.

In the latter match, CdM (10-3) couldn't quite hold a two-goal lead in the final minute.

"I think today showed a little bit of our inexperience, but I think my guys can learn from it," CdM coach Lucas Reynolds said. "We're going to be a better team from it. We're young, but we're rapidly improving, and I'm really proud of our position here. Being top eight in this tournament is a big deal. It's the biggest tournament of the year. I think my guys battled hard this weekend and I'm proud of what they did."

Laguna Beach finished 21st, capping its tournament with a win over San Juan Hills, and Huntington Beach won its final match against Ventura to finished 25th. Edison placed 32nd in the tournament.

Ovation's services. After one previous unsuccessful attempt to conceive a boy, their final, supposedly viable, male embryo was transferred last May. But that procedure also failed.

"The Plaintiffs worried and continue to worry to this day — that their shared dream of having a son might never become a reality," attorneys for R.N. and E.K. wrote in the suit.

The lawsuit claims that second male embryo had already been killed in a "toxic incubator" and that Ovation should have known but failed to inform the plaintiffs. It also alleges the clinic failed to adequately follow safety measures and also called promotional material claiming the company runs a "preachievement," Suhr said Tuesday.

CSEA representatives bargained not only for pay raises, but to have Newport-Mesa Unified participate in the California Department of Education's Classified Employee Summer Assistance Program starting in 2025-26.

Because many classified employee positions follow academic schedules that do not last throughout the entire calendar year, workers facing income loss during

supporting employees, particularly those who work part time. "They have tough. unglamorous jobs but they are an important part of

supporting positive student outcomes," Ching said. "By approving participation in [the summer assistance program], you have shown your support for these valuable employees — this is the good work."

Lawyers for others who have sued Ovation have suggested that systemic issues are present at their Newport Beach location and that other people who have not yet come forward may have also been affected.

Following a three-and-out by its defense, Newport Harbor (11-2, 6-0 in the Sunset League) would again find the end zone, this time through the air. Maia Helmar found Dick open on the right sideline for an eight-yard score on a fourth-down play, doubling the Sailors' lead to 14-0.

Ashlyn Spicer then intercepted CdM quarterback Alexa Rokos, giving Newport Harbor a chance to add on further. The Sailors came close to doing so when freshman speedster Skylie Cid pulled in a catch and went for the goal line, but the play was ruled dead a yard short as Anna Sofia Dickens and Isabelle Morris converged on her. Then the half expired.

Cid would not be denied later on a 15-yard catch-and-run for a score with four minutes remaining. In establishing a three-possession lead, the Sailors celebrated by leapfrogging each other in the end zone.

"We were planning that specif-ically for this game," Cid said of the celebration. "It was leapfrog. We just got so excited and got [an unsportsmanlike conduct] penalty for that, but it still counted as a touchdown. It was 100% worth it."

For the first time this fall, the CIF Southern Section will host championships for girls' flag football.

"Last year was the first year that [flag football] was CIF [sanctioned]," Guyser said. "Last year, our goal was to win every single game because we wanted to finish first in the state, which we did, but that was because there were

no CIF playoffs.

"Now this year, our goal was a little bit different. ... We don't need to win every single game. We want to get as good as we possibly can, get as many reps in as possible for different players, so

that by the end of the year when CIF playoffs come around, we're playing our best football."

Helmar finished with 241 passing yards and two touchdowns, showing an ability to find receivers all over the field. She had the help to make downfield throws, as Abigail George made a grab in double coverage for a 36-yard gain in the second half.

Cid compiled 129 total yards (91 receiving), and Dick had four catches for 58 yards.

"I've been playing flag football since first grade with my friends," said Cid, who is the daughter of Newport Harbor boys' soccer coach Ignacio Cid. "The friendships that I've gained [through] the sport definitely encourage me to keep it going. Winning is my favorite thing. I'm very competitive.'

Rokos produced 187 yards of total offense, including 89 rushing yards on 11 carries for CdM (10-3, 5-1).

"There's never a moment that she doesn't have 100% for you," CdM coach Yvonne Sturgeon said of Rokos. "It just doesn't register

for her any other way." Dickens was the Sea Kings' leading receiver with five catches for 42 yards. Addison Stern contributed a sack and batted down another pass attempt rushing Helmar on defense.

Corona del Mar will host Newport Harbor in the season finale on Oct. 14.

Sturgeon said she found the Sea Kings' performance to be short of a collective effort, particularly on defense, but she vowed that CdM would be "more than prepared" for the rematch.

Detroit to Romanian immigrant parents, to his service in the U.S. Air Force during the Korean War, to his education under the GI bill at Michigan State and, later, the state's Cranbrook Academy of Art.

"He was always such a positive person, always complimentary and sweet, even though he was this artist who'd done all these things in his life," McMurray said Tuesday.

While serving as a visiting professor at the University of Mississippi in 1962 when a Supreme Court ruling allowed Black student James Meredith to attend classes on the segregated

campus — Kerciu created works for an exhibition centered around themes of bigotry and racial justice.

One painting, "Never," features a depiction of a pin worn by segregationists at the time, with Confederacyinspired stars and bars in the background. "America the Beautiful," portrayed the same flag covered by racial slurs, McMurray's story details.


For his so-called desecration of the Confederate flag, Kerciu was imprisoned in what would attract a media frenzy and letters of support from John Steinbeck and Malcolm X, who reportedly told the artist, "Get those Dixie rats!'

After a brief time in New York, Kerciu moved to California and accepted a job at what is now Cal State Fullerton, where he helped grow the university's art department. He moved to Laguna Beach in 1967, buying a cottage on Crestview Drive that would be his home for nearly 60 years.

Mihae Park met Kerciu in the early 1990s, when she enrolled in a stained glass class at Cal State Fullerton with a friend. He was a great teacher and artist who had an unassuming attitude, even about his own accomplishments. The two married on March 25, 1995.

"He was so incredibly loved by everybody," Park recalled Tuesday. "I think that comes from his having so much grace to meet people where they're at and not



imposing his values or beliefs onto them."

The artist and sculptor was well known by the mid 1990s, when the board of Laguna Art Museum quietly approved a merger with the Newport Harbor Art Museum, now the Orange County Museum of Art. Concerned for the fate of the institution and its 3,800-piece collection, Kerciu led the Save Laguna Art Museum (SLAM) campaign, which succeeded in disrupting the move.

"It was a big wake-up call and the community responded positively, based on G. Ray's [advocacy]," Perlin Lee said Wednesday. "It's incredible to think of all the good things that have come out of the museum since then." After the museum's rein-

corporation in 1996, Kerciu served as board president but later stepped down, continuing a close affiliation and serving with other organizations as he continued to create works in his home studio. His art appears in collections held by his home museum, as well as the Smithsonian American Art Museum and National Gallery of Art. In later years, when art making became physically taxing, the artist took to creating digital works on an iPad bought for him by his wife and continued to create.

"All my adult life I was with him," Park said Tuesday. "I am the person I am because of him - he is woven into my cells."
