# Park work to be done in May

The renovations at Laguna's Main Beach Park include irrigation, landscaping, park bench, sidewalk maintenance.

It's hard for any passersby to ignore the sight of construction fencing and activity throughout Main Beach Park in Laguna Beach, known locally as the town's "window to the sea."

As the days grow longer and the tourist season approaches, the question of what's behind the uninviting change of scenery came from a member of the audience at last month's State of the City event.

Mark McAvoy, the city's director of public works, described it as a "major maintenance project." The construction began in January and is expected to wrap up in May.

"It's upgrading some irrigation and taking care of some overdue maintenance needs on the lighting systems, the benches, the sidewalks and the landscaping out there," McAvoy told those gathered at the event held March 19 at the Montage Laguna Beach.

The work stems from a City Council meeting on Nov. 12, when the five-member panel approved a \$1.4 million-contract for the rehabilitation project to be completed by R2Build.

At the time, the city had approximately \$925,700 budgeted for project-related costs. At the request of city staff, the council gave direction to have \$755,000 transferred from the Bolsa Way storm drain improvement funds to cover the estimated \$1.68 million total cost of the Main Beach Park project.

The latter project, city staff noted, was not expected to get

# Creatives lock in to sound lab at Newport Beach Library

he sound lab tucked just down the hall from the elevators on the first floor might be one of the only places in the Newport Beach Library where staff actually encourage patrons to make noise. A computer loaded with editing software

and a pair of microphones sat on a plain white table within the lab's thickly padded walls Wednesday afternoon, along with two keyboards, a Fender Champ 12" guitar amplifier, sheet music stands and a handful of mismatched chairs taken from different parts of the library. The humble space was part of a major expansion to the public building in 2013, and has become one of its most popular amenities, Library Assistant

# Costa Mesa names UCI poetry instructor Danielle Hanson its first poet laureate

Danielle Hanson in 2016 left a thriving corporate communications job in Atlanta to devote her time to her first love — poetry.

That departure kicked off a six-year period of serving as a volunteer editor at various small

publishing companies and literary journals, during which Hanson saw her own work published before securing a job as a parttime instructor in UC Irvine's School of Humanities.

"The curse, and also the blessing, of writing poetry is you're absolutely never going to make a living doing this," the 53-yearold Irvine resident quipped in an interview Monday.

Still, despite that rule of thumb, Hanson seems to be making a pretty good go at a life steeped in verse. In addition to teaching poetry, she's published two books of her own work, "Ambushing Water" in 2017 and "Fraying Edge of Sky" the following year. And she's currently working on a third.

For those reasons and more, Hanson has been named the first-ever Costa Mesa Poet Lau-

April brings a fresh start to aspiring Championship Tour professional surfers.

The first event of the 2025-26 World Surf League Qualifying Series season, the Vans Jack's Surfboards Pro presented by 805, launches Thursday morning on the south side of the Huntington Beach Pier.

The Jack's Surfboards Pro started in 2017 as a men's QS 1,000 event, and is now a QS 4,000 event for both genders as part of a new points system put in place by the league this year.

Past champions of the event include 2024 Championship Tour Rookies of the Year Sawyer Lindblad and Crosby Colapinto, both of whom call San Clemente home.

"We're thrilled to kick off the 2025-26 season with the Jack's Pro, and even more excited to host it right here in our hometown of Huntington Beach," Jack's Surfboards co-owner Abdelmuti said in a news release. "It's a fantastic opportunity to support the young, up-and-coming surfers from our region. This year marks our eighth edition of the Jacks Pro, and thanks to our incredible partners in the surf industry, the event continues to grow and evolve.'

Lucca Mesinas of Peru won the men's Jack's Surfboards Pro last





Greg Johnson told the Daily Pilot.

The lab is open every day except holidays, and is typically booked solid at least a week in advance, Johnson said. He has spotted people dancing, singing, recording voice-overs or audiobooks and creating all kinds of music while peering through a square window in the lab's heavy, soundproof door to occasionally check in while it's in use.

Lately, a growing number of those reserving the space have been coming in with cameras, lights and stands to shoot podcasts. They include one who dives into Newport Beach history, and another who conducts guided meditation, Johnson said. He and others who

support making content creation more accessible want to update the sound lab into a podcast-friendly space. The Newport Beach **Public Library Foundation** is reaching out to the

public in hope of raising \$4,000 for the necessary equipment.

'This is basically us recognizing a need among our patrons and trying to grow with them to meet that," Johnson said.

He has been talking to people who use the sound lab and other members of the community to find out what kind of gear might help them create better content. Some of the items that have been mentioned include a green-screen, cameras, lighting, additional microphones, a video switcher and more.

Johnson said libraries have always been a place where people can "lock in" and get productive, making the sound lab an ideal environment for podcasters. It's also within arms reach of a near limitless collection of books, films, recordings and other resources to draw inspiration from.

In addition, library staff are on hand to help troubleshoot glitches or bounce ideas back and forth with content creators. They often get personally invested when they help patrons with their projects, Johnson

He said that can be bittersweet at times, and recalled noticing when one of their regulars stopped visiting.

"I thought of them and was like, 'oh, I haven't seen them; that means they must be done," Johnson said. "And I was happy for them because I know finishing a project is one of the best feelings in the world."

The sound lab is just one of many multimedia resources available to patrons. Others include Canopy, a free video streaming service with over 30,000 titles, numerous digital databases as well as audio-visual equipment and even vintage gaming consoles available for library card-holders to borrow. These and much more will be featured for patrons to discover during Digital Saturday at the library on April 12.

reate, a position that runs for two years and will see the UC Irvine instructor lending poetic flair to a host of city-sponsored events and creative programs.

Officials announced Hanson's selection in a news release Monday, explaining the laureate program is one more investment being made to promote Costa Mesa's status as "City of the Arts."

"Not every city has a poet laureate, and I'm pleased to hear that we have one now," Mayor John Stephens said in the release. "Poetry is an important literary art form that provides a wonderful complement to the city's exciting performing and visual arts.'

The program stems from the city's Arts & Culture master plan, a document adopted in 2021 to guide the development of cultural programs and initiatives. Selection of a poet laureate adheres to a goal stated in the plan to "professionalize and elevate the status of arts and culture in city government.'

Costa Mesa arts specialist Laurette Garner worked with members of the Arts Commission to review candidates for the new role. She said Tuesday the program is a conscious effort to include the literary arts

among the city's rich cultural offerings.

"We needed someone who was solid, could work independently and could kind of take the reins," Garner said of the ideal candidate. "We weren't sure what we were looking for because it was a new program, and we didn't know what direction to go in. But, across the board, everyone liked Danielle."

Working on a \$2,500 annual stipend, Hanson will produce original poetry and make appearances and lead workshops at city events, such as Costa Mesa's ARTventure.

Hanson — who fell in love with verse as an undergrad at University of Tennessee at Chattanooga and went on to earn two master's degrees, in creative writing and applied mathematics — is married to UCI Dean of Engineering Magnus Egerstedt and has twin daughters attending college.

She encourages her students to read poetry and then try it for themselves by responding to prompts or phrases intended to inspire their creative thinking. And while she's not worked out the details of her two-year stint in Costa Mesa, Hanson is already thinking of bringing poems to local parks and organizing "poetryoke" sessions, in which people recite famous works in an open mic format.

"I see who likes poetry among those whom I interact with, and I know they're representing a sample of all people out there who would like poetry if they in-teracted with it," she said Monday. "So how do we get it out there where people already are?"

Costa Mesa is not alone in appointing poets laureate to further the cause of literary arts on a civic level. A countywide program, launched in 2021, selected Natalie J. Graham to a twoyear term through a joint effort of the nonprofit LibroMobile Arts Cooperative and Orange County Public Libraries. Gustavo Hernandez is the county's current poet laureate.

Municipally, the Laguna Beach Arts Commission named resident Kate Bucklev poet laureate in 2017 as a means of "promoting the literary community and celebrating the written word," Cultural Arts Director Sian Poeschl confirmed Monday.

In later years, that program shifted to a wider literary focus and then into a pandemic-era Artist-in-Residence program, followed by a Creativity in a time of Crisis grant pro-

gram, that later morphed to an Artistic Innovation Grants program, the latter of which this year be-stowed \$100,000 to artists in varying stages of their according careers,

While the city of Anaheim has a Poet Laureate program, no such titles exist in Huntington Beach or

Poeschl.

Newport Beach, although the latter did maintain a program as far back as 1978, a city spokesperson reported Monday.

Hanson's own Irvine, has no laureate program, but the UC Irvine instructor was able to apply for the Costa Mesa designation, after the city extended eligibility to published poets throughout Orange County, and is glad she did.

"At its best, a poet laureate position is like a cheerleader for poetry out in the community," she said of her new position. "That's how I approach it."



# Newport Harbor's McCarty sweeps hurdles

Natalie McCarty has competed at a high level in numerous events in her time with the Newport Harbor track and field program, but she did something Saturday she had yet to accomplish.

The two-time titlist at the Orange County track and field championships added to her first-place medal count at the meet, winning both the 100- and 300-meter hurdles at Mission Viejo High.

McCarty's day began with a dramatic, come-from-behind win in the 100 hurdles. She completed the race in 15.55 seconds, just ahead of Mater Dei senior Kendall Jordan (15.60), who clipped the penultimate hurdle and knocked down the last.

"I knew it was going to be a close race," McCarty said. "I knew I had some good competition, so I knew my form had to be good. Little technique things made it closer than I wanted it to be, but I was able to finish strong and get them at the end, so that's all that mat-

Nearly five hours later, McCarty cruised to victory

in the 300 hurdles in 44.52 seconds, nearly mirroring her seasonal-best time in the event.

"I'm grateful," McCarty, a junior, said of sweeping the hurdles at the county championships. "It's awesome that I had this competition pushing me to do better. It feels good. There are always things I can im-

Expectations have followed McCarty from the jump, literally. When she debuted for the Sailors at Santa Margarita's Eagle Invitational in 2023, she posted a clearance of 5 feet, 6 inches in the high jump. That mark got her into the Arcadia Invitational, and she won the county title in the event the next week.

As a sophomore, McCarty won the 300 hurdles in the county championships, before going on to win both hurdles events in the CIF Southern Section Division 2 finals. She helped the Sailors finish as the division's runner-up in the CIF finals.

Newport Harbor added another event winner, as Marley McCullough set the pace in the 3,200 with a winning time of 10:55.70. Last season, McCullough produced her personal record in the event, finishing as the runner-up with a time of 10:29.47.

The Orange County track and field championships came early this year, three weeks earlier than usual, which impacted where athletes were within the planning of their workouts.

While many hope to peak toward the end of the season, new personal bests are always welcomed. That was the case for Huntington Beach senior Alia Pasternak, who improved her lifetime-best mark in the triple jump by a full foot.

Pasternak leapt to a mark of 36 feet, 111/2 inches, giving her the school record in

the event, which had belonged to Tammy Chick (36-2). Huntington Beach coach Kareen Shackelford said Pasternak broke a 38year-old record.

"I'm so happy," Pasternak said. "I started tearing up a little bit after because it's just been a lot, really frustrating, up-and-down seasons. I know when I was hurt, it was really frustrating for me, especially because I knew I could do more.

"Yes, I made it to CIF, but I knew it wasn't my best mark. I actually don't think I made it for triple jump CIF my sophomore year. I was just short of it, so just going from that to qualifying last year, and to now having like 37 [feet], I'm just ecstatic. I did tear up a little bit on the side before I went again. I'm just so happy right

The Oilers have seen two other program records fall this year. Junior Sydney Mc-Gill's 15.41 seconds in the 100 hurdles at the Laguna Beach Trophy Invitational, and junior Rachel Carlton's 25.29 seconds in the 200meter sprint at the Mater Dei Invitational have set new wind-legal program

Huntington Beach placed second behind Mater Dei, 81.5-40, in the girls' team standings. Corona del Mar placed fifth with 32 points, with junior Estheleen Charalabidis factoring heavily into those points with three top-three finishes in the 100 and 200 sprints, as well as the 400 relay.

Rounding out the local winners was Pacifica Christian junior Lila Glidewell, who finished first in the girls' rated 1,600 meters with a new personal record of 5:30.18.

"I was settlling behind people because my coaches told me to wait behind them, but overall, I felt like I had more in me at the end of the race," Glidewell said. "I thought if I were in the seeded [heat] and it was not [about] winning, more about a PR record), I would have gotten a better PR, just to have people to chase.

Sage Hill, which tied for ninth place, was the lone local program to finish among the top 10 in the boys' team standings.

# Los Amigos Lobos learning, looking for more success

GARDEN GROVE — Los Amigos reached the CIF Southern Section softball playoffs the past two years after missing out the previous decade, advanced both times, then reeled off eight victories to start this sea-

It's nice to be winning, of course, and the Lobos treasure their successes aspire to more and better – but let's not, head coach Jeff Holley suggests, get ahead of ourselves.

Los Amigos is not, in any sense, a softball powerhouse, and so when those eight wins were followed by two lopsided losses — the second a 10-0, six-inning Coast League decision Friday afternoon at Santiago — there was disappointment, but no surprise.

Los Amigos' old Garden Grove League rivals made it 21 in a row in the series since 2013 — hitting double digits for the 13th time in the past 14 meetings.

"I wanted to get out of here 5-0, 6-0. I would have been really excited by that," Holley, in his fourth season in charge, said afterward. "This still wasn't that bad, 10-0 in six innings. They have beaten us by a lot

know where they stand, and there's pride in the strides the Lobos (8-2 overall, 1-2 in the Coast League) have taken since hitting bottom after the pandemic. He stepped in after a winless 2021 campaign, won four games in his first season with what were basically beginners, and has since gone 32-18-1 with three playoff wins and more, they hope, on the horizon.

That's not really the point, more so fruits-of-labor stuff: Los Amigos' program, Holley says, is about 'learning the game of softball." Literally.

"We have people who haven't played before," he said. "When they come to us, they're brand new, and so we teach them the game, we teach them to be enthusiastic and have energy and leave everything on the field. And everything else will take care of itself.'

Success, he said, is measured by "getting better every single day." Every year "is very rewarding, because you see the growth, especially with players that don't have the background. They're always growing and learning and getting bet-

The Lobos have some experience this year, with six seniors who have grown within the program, but not much depth: just 11 players, including junior varsity call-ups, after two starters senior Ingrid Alvarado and her sister, freshman Angie Cervantes - transferred this week to El Modena after a family move. "A big loss," Holley called it.

Half the team is "newcomers that we're going through what we did three years ago with [the seniors]," he said. "And [the seniors] are staying on them, to say, 'Hey, you can do this. We went through this. You can learn this. You've just got to give it your all."

"We get girls who have never touched a ball before," senior first baseman Maria Castillo said. "Seeing them go from not touching a ball before to simply falling in love with the game is what it's all about."

The experience against stronger programs, such as Santiago's, helps. The Cavaliers (9-3, 3-0) hammered 13 hits behind a nine-for-12, six-run, seven-RBI collaboration from the first three hitters in the lineup and rode senior right-hander Ihilani Berard, who limited Los Amigos to three hits second- and fourth-inning singles by Alina Mendez and a fifth-inning single by Yvonne Gonzalez — and al-

lowed just one runner past first base. She struck out nine, five on three pitches.

It was over, for all intents, in the third, all through the top of Santiago's lineup. The Colonists (10-1, 2-0), beat Los Amigos, 10-0, in a five-inning game Wednesday. Savanna took both teams the full seven innings.

"This is going to be the hardest year to make the playoffs because the league we're in is the toughest league we've been in," Holley said. "It would be an even greater accomplishment to do it this year."

That's the plan.

"We've accomplished so much," Castillo said. "And we have even more to accomplish."

underway with construction before the end of the fiscal year, which is June 30. The staff report said funding would be requested for the storm drain through the capital improvement program in the next budgetary cycle.

McAvoy told the council in November that multiple years had passed since the park project had been budgeted, leading to a deficit in funding for the renovations. The council reviewed the preliminary design for the project in October 2019.

"Construction costs only go in one direction, and that is exponentially higher every minute of every day," McAvoy said at the meeting.

Yun-Yun Lee, the project manager, said in a phone interview Wednesday that the construction is being broken down into four phases, working from Laguna Avenue to the south toward the marine safety headquarters to the north. It is anticipated that the second phase, an area extending toward Broadway Street, will be completed between the middle and the end of April, Lee said.

The goal remains to finish the renovations ahead of Memorial Day weekend, the unofficial kickoff to the busy summer season for beach cities.

"We're doing our best to try to keep the project moving along to meet the deadline," Lee said. "We're doing what we can to try to still provide a new updated

version of the park, so the residents are able to enjoy, and all the guests that do come to Laguna Beach are able to enjoy Main Beach and the beauty it brings to the city."

stones. "This is our frontyard," Councilman Bob Whalen said then. "This is our living room, so it should look really good."

Construction remains ongoing Monday through Friday from 7:30 a.m. to 5 p.m. Main Beach Park has remained open to the public.
