# Drones used in search for N.B. hiker

Quang Trong Than, 66, was last seen on Sunday, Aug. 21 near the peak of Split Mountain in the Sierra Nevada range.

The search continued this week for a Newport Beach man who went missing on the afternoon of Sunday, Aug. 21 near the peak of Split Mountain, close to the boundary between Kings Canyon National Park and Inyo National Forest, according to a news release issued Tuesday by the National Parks Service.

Quang Trong Than, 66, was reported missing on Aug. 22 to the Inyo County Search and Rescue. Than was expected to complete a day hike to the summit of Split Mountain and then exit that same day by way of the Inyo National Forest. He was not carrying overnight gear.

Split Mountain has an elevation of little over 14,000 feet.

The Inyo County Sheriff's Department said Than became separated from his group at the base of the summit.

Than was traveling with two other people, according to officials. At around the 13,200-feet mark, Than reportedly "waved them on" to indicate he would either fall behind, wait for them there or head down. No plan was made.

The other two hikers in his party made it back to their car at around 3 a.m. on Aug. 22, officials said.

Than apparently stashed a hel-

# Newport Beach resident told herself to 'just go' to Ukraine

magine seeing a procession of Russian military tanks randomly blowing up buildings as it travels along Newport Boulevard toward the harbor.

That was the image that struck the Rev. Canon Cindy Evans Voorhees when she first set foot on Ukraine soil amid the devastation.

"I was waking up at 3 in the morning, worrying about the innocent people being slaughtered in Ukraine," Voorhees told the Daily Pilot. "I just wanted to be a neutral eyewitness — not a reporter or politician and see where I could help as one person." In March, Voorhees' house of worship, St. "I just wanted to be a neutral eyewitness — not a reporter or politician — and see where I could help as one person," said the Rev. Canon Cindy Evans Voorhees of St. James Episcopal Church.

James Episcopal Church in Newport Beach, had attached a large blue and yellow flag banner in support of Ukraine weeks after Russian President Vladimir Putin launched a full-scale invasion there in late February. The banner drew the attention of Ukrainians living in Orange County who not only sought assistance but brought native baked goods to Barbara to San Clemente to 29 Palms who had any Ukrainians, according to the 25 priests who attended a recent diocese meeting."

Two Ukrainian young women arrived at St. James first, sharing a Ukrainian cake. They later asked for baby formula and military first aid to be sent to their homeland.

# Effects of extreme 'heat dome' will be felt through Monday

Close the windows, crank up the air and stay hydrated — a massive ridge of high pressure has created a "heat dome" that will burden coastal and inland Orange County with exceedingly high temperatures and humid conditions into next week.

In an excessive heat warning issued Tuesday, National Weather Service meteorologists cautioned dangerously hot conditions would continue at least through Monday night as temperatures soared into the upper 80s in coastal areas and well into the 90s immediately inland.

"There is a big ridge of high pressure sitting over the Great Basin right now — in Nevada, Arizona, Idaho and Utah — that is basically going to lead to mostly clear skies, which will lead to skyrocketing temperatures throughout the Southwest region," NWS meteorologist Elizabeth Schenk said Wednesday, indicating heat warnings extend into the Pacific Northwest. "It's a very large-scale event," she added. "It's been brewing for days."

Along with heat, high levels of humidity will make daytime highs feel even hotter, while overnight lows will remain in the 70s for the next week, officials reported.

Forecasts indicate inland communities, including Santa Ana, Anaheim, Irvine and Orange, could experience triple-digit temperatures over the weekend before a slight cooling trend brings the mercury down slightly by Wednesday or Thursday of next week.

Extreme heat increases the potential for heat-related illness, ranging from exhaustion to heat stroke, particularly for people working outdoors or participating in outdoor activities, according to the National Weather Service. Residents are asked to monitor their own risk and symptoms and to check on sensitive groups, including children, the elderly and immunocompromised individu-

As of Wednesday, Roper said the search had moved into a "limited continuous" search, meaning that teams are no longer actively searching the terrain but are instead refocusing their efforts on known clues and new points of interest.

Orange County has released a list of cooling centers, mainly libraries, community and senior centers open during hours when locals can escape daily high temperatures.

Meanwhile, coastal cities and destinations are gearing up for an influx of visitors and heat refugees from areas like the Inland Empire, where cities like Riverside are expected to see 111 degrees this weekend.

The Newport Dunes Waterfront Resort and Marina is one such refuge. Jan Yerzik, a spokesman for the facility, said Wednesday activities like pedal boating, and kayaking paddle boarding are swiftly booking up as more people seek to escape the heat.

An on-site water park offers inflatable slides, trampolines and other kidfriendly adventures that allow resort members, and the general public can cool

down in the calm waters of Newport's Back Bay for an hourly fee.

"It's just a fun activity and it gets you out on the water, and kids get a good workout," she said, adding that trees on the property offer a good escape from the sun. "It's going to be a very busy weekend for us bring your floats and come float in the water."

Schenk said coastal areas may be periodically protected from the worst of the impacts if the marine layer lingers, although high dewpoint levels in the 60% to 70% range will lend an uncomfortable, "sticky" feeling verging on tropical. It will be important, she said, to limit outdoor activities to the morning or evening and stay aware of how you feel.

"Ask, am I feeling lightheaded? Am I feeling dizzy? Do I need to take a break?" the meteorologist advised. "Make sure you're checking on yourself and others.'

inside the church to be shown in Ukraine. A Taiwanese American woman told Voorhees she was compelled by the church's outreach to travel to the front line to drive a truck for supplies.

Then there was a request for assistance from a missionary in Ukraine working the front lines with women who had been raped.

"She said they need female chaplains over there and asked me to come and work with women and children who had been raped by Russian military," said Voorhees, who had begun opening the St. James parish hall to meetings with 50 to 60 Ukrainian refugees.

"I was very torn while going through the discernment process, asking myself, 'Why me?'" Voorhees recalled. "And then the answer came by way of an NPR interview question to an American who had just returned, who said, 'If you have something to offer ... go!"

Three weeks later, she went on her own to see the conditions on the ground. "Once I was there, I knew I was supposed to be there," Voorhees said.

She was accompanied by a Ukrainian friend who served as an interpreter during the 14-day journey. They first landed in Caux, Switzerland, where they connected with Initiatives of Change, a network for religious and traditional peacemakers. The organization, which was housing 25 refugees in its home at the time, was an integral part of facilitating the tran-

"I met with dignitaries and refugees and Archpriest Mykolaiv Danilevich of the Ukrainian Orthodox Church for international relations. It was wonderful going on my own to let people know they're being supported and not alone.

"I served food in the soup kitchen that had been set up by a local businessman who felt he had to do something, I had the same feeling about how could war," Voorhees said. One of the most significant meetings occurred toward the end of the trip when Voorhees spent three hours with military psychologist Dr. Natalya Zaretska, during which they discussed the psychological effects of occupation and isolation.

The feelings expressed by Zaretska, according to Voorhees, were that the world needs to know Russia is a global existential threat to democracy and that its radical ideology since 2014 is that "Ukrainians are not considered human.' Zaretska told Voorhees that psychological help is of value and there is a need for female chaplains to serve in the affected communities because they are trained in listening techniques and spiritual values. Voorhees met with civilians serving alongside the Ukrainian army such as movie production people, contractors and accountants. They were being trained to take on the fight and also cleaning guns, digging trenches and creating makeshift weapons. 'Genius thinking. Unbelievable dedication to their country," said Voorhees. "I visited a women's shelter, so heartbreaking to see damage being done, and [the experience] gave me the feeling we need to do more.

sition into Ukraine.

"A few days later we arrived at the civilian airport at the Polish border and saw U.S. military everywhere," Voorhees said. "It was definitely sobering."

They took an overnight train ride to Kyiv in 80 degree heat and with four people to a room sleeping in bunks. Their luggage didn't make it onto the train with them, an annoyance that was put into perspective after they witnessed refugees fleeing with only the clothes on their back. The train station they disembarked at was a madhouse, Voorhees said.

"I didn't have appointments set up but went on faith and on the spur of the moment because of the connections that opened doors ... people want to be heard and not just by news media," Voorhees said.

One who approached her was Ukrainian opera singer Alex Luna, who also works for a member of the Verkhovna Rada, Ukraine's parliament.

"He asked what we needed and then connected us to the member of parliament, Tetiana Tsyba," Voorhees said. you not not help."

Voorhees said the people accepting food in the soup kitchen did not want to talk. She observed that they appeared dispirited by having to seek a handout.

Luna drove Voorhees to Irpin and Bucha, where many atrocities took place. The Newport Beach woman saw for herself the bombed-out buildings, which she said was a hard thing to wrap her head around.

"I spoke to a man who pointed to a house with the side open who said, 'That used to be my home, the Russians came through so fast I hardly had time to move, my neighbors died."

"They definitely wanted to talk to a pastor," said Voorhees who said she wasn't there to give sermons but instead to provide a nonanxious presence that would allow people to tell their story and feel that they were being heard.

When Voorhees met with Tsyba, her message was, 'Please do not forget that we are at war defending democracy.'

"There was no question, everyone in Ukraine believes they will win the "Sometimes it only takes one person to make a difference," she said.

The surf and the sand drew a crowd in Laguna Beach over the weekend, as two popular water sporting events returned to town.

After a four-year hiatus, the Brooks Street Surfing Classic got back in the water, continuing a time-honored tradition with the 56th annual running of the event.

Brandy Faber, the director of the surfing contest, said the competition is open only to Laguna Beach residents, as it has been since its inception in 1955. It had not been held since 2018, which of course preceded the coronavirus pandemic. The other factor in the event's absence had been the surf itself.

"The Brooks Street contest is unique in the sense it's not like other events, where you can just show up at Huntington or Trestles or Salt Creek and just have waves on any particular weekend," Faber said. "We have a waiting period that begins in June, and it goes all the way to the end of October, and we need enough surf to run two full days — sunup to sundown – on a Saturday and Sunday.

"In 2019, we never had a swell that hit on the weekend that was able to give us enough surf to run the event," Faber said.

There were winners crowned in 14 divisions, ranging from young boys and girls to legends (competitors of at least 60 years of age).

Cash prizes also went out to the pro-am division, with teenager Hudson Saunders taking home \$1,000 as the first-place finisher. Travis Booth (\$750), Eli Viszolay (\$500) and Michael Chapman (\$250) rounded out the top four.

Walter Viszolay, Eli's father, set himself apart as the winner of the legends division.

There were also competitions held for those riding the waves on longboards, bodyboards and paddleboards.

The Cy Chambers Award, given to a high school or middle school contestant who exhibits the quality of sportsmanship while also performing well in the classroom, went to Brooks Carter.

Maddox Rapp was the recipient of the Thom Chambers Award, a

recognition that goes to a middle school or high school competitor who has shown an affinity for the arts

Faber also thanked local artists Kaj Garmshausen and Robert Jones for designing the T-shirts and the trophies, respectively, for the Brooks Street Surfing Classic. Jones is an exhibitor in the Sawdust Art Festival.

"We always get custom-made trophies by local artists that are part of the surf community," Faber said. "Robert Jones is a local ceramicist who displays every year at the Sawdust Festival, and he is a past Brooks Street champion himself, so that was cool that he made the trophies.

'Kaj Garmshausen, who made the T-shirts, a local artist and surfer. ... We try to keep everything really local and tapping into our local art community where we can, so I think that's kind of an important part to the contest. We don't just get your standard plastic, doorstop type of trophies.

With two big-time events happening on Laguna's beaches, some residents embraced the challenge of going back and forth between Brooks Street and Aliso Beach to compete in surfing and skimboarding. That group in-cluded Dia Prietto, who won the boys' 13-and-under division in the Brooks Street Surfing Classic and the amateur division for competitors between the ages of 12 and 14 in the Vic West skimboarding contest, put on by Laguna Beachbased Victoria Skimboards.

It was the 45th annual running of the Vic, which drew an international field of competitors and provided \$9,000 in prize money for individuals competing in the professional divisions.

In the professional divisions, Yahir Valencia of Barra de Navidad, Mexico, won the men's championship, while Chabe White of Mazunte, Mexico, won the women's title.

The Vic is part of the United Skim Tour, which will also have the Exile Oktoberfest in Newport Beach Sept. 17 and 18.

"We had two really good staff days, we had an awesome freshman orientation last week, and you just feel the excitement, the energy. The people are excited to be back."

Things seemed to be going smoothly on the Oilers' campus Wednesday. The district has issued students digital identification cards this year, and schedules were also available digitally.

Huntington Beach was one of six comprehensive high schools in the district to return to classes, along with Edison, Fountain Valley, Marina, Ocean View and Westminster.

The number of students on campus Wednesday was not immediately available. But the district, which also has a continuation high school, alternative school and adult school, has about 16,000 students altogether.

"The start of a new year brings endless opportunities for learning, growth and success," HBUHSD Supt. Clint Harwick said in an email. "We know our students are in great hands, as our teachers and staff are well prepared and equipped to assist students in excelling both inside and outside of the classroom."

Though none of the six high schools has a new head principal, there are new assistant principals at several of them. Rachel Kloppenburg has returned to her alma mater of Fountain Valley High as assistant principal of guidance, while Edison High graduate Mia White has joined Marina as the assistant principal of supervision.

Ocean View welcomes Marina High graduate Stephanie Scott as its new assistant principal of supervision. Katrina Handel, a Huntington Beach High alumna, is now the assistant principal of guidance at Edison.

Huntington Beach High is one of the larger schools in the district, with about 3,000 students. Many parents dropped off their students around 8 a.m., half an hour before first period began.

A California law that went into effect this year mandates that public high schools must begin classes no earlier than 8:30 a.m.

Morris said the school, along with many in the district, went to an 8:30 a.m. start last year in preparation for the change.

"It's not going to affect us as much on our campus, but where I do see some potential challenges is with the arts, athletics, our extracurricular programs like [Model United Nations]," he said. "It does push the day back a little bit. Really, at this point, we don't know what we don't know. Having that earlier period created some space in students' schedules ... but overall, I think we've

been able to bridge a lot of those gaps and challenges.'

Huntington Beach High English teacher Rosie Harshman is beginning her 12th year in that role. She said coming back to campus is not quite as heavy this year.

"Even though COVID is still there and a threat, it just feels a little bit more natural again," she said. "There's a lot less stress with coming to school, which is really nice."

Harshman herself was itching to get back in the classroom.

"I just love that we're all in the same boat," she said, pausing to greet a male student carrying a skateboard and ask him how his summer was. "Every teacher is just as nervous and excited as the kids are. We try to hide it a little bit, but we are. I didn't sleep for the past two days. It's like that nervous Christmas feeling where you're so excited, but you're also like, 'What's this year

going to bring?'

"I just love it because it's different every class period. Every class has its own identity."

day of school in the Ocean View School District and Fountain Valley School District is Sept. 7, while the Huntington Beach City School District returns the following day.
