Igarashi's quest for third **U.S. Open title continues**

The Surf City native has advanced to the final eight and will compete Saturday against George Pittar of Australia.

Huntington Beach native Kanoa Igarashi said he sees a two-man surfing heat like a chess game.

His opening gambit at the U.S. Open of Surfing on Friday involved setting up far south of the Huntington Beach Pier.

"When I surf here in Huntington, I trust my instincts a lot," said Igarashi, the two-time U.S. Open champion. "I don't like to watch the waves too much before my heat. I feel like when I'm on a normal day free surfing out here, I park my car, I change and I just run out wherever I feel like going out. I kind of want to follow those instincts, not overthink it. Today, I think the ocean kind of dragged me over there.


Duke Kahanamoku, a Hawaiian regarded as the father of modern surfing, first expressed his desire for surfing to be an Olympic sport as early as 1912.

Buzz over proposed pot shop reveals laws may be too hazy

When Costa Mesa approved an ordinance to allow retail cannabis sales and delivery into the city, lawmakers maintained there would be no way to gauge the success of the legislation until it was put into practice.

Now, two years later and with multiple dispensaries already doing business as dozens more continue to navigate the planning process, Costa Mesa officials are struggling to reconcile the letter of the law with real-world scenar-

Take, for example, a recent application for a conditional use permit to operate a 2,157-squarefoot cannabis storefront in a multi-tenant commercial building on the southeast corner of Harbor Boulevard and Adams Av-

Newport Beach OKs \$6.7-million budget for tourism marketing

The Newport Beach City Council late last month reviewed the \$6.7-million budget allotted to a marketing agency for the upcoming fiscal year and gave its unanimous approval, albeit with some reservations over the agency's top executive's compensation.

Through an agreement with the city, nonprofit marketing agency Newport Beach & Co., which operates Visit Newport Beach, receives about 18% of all transient occupancy taxes collected in a given year for operation purposes. The levy, typically referred to as the hotel tax is paid on any hotel stay of under 30 days. It is one of the primary contributors to the

city's general operating budget and covers the entirety of Newport Beach & Co.'s budget.

Newport Beach & Co. projects the amount collected in 2024 will be around \$6.7 million lower than the city's estimate of \$7 million by about 4.7%.

The largest portion of the agency's budget in the coming year, \$3 million, will be spent on advertising, followed by an estimated \$935,000 for public relations and communications. A not insignificant portion — \$199,000 — will be spent on community relations, such as work done boosting other local events like the Hoag Classic at the Newport Beach Country Club.

'Inquire Within' artwork considers our 'plastic problem'

Passersby in front of Laguna Beach City Hall will see a new figure in the weeks to come, one that conspires to change human behavior for a lifetime.

An 8-foot-tall plastic sculpture of a human head has been set upon the lawn, leaving a hole where a brain ought to be. Instead, an assortment of twigs can be found in that space, inviting the viewer to contemplate the impact of their plastic use on the natural

Joel Dean Stockdill and Yustina Salnikova are the creators of the latest temporary public art installation to be displayed in front of City Hall. The piece is called "Inquire Within." A dedication ceremony was held for the artwork

"The plastic pollution problem is fairly a new one in the grand scheme of human history, and we have really entered into the problem with a mind of convenience," Salnikova said. "We never really like to only show a problem. We also like to inspire a solution and inspire a way that we can think differently about the problems we

"That's why we put a hole in where the brain should be, and that was symbolism to be able to [say], 'What if we cleared our minds and listen to nature and see what emerges from there,' because a lot of the times, we are solutioning from these problems from the same thinking that created them. This piece encourages

us to take a step back and look at

our perspectives differently and listen, instead of always thinking we know what to do and what the next step is, so that we can actually form new solutions in the future and maybe tackle this plastic problem that we have created."

Size can send a strong message. The artists are known for their large-scale projects, including a life-size whale made of single-use plastics that ran 84 feet, 11.6 inches in length. That project, known as Ethyl, went down as a Guinness World Record for the largest recycled plastic sculpture.

Stockdill and Salnikova are a rare artistic couple that collaborate on their projects. In his own words, Stockdill referred to the act of creating together as "birthing."

Commission in a May 22 hearing to explain his business plan and the public benefits it would bring the city.

He extolled the virtues of the company, which gives employees the option to unionize and formed a nonprofit foundation that donates 1% of gross revenue to philanthropic groups and causes, particularly youth organizations.

"Our company was born on philanthropy," he said, describing sending middle-schoolers from Watts to camp and donating 5,000 backpacks to Santa Ana Unified School students. "I can assure you, if we're given this opportunity to set up a location in Costa Mesa, we'll be doing the same.

That was a fact that did not sit well with some commissioners, who questioned a cannabis business' affiliation with minors and the entities entrusted with their care. The discussion became tense when public speakers, in droves, shared their concerns.

A beauty salon in the building would be forced to move to accommodate the dispensary, while some complained a new cannabis business would take up too much shared parking. Still others said a dispensary already in the same shopping plaza — STIIIZY — was burdening the area with noise and the odor of cannabis.

Although an effort was made by some planning commissioners to move ahead with a staff recommendation to approve the permit, new Commissioner Tim Taber made a substitute motion to deny Zaharoni's application.

"Technically, while it might fall within the city plan, we need to use what's in front of us and evaluate operators, and there are too many little things adding up for me to want to accept this application," Taber rea-

soned.

From the Earth's plan, two years in the making, was grounded by a 5-2 vote supporting Taber's motion. And so, Zaharoni appealed the matter to the City Council, which has so far heard a handful of cannabis cases and each time overturned the Planning Commission's denial.

In a regular City Council meeting Tuesday, however, Zaharoni met with even more turmoil as council members peppered him with questions raised during the May 22 Planning Commission hearing.

Some council members seemed to take umbrage with the retailer's affiliation with youth organizations, particularly a portion of Zaharoni's same presentation that included the logo for local youth athletic organization Costa Mesa United.

"When you used the logo in your first presentation at the Planning Commission, did you have any type of agreement or partnership with them to accept any

type of donation?" Councilman Loren Gameros asked.

Zaharoni said he hadn't but had called the organization's president and gotten confirmation they did not have a problem with it. He added that he typically includes the names and logos of groups the company would like to support in presentations to other communities.

"The fact that that was considered a bad thing was a little surprising to us," he said. "We tend to donate to youth-based organizations, we do that all the time. But we don't mix our brand, we don't mix our products or operations with young children. That would be inappropriate."

Mayor John Stephens made a motion to overturn the commission's denial, stating it would be unconstitutional to deny an applicant based on the voluntary associations youth groups had with a particular business, a fact City Atty. Kimberly Hall Barlow confirmed.

"I don't see any basis, as a matter of land use, for deapplicant,' nying this Stephens said. "There's no question certain people in the community don't want cannabis. [But] we went through a rigorous process and we voted to have the ordinance, the ordinance is on the books.'

When the question was called, however, only Mayor Pro Tem Jeff Harlan sided with Stephens and, with a 2-5 vote, the Planning Commission decision was upheld.

Barlow reminded the council they would need to point to a finding in the city's general plan that could not be met to serve as a reason for denying the proposal, and the panel decided the use or intensity of the business would not be in accordance with the general plan, even though STIIIZY was previously allowed in the same com-

The council was also set Tuesday to have a discussion about whether officials should review, and potentially amend, the city's retail cannabis ordinance a request that has been made repeatedly by Councilwoman Andrea Marr and past planning commission-

But, as 1 a.m. loomed, the panel decided to adjourn the meeting, effectively continuing that conversation and two other items to a date uncertain.



Aguerre, formerly a successful businessman who founded Reef sandals with brother, Santiago, his turned his attention to bringing surfing to the Olympics after becoming ISA president in the 1990s. That dream was realized at the 2021 Tokyo Games with Ferreira as the first Olympic gold medalist in men's surfing.

Aguerre, from Argentina, told a story of deciding to try to change the order of the first Olympic finals at the last minute, with the women surfing last after

the men. It happened.

"At the end of your life, you're going to look at things and did you do something about it, or did you just watch?," Aguerre, who attended the Surfers' Hall of Fame induction ceremony with his four children. "I was never a watcher. I regret things that I did, and I've apologized many times in my life, but at least I don't regret things

that I didn't do. That would be the saddest way to go down, no? There's opportunities to change the world every day."

Bob Fasulo, a Newport Beach resident who's the executive director of the ISA, said he was blown away by Aguerre from the

beginning.
"I think I understood in the very first moment that I met Fernando that he had

this unique combination of passion, entrepreneurship and most importantly authenticity," Fasulo said. "That's very hard to find in anything we do in life. Behind all of these accomplishments is his amazing value system."

Connelly started as a weekly surf columnist for the Orange County Register more than 20 years ago, and that turned into a full-

time gig as the newspaper's "beach reporter" — a new

She grew to love surfing and now seeks to get away to San Onofre with her husband, Jon Perino, and children Kai and Liliani. She has enjoyed telling the stories of many aspects of the surf culture over the decades.

Connelly cited two late Huntington Beach locals and Hall of Fame inductees surf pastor Sumo Sato and Rick "Rockin' Fig" Fignetti — as two of her favorite subjects.

She was given her trophy Friday by Fignetti's daughter, Chanel.

'You guys were not just sources to me, you became family," she said to those assembled Friday morning. 'There was this culture that just needed to be written about and documented. [My editors] fell for it and let me do it. People didn't want to always read about the bad news and the bummer stuff. They wanted something to be stoked about, and things that they can relate to in this tightknit community of the surf world."

Ferreira is the first from Brazil to be inducted into the Surfers' Hall of Fame, event emcee Todd Kline

said. Born to a fisherman, he first rode waves with the top of an ice cooler at age 8.

Now 29, he became the 2019 world champion after besting compatriot Gabriel Medina in the finals of the Billabong Pipe Masters in Hawaii.

"When he arrived on tour I honestly underestimated his talents," legendary surf-er Kelly Slater said in a statement read by Kline. "He has proven to be one of the most exciting and dynamic surfers ever on tour, and showed us some things that nobody has done before."

Before all the inductees cemented themselves into history, Pai offered a few words on what the Surfers' Hall of Fame continues to mean for the culture.

"This place becomes more special with every induction, every month and every year that goes by," he said. "After we are all gone, our kids and their kids will be able to come here and experience a little slice of surfing culture from years past. Times have changed and moments have passed, but the sport of surfing has kept us stoked and intrigued in many ways."

Rapoza will face Reef Heazlewood of Australia in the first men's quarterfinal heat Saturday, scheduled for about 10:05 a.m.

Crosby Colapinto of San Clemente surfs against Mateus Herdy of Brazil in the second quarterfinal, with Jake Marshall of Encinitas against Eli Hanneman of Hawaii in the third quarterfinal heat.

On the women's side, San Clemente ripper Sawyer Lindblad remained in contention after beating India Robinson of Australia, 13.50 to 7.47 in the round of 16.

"It was a really fun heat," said Lindblad, adding that it felt good to beat Robinson after losing to her in the final of the Gold Coast Pro in Australia earlier this year.

Lindblad has had success at the U.S. Open, with a fifth-place finish in 2021 and a ninth-place showing last year. She will face Luana Silva of Brazil in the second quarterfinal heat Saturday morning.

She turns 18 next weekend, too, so are there any big plans?

"No," Lindblad said with a smile. "I just want to surf." The women's quarterfinal

heats start at 8:05 a.m. Saturday. Nadia Erostarbe of Spain faces Ellie Harrison of Australia in the first quarterfinal heat. Daniella

Rosas of Peru will battle 2011 U.S. Open champion Sally Fitzgibbons of Australia in Heat 3, while Leilani McGonagle of Costa Rica faces Ariane Ochoa of Basque in Heat 4.

The women's and men's Huntington Beach Longboard Classic competitions will also have their quarterfinal heats on Saturday afternoon.

Semifinal and final heats for all competitions are slated for Sunday.

"After doing this together for seven years, it would be so hard to think about being in a romantic partnership where we weren't creating together because the depth is so much," Stockdill said. "It's very difficult. ... Through both of our communities and acquaintances, we know hundreds of artists. but I could probably count all the artist couples I know on one hand, so I think it's very rare. When you can find that dynamic, or nurture that dynamic, it's really rewarding. It becomes like the practice of your love."

The new piece at City Hall has an element of illumination after dark, powered by solar panels. The structure itself was made from recyclable materials, specifically 50-gallon plastic drums.

"I just want to thank the artists because the catalyst for this was a conversation that we had very early on

about how to bring plastic awareness to the community in a very meaningful way that will create a conversation," Laguna Beach Cultural Arts Manager Sian Poeschl said. "I'd like to thank you both because there were many long conversations, ... not just with me, but with the arts commissioners, and you listened and you heard, and

with sensitivity, you've created a piece that offers a sense of hope that we can make a change, and that we should make a change. Hopefully, the community will be discussing how they personally can make a change towards their relationship with plastic."

According to documents filed with the IRS and published by ProPublica about Newport Beach and Co., the nonprofit reported chief executive officer and president Gary Sherwin's compensation as \$329,134 in the 2021-22 fiscal year. Sherwin also received \$28,841 in retirement and other deferred compensation and \$40,565 in nontaxable benefits, for a combined total of \$398,540 in overall compensation for the year.

Mayor Pro Tem Will O'Neill, who is also chair of the city's finance committee, raised concerns about Sherwin's compensation, as well as that of the marketing agency's other officials.

"Because all of the money going to [Sherwin] is

taxpayer money and it flows through the city, it's important for us to have really solid transparency when it comes to the money, and as this has grown significantly from even the time I got onto City Council until now we're looking at almost \$7 million going to the organization and then we're anticipating more than \$7 million going next year," said O'Neill.

"That pot of money is substantially bigger and, so, all the more reason for us to have better eyes on how the money's being spent," he said.


According to the same ProPublica data, marketing officer Doug McClain earned a total of \$203,913 in pay and benefits in 2021-22, while vice president of finance Lily Pearson received \$173,781 in compensation and ben-

O'Neill noted that up until the recent discussion on the item, he'd never seen the compensation given to the nonprofit's top brass, Sherwin specifically.

"That is literally more money than every employee in the city of Newport Beach [is paid]," O'Neill said, adding that it was a discussion that needed to be had when contract negotiations occur in the upcoming year.

O'Neill said his comments were not a criticism of Sherwin, nor his work, but the compensation package is still substantial for a nonprofit funded by taxpayer dollars. He said he felt compensation totals should be included in the budget documents to inform the council as an oversight body.
